This Schedule is reproduced from the Schedule of Clothing Items to the Industrial Training (Clothing Industry) Ordinance, Chapter 318 of the Laws of Hong Kong. Any item of apparel which is specified in the Schedule and manufactured in Hong Kong is subject to a Clothing Industry Training Levy on export. This Schedule is appended for the convenient reference of exporters and does not form part of the Imports and Exports Classification List (Harmonized System). Where a Chapter, Heading or Subheading of the HK HS is quoted, all the items under it are included unless otherwise specified.
