# 2023 Amendments to Hong Kong Imports and Exports Classification List (Harmonized System)

## 香港進出口貨物分類表(協調制度) 2023年修改部分

香港進出口貨物分類表(協調制度)現行版將作修訂,有關修訂內容已刊載於 2022 年 11 月 11 日出版的香港特別行政區政府憲報,並將於 2023 年 1 月 1 日起生效。進出口人士於 2023 年 1 月 1 日或以後裝運的進出口貨物,必須按照經修訂的分類表報關。

這次修訂涉及 12 個貨物項目,包括化學產品、帽類、礦物製品、機械及電動設備和運輸設備。香港進出口貨物分類表的修訂部分可於下述途徑獲取:

# Hong Kong Imports and Exports Classification List (Harmonized System), 2023 Amendments

The current edition of the Hong Kong Imports and Exports Classification List (Harmonized System) (HKIECL) will be amended and the amendments, published in the Government of the Hong Kong Special Administrative Region Gazette on 11 November 2022, will take effect from 1 January 2023. Import and export declarations for shipments on or after 1 January 2023 must be completed in accordance with the amended classification made to the HKIECL.

The amendments involve 12 commodity items, including chemical products, headgear, mineral substances, machinery and electrical equipment, and transport equipment. A summary of the amendments to the HKIECL is available through the following channels:
