2024年修改部分**

香港進出口貨物分類表（協調制度）現行版將作修訂，有關修訂內容已刊載於 2023 年 11 月 10 日出版的香港特別行政區政府憲報，並將於 2024 年 1 月 1 日起生效。進出口人士於 2024 年 1 月 1 日或以後裝運的進出口貨物，必須按照經修訂的分類表報關。

這次修訂涉及 16 個貨物項目，包括果汁、化學產品、木製品、電線及電纜和汽車。香港進出口貨物分類表的修訂部分可於下述途徑獲取：

**Hong Kong Imports and Exports Classification  
List (Harmonized System), 2024 Amendments**

The current edition of the Hong Kong Imports and Exports Classification List (Harmonized System) (HKIECL) will be amended and the amendments, published in the Government of the Hong Kong Special Administrative Region Gazette on 10 November 2023, will take effect from 1 January 2024. Import and export declarations for shipments on or after 1 January 2024 must be completed in accordance with the amended classification made to the HKIECL.

The amendments involve 16 commodity items, including juice, chemical products, articles of wood, wire and cable, and motor vehicles. A summary of the amendments to the HKIECL is available through the following channels:
