## 政府統計事務體系的組織及管理

## Organisation and Administration of the Government Statistical Service

### 1 組織 Organisation

- 1.1 政府統計處連同設於政府多個部門及決策局的統計組構成政府統計事務 體系,是一個提供政府統計服務的網絡。
- 1.2 概括而言,供一般用途的統計數據,大部分由政府統計處負責編製。而設於政府不同部門和決策局的統計組,則負責特定用途的統計數據(專門用於有關部門或決策局的工作上)及在統計運用方面提供支援。
- 1.3 政府統計處處長是政府的統計事務總顧問,也是政府統計事務體系的主管,一方面管理政府統計處,另一方面協調各「外調統計組」的工作,以及監督它們的技術水平。統計處處長屬下有一名副處長及五名助理處長,協助執行職務。

#### 政府統計處

- 1.4 政府統計處分為五個部,每部由 一名助理處長擔任主管,各部的職責如 下:
- (一) 經濟統計(一)部:負責對外商品貿 易統計和價格統計;
- (二) 經濟統計(二)部:負責按行業劃分的經濟統計,例如製造業、建造業、運輸業、商用服務業、分銷業、食肆和酒店業等,提供數據範圍包括業務表現、運作特徵和服務貿易方面等情況;亦負責科技、資訊科技在工商業的使用情況和普及

- 1.1 The Census and Statistics Department (C&SD) together with statistical units established in various government departments and policy bureaux form the Government Statistical Service (GSS), representing a network for the provision of government statistical services.
- 1.2 Broadly speaking, most general-purpose statistics come under the responsibility of the C&SD. The statistical units in various government departments and policy bureaux will take care of specific-purpose statistics (for dedicated use in their respective work) and provide necessary support in the application of statistics.
- 1.3 The Commissioner for Census and Statistics is the Government's principal adviser on all statistical matters and the head of the GSS. On the one hand, he fulfills his responsibilities by being the head of the C&SD and, on the other hand, co-ordinates the work of outposted statistical units and monitors their technical standards. He is assisted by a Deputy Commissioner and five Assistant Commissioners in discharging his duties.

#### The Census and Statistics Department

- 1.4 The C&SD is organised into five divisions. The functions of these five divisions, each headed by an Assistant Commissioner, are :
- (a) Economic Statistics Division (1): This Division deals with external merchandise trade statistics and price statistics;
- (b) Economic Statistics Division (2): This Division deals with sectoral economic statistics covering such sectors as manufacturing, construction, transport, business services, distributive trades, restaurants and hotels; providing data on such aspects as business performance, operating characteristics and trade in services. It also deals with statistics on science and technology, information

- (五) 綜合統計部:負責勞工統計數據和 進行就業、薪金總額、工資及人力 統計調查;為部門內的資訊科技應 用提供支援服務;組織人力資源發 展有關活動;處理出版事宜;監察 多個政府部門統計組的工作;以及 為其他政府部門(尤其是並沒有設 立統計組的部門)提供統計專業服 務。

- technology usage and penetration in the business sector, and regional offices in Hong Kong representing companies outside Hong Kong;
- (c) Economic Statistics Division (3): This Division deals with national income statistics and Balance of Payments statistics;
- (d) Social Statistics Division: This Division deals with demographic, labour force and other social statistics; plans and executes population censuses and conducts social surveys; and oversees the statistical units in a number of government departments; and
- (e) General Statistics Division: This Division deals with labour statistics and undertakes surveys of employment, payroll, wages and manpower; provides support in applications of information technology in the department; organises human resources development activities; handles publication matters; oversees statistical units in a number of government departments; and provides statistical professional services to other government departments, particularly those where statistical units have not been established.

- 1.5 此外,還有三個科由副處長直接管轄,分別是技術支援科、發展科和行政科。
- 1.6 政府統計處的組織表見附件甲。

#### 工作方針

- 1.7 在執行職務時,本處跟隨國際標準和慣用方法。其中一個主要的參照,就是聯合國於一九九四年議決採納的「官方統計基本原則」。在資料發布方面,本處亦遵守國際貨幣基金組織的「發布數據特別準則」。另外,本處人員亦經常參考國際統計學會的「專業操守宣言」。
- 1.8 作為一個專業部門,本處重視科學化及專業的形象,辦事方面則持着不偏不倚、正直及客觀的態度。在向公眾提供服務時,同時亦重視保持良好服務素質、友善的態度和順暢的溝通。
- 1.9 有關本處在執行職務時所採用的政策和實踐方法的資料,上載於聯合國統計司的「官方統計優良實踐方法」的網站內(esa.un.org/unsd/goodprac/default.asp)。這個網站載列參考資料,說明聯合國「官方統計基本原則」的應用,並詳述每個原則背後的基本元素,更就各統計機關為體現這些原則而採取的政策和實踐方法,列舉例子。

### 其他政府部門及決策局的統計組

1.10 除政府統計處外,統計人員亦派 駐 30 個政府部門及決策局,工作範圍包 括教育、房屋、衞生、社會福利、治 安、運輸和策略性規劃等。外調的統計 人員在日常工作上直接向所屬部門負

- 1.5 In addition, there are three branches directly supervised by the Deputy Commissioner, namely Technical Secretariat, Development Branch and Administration Branch.
- 1.6 The organisation chart of the Census and Statistics Department is shown in Annex A.

#### Guiding principles of work

- 1.7 In carrying out its various activities, the department follows international standards and practices. In this regard, a central piece of reference is the Fundamental Principles of Official Statistics adopted in 1994 by the United Nations. In the area of data dissemination, the department also complies with the Special Data Dissemination Standard (SDDS) of the International Monetary Fund. In addition, staff of the department also make regular reference to the Declaration of Professional Ethics of the International Statistical Institute.
- 1.8 As a professional department, the department places emphasis on a scientific and professional image, and always works with impartiality, integrity and objectivity. At the same time, great importance is attached to good quality of service, friendliness and smooth communication in providing services to the public.
- 1.9 Information on policies and practices which the department adopts in discharging its duties is uploaded on the website on "Good Practices in Official Statistics" maintained by the United Nations Statistics Division (esa.un.org/unsd/goodprac/default.asp). This website provides reference materials to illustrate the application of the United Nations Fundamental Principles of Official Statistics. It elaborates the essential elements behind each of the Principles and provides examples of policies and practices adopted by statistical authorities for implementing the various elements of the Principles.

## Statistical units in other government departments and policy bureaux

1.10 Apart from the C&SD, statistical staff are posted to 30 government departments and policy bureaux. Subject matter areas include education, housing, health, social welfare, law and order, transport and strategic planning, etc. While staff in outposted statistical units are responsible to the departments/

責;但在有需要時,統計處總部會提供 專業意見和協助。外調統計人員的招 聘、培訓、調派及晉升等事宜,亦由統 計處負責。藉着這種安排,各政府部門 在統計工作方面的素質水平得以保持。 bureaux to which they are posted in respect of the day-to-day work, professional advice and assistance are provided to them by the C&SD headquarters when it is deemed necessary. Moreover, the outposted staff come under the C&SD in such matters as recruitment, training, posting and promotion. Through this arrangement, the quality standard of statistical work across the Government is maintained.

#### 統計諮詢委員會

1.11 為確保統計工作的發展能適當配 合社會上各界的需要,政府於一九七二 年成立了統計諮詢委員會。該委員會屬 於非法定的諮詢團體,由政府統計處處 長擔任主席,委員包括十名非官方委員 和三名官方委員。非官方委員分別來自 商業、學術和社會各界別,有均衡的代 表性,並能綜合數據使用者、原始數據 提供者和統計學家三方面的意見。委員 會的官方成員包括財經事務及庫務局局 長、衞生福利及食物局局長和政府經濟 顧問的代表。他們代表政府就經濟及社 會統計數據方面,提供意見。該委員會 一直就政府統計事務體系的統計事宜, 向統計處處長提供寶貴的意見。委員會 於二零零四年六月至二零零六年五月任 期內的委員名單,載列於附件乙。

#### Statistics Advisory Board

1.11 To ensure that the needs of various sectors of the community can be suitably taken into account in the development of government statistical activities, a Statistics Advisory Board was established by the Government in 1972. The Board is a non-statutory advisory body chaired by the Commissioner for Census and Statistics and consists of ten non-official members and three official members. The nonofficial members offer a balanced representation from businesses, the academia and the community. Views of the three sectors, namely data users, raw data suppliers and statistical scientists are integrated. Representatives of Secretary for Financial Services and the Treasury, Secretary for Health, Welfare and Food and Government Economist serve as the three official members. They represent Government interests in regard to statistics on economic and social fronts. The Board has been providing valuable advice to the Commissioner on statistical matters pertaining to the GSS. Membership of the Board for the session from June 2004 to May 2006 is given in Annex B.

#### 香港特別行政區的統計系統

1.12 中華人民共和國政府於一九九七年七月一日恢復對香港行使主權。香港特別行政區依據「一國兩制」的原則,於該日成立。根據香港特別行政區基本法,香港在回歸後實行高度自治。在統計工作方面,香港特別行政區保留其本統計工作方面,香港特別行政區情況的統計數據,政府統計處只對香港特別行政區政府統計數域所,與中國內地的相應部門並無行政上的關係。

## Statistical systems of the Hong Kong Special Administrative Region

1.12 The Government of the People's Republic of China resumed its exercise of sovereignty over Hong Kong on 1 July 1997. On this day, the Hong Kong Special Administrative Region (HKSAR) was established under the "One Country, Two Systems" principle. As stipulated in the Basic Law of the HKSAR, Hong Kong would exercise a high degree of autonomy. In respect of statistical work, the HKSAR maintains its separate statistical systems and continues to compile and disseminate statistical data about the HKSAR. As regards the C&SD, it is responsible to the Government of the HKSAR only and there is no administrative relationship between it and the corresponding departments in the mainland of China.

### 2 財政及人力資源 Finance and Human Resources

#### 編制


2.1 統計人員分別屬於四個職系:統計師職系、統計主任職系、外勤統計主任職系和統計督導職系。統計師職系由統計專業人員組成,負責策劃及管理統計系統和統計計劃,並督導其他三個職系人員的工作。統計主任主要進行統計運算和協助進行統計分析。外勤統計主任職系人員負責進行各項普查及統計調查的外勤工作。統計督導職系人員協助監督處理貿易報關單及貨物艙單的工作。

2.2 下圖列出在所示日期政府統計處的編制人數,以及在其他政府部門及決策局的統計職位數目。在二零零六年一月一日,政府統計處的編制人數有1277人,在其他政府部門及決策局的統計職位則有191個。各類統計職位的分布詳情,載列於附件丙一及丙二。

#### Establishment

2.1 There are four grades of statistical staff, namely the Statistician grade, the Statistical Officer grade, the Census and Survey Officer grade and the Statistics Supervisor grade. Professional staff, who constitute the Statistician grade, function as planners and managers of statistical systems and projects, and supervise the work of the other three grades of staff. Staff of the Statistical Officer grade mainly handle statistical computation and assist in statistical analyses. Fieldwork of censuses and surveys is carried out by staff of the Census and Survey Officer grade. Staff of the Statistics Supervisor grade assist in supervising the processing of trade declarations and cargo manifests.

2.2 The following charts show the establishment of the C&SD as at the dates indicated. Figures in respect of statistical posts in various other government departments and policy bureaux are also given. As at 1 January 2006, the establishment of the C&SD was 1 277 and the number of statistical posts in various government departments and policy bureaux was 191. Further details of the distribution of statistical posts are presented in Annexes C1 and C2.



#### 財政

2.3 下圖顯示二零零二至二零零三年度至二零零六至二零零七年度的財政數字,可供互相比較。在二零零六至二零零七年度政府統計處的預算開支為5.296億港元,較二零零五至二零零六年度的修訂預算增加5,260萬港元。預算增加的開支主要為二零零六年中期人口統計工作的撥款。在其他政府部門及決策局的統計人員預算薪酬為6,290萬港元。

#### **Finance**

2.3 The following charts give comparative financial figures for the period 2002-2003 to 2006-2007. The expenditure of the C&SD in 2006-2007 is estimated to be HK\$529.6 million, representing an increase of HK\$52.6 million as compared to 2005-2006. This is mainly due to the provision for the conduct of the 2006 Population By-census. The personal emoluments of statistical staff in other government departments and policy bureaux are estimated to be HK\$62.9 million.



#### 員工培訓及發展

- 2.4 政府統計處十分重視發展其人力 資源的潛能,故實施了一系列全面的培 訓及發展項目。推行這些項目的主要目 的,是培育每一名員工成為協助本處有 效運作的一員,並使他們在執行職務時 能達致最佳表現,從而建立一支能幹、 充滿活力、勇於承擔和積極進取的工作 隊伍。
- 2.5 本處的培訓及發展活動涵蓋以下 各個不同層面,務使員工能具備多方面 的才能:
- (一) 統計知識(包括理論和實踐方面);
- (二) 統計管理;
- (三) 一般管理;
- (四) 對特定課題的認識;
- (五) 資訊科技的應用;及
- (六) 語文及溝通技巧。

### Staff training and development

- 2.4 The C&SD attaches great importance to developing its human resources to their full potential through instituting a comprehensive range of training and development (T&D) programmes for its staff. The primary objective of these programmes is to nurture people to maximise individual performance for the effective functioning of the department, thus bringing about a versatile, dynamic, resilient and motivated staff force in the department.
- 2.5 In order to meet the objective of achieving multiple skills by the staff, the T&D programmes of the department cover the following areas :
- (a) Statistical knowledge, both in theory and practice;
- (b) Statistical management;
- (c) General management;
- (d) Subject matter knowledge;
- (e) Application of information technology; and
- (f) Language and communication skills.

- 2.6 大部分培訓及發展項目由本處自 行舉辦或與其他專業團體合辦,亦有一 些是由私營培訓機構提供的。以一些與 專業知識有關的培訓為例,本處會不時 委派員工參加在本地及海外舉行的課 程/工作坊、座談會及會議,以鼓勵他 們與本處以外的統計學家及統計工作者 分享經驗及交流心得。
- 2.7 除正規的訓練課程外,本處亦安排一些輔助計劃,以便員工能透過分享經驗,鞏固及增進知識,從而提升各項正規培訓及發展活動的有效性。為着類似目的,本處也鼓勵員工在其辦公地點舉行一些定期和不定期的組別會議及討論,以啟發可改善機構管理及其他方面的創新意念。
- 2.6 Most of the department's T&D programmes are run inhouse or in collaboration with other professional bodies while some others are organised by training institutions in the private sector. For professional subjects in particular, staff are sent to attend training courses/workshops, seminars and conferences held locally and overseas. These activities will go a long way in facilitating the sharing of experience and exchange of ideas with scholars and practitioners in statistics outside the department.
- 2.7 Besides formal programmes, supplementary schemes are also in place to facilitate knowledge consolidation and enhancement among staff members through participation in sharing sessions in their workplace, which in turn helps enhance the effectiveness of various formal T&D activities. For similar purposes, regular and ad hoc sectional meetings and discussions are held at the workplace for generating new, innovative ideas essential for organisational management and advancement.

### 3 法例 Legislation

- 《普查及統計條例》是直接規管政 府統計處工作的主要法例,授權政府統 計處處長進行人口普查及強制性質或自 願參與性質的統計調查。就人口普查及 強制性質的統計調查而言,《普查及統 計令》以清晰明確的字眼,描述該項普 查或統計調查涵蓋的範圍和調查的項 目,並規定受訪者必須提供統計令訂明 的資料。至於自願參與性質的統計調 查,統計處會在展開統計調查前在政府 **憲報刊登公告。此外,《普查及統計條** 例》規定任何個人、住戶或公司的資料 必須保密。這項保障條文適用於強制性 質及自願參與性質的統計調查,有助取 得受訪者合作,提供所需資料。附件丁 及戊分別載列根據《普查及統計令》進 行的統計調查,以及在二零零五至二零 零六年度進行的自願參與性質統計調 杳。
- The main legislation governing the work of the department is the Census and Statistics Ordinance, which empowers the Commissioner for Census and Statistics to carry out censuses of population and statistical surveys of mandatory or voluntary nature. For population censuses and mandatory statistical surveys, respondents are required to provide information as specified and promulgated under relevant Census and Statistics Orders which describe in clear and explicit terms details of the survey coverage and items of enquiry in the survey. For voluntary surveys, advance announcement of their implementation has to be made in notifications in the Government Gazette. The Ordinance contains provision for protection of confidentiality of information in regard to individual persons, households or companies. The provision, which applies to surveys of both mandatory and voluntary nature, is important in securing co-operation and willingness of respondents to supply the enquired data. A list of surveys conducted under enacted Census and Statistics Orders and a list of voluntary surveys conducted in 2005-2006 are given respectively in Annexes D and E.

- 3.2 貿易統計是本處一項重要的統計 工作。根據《進出口條例》,進出口商 必須依時及準確地填報進出口報關單, 以提供主要數據作編製貿易統計之用。
- 3.3 有關統計的法例賦予政府統計處明確及獨立的身分,搜集、分析及發布統計資料。雖然本處是政府內的一個部門,但卻有別於其他負責制定和執行政策的部門。這一獨特的身分,讓其執行工作時更為便利,予人處事公正、客觀的印象。
- 3.2 Trade statistics constitute a very important part of the work of the department. The Import and Export Ordinance stipulates that importers/exporters are required to submit import/export declarations, which provide the main data for compiling trade statistics, in a timely and accurate manner.
- 3.3 Through enactment of the Ordinances, the C&SD is designated with a clear and independent role in collecting, analysing and disseminating statistical information. While being a government department, the C&SD is to be distinct from other departments of the Government responsible for policy making and enforcement activities. This positioning of the C&SD in the Government facilitates its work and enables it to be perceived as working in an impartial and objective manner.

#### 4 資料發布 Data Dissemination

#### 資料發布

- 4.1 本處編製及發布統計數據時,會 盡量採用由國際組織頒布及廣受接納的 統計定義、概念和方法,以及分類制 度。這些國際組織包括聯合國、國際勞 工組織和國際貨幣基金組織,採用國際 接納的標準,有助確保所編製的統計數 據維持一定的素質水平,並可與其他經 濟體系的數據互相比較。
- 4.2 本處會以發布可信的統計數據, 以及保密個別公司、住戶或個人衛子 調查結果和由各個統計系統得出的 數字。本處會視乎情況提供統計數 數字。本處會視乎情況提供統計數 時間數列,以便使用者進行分析,原數 時間數內,以便使用者進行分析,原數 時間數內情況下,於提供原數 時,提供經季節性調整的統計數據,中 文和英文都是香港的法定語文 文和英文都是香港的法定語文 。因此,本處採用雙語 發布不同形式的數據,如統計報告和本 處的網站等。

#### Data dissemination

- 4.1 The department follows closely the widely accepted definitions, concepts and methods on statistical matters and classification systems promulgated by international organisations such as the United Nations, International Labour Organisation and International Monetary Fund (IMF) in compiling and disseminating statistics. The adoption of internationally accepted standards helps ensure a definite level of quality in the statistics compiled and comparability with statistics of other economies.
- 4.2 Results of statistical surveys and statistics derived from various statistical systems of the department are disseminated in different forms, subject to consideration of reliability of the statistical data concerned and the need to preserve confidentiality of data pertaining to individual firms, households or persons. Time series of statistics are presented wherever appropriate to facilitate analysis by users. Seasonally adjusted statistics are also presented as far as practicable in addition to the original series. Chinese and English are both official languages in Hong Kong; and they are indeed both popularly in use. Accordingly, bilingualism is adopted in various forms of data dissemination such as statistical reports and the department's website.

#### 發布數據特別準則

- 4.3 在發布經濟及金融統計數字方面,本處以國際貨幣基金組織在一九九六年正式訂立的「發布數據特別準則」 為實務指引。
- 4.4 國際貨幣基金組織於一九九七年四月接納香港簽署「發布數據特別準則」。這表示本處在發布經濟和金融數據方面會遵守有關的國際標準,包括數據的範圍、周期性、及時性、誠信性、素質及數據開放予公眾的程度各方面。
- 4.5 香港現時已全面符合「發布數據特別準則」的規定,在某些範疇上更超越了有關的標準。
- 4.6 香港經濟和金融數據的資料和數據發布的慣常做法,刊載於國際貨幣基金組織在互聯網上的「發布數據準則告示板」(dsbb.imf.org),更廣泛地讓世界各地人士認識。

#### 發布數據的方法

- 4.7 為切合數據使用者的不同需要,本處透過多種媒體發布官方統計數字, 以符合易於獲取和迅速傳遞的服務原 則。
- 4.8 本處會就大眾關注的統計數據向 傳播媒介發出新聞稿,並且在每年九月 公布下一曆年定期統計數列的新聞發布 時間表。發布時間表詳列統計處每年 120個新聞發布的日期,會分發給傳媒 參考,並列載於本處的網站內。二零零 六年的時間表載於附件己。過往多年, 本處所有新聞稿均按照原定日期發放。

#### Special Data Dissemination Standard

- 4.3 In respect of dissemination of economic and financial statistics, the SDDS of the IMF, which was formally established in 1996, serves as a practical guide.
- 4.4 In April 1997, the IMF accepted Hong Kong's subscription to the SDDS. The department has undertaken to follow international standards regarding the coverage, periodicity, timeliness, integrity and quality of disseminated data and access by the public in respect of economic and financial data.
- 4.5 Hong Kong is now in full compliance with the SDDS and has even exceeded the SDDS requirements in certain areas.
- 4.6 Relevant information about economic and financial data of Hong Kong and the data dissemination practices are posted on the IMF's Dissemination Standards Bulletin Board on the Internet (dsbb.imf.org), making them more widely known to people around the world.

#### Means of data dissemination

- 4.7 In meeting the divergent needs of data users, the department disseminates official statistics through different media, emphasising the service principles of friendly access and prompt delivery.
- 4.8 For statistics of common interest, the department issues press releases to the media. The schedule for issuing press releases on regular series of statistics for each calendar year is announced by the department in September of the preceding year. The schedule, covering 120 press releases per year, is distributed to the media and also made known to the general public on the website of the department. The 2006 schedule is given at Annex F. In past years, all releases were made exactly on the scheduled dates.

- 4.9 所有的新聞稿在發放後隨即上載 於本處的網站(www.censtatd.gov.hk), 方便本地及世界各地人士獲取最新的統 計數據。一些為大眾所認識的常用統計 數字也可在網站內的「香港統計資料」 部分取得。
- 4.10 至於較詳細的統計數字,則連同 其涵蓋範圍、定義、方法和資料來源刊 載於本處出版的刊物,供市民購買。目 前,本處定期出版的刊物約有50種,總 計每年出版超過200期。此外,本處亦 就社會關心的課題特別出版專題刊物。
- 4.11 本處亦自行或與私人公司合作製造唯讀光碟產品,以發布大量的數據,包括人口普查/中期人口統計的詳細結果、對外商品貿易數字和船務統計數字。
- 4.12 本處供銷售的統計刊物/產品大致可透過三種途徑獲取:網上的「香港統計數據書店」(www.statisticalbookstore.gov.hk),本處的銷售中心,以及郵購服務。
- 4.13 按年出版的《統計產品及服務一 覽》介紹本處的刊物及其他統計產品、 本處所提供的服務,以及獲取這些統計 產品和服務的方法。這概覽備有印刷版 及電腦唯讀光碟,免費派發給市民。

- 4.9 All press releases are posted on the C&SD Website (www. censtatd.gov.hk) shortly after their release, making up-to-date statistics readily accessible to the local public and the international community. Statistics, which should be of general public knowledge, are also uploaded on the Website under the "Hong Kong Statistics" Section.
- 4.10 More detailed statistics, together with their coverage, definitions, methodology and sources of data, are readily available to the public in publications. Today, the department publishes about 50 titles of regular publications amounting to over 200 issues each year. Ad hoc publications on topics of current interest to the community are also published.
- 4.11 To facilitate the dissemination of massive data, viz. detailed results of Population Censuses/By-censuses, merchandise trade figures and shipping statistics, CD-ROM products are produced, either in-house or in partnership with private companies.
- 4.12 Basically, there are three means of obtaining saleable statistical publication/products of the department, viz. the online "Statistical Bookstore, Hong Kong" (www. statisticalbookstore.gov.hk), the sales centre operated by the department and mail order service.
- 4.13 A Catalogue of Statistical Products and Services is published annually to introduce the publications and other statistical products that the department produces, various services it renders and the means of obtaining them. It is available in both print and CD-ROM versions for free distribution.

To cater for the divergent needs of data users, the department disseminates official statistics through different media.

4.14 本處十分重視市民的知情權。大部分本處出版的刊物均已存放於公共圖書館,供市民查閱。此外,本處製備大量宣傳/教育單張、小冊子等,免費派發給市民。這些免費參考資料的下載版存放於本處網站(www.censtatd.gov.hk/chinese/prod\_serv/index.html),以供閱覽或下載。如欲獲取這些資料的印刷版,可與本處的刊物主任聯絡(電話:(852) 2582 4736 ,圖文傳真:(852) 2827 1708 ,電郵:publications@censtatd.gov.hk)或親臨本處各辦事處的詢問處索取。

4.15 倘若使用者未能從本處的產品或網站獲得所需的統計數字,可隨時向本處人員查詢。此外,市民亦可以開設戶口使用本處的圖文傳真服務,或在有需要時親臨本處的貿易統計數據服務中心,獲取貿易統計數字。

4.14 The department devotes much attention to people's right to know. Nearly all publications of the department are placed at the public libraries for public access. Also, a good number of publicity/educational leaflets and pamphlets of the department are available free of charge. Download versions of these free reference materials are available on the website of the department (www.censtatd.gov.hk/eng/prod\_serv/index. html) for viewing or downloading. Print version of these materials can be obtained by contacting the Publications Officer of the department (Tel.: (852) 2582 4736, Fax: (852) 2827 1708, E-mail: publications@censtatd.gov.hk) or in person at enquiry counters of the offices of the department.

4.15 Users are welcome to approach staff of the department for assistance in case the statistics they need are not accessible from the products or website of the department. Besides, users are recommended to use the fax service on statistics by opening an account with the department or visit the Service Centre on Trade Statistics to obtain trade statistics when needs arise.

## 政府統計處網站 (www.censtatd.gov.hk)

4.16 政府統計處的網站在一九九六年 三月推出,是瀏覽人數眾多的香港特別 行政區政府網站之一。網站的內容充 實,包括最新的本地主要社會和經濟數 據,以及統計發展的最新資訊。此外, 本處的網站亦是一個入門網站,方便互 聯網用戶查閱其他政府部門和決策局所 編製的官方統計數據。

4.17 本處不斷加強其網站的內容和功能,務求更能滿足用戶的需求。最近推出經重建的「政府統計處網站」不但內容更為豐富,導覽及搜尋功能更為完善,還提供多項增值服務,包括以地局形式顯示統計數據、建立簡易資訊聚合(RSS)資訊頻道和提供電郵通知服務。此外,新網站引入了按主題劃分的表達方式,使所有有關某一主題的最新統計數字、新聞稿、專題文章、刊物及其他內容,在單一網頁內顯示,讓使用者更方便地得到所需的統計資訊。

#### 擴展數據發布的途徑

4.18 一直以來,本處與私營的數據代 理機構及資訊服務提供者緊密合作,把 香港官方統計數據併入該等機構的增值 資訊產品及應用系統內,包括地理資訊 系統地圖、經濟及財經數據服務產品 等。來年,本處會進一步研究擴展發布 數據的途徑,從而推廣官方統計數字在 社會各界的應用。

## The C&SD Website (www.censtatd.gov.hk)

4.16 The C&SD Website, which was launched in March 1996, is a popular website of the Government of the HKSAR. It provides Internet users with up-to-date statistics covering major social and economic aspects of Hong Kong as well as information on recent statistical developments. It also serves as a portal of official statistics compiled by other government departments and policy bureaux.

4.17 The department has been making continuous improvements to enhance the contents and functionalities of its website to better serve users' needs. The C&SD Website has recently been revamped to provide enriched contents, enhanced navigation and search functions as well as value-added services, which include map based statistical data presentation, Really Simple Syndication (RSS) information feeds and e-mail notification service. In addition, a thematic presentation approach has been adopted whereby the latest statistics, press release, feature articles, publications and other contents relating to a particular subject area are displayed on a single web page to enable users to obtain the statistical information in need in a more convenient manner.

#### Expanding the channels of data dissemination

4.18 The department has been making extensive collaboration with data agencies and information providers in the private sector in incorporating official statistics about Hong Kong in their value-added information products and applications, which include Geographic Information System (GIS) mapping, economic and financial data products, etc. In the coming year, the department will continue its efforts in further promoting the use of official statistics in the community by expanding the channels of data dissemination.

#### 5 資訊科技的應用及電子政府措施

Application of Information Technology and E-Government Initiatives

#### 資訊科技在統計工作的應用

5.1 本處在各項統計程序中廣泛應用 資訊科技,包括抽樣框的更新、資料搜 集,以及數據處理、分析和發布。先進 科技的應用包括以電腦輔助電話訪問技 術進行統計調查、運用地理資訊系統支 援人口普查/中期人口統計的外勤工 作,以及經由互聯網提供不同的電子化 統計服務。

## Information Technology (IT) applications in statistical work

5.1 IT is applied extensively throughout the statistical processes including sampling frame maintenance, data collection, data processing, data analysis and data dissemination. Advanced applications include the use of Computer-Assisted Telephone Interviewing technique for conducting survey interviews, the deployment of GIS to support the fieldwork of population censuses/by-censuses and the use of Internet for the provision of various electronic statistical services.

The department has all along been applying information technology in a wide range of statistical work and services and is keen to participate in the related promotional activities. Mr. H. W. FUNG, Commissioner for Census and Statistics, (1st on the right) attended the launch ceremony of the "Science in the Public Service" on 13 January 2006 as one of the officiating quests.

#### 電子政府措施

5.2 為配合政府整體的電子政府政策,本處成立了一個高層次的跨部別工作小組,制定部門的電子政府政策及統籌部門內不同科別的電子政府構思和協調有關的工作。

#### E-Government initiatives

5.2 In line with the overall e-government policy, a high level inter-divisional working group has been set up to formulate an e-strategy for the department and to co-ordinate e-government ideas and work in various offices within the department.

- 5.3 本處的電子政府措施主要在數據 發布、資料搜集和申請統計服務等三個 業務範疇,以及內部運作上發展。總括 而言,本處所有適用於電子模式傳送資 料的統計服務已提供電子化模式,供使 用者選擇。
- 5.4 在發布數據方面,除了上文 第 4.17 段提及重建政府統計處網站之 外,本處正計劃在部門網站和網上的 「香港統計數據書店」提供免費下載的統 計刊物及個別統計表。推行這項計劃不 僅是本處電子發布數據的重要里程碑, 本處也期望藉此進一步提高大眾對統計 的認知,並讓社會各界充分掌握資訊作 決策和決定。
- 5.5 在資料搜集方面,自二零零一年起,本處所有適用於電子模式傳送的統計調查問卷經已備有電子版本。本處亦已計劃於二零零六年的中期人口統計引入嶄新的電子報表方案。此方案讓受訪者使用免費軟件填寫便携文件檔案格式的電子問卷,然後把填妥的問卷經由互聯網安全地傳送至本處。本處將會參考二零零六年中期人口統計中使用電子問卷的情況,再決定是否把這方案推廣至其他統計調查。
- 5.6 至於申請統計服務方面,本處已 為不同的統計服務提供電子表格。
- 5.7 為營造有助內部運作電子化及促進電子政府發展的工作環境,政府最近全面展開「資訊科技設施普及計劃」。此計劃在本處的推行已完成,超過一千位同事曾出席訓練課程,學習使用有關的電腦設施作一般應用。同時,本處亦已開發多個「政府與政府」應用系統及政府內部的「政府與僱員」應用系統及辦公室自動化應用系統,以提升內部運作的效率。

- 5.3 E-government developments of the department focus on three main business areas, namely data dissemination, data collection and application for statistical services as well as internal operations. In general, e-options have been provided for all services amenable to the electronic mode of delivery.
- 5.4 In the area of data dissemination, apart from the revamping of the C&SD Website as mentioned in paragraph 4.17, plans are in place to provide free download versions of statistical publications and individual statistical tables on the C&SD Website and the online "Statistical Bookstore, Hong Kong". This represents an important milestone in electronic data dissemination of the department and is expected to further contribute to promoting statistical literacy and informed decision making in the community.
- 5.5 In the area of data collection, electronic questionnaire templates have been made available for all surveys amenable to the electronic mode of delivery since 2001. The department has also planned to adopt a new e-reporting option for the 2006 Population By-census. The option allows respondents to make use of a freeware to complete e-questionnaires in Portable Document File (PDF) format and upload completed e-questionnaires securely over the Internet. Based on the usage of e-questionnaires in the 2006 Population By-census, consideration will be given to extending the new option to other surveys.
- 5.6 As for e-government developments in the application for statistical services, e-forms are available for online application for various statistical services.
- 5.7 To create an e-enabled work environment, which facilitates internal operations to be conducted electronically and helps accelerate the development of e-government, a government-wide Accessibility Programme has been rolled out. The implementation of this programme in the department is completed, with over 1 000 staff members having attended training on how to use the available computer resources for general applications. A number of Government-to-Government (G2G) services, government- wide Government-to-Employee (G2E) services and office automation applications have also been developed to enhance internal operation efficiency.

#### 資訊科技策略

5.8 資訊科技日新月異,為統計工作 帶來新的契機,從而提高工作效率,推 動業務流程重組和系統整合。根據資訊 科技策略研究的建議,本處已展開多項 策略性計劃,以改善部門的資訊科技基 礎設施、推行知識管理、建設數據處理 和分析的綜合平台,以及檢討業務流程 和研究實施部門通用的數據輸入系統的 可行性。

#### IT strategy

5.8 IT advancement opens up new application opportunities in statistical work for efficiency improvement, business process re-engineering and systems integration. A number of strategic IT projects recommended in the Information Systems Strategy Study have been launched to enhance departmental IT infrastructure, implement knowledge management, establish a common data processing and analysis platform, and conduct process review and feasibility study for implementing department-wide data capturing systems.

### 6 統計研究及素質監控 Statistical Research and Quality Assurance

- 6.1 政府統計處對其他政府統計機構 及國際組織所應用的統計技術和統計管 理方法,進行研究,以尋求合適方法, 應用於本地政府統計工作中。研究重點 包括季節性調整時間數列的方法、統計 素質監控及數據發布方法等。
- 6.2 本處不斷致力貫徹提供高素質統計服務的承諾,並設立一套檢定計劃,透過自我評估及由第三者獨立檢定相關的統計程序,鞏固各個統計系統的素質監控機制。在檢定過程中,本處參照國際經驗,以確保所有統計數據的編製和發布均符合科學原理、專業操守及國際標準。
- 6.1 The C&SD undertakes studies on statistical techniques and management methods developed or employed by other government statistical authorities and international organisations with a view to identifying appropriate practices for possible adoption in local government statistical work. Areas of study include seasonal adjustment of time series, statistical quality assurance and data dissemination practices.
- 6.2 Continued and dedicated effort is made by the department in meeting the pledge of providing quality statistical services. A review programme of the quality assurance mechanism of various statistical systems has been established involving both self-assessment and independent third-party review of the statistical processes concerned. In the review process, the department draws upon international experience and strives to ensure that statistics are compiled and disseminated in accordance with scientific principles, professional ethics and international standards.

#### 7 與國際和本地統計社群的關係

Relationship with the International and Local Statistical Communities

#### 國際會議和交流訪問

7.1 要掌握國際統計社群的最新發展,本處的統計專業人員多年來一直積極參與有關的國際會議、工作坊、研討會及工作小組。此外,本處的統計專業人員與其他統計機構亦不時作交流訪問,就不同的技術性項目討論及交流意見和經驗。

7.2 近年,香港和中國內地在發展和協調統計事宜方面的聯繫日趨緊密。為有助日後安排雙方合作和交流統計事宜,本處與中華人民共和國國家統計局已於二零零三年四月一日就定期和內地統計機關接觸達成協議。該協議就本處和國家統計局(包括其省級和市級的附屬局)的直接接觸釐定程序和原則。

#### International conferences and exchange visits

7.1 To keep abreast of developments in the international statistical community, statistical professional officers of the department have been actively participating in international conferences, workshops, seminars and working groups. There are also exchange visits between statistical professional officers of this department and other statistical agencies to discuss and exchange views and experience on a variety of technical issues.

7.2 There have been increasingly closer ties between Hong Kong and the mainland of China in the development and co-ordination of statistical matters in recent years. To facilitate future arrangements for co-operation and exchanges on statistical matters, an agreement on regular contacts with statistical authorities in the mainland was signed between the department and the National Bureau of Statistics of China (NBS) on 1 April 2003. The agreement lays down procedures to be followed in making direct contacts between this department and the NBS, including its subordinating bureaux at the provincial and city levels.

#### 參與國際統計組織事務

7.3 為與著名國際機構和先進經濟體 系的統計機關維持和發展緊密的雙邊關 係,本處內一些同事也是國際統計組織 的活躍成員。這些組織包括英國皇家統 計學會及國際統計學會等。其中,政 統計處處長馮興宏先生為亞洲及太平 區國際比較方案區域諮詢委員會成員, 理處長歐陽方麗麗女士目前是該組織 下的國際收支平衡統計委員會成員 中,而部門內的一位高級統計師亦為該 委員會轄下直接投資統計技術專家組的 成員。

#### 參與香港統計學會事務

7.4 在本地方面,本處的統計專業人員亦積極參與香港統計學會的事務,出任該學會的執行委員會、各項活動的籌備委員會和工作小組成員。

## Participating in affairs of international statistical organisations

7.3 To maintain and develop strong bilateral relationships with statistical offices of renowned international organisations and advanced economies, some of our colleagues are active members of various international statistical organisations such as the Royal Statistical Society (RSS) of the United Kingdom and the International Statistical Institute (ISI). In particular, Mr. H. W. FUNG, Commissioner for Census and Statistics, is a member of the Regional Advisory Board for the International Comparison Program for Asia and the Pacific. Besides, at the invitation of the IMF, Mrs. Lily OU-YANG, Assistant Commissioner, is serving as a member of the IMF's Committee on Balance of Payments Statistics, and a Senior Statistician of the department is also serving as a member of the Direct Investment Technical Expert Group of the Committee.

## Participating in affairs of the Hong Kong Statistical Society

7.4 Locally, statistical professional officers of the department have also been participating actively in the affairs of the Hong Kong Statistical Society (HKSS) by serving on the Executive Committee, organising committees and working groups of various projects undertaken by the HKSS.

7.5 Since the taking over of the examination from the RSS of the United Kingdom by the HKSS in May 2002, all the certificates issued by the HKSS are recognised as of a standard equivalent to the certificates issued by the RSS for the same levels of qualification. This development marks an important milestone in the establishment of a local accreditation and examination system for statistical professionals in Hong Kong. As from the May 2004 round of examination, Chinese papers have been introduced for selection by candidates sitting the examinations of the Ordinary Certificate and the Higher Certificate. Mr. H. W. FUNG, Commissioner for Census and Statistics, is the Chairman of the HKSS Examination Board.

### 8 為其他政府部門提供的專業協助

Professional Assistance Rendered to Other Government Departments

- 8.1 本處為政府進行的各項統計活動 提供專業意見。此等工作部分是由調派 到各政府部門和決策局的統計人員執 行。至於沒有統計專業人員派駐的政府 部門或決策局,本處會在有需要時提供 專業協助,包括就應用統計數據方面和 進行統計調查時應採用的正確方法提供 意見。
- 8.2 在處理各方面的公共事務上,統計的應用相信會不斷增加。本處會繼續為各政府部門和決策局提供有關編製、應用及闡釋統計數據的專業協助,以便有關當局就公共事務制定政策及作出決定,使公眾得到高素質的服務。
- 8.1 The C&SD advises on statistical activities within the Government. This is put into effect partly through the arrangement of outposted statistical staff in various government departments and policy bureaux. For those departments or policy bureaux without professional statistical staff, the C&SD renders professional assistance as necessary, by advising on such aspects as application of statistics and adoption of proper methods in conducting statistical surveys.
- 8.2 Increasing use of statistics is expected in various aspects of public affairs. Professional assistance will continue to be provided to other departments and policy bureaux in the compilation, application and interpretation of statistics to facilitate policy formulation and decision making on public issues as required for providing quality services to the community.

### 9 服務市民 Serving the Community

#### 服務承諾

9.1 服務市民是本處一項持續而長遠 的承諾。為配合政府致力改善公共服務 的工作方針,本處自一九九三年起,每 年透過出版《服務承諾》小冊子,公布 各項服務所承諾的標準。

### 增進與原始數據提供者及統計數據 使用者的融洽關係

9.2 本處能成功編製準確和及時的統計數據,主要有賴原始數據提供者的合作,提供高素質的數據。為爭取和保持這些人士對各統計調查的支持,本處自一九九九年開始經常與他們舉行座談會,並不時拜訪一些主要機構。此外,本處亦向參與多項統計調查的主要公司,本處會安排一名統計員統籌辦理某參與計劃公司所有與本處統計調查有關的事

### Performance Pledge

9.1 It is a continuous, long-term commitment of the department to serving the community. The department has been releasing annually performance pledges in the form of a booklet entitled *Performance Pledge* since 1993, in line with the government's efforts in improving services to the public. The standards of services that may be expected of the department are detailed therein.

## Strengthening rapport with raw data suppliers and statistical data users

9.2 Our success in producing accurate and timely statistics largely rests on the co-operation of raw data suppliers in furnishing quality data. To gain and maintain their support for various statistical surveys, the department has been conducting discussion sessions with them and paying courtesy visits to prominent establishments from time to time since 1999. Moreover, a Customer Window Scheme has been implemented for major companies participating in multi-surveys of the department. Under this Scheme, a census officer is appointed to co-ordinate all survey matters of the department with a

- 9.3 本處亦定期與一些主要的統計數 據使用者接觸,以確保統計工作的發展 能適當地配合他們的需求。
- 9.4 在建立新統計系統和計劃進行新統計調查前,本處會適當地向統計數據使用者和或會成為原始數據提供者的人(例如統計調查的訪問對象)進行諮詢。這樣做既可搜集使用者對數據需求的意見,也可評估從原始數據提供者獲取所需資料的可行性和了解他們的填報負擔。

## 貿易事宜客戶聯絡小組及顧客意見 調查

9.5 本處其中一項主要工作是根據貿易報關單及貨物艙單上的資料編製貿易及有關的統計數字。本處自一九九四年起,設立了「貿易事宜客戶聯絡」,聽取客戶對本處服務的意見。 組」,聽取客戶對本處服務的意見, 組成員來自各界,包括貿易數據使用 和使用本處貿易報關單或貨物艙單遞交 服務的機構。此外,本處每年都會進行 顧客意見調查,搜集顧客對本處的貿易 統計數據服務中心的意見。 participating company so as to minimise field efforts and reduce respondent burden, thereby improving survey response and ensuring data consistency.

- 9.3 Regular meetings with major statistical data users have also been conducted to ensure that their demands can be suitably taken into account in the development of government statistical work.
- 9.4 In establishing new statistical systems and planning to conduct new statistical surveys, the department conducts consultations with both users of statistical data and prospective raw data suppliers (such as survey respondents) where appropriate. This has the advantages of tapping the users' views on data requirements, assessing the feasibility of obtaining the required information and understanding the reporting burden of the raw data suppliers.

## Customer Liaison Group on Trade Matters and customer opinion surveys

9.5 One main area of work of the department is to compile trade and other related statistics from information contained in trade declarations and cargo manifests. The department has been operating a Customer Liaison Group on Trade Matters (CLG) since 1994 to obtain customers' opinions on the services provided by the department. The CLG comprises personnel from various sectors who are either users of trade statistics or users of services provided by the department in the lodgement of trade declarations or cargo manifests. Customer opinion surveys are also conducted annually to collect opinions of customers visiting the Service Centre on Trade Statistics of the department.

#### 推廣統計認知

9.6 統計在社會上的應用愈來愈普及,公眾對統計的正確認識因而更形重要。因此,本處不斷致力加強大眾對官方統計數字的認知,以及對統計概念和方法的了解。本處經常舉辦不同類型的推廣統計認知活動,以迎合社會上不同階層人士(包括中學生、中學教師市民大眾)的需要。這些活動主要包括舉辦統計講座、研討會、課程和展覽,以及出版教育性單張/小冊子和有關統計知識的文章。

#### Promotion of statistical literacy

9.6 With the widespread use of statistics in the community, it is becoming more important for members of the public to have a proper understanding of statistics. Hence, the department has been making continuous efforts in promoting a higher level of awareness of official statistics and understanding of statistical concepts and methodologies. A variety of activities for promoting statistical literacy have been organised to cater for the needs of different sectors in the community (e.g. secondary students, secondary school teachers, tertiary students, government officers, media workers and members of the public). Such activities mainly include the organisation of statistical talks, seminars, courses and exhibitions, and the publication of educational pamphlets/leaflets and statistical articles.













### 統計發展

## **Statistical Developments**

### 10 人口 Population

#### 人口數據系統與人口普查

10.1 香港自一九六一年起,每十年進行一次人口普查;而在兩次人口普查中間,則進行一次中期人口統計。人口普查及中期人口統計的目的是搜集有關人口的數目及其社會經濟特徵和地區分布情況的最新基準資料。

10.2 從人口普查和中期人口統計得到的統計數據,對政府在規劃和制定政策方面,特別是有關教育、房屋、交通、醫療及社會福利的政策,尤為重要。此外,私人機構亦會運用這些數據釐定業務方針。

10.3 人口普查及中期人口統計提供基準人口數據,並且是細小分區及人口分組資料的重要來源。這些基準數據,再加上其他行政系統的統計資料(例如出生、死亡及出入境記錄)及抽樣統計調查(特別是持續進行的「綜合住戶統計調查」)的結果,連結成一個人口統計數據資料庫,資料可用作編製人口估計及其他眾多用途。

#### 二零零六年中期人口統計

10.4 二零零六年中期人口統計將於二 零零六年七月十五日至八月一日期間進 行,為期十八天。詳細籌劃工作如抽樣 設計及外勤工作(包括招聘及訓練臨時 外勤統計員)的安排已展開。

#### The population data system and population censuses

10.1 It is established practice in Hong Kong since 1961 to conduct a population census every ten years and a by-census in the middle of the intercensal period. The purpose of population censuses/by-censuses is to obtain up-to-date benchmark information on the size and socio-economic characteristics of the population and on its geographical distribution.

10.2 The statistical data obtained from population censuses/ by-censuses are vital to government planning and policy formulation, particularly in such fields as education, housing, transport, medical services and social welfare. The data are also important to the private sector for formulating business strategies.

10.3 Apart from providing benchmark population data, population censuses/by-censuses also serve as the prime sources of data for small areas and population sub-groups. These benchmark data, taken together with statistics generated from administrative systems (such as birth, death and passenger movement records) and sample surveys (in particular the continuous General Household Survey), provide a population statistical database which serves the purpose of compiling population estimates as well as a multitude of other purposes.

#### 2006 Population By-census

10.4 The 2006 Population By-census will be conducted during the 18-day period from 15 July to 1 August 2006. Detailed planning work on such aspects as sampling design and field operation (including recruitment and training of temporary field workers) is underway.

10.5 本處正發展電腦系統,以支援中期人口統計的各項活動,包括分派工作、聘任臨時外勤工作人員、輸入數據、發布統計數字等。除了更廣泛使用地理訊息系統技術支援外勤工作外,本處亦會應用電子系統協助數據搜集的工作。當中包括讓抽樣選取的住戶在互聯網上選擇合適的時段預約受訪,以及處理受訪者關於使用電子問卷的要求。

10.6 二零零六年中期人口統計的測試性統計調查已於二零零五年七至八月期間進行,以測試問卷設計、問題提問方法及運作程序等。測試結果顯示中期人口統計各方面的籌備工作妥善進行。

#### 人口估計及人口推算

10.7 本處使用「居住人口」方法編製的臨時人口估計,於統計時點後兩個月內發布,以供參考,而經修訂的人口估計會在其後六個月再公布。每半年公布一次的數字反映年中及年底的人口估計。

10.8 當二零零六年中期人口統計的結果於二零零七年年初備妥後,本處將會進行人口向後推算,修訂二零零一年至二零零六年的人口數字。修訂的人口數字將於二零零七年二/三月公布。

10.9 此外,本處將會編製以二零零六年年中人口估計為人口基數的新一套人口推算。結果將於二零零七年年中公布。

10.10 本處根據有關的登記系統所搜集 的資料,編製出生、死亡和婚姻統計數 據,並每年公布有關人口的重要指標。 10.5 Computer systems are being developed to support the whole range of by-census activities, from allocation of assignments and recruitment of temporary field workers, to data capturing and statistics dissemination. Apart from making more extensive use of the Geographic Information System technology in supporting field operation, a number of electronic applications will also be implemented to facilitate the data collection process. These include allowing the sampled households to make appointments for enumeration at preferred time slots through the Internet and processing requests of respondents for the use of electronic questionnaires.

10.6 A pilot survey of the 2006 Population By-census was conducted in July to August 2005 to test the questionnaire design, questioning approach and operational procedures. The pilot results indicated that various aspects of planning work undertaken for the by-census were generally in order.

#### Population estimates and population projections

10.7 Provisional population estimates compiled using the "resident population" approach are released for reference within two months after the reference time-point. Revised estimates are released after a further six months. Population estimates are released at half-yearly intervals to reflect the mid-year and year-end positions.

10.8 When the results of the 2006 Population By-census are available in early 2007, a retrojection exercise will be carried out to revise the population figures from 2001 to 2006. The revised population figures will be released in February/March 2007.

10.9 Besides, an updated set of population projections using the mid-2006 population estimate as the population base will be compiled. The results are expected to be available in mid-2007.

10.10 Birth, death and marriage statistics are compiled based on data collected through the relevant registration systems, with important demographic indicators published every year.

10.11 鑑於近年內地婦女在香港所生的嬰兒數目有上升的趨勢,編製香港的生育統計數字所需的數據涵蓋範圍已在二零零五年年初作出檢討。就經改進後的數據涵蓋範圍,由一九九六年起的生育統計數字隨之而作出修訂。有關的改進已在二零零五年四月號《香港統計月刊》內一篇題為「一九七五年至二零零四年香港生育趨勢」的專題文章內發布。

10.12 本處繼續進行深入的人口研究。 其中一項研究利用了分解技術將香港的 總和生育率的轉變分解為兩個部分: (一) 女性已婚百分比的轉變;及(二) 已婚女性生育率的轉變。分析結果已在 二零零五年九月號《香港統計月刊》內 一篇題為「總和生育率轉變的分析」的 專題文章內發布。 10.11 In view of the increasing trend of Mainland women giving births in Hong Kong in recent years, a review was conducted in early 2005 on the data coverage in compiling fertility statistics in Hong Kong. Revisions have subsequently been made to the fertility statistics since 1996, with an enhanced data coverage. The enhancement was announced in a feature article "The fertility trend in Hong Kong, 1975-2004" published in the April 2005 issue of the *Hong Kong Monthly Digest of Statistics*.

10.12 In-depth demographic analyses continue to be carried out. In particular, an analysis employing decomposition technique was carried out to split the change in the total fertility rate in Hong Kong into two components: (a) the change in proportion of now married females; and (b) the change in marital fertility rate. The results were released in a feature article "Analysis of the change in the total fertility rate" in the September 2005 issue of the *Hong Kong Monthly Digest of Statistics*.

#### 11 勞工 Labour

#### 勞動人口、就業及空缺統計

11.1 本處經由不同的統計調查的結果 編製有關就業統計數字。其中,經由 「綜合住戶統計調查」和「僱傭及職位空 缺按季統計調查」所編製的就業統計數 字,更是數據使用者經常參考的資料。

11.2 「綜合住戶統計調查」是持續進行的抽樣統計調查,搜集有關勞動人口、就業、失業及就業不足等方面的資料。這項統計調查涵蓋全港陸上非住院人士及口,但不包括居於院舍的住院人士及水上居民,涵蓋範圍約佔居港人口及水上居民,涵蓋範圍約佔居港人口移動。「綜合住戶統計調查」直接從中個覆蓋全港的屋宇單位樣本內的住戶搜集有關勞動人口的資料;同時,亦有搜集一些有關人口和社會經濟特徵的資料。除面談訪問方式外,該統計調查亦採用「電腦輔助電話訪問」方式以搜集數據。

#### Labour force, employment and vacancies statistics

11.1 The department compiles employment figures based on results of different surveys. Among these, the employment statistics compiled from the General Household Survey (GHS) and those from the Quarterly Survey of Employment and Vacancies (SEV) are frequently referred to by data users.

11.2 Conducted on a continuous basis, the GHS is a sample survey aiming at collecting information on the labour force, employment, unemployment and underemployment. The survey covers the land-based non-institutional population of Hong Kong and excludes inmates of institutions and persons living on board vessels. It thus covers about 99% of the Hong Kong resident population. It collects data on the characteristics of the labour force as well as the demographic and socioeconomic characteristics of the population directly from households in a sample of quarters scattered over the whole territory. Apart from face-to-face interviewing, the Computer-Assisted Telephone Interviewing (CATI) approach is also adopted for data collection in the GHS.



本處應用的「電腦輔助電話訪問」 技術有助提高統計 調查工作的效率。

The Computer-Assisted Telephone Interviewing technique adopted by the department helps enhance efficiency in conducting statistical surveys.

11.3 「僱傭及職位空缺按季統計調查」 在不同行業中抽選機構單位成為統計樣 本,從而搜集就業人數、職位空缺數目 及業務性質等資料。這項統計調查所得 的就業人數統計數字,加上職位空缺資 料,反映各行業的勞工需求。該統計調 查亦提供不同行業按區議會分區的就業 人數和機構單位數目。

11.4 由於「僱傭及職位空缺按季統計調查」沒有涵蓋建造業,本處另外進行一項「建築地盤就業人數按季統計調查」搜集主要地盤的工人就業及空缺資料。主要建築地盤指已取得屋宇署的展開工程通知書的私營工程,與及政府各工務部門轄下的公共工程,包括機電工程署及環保署管轄的工程。

11.5 為提高工作效率,本處鼓勵「僱傭及職位空缺按季統計調查」的受訪者透過郵寄、傳真、電郵或音頻電話回應系統交回問卷。本處會以「電腦輔助電話訪問」技術跟進未回應的個案,並採用「光學文字識別」技術和電腦輔助編碼系統來處理問卷。

11.3 For each round of the SEV, establishments are sampled from different industries. Information on employment, job vacancies and nature of business is collected. Together with data on vacancies, the employment statistics show the demand for labour for individual industries in the economy. The SEV also provides statistics on employment and number of establishments analysed by District Council district in different industries.

11.4 To supplement the coverage of SEV for the construction industry, a separate Employment Survey of Construction Sites is conducted quarterly to collect information on manual workers at major construction sites. Major construction sites cover private sector construction projects having obtained notice of commencement of works from the Buildings Department and public sector projects under the charge of various government works authorities, including the Electrical and Mechanical Services Department and the Environmental Protection Department.

11.5 For operational efficiency, respondents of SEV are encouraged to complete and return the questionnaires by mail, fax, e-mail or through a touch tone telephone response system. CATI technique is used to follow up outstanding cases. The optical character recognition (OCR) technique and a Computer-Assisted Coding system are employed in processing the returned questionnaires.

- 11.6 為減輕受訪者的負擔及更有效地調配資源,本處已在二零零四年年初精簡了統計調查中行業資料更新及職位空缺的填報要求。為進一步節省資源,「僱傭及職位空缺按季統計調查」的樣本規模已從二零零六年第一季度開始,由大約60000間機構單位縮減至大約32000間。統計調查的樣本設計已相應地作出修改,以便繼續提供較重要行業的詳細就業及空缺統計數字。
- 11.7 本處每月發表對上三個月期間的 失業和就業不足統計數據。至於經由 「僱傭及職位空缺按季統計調查」所編製 的就業及職位空缺統計數字則按季發 表。值得一提的是本處採用「X-11 自迴 歸 - 求和 - 移動平均」方法計算及發表 經季節性調整的失業率,從而可更清楚 反映失業的基本趨勢。
- 11.8 「綜合住戶統計調查 | 和「僱傭及 職位空缺按季統計調查」所編製的就業 統計數字各有本身的用途和優點。但是 就反映按行業劃分的本地整體就業分布 情況而言,兩項統計調查都各有一些局 限。故本處利用統計方法將這兩種數據 協調,從而編製一套「就業綜合估計數 字」,以補該兩種數據的不足。「就業 綜合估計數字」的數列自一九九七年三 月起按年於《香港統計月刊》內以專題 文章形式發表,其編製方法經二零零五 年的檢討後加以改良,務求更緊貼地反 映近年本地勞動市場隨着經濟轉型而出 現的變化,並滿足對細分項目統計數字 日益增加的需求。經修訂後的最新數字 已刊載於二零零五年六月號《香港統計 月刊》內。
- 11.9 參考二零零六年中期人口統計所 採用的各項概念及定義,「綜合住戶統 計調查」正就有關的概念及定義進行檢 討。

- 11.6 To reduce respondent burden and to redeploy resources more effectively, the reporting requirements on industry updating and job vacancies were simplified in early 2004. To achieve further savings, the SEV sample size has been reduced from about 60 000 to around 32 000 establishments as from the first reference quarter of 2006. Correspondingly, the sample design has been revised so that employment and vacancies statistics will continue to be made available at detailed levels for the more important industries.
- 11.7 While unemployment and underemployment statistics covering the latest three-month period are published every month, employment and vacancies statistics compiled from the SEV are published on a quarterly basis. It is worth mentioning that seasonally adjusted unemployment rate derived using the X-11 ARIMA method is also published so as to better reflect the underlying trend of unemployment.
- 11.8 The GHS and SEV employment data have their own uses and merits. However, each set is subject to some limitations in reflecting the territory-wide employment structure by industry. Hence, a set of Composite Employment Estimates (CEE) is compiled by reconciling the GHS and SEV estimates under a statistical framework to serve such purpose. The series of CEE has been published annually in the form of a feature article in the *Hong Kong Monthly Digest of Statistics* since March 1997. Its compilation methodology was reviewed and improved in 2005 to reflect more closely the recent changes in the local labour market following the restructuring of the economy and to meet the growing demand for detailed statistics at disaggregate levels. The latest set of the revised CEE was published in the June 2005 issue of the *Hong Kong Monthly Digest of Statistics*.
- 11.9 With reference to the various concepts and definitions adopted in the 2006 Population By-census, the relevant concepts and definitions of the GHS are being reviewed.

#### 工資及勞工收入統計

11.10 本處經由「勞工收入統計調查」和「經理級與專業僱員(高層管理人員除外)薪金及僱員福利統計調查」搜集數據,以編製有關不同行業的工資/薪金和薪金總額的統計數字。

11.11「勞工收入統計調查」按季經由涵蓋各行業的機構單位樣本,搜集選定職業的工資數據和所有僱員的整體薪金總額,並編製和發表按行業分類的督導級及以下職業的工資率和工資指數,以及按行業分類的薪金總額指數,用以反映勞工價格和勞工收入的變動。

11.12 本處正就近年勞動市場結構的轉 變,檢討「勞工收入統計調查」涵蓋的行 業及職業範圍。

11.14 一般來說,工資及勞工收入統計 數據可提供有用的參考資料,作為釐定 薪金調整幅度、估計勞工成本,以及進 行經濟分析之用。

#### Wages and labour earnings statistics

11.10 The department compiles wages/salaries and payroll statistics covering different sectors of the employment based on data collected via the Labour Earnings Survey (LES) and the Survey of Salaries and Employee Benefits – Managerial and Professional Employees (Excluding Top Management) (or Managerial Salary Survey in short).

11.11 The LES is conducted quarterly for collecting data on wages of selected occupations and total payroll via a sample of establishments from various industries. Wage rates and wage indices for selected occupations at supervisory level or below by industry as well as payroll indices of all employment by industry are compiled and published for indicating the change in labour price and labour earnings.

11.12 In view of the change in the labour market structure in recent years, review of the industry and occupation coverages of the LES is in progress.

11.13 As regards salary of managerial and professional employees, statistics on their salaries and fringe benefits in every June are compiled and published via data collected from the Managerial Salary Survey. In particular, two salary index series, viz. Salary Index (A) and Salary Index (B), are compiled. The former aims to reflect the general changes in salary levels, not only including changes for employees remaining in the same occupations of the same companies, but also changes resulting from employee movements across companies. The latter measures changes in salary levels only for employees remaining in the same occupations of the same companies, and thus reflecting salary changes brought about by general salary increment, changes in performance and gain in seniority.

11.14 Generally speaking, wages and labour earnings statistics are useful reference for making salary adjustment, estimating labour cost and conducting economic analyses.

11.15 本處正為勞工處進行一項統計調查,搜集關於僱主按《僱傭條例》及其他相關法例提供的各項法定僱員福利的資料。該項統計調查旨在分析聘用受《僱傭條例》保障的不同組別僱員對勞工成本的影響。

11.16 本處亦為經濟發展及勞工局提供統計支援,評估標準工作時數及最低工資措施對勞工成本的影響。該評估將就2006年的勞工市場情況作出更新。

#### 人力統計

11.17 為協助職業訓練局確定本港各行業類別的人力及訓練需求,本處協助該局進行各項有關個別行業類別的人力統計調查。這些統計調查大部分是每兩年進行一次。

11.18 本處亦在有需要時,向有關政府 部門及決策局提供統計支援,以助人力 資源政策的制定和檢討。

#### 香港標準行業分類

11.19「香港標準行業分類」以聯合國的標準為藍本,是香港各經濟活動單位行業分類標準。最新的版本為「香港標準行業分類 1.1 版」。

11.20 本處出版一套載列詳盡行業分類 及說明的使用手冊,以及方便行業編碼 及名稱檢索的《香港標準行業分類 1.1 版 — 行業編碼索引》小冊子,供市民 大眾參考。 11.15 The department is conducting a survey for the Labour Department to collect information relating to the provision of various statutory employment benefits by employers under the Employment Ordinance and other related Ordinances. The survey aims at analysing the impact on labour cost for employing different groups of employees as covered by the Employment Ordinance.

11.16 Statistical support has also been given to the Economic Development and Labour Bureau for assessing the impacts of the measures of standard working hours and minimum wages on labour cost. An updating for the 2006 labour market situation will be carried out.

#### Manpower statistics

11.17 The department has been conducting manpower surveys on behalf of the Vocational Training Council to assess manpower requirements and training needs in different industries/sectors. Most of these surveys are organised in a two-year cycle.

11.18 The department also provides statistical assistance to relevant government departments and policy bureaux to support the formulation and review of manpower policy as needed.

#### Hong Kong Standard Industrial Classification

11.19 The "Hong Kong Standard Industrial Classification" (HSIC), which adapts the standards of the United Nations, serves as a standard framework for the industrial classification of economic units in Hong Kong. The latest version is "Hong Kong Standard Industrial Classification Version 1.1" (HSIC V1.1).

11.20 A set of manuals on the detailed classification and descriptions of industries and a booklet entitled *HSIC V1.1 – Index of Industry Codes* for quick search of industry codes and titles are available for the reference of the general public.

11.21 聯合國統計委員會已同意於二零零七年推出「所有經濟活動的國際標準行業分類第四修訂版」。本處於二零零四年收到該修訂版的分類架構草擬本,並提交意見給聯合國統計司參考。為配合聯合國的最新修訂版,本處現正檢討和修訂「香港標準行業分類」,並計劃於二零零八年推出。

### 機構單位記錄庫

11.22 機構單位記錄庫是一個載有本港約 35 萬個活躍機構單位的電腦化資料庫。該記錄庫內的資料,是根據本處統計調查的結果及有關政府部門的行政記錄而更新的。

11.23 機構單位記錄庫主要為本處的商業機構統計調查提供一個抽樣框,亦為其他政府部門及公眾人士提供個別機構單位的可披露資料作統計調查及其他有關應用。可披露資料包括機構單位的名稱、地址、業務類別及僱員人數組別。

11.24 公眾人士可付費申請索取機構單位的可披露資料,有關資料是以一個記錄庫隨機樣本名單的形式提供。另外,亦可透過一個配對程序,提取指定機構單位的可披露資料。

11.25 除商業機構記錄庫外,本處亦設有電腦化建築地盤記錄庫,作為各項有關建築地盤統計調查的抽樣框。

11.21 The United Nations Statistical Commission had endorsed the release of the "International Standard Industrial Classification of All Economic Activities (ISIC) Revision 4" in 2007. The department received a copy of the draft classification framework of this revision in 2004 and comments were subsequently forwarded to the United Nations Statistics Division. To align with the latest revision of the United Nations, plans are in hand to review and revise the HSIC for implementation in 2008.

#### **Central Register of Establishments**

11.22 The Central Register of Establishments (CRE) maintains computerised information of some 350 000 active establishments in Hong Kong. Information kept in the CRE is updated through feedback from surveys of the department and administrative returns from relevant government departments.

11.23 The CRE serves mainly as a sampling frame for surveys on business establishments conducted by the department. It also provides disclosable particulars on individual establishments to other government departments and the general public for conducting statistical surveys and other relevant applications. Disclosable particulars include the name, address, type of business and employment size class of an establishment.

11.24 The general public may obtain the disclosable particulars of establishments at a charge in the form of a random sample listing of the CRE, or through a matching procedure to extract disclosable particulars of specified establishments.

11.25 Apart from the CRE for business establishments, a computerised register of construction sites is also maintained as a sampling frame for statistical enquiries on construction sites.

#### 12 工商業 Commerce and Industry

#### 按年經濟統計調查計劃

12.1 本處進行按年經濟統計調查,提 供資料作量度本港各類經濟活動的結構 轉變之用,並配合其他來源所得的資 料,編製本地生產總值。

#### **Programme of Annual Economic Surveys**

12.1 Annual economic surveys are conducted to provide information for gauging structural changes in various activities of the economy and, together with data from other sources, for compiling the Gross Domestic Product (GDP).

- 12.2 整個按年經濟統計調查計劃包括 就下列各類經濟活動而進行的統計調 查:
- (一)工業生產;
- (二)屋宇建築、建造及地產;
- (三) 批發、零售、進口與出口貿易、食 肆及酒店;
- (四)運輸及有關服務;及
- (五) 倉庫、通訊、銀行、金融、保險及 商用服務。

- 12.2 The programme of annual economic surveys (PAES) comprises separate surveys on the following economic activities:
- (a) industrial production;
- (b) building, construction and real estate;
- (c) wholesale, retail and import and export trades, restaurants and hotels:
- (d) transport and related services; and
- (e) storage, communication, banking, financing, insurance and business services.



- 12.3 本處繼續安排由同一位外勤統計 職員向一些獲選參與多項統計調查的大 型機構搜集數據。這項安排有助減輕受 訪者的填報工作。
- 12.4 在二零零六年,按年經濟統計調查計劃的問卷已加強搜集更多營運開支的數據,以助進行更詳細的經濟分析。
- 12.3 The department continues the arrangement of enumerating prominent firms sampled in multiple economic surveys by the same field officer. This arrangement helps reduce respondent burden.
- 12.4 In 2006, the questionnaires for PAES have been enhanced to collect additional data items on operating expenses, which will support more detailed economic analyses.

#### 各行業統計調查及統計數據

12.5 除了按年經濟統計調查外,本處亦進行多項按月和按季經濟統計調查,以提供及時的經濟指標和用於編製按季本地生產總值的數據。

12.6 本處自二零零六年初已將「零售 業銷貨額按月統計調查」及「食肆的收 入及購貨額按季統計調查」結果的發布 時間分別提前約六天及三天。

12.7 本處自二零零三年首季開展「業務展望按季統計調查」,以編製按行業的業務展望數據,為預測本地的未來短期經濟表現提供快捷的參考。為了向統計數據使用者提供額外資料以預測整體情況,本處已由二零零六年的統計季度開始公布業務展望數據的總體數字。

12.8 本處正計劃編製香港資產管理的統計數字。除改善抽樣框及加大樣本外,亦會編製新的統計數字,包括資產管理服務的服務收益,以及一項資產管理業按季業務收益指數。這些改進有助量度和掌握香港的資產管理活動的經濟貢獻、營運特色及短期表現。

#### 其他主要經濟統計調查

12.9 「海外公司駐香港的地區代表按年統計調查」提供主要的統計數字,以反映代表香港境外母公司的駐港地區總部、地區辦事處及當地辦事處的情況。在二零零五年,這項統計調查結果的發布時間較二零零四年提前了近三個星期。

#### 科技統計

12.10 本處編製的科技統計指標,涵蓋 範圍包括研究及發展的投入、創新、科 技人力資源、專利、對外科技流動及科

#### Other sectoral surveys and statistics

12.5 In addition to annual economic surveys, monthly and quarterly surveys of various economic sectors are conducted to provide prompt economic indicators and to provide data for compiling quarterly estimates of GDP.

12.6 Since early 2006, the release of the results of the Monthly Survey of Retail Sales and the Quarterly Survey of Restaurant Receipts and Purchases has been advanced by about six days and three days respectively.

12.7 Since launching the Quarterly Business Tendency Survey in the first quarter of 2003, business expectations statistics at sectoral level have been compiled to provide a quick reference for predicting the short-term future economic performance of the local economy. To provide statistics users with an additional reference to predict the overall situation, business expectations statistics at aggregate level have been released as from the reference quarters of 2006.

12.8 Plans are in hand to compile asset management statistics of Hong Kong. Apart from improving the sampling frame and enlarging the sample size, new statistics on service receipts in respect of the asset management services and a quarterly series of business receipt index on the asset management industry will also be compiled to help gauge and monitor the economic contribution, operating characteristics and short term performance of asset management activities in Hong Kong.

#### Other major economic survey

12.9 The Annual Survey of Regional Offices Representing Overseas Companies in Hong Kong provides the key statistics for reflecting the situation of regional headquarters, regional offices and local offices in Hong Kong that represent their parent companies located outside Hong Kong. In 2005, the release of results of this survey was advanced by nearly three weeks.

#### Science and technology statistics

12.10 Science and technology (S&T) statistical indicators, covering research and development (R&D) inputs, innovation, human resources in S&T, patents, external technology flow and

12.11 本處進行「工商業創新活動按年統計調查」,以搜集工商業機構內創新活動(包括研究及發展)的資料。二零零四年度的統計調查報告已於二零零五年十一月初發布,而二零零五年度統計調查的資料搜集工作,亦已於二零零六年二月展開。

12.11 The Annual Survey of Innovation Activities in the Business Sector is conducted to collect data on innovation activities (including R&D) in the business sector. The report of the 2004 survey was released in early November 2005. Data collection for the 2005 survey has started in February 2006.

12.12 二零零五年度「資訊科技在工商業的使用情況和普及程度按年統計調查」及二零零五年度「資訊科技的使用情況和普及程度主題性住戶統計調查」的結果,已一併於二零零五年十二月初發布。兩項統計調查二零零六年度的資料搜集工作,將在二零零六年四/五月展開。

12.12 Results of the 2005 Annual Survey on Information Technology Usage and Penetration in the Business Sector and the 2005 Thematic Household Survey on Information Technology Usage and Penetration were released together in early December 2005. Data collection for the 2006 round of the two surveys will start in April/May 2006.

12.13 本處於二零零五年十二月首次發布一套從知識型經濟角度,描述香港發展情況的統計指標,分析框架包括四個範疇:(一)資訊及通訊科技;(二)人力資源發展;(三)創新系統;及(四)營商環境。為配合這個熱門課題的發展,本處會繼續發展相關統計指標,協助政策的制定和監察。

12.13 A set of statistical indicators to portrait the development of Hong Kong as a knowledge-based economy was published for the first time in December 2005. The analytical framework has four dimensions: (a) information and communication technology; (b) human resources development; (c) innovation system; and (d) business environment. To tie in with the development in this hot topic, the department will continue the enhancement of related statistical indicators for policy formulation and monitoring.

#### 13 物價及住戶開支 Prices and Household Expenditure

#### 消費物價指數

13.1 本處按月編製四項消費物價指數數列,以反映住戶普遍購買的消費商品及服務的價格變動情況。甲類、乙類和丙類消費物價指數是根據不同開支組別的住戶的開支模式編製的,而綜合消費物價指數是根據以上三項指數涵蓋的所有住戶的整體開支模式而計算。

#### **Consumer Price Indices**

13.1 Four series of Consumer Price Index (CPI) are compiled monthly to reflect changes in the price level of consumer commodities and services generally purchased by households. The CPI(A), CPI(B) and CPI(C) are compiled based on the expenditure patterns of households in different expenditure ranges. The Composite CPI is derived based on the aggregate expenditure pattern of all households covered by the above three CPIs.

#### 工資及材料成本指數

13.2 本處按月編製兩項分別以二零零 三年四月和一九九五年六月為基期的公 營建築工程工資及材料成本指數數列, 相關的數字每月在憲報內刊登。此外, 本處亦按月編製一些選定建築材料的平 均價格。

#### 住戶開支統計調查

13.3 「二零零四至零五年住戶開支統計 調查」的數據搜集工作已完成。本處現 正分析有關數據,並將於二零零六年年 中出版統計調查報告書。

#### Cost of labour and materials indices

13.2 Two series of index numbers of the costs of labour and materials used in public sector construction projects, with April 2003 and June 1995 as their respective base periods, are compiled and published monthly in the Government Gazette. In addition, average prices for selected building materials are also compiled on a monthly basis.

#### Household Expenditure Survey

13.3 Data collection for the 2004/05 round of Household Expenditure Survey has been completed. The data are being analysed and the survey report will be published in mid-2006.

13.4 本處亦正根據上述統計調查的結果,更新用來計算消費物價指數的住戶開支模式。以二零零四至零五年度為基期的消費物價指數數列將約在二零零六年四月公布。

13.4 Based on the results of the survey, the expenditure patterns of households used in compiling the CPIs are also being updated. The 2004/05-based CPI series will be released around April 2006.

#### 國際比較方案

13.5 香港正參與由世界銀行統籌的新一輪國際比較方案。這個比較方案提供數據以衡量不同貨幣的購買力平價,從而令本地生產總值及一些其他重要輕較總體數字可作更佳的跨經濟體系比較應不處在二零零五年已搜集消費商品及經濟務的價格數據,現正搜集本地生產總值其他組成部分的價格數據。香港亦參與「扣環比較」項目,此乃將亞太區的價格水平與世界其他地區比較的技術機制。這項扣環比較的價格搜集工作正在進行中。

#### **International Comparison Program**

13.5 Hong Kong is participating in a new round of the International Comparison Program co-ordinated by the World Bank, which provides data for measuring Purchasing Power Parities among different currencies and hence enabling better cross-economy comparison of GDP and some other important economic aggregates. Prices for consumer goods and services were collected in 2005 while those for other components of the GDP are being collected. Hong Kong also takes part in the "Ring Comparison", which is the technical mechanism to link the price levels in the Asia Pacific region to those in other regions of the world. Collection of prices for this ring comparison is underway.

#### 14 對外貿易 External Trade

#### 商品貿易統計

14.1 對外商品貿易統計數字是根據進 出口報關單上的資料編製而成。在二零 零五年,本處共處理約 1 900 萬份報關 單和 800 萬份貨物艙單。

14.2 每月的對外商品貿易數字,大約會在該月完結後四星期內透過新聞稿發布,內容包括整體貿易數字及按貨品及國家/地區分析的詳細貿易統計數據。而貿易指數則在隨後三至四星期內發布。

#### Merchandise trade statistics

14.1 External merchandise trade statistics are compiled from import/export declarations lodged by importers and exporters. In 2005, some 19 million import/export declarations and 8 million cargo manifests were processed.

14.2 Every month, merchandise trade statistics, which include figures at aggregate level and detailed trade statistics by commodity and country/territory, are disseminated by way of a press release in about four weeks after the reference month. This is followed by the release of trade index numbers in another three to four weeks.

#### 商品貿易統計數字發布

#### Dissemination of merchandise trade statistics

14.3 Continuous efforts are being made to enhance the means of disseminating merchandise trade statistics, particularly through the electronic media. Apart from press releases, trade statistics are disseminated in the form of bilingual publications and computer printouts. Users may also visit the Service Centre on Trade Statistics of the department for access to detailed merchandise trade statistics using a simple, user-friendly electronic data retrieval system. For certain analysis and research purposes where large volume of merchandise trade data are required, users may obtain trade statistics in the form of diskettes or CDs to facilitate further processing by computer. The department also disseminates merchandise trade statistics on CD-ROM on a monthly basis in partnership with a private company.

#### 商品貿易統計數字分類

14.4 進出口報關所使用的「香港進出口貨物分類表(協調制度)」,參照世界海關組織所編訂的「貨物名稱及編號協調制度」而制定,每年更新一次。

14.5 本港採用聯合國所制定的「標準國際貿易分類(第三次修訂版)」,作為編製商品貿易統計報告之用,該分類較適用於經濟分析。雖然按「貨物名稱及編號協調制度」分析的貿易統計數據並沒有在貿易統計報告中發表,但本處可應市民的要求提供該等數據。

#### Classification of merchandise trade statistics

14.4 The Hong Kong Imports and Exports Classification List (Harmonised System) used for import and export declaration purpose adopts the Harmonised Commodity Description and Coding System (HS) developed by the World Customs Organisation and is updated annually.

14.5 The Standard International Trade Classification (SITC) Revision 3 developed by the United Nations is used for merchandise trade statistics reporting. The SITC is more suitable for economic analysis. Trade statistics analysed by the HS are also available to the public upon request even though they are not published in trade statistics reports.

#### 與中華人民共和國海關總署的 合作方案

14.6 根據中華人民共和國海關總署與本處在二零零零年十一月簽訂的合作方案,彼此同意互相提供商品貿易統計數據,並交流統計方法和統計實務經驗。

#### 以電子形式遞交貿易文件服務

14.7 由二零零四年起,進出口商可從 兩家服務供應商選用電子報關服務或紙 張轉電子報關服務,遞交進出口報關 單。電子艙單服務則由一家服務供應商 提供。

14.8 現時,空運及鐵路運輸已全面採 用電子貨物艙單方式遞交。海運及河運 的貨物艙單亦將會由二零零六年六月 起,全面以電子方式遞交。與此同時, 處理電子貨物艙單電腦系統的改善工作 亦已完成。

14.9 在路運方面,政府正就發展可便 利跨界交通的電子貿易文件處理方案進 行深入研究,並全面諮詢業界。

#### 有關對外貿易的統計調查

14.10 本處透過「涉及外發中國內地加工貿易統計調查」搜集資料,計算有關出口往中國內地、由內地進口及原產地為內地的轉口貨品的外發加工比重。統計調查簡要結果,分別按季載於《香港對外商品貿易》及按年載於《香港對外商品貿易回顧》內。

14.11「轉口貿易統計調查」提供貨物轉口毛利比率的估計,作為編製本地生產總值之用。

## Co-operation programme with the Customs General Administration of the People's Republic of China

14.6 According to the programme of co-operation agreed between the Customs General Administration of the People's Republic of China and the department in November 2000, provision of merchandise trade statistics to each other and exchange of views on statistical methods and practical experience were made.

### Electronic submission service for trade-related documents

14.7 Starting from 2004, importers/exporters can choose to subscribe to the electronic service or paper-to-electronic conversion service provided by two service providers for submitting import/export declarations. The Electronic Cargo Manifest Service is rendered by one service provider.

14.8 At present, electronic submission of cargo manifests for air and rail modes has been fully implemented. Cargo manifests for ocean and river modes will go fully electronic as from June 2006. In parallel, the enhancement of the system for processing cargo manifests has been completed.

14.9 As for road mode, the implementation of electronic trade documents to facilitate cross-boundary cargo traffic is being explored in full consultation with the industry stakeholders.

#### Surveys related to merchandise trade

14.10 The Survey on Trade Involving Outward Processing in the Mainland of China is conducted to assess the proportion of merchandise trade related to outward processing in the mainland of China with regard to exports to the Mainland, imports from the Mainland and re-exports of the Mainland origin. Summary results of the survey are published quarterly in the *Hong Kong External Merchandise Trade* and annually in the *Annual Review of Hong Kong External Merchandise Trade*.

14.11 The Survey of Re-export Trade provides estimates of rate of re-export trade margin of goods which are used in the compilation of GDP.

14.12 本處進行「進口貿易保險費及運費統計調查」,以編製一套以離岸價計算的進口貨值,用相同的貨值計算方法比較不同國家/地區之間的貿易流量。

14.13 本處根據「進出口價格按月統計 調查」就選定商品所搜集的價格資料, 每月編製進出口價格指數。把進出口價 格指數併入貿易統計中的單位價格指數 系統內計算,有助為量度對外貿易價格 變動提供更佳的指標。

#### 服務貿易及離岸貿易統計

14.14 本處編製香港服務貿易統計數字,並作為以開支面計算的本地生產總值中的組成部分公布。為配合估計國民經濟核算統計數字,有關處理由銀行所提供的金融中介服務的最新發展(詳見第15.4段),服務貿易統計數字亦已作出改進,把金融中介服務輸出及輸入涵蓋其中。

14.15 本處繼續出版按年《香港服務貿易統計報告》,按較詳細的服務項目及目的地/來源地分項發表詳細的服務貿易按年統計數字。本處亦同時在該報告內發表按服務類別及目的地劃分的香港離岸貿易統計數字作為補充統計數字。在二零零六年,這項統計結果的發布時間將較二零零五年提前五個星期。

#### 船務及貨物統計

14.16 本處繼續按季出版《香港船務統計》報告。船隻統計數字是由海事處根據船長或受委託的船務代理遞交的一般事項申報表編製,而貨物和貨櫃統計數據則從船務公司遞交給本處的貨物艙單中抽取一些託運貨物作為樣本編製而成。

14.12 The Survey on Insurance and Freight Costs for Import Trade is conducted to produce statistics on "free on board" (f.o.b.) value of imports of goods for comparison of trade flow between countries/territories on a common basis of valuation.

14.13 Import and export price indices are compiled monthly for selected commodities using price data collected from the Monthly Import and Export Price Survey. The price indices are incorporated into the unit value index system of trade statistics to give a better measure of price movements in external trade.

#### Trade in services and offshore trade statistics

14.14 The department has been compiling statistics on Hong Kong's trade in services and publishing them as components of the expenditure-based GDP. To tie in with the recent development in dealing with financial intermediation services provided by banks in the estimation of national accounts statistics of Hong Kong (see more details in paragraph 15.4), trade in services statistics have also been enhanced to incorporate the exports and imports of financial intermediation services.

14.15 The department continues to release detailed annual trade in services statistics, with more detailed breakdowns on the service items and also with breakdowns by destination/source, in the annual *Report on Hong Kong Trade in Services Statistics*. Hong Kong's offshore trade statistics with breakdowns by type of service and destination are also released as supplementary statistics in the Report. In 2006, the release of the results will be advanced by 5 weeks.

#### Shipping and cargo statistics

14.16 The *Hong Kong Shipping Statistics* report continues to be published quarterly. Shipping statistics are compiled by the Marine Department based on general declarations submitted by ship masters or authorised shipping agents for declaring entry and clearance. Cargo and container statistics are compiled based on a sample of consignments listed in the cargo manifests supplied by shipping companies to this department.

14.17 本處操作一個綜合統計系統,以編製港口貨物及貨櫃的統計數據。這系統有助於詳細分析海運與河運貨物及貨櫃之間的關係,從而對港口貨物及貨櫃運輸的發展有更全面的了解。

#### 經濟發展及勞工局港口航運物流 發展組統計組

14.18 設於經濟發展及勞工局港口航運物流發展組的統計組就發展組進行的多項有關港口航運和物流的研究,提供支援服務。

#### 工業貿易署統計組

14.19 工業貿易署統計組主要負責編製和分析有關紡織品貿易的統計數據,這些數據對工業貿易署維繫對外貿易關係甚為重要。統計組會因應需要,為工業貿易署內各科提供統計諮詢和技術支援服務,並就特別專題進行研究。

14.17 The department operates a consolidated statistical system for compiling port cargo and container statistics. The system facilitates more detailed cross analysis for the seaborne and river cargo and container statistics so that a more comprehensive picture on port cargo and container development can be obtained.

#### Statistical Unit of the Port, Maritime and Logistics Development Unit, Economic Development and Labour Bureau

14.18 The statistical unit established in the Port, Maritime and Logistics Development Unit (PMLDU) in the Economic Development and Labour Bureau provides support to the PMLDU in conducting various research studies relating to the port, maritime and logistics sector.

#### Statistical Unit of the Trade and Industry Department

14.19 The statistical unit of the Trade and Industry Department (TID) is mainly responsible for compiling and analysing statistics related to the textiles trade, which are important for TID in fostering external trade relations. It also provides statistical advisory and technical support services to various branches in TID and conduct research studies on special topics as and when required.

#### 15 國民收入及國際收支平衡 National Income and Balance of Payments

#### 本地生產總值

15.1 本處編製和發表按開支組成部分和按經濟活動劃分的本地生產總值,數據分別以當時市價和固定(二零零零年)市價計算。按開支組成部分劃分的本地生產總值的按年數列追溯至一九六一年,按季數列則追溯至一九七三年。就按經濟活動劃分的本地生產總值而言,以當時價格計算的按年數列及以固定(二零零零年)價格計算的按季數列分別由一九八零年及二零零零年開始編製。

#### **Gross Domestic Product**

15.1 The department compiles and publishes the GDP by expenditure component and by economic activity at both current and constant (2000) market prices. Annual series of GDP by expenditure component dating back to 1961 and quarterly series dating back to 1973 are published. For GDP by economic activity, annual series at current prices and quarterly series at constant (2000) prices have been compiled since 1980 and 2000 respectively.

15.2 《本地生產總值(年刊)》載錄至 上一年度為止之本地生產總值的詳細數 據,此報告通常於每年三月出版。按開 支組成部分劃分的按季本地生產總值數 字在統計季度後約兩個月內於《本地生 產總值(季刊)》發布。以固定價格計算 按經濟活動劃分的按季本地生產總值的 數字在統計季度後約三個月內發布。

15.3 本處編製一系列統計數字,反映四個主要行業(即金融服務、貿易及物流、旅遊和工商業支援及專業服務)對香港經濟的貢獻。有關這四個主要行業對本港經濟貢獻及就業情況的最新分析,已於二零零六年三月號《香港統計月刊》內以專題文章形式發表。

15.4 本處自二零零五年八月起,採用 最新國際指引,處理國民經濟核算統計 數字中,銀行所提供的金融中介服務。 最新指引使國民經濟核算統計數字,更 有效地反映銀行在促進資金從擁有盈餘 資金的單位(例如存款者)轉移到需求 資金的單位(例如貸款者)所帶來的經 濟貢獻。

15.5 本處正根據國民經濟核算的最新 國際統計指引,研究採用環比銜接法編 製香港本地生產總值的物量計算的可行 性。

15.6 本處採用「綜合貿易及本地生產 總值預測模型」,協助政府就香港經濟 情況按季作最新預測。

#### 本地居民生產總值

15.7 本處自一九九三年統計期開始,編製按年的本地居民生產總值,而按季的本地居民生產總值則由一九九九年第一季統計期開始編製。

15.2 The report *Gross Domestic Product (Yearly)*, which is usually published in March each year, contains detailed GDP figures up to the previous year. The quarterly GDP by expenditure component is released around 2 months after the reference quarter in the report *Gross Domestic Product (Quarterly)*. The quarterly constant price GDP by economic activity is available around 3 months after the reference quarter.

15.3 Statistical series have been compiled to reflect the economic contribution of the Four Key Industries, viz. financial services, trading and logistics, tourism together with producer and professional services, to the Hong Kong economy. An article analysing the latest economic contribution and employment situation in respect of the Four Key Industries was published in the form of a feature article in the March 2006 issue of the *Hong Kong Monthly Digest of Statistics*.

15.4 Starting from August 2005, the department has followed the latest international guidelines on the handling of financial intermediation services produced by banks in the estimation of national accounts statistics. The latest guidelines enable national accounts statistics to reflect in a better way the economic contribution of banks in facilitating the channeling of funds from units with surplus funds (e.g. depositors) to units with demand for funds (e.g. borrowers).

15.5 The feasibility of applying the chain linking method for compiling the volume measures of Hong Kong GDP is being studied with a view to further aligning the compilation method with the latest international statistical guidelines for national accounts statistics.

15.6 The "Integrated Trade and GDP Forecasting Model" is operated by the department to assist the Government in preparing quarterly updates of economic forecasts for the Hong Kong economy.

#### **Gross National Product**

15.7 Annual Gross National Product (GNP) has been compiled since the reference period of 1993, while quarterly GNP is compiled as from the reference period of the first quarter of 1999.

15.8 由於在估計香港國民經濟核算統計數字時,採用最新國際指引處理由銀行所提供的金融中介服務,對外要素收益流動中其他投資收益的數字已作出修訂。追溯至一九九三年的本地居民生產總值及對外要素收益流動的修訂數列已於二零零五年八月發布。

#### 國際收支平衡統計

15.8 As a result of the implementation of the latest international guidelines on dealing with financial intermediation services provided by banks in the estimation of national accounts of Hong Kong, figures on other investment income in External Factor Income Flows (EFIF) were revised. Revised series of GNP and EFIF backdated to 1993 were released in August 2005.

#### **Balance of Payments statistics**

15.9 The department compiles and disseminates Balance of Payments (BoP) account, International Investment Position (IIP) statement and External Debt (ED) statistics in accordance with the requirements stipulated in the Special Data Dissemination Standard of the International Monetary Fund (IMF). While quarterly BoP account is compiled as from the reference period of the first quarter of 1999, annual BoP account can be dated back to the reference period of 1998. Furthermore, annual IIP statement is compiled as from the reference period of 2000, whereas quarterly ED statistics are compiled as from the reference period of the first quarter of 2002. Details of these statistics are published in the quarterly report *Balance of Payments Statistics of Hong Kong*.

15.10 編製國際收支平衡表、國際投資 頭寸報表和對外債務統計所需的數據主 要來自「對外申索、負債及收益統計調 查」。自一九九八年統計期開始發布的 詳細對外直接投資統計,亦是根據該統 計調查所搜集的數據而編製。最新的 《二零零四年香港對外直接投資統計》年 報已於二零零五年十二月出版。

15.11 國際貨幣基金組織將於二零零八年出版用以編製及發布國際收支平衡表和國際投資頭寸統計的新版手冊。在未來數年,本處將積極參與此項發展工作。

15.12 國民收入及國際收支平衡統計統 籌委員會定時開會,以統籌有關編製及 發展國民收入及國際收支平衡統計工作 的事宜。委員會成員包括財政司司長辦 公室轄下的經濟分析及方便營商處的經 濟分析部和香港金融管理局的代表及本 處的專業人員。

15.13 本處曾參與由國際貨幣基金組織 進行的「二零零四年協調有價證券投資 統計調查」。本處將繼續參與該統計調 查系列。 15.10 Data required for compiling BoP account, IIP statement and ED statistics are mainly collected from the Survey of External Claims, Liabilities and Income (SECLI). The data from SECLI have also been used for the compilation of detailed external direct investment statistics since the reference year of 1998. The latest annual report on External Direct Investment Statistics of Hong Kong 2004 was published in December 2005.

15.11 A new version of the manual for the compilation and dissemination of BoP account and IIP statistics will be published by the IMF in 2008. In the coming few years, the department will actively participate in this development.

15.12 Meetings of the Co-ordinating Committee on National Income and Balance of Payments Statistics (CCNB) are conducted regularly to co-ordinate matters relating to the compilation and development of National Income and BoP statistics. Members of the CCNB include representatives from the Economic Analysis Division of the Economic Analysis and Business Facilitation Unit under the Financial Secretary's Office and the Hong Kong Monetary Authority, as well as professional officers of the department.

15.13 The department participated in the 2004 round of the IMF's Coordinated Portfolio Investment Survey (CPIS). The department will continue to participate in the series of CPIS.

#### 16 貨幣、銀行、金融 Money, Banking and Finance

16.1 香港金融管理局(金管局)向持牌銀行、有限制牌照銀行及接受存款公司搜集金融及銀行統計數據。此外,金管局亦定期搜集有關匯率、利率及其他貨幣和金融指標的資料。

16.2 有關本港金融及銀行業詳盡的統計數據載於金管局出版的《金融數據月報》。各界可以在金管局網站免費查閱

16.1 Monetary and banking statistics are collected from licenced banks, restricted licence banks and deposit-taking companies by the Hong Kong Monetary Authority (HKMA). In addition, information on exchange rates, interest rates, and other monetary and financial indicators is also collected regularly.

16.2 Comprehensive statistics on Hong Kong's monetary and banking sector are published in the *Monthly Statistical Bulletin* of the HKMA. The Bulletin is available free of charge on the

16.3 金管局亦定期進行有關認可機構的統計調查,涵蓋住宅按揭貸款、信用卡應收帳款及負資產的按揭貸款等範疇。

HKMA website (www.info.gov.hk/hkma/eng/statistics/msb/index.htm).

16.3 The HKMA also conducts regular surveys on authorised institutions, covering such areas as residential mortgage loans, credit card receivables and residential mortgage loans in negative equity.

#### 17 策略性規劃 Strategic Planning

#### 規劃署統計組

17.1 規劃署統計組負責編製按地區劃 分的人口分布情況的估計及推算數字。 統計組按需求編製未來十年,按規劃統計小區劃分的人口推算數字,以供政府 一般規劃工作之用。統計組於二零零五 年十月至二零零六年三月期間特別編製 了一套按街段和鄉村群劃分的二零零七年區議會選舉劃定地方選區界線之 用。

17.2 統計組亦負責編製按運輸研究區分布的人口和就業遠期推算數字,以供全港發展的策略性規劃之用。這些推算數字是根據不同土地用途方案編製而成,用以測試全港和次區域各發展方案的可行性。在二零零五年,統計組根據「香港 2030 研究」裏所訂立的基本發展情況,編製了三套規劃數據矩陣。

17.3 統計組於二零零五年,完成了兩項特別的統計調查。一項名為「近年落成住宅單位使用情況統計調查」,搜集了近年落成的私人住宅單位的入住情況,以及其住戶特徵的統計數字,用以更新人口分布工作所採用的參數。另一項名為「工商業建築物樓面空間使用情況統計調查」,搜集了有關數據,以便更新於編製就業分布推算數字所採用的參數。

#### Statistical Unit of the Planning Department

17.1 The statistical unit of the Planning Department is responsible for producing estimates and projections of the population by geographical area. Projections of population distribution by Tertiary Planning Unit (TPU) for the next ten years are compiled from time to time for general government planning purposes. For the demarcation of constituency boundaries for the 2007 District Councils Election, a special set of population distribution forecasts as at mid-2007 by street block and village cluster was compiled during October 2005 to March 2006.

17.2 For strategic planning of territorial development, projections of population and employment distribution by transport study zone for a more distant time horizon are produced. These sets of data are compiled under different landuse scenarios and for testing various development options at territorial and sub-regional levels. Three sets of planning data matrix for the reference scenarios of the Hong Kong 2030 Study were compiled in 2005.

17.3 In 2005, the unit completed two ad hoc surveys. One is the Survey on Occupancy of Recently Completed Housing Units, which was conducted to collect data on the occupancy of housing units in recently completed private residential development projects and the characteristics of the occupants for updating the parameters used in the compilation of population distribution statistics. The other was Commercial and Industrial Floor Space Utilization Survey, which collected data for updating the statistical parameters used in the compilation of employment distribution projections.

17.4 統計組每年會就跨界旅運項目搜集和編製統計數字,其中包括過境旅客、汽車、船隻及航機,以便政府進行有關規劃時參照使用。由一九九七年開始,統計組借助由入境事務處所提供的「旅客過境記錄」(不含可辨別個人身份資料),按年編製有關香港居民跨界旅運模式的統計數字。

17.5 統計組每兩至三年會進行一項 「跨界旅運統計調查」,以更新有關跨界 旅程特徵及旅客的統計數字。搜集的資 料包括旅程起點和目的地、來往目的與 所用的交通工具。每次進行是項統計調 查,所有在指定的兩星期內往來中港兩 地的人士均包括在內。 17.4 The unit also collects and compiles statistics on cross-boundary travel annually in relation to cross-boundary passengers, vehicles, ferries and flights for use in government planning activities. By using information captured on Passenger Movement Records (without personal identifiers) provided by the Immigration Department, statistics on cross-boundary travelling patterns of Hong Kong Residents have been compiled annually since 1997.

17.5 The unit launches a Cross-boundary Travel Survey every two to three years to collect data on the characteristics of cross-boundary trips and the trip makers. The information collected includes origin and destination of trips, trip purposes and transportation modes. In each round of the survey, all persons travelling between Hong Kong and the Mainland during a specified two-week period are covered.

#### 中央政策組統計組

17.6 中央政策組的統計組負責搜集、編製和分析有關數字,以協助特區政府制定及檢討本港經濟及社會政策。

#### Statistical Unit of the Central Policy Unit

17.6 The statistical unit of the Central Policy Unit collects, compiles and analyses statistics for the purpose of formulating and reviewing economic and social policies of the Government.

#### 18 教育 Education

#### 教育統籌局統計組

18.1 教育統籌局統計組包括兩個不同 組別,分別專注於學校教育統計,以及 人力和高等教育統計。

18.2 學校教育統計數據主要分為三個範疇,包括學生、教師及學額。有關數據來自學校教育統計組定期進行的統計調查,並以該局資訊系統內的行政記錄作補充。為配合於二零零五年九月推行的協調學前服務措施,學生人數及教師統計調查的涵蓋範圍已擴大至包括新註冊成為幼稚園的幼兒中心。

18.3 學生人數統計不但提供各級學生 人數的情況,亦是用作推算未來學生人 數的基礎數據。加上詳細的教師數據及 流動資料,更可用以推算教師的需求和 供應情況。這項推算對策劃及檢討師資 訓練提供有用的資料。

18.4 學校教育統計組根據學生人數及 人口分布推算數字,推算個別地區及全 港對幼稚園、小學及中學學額的需求。 當局在策劃提供教育設施時,會參考這 些需求數字,並與相應的供應推算作比 較。

18.5 在過去一年,學校教育統計組就 建校計劃檢討和各項教育政策(如將於 二零零九/一零學年推行的新高中學制 及多項教師提早退休計劃)作出各項情 景推算,以供局方作政策審議之用。

#### Statistical Unit of the Education and Manpower Bureau

18.1 The statistical unit of the Education and Manpower Bureau (EMB) comprises two separate sections specialising respectively in school education statistics, and manpower and post-secondary education statistics.

18.2 There are three main areas of statistics on school education, viz. pupils, teachers and school place provision. Relevant data are collected through regular surveys conducted by the School Education Statistics Section, supplemented by administrative records kept in the bureau's information systems. To cater for the harmonisation of pre-primary services which took effect as from September 2005, student enrolment and teacher surveys have been extended to cover child care centres newly registered as kindergartens.

18.3 The pupil statistics not only give the enrolment situation at various education levels, but also serve as fundamental inputs for the projections of enrolment in future years. Coupled with detailed statistics on the stock and flow of teachers, the demand and supply of teachers can also be projected. Such projections provide useful information for the planning and review of teacher training provision.

18.4 Using data from enrolment projections and population distribution projections, demand for school places at kindergarten, primary and secondary levels in individual districts and the territory as a whole are projected. The demand is matched against projections of the corresponding supply for use in planning the provision of educational facilities.

18.5 In the past year, various scenario projections were compiled to facilitate policy deliberations in regard to the Review of the School Building Programme and various education policies, such as implementation of the new senior secondary academic structure as from the 2009/10 school year and early retirement schemes for teachers.

18.6 人力及專上教育統計組定期更新及加強涵蓋教育及勞工的主要統計數字及指標的資料庫,並就有關政策的制定及檢討,提供方便的參考資料。

18.7 該局高等教育分部轄下的系統發展小組持續進行自資全日制經評審專上課程數據庫的統計數據分析。該數據庫的建立有助監察六成高中畢業生有機會接受專上教育的政策目標的執行情況。系統發展小組也負責建立網上的「非本地學生來港就讀」資料庫,藉以監察放寬非本地學生來港就讀安排的行政工作。此外,網上「非本地高等及專業課程」及「持續進修」數據庫也由該小組負責管理。

18.8 就教育統籌局多項外判的統計調查/研究,統計組提供專業統計意見及支援,當中包括「持分者對教育制度改革措施意見調查」及有關資訊科技教育的研究。

#### 大學教育資助委員會秘書處統計組

18.9 大學教育資助委員會(教資會) 秘書處統計組定期編製有關教資會資助 院校的學生、教職員、財務及研究的統 計指標,供教資會委員參考。

18.10 為提供教資會界別發展所需要的 數據,統計組每年檢討統計系統的數據 涵蓋範圍及分類。二零零五至零六學年 的檢討工作已完成。 18.6 On manpower and post-secondary education statistics, the statistical databases covering summary statistics and indicators on education and manpower are regularly updated and enhanced to provide convenient reference for the formulation and review of the related policies.

18.7 Statistical analyses from the database on "Full-time Accredited Self-financing Post-secondary Programmes" are conducted on a continuous basis by the Systems Development Team of the Higher Education Division of the EMB. The database facilitates the monitoring of the policy target on achieving the 60% of post-secondary education. The Team also develops the web-based register for "Admission of Nonlocal Students" for monitoring the administration on the increasing admission of non-local students. Moreover, the Team maintains the web-based databases on "Non-local Higher and Professional Courses" and "Continuing Education".

18.8 Professional statistical advice and support are rendered to a number of outsourced surveys/studies of the bureau, which include the Stakeholder Monitoring Survey on Education Reform and Major Education Initiatives and studies relating to Information Technology in Education.

### Statistical Unit of the University Grants Committee Secretariat

18.9 Statistical indicators on students, staff, finance and research in respect of the institutions funded by the University Grants Committee (UGC) are compiled regularly by the statistical unit of the UGC Secretariat for the reference of UGC members.

18.10 The coverage and classification of the data in the statistical system are reviewed on an annual basis so as to provide the data needed for the development of the UGC sector. The review for the 2005/06 school year has been completed.

#### 19 房屋 Housing

#### 房屋署統計組

- 19.1 房屋署統計組主要的工作是進行統計調查與專題研究、編製統計刊物、整理統計資料庫,以及為部門內各個組別提供有關統計方法及數據分析等支援服務。
- 19.2 為檢討及制定房屋政策,統計組在二零零五年進行了一系列的房屋統計調查及研究:
- (一)統計調查 公屋住戶對屋邨管理服務的意見調查及其對所住屋邨內進行的保養及改善工程的滿意程度、居住在新落成屋邨的住戶的生活式樣及他們對屋邨建築設計的期望、公屋輪候冊申請人的社會經濟特徵、置業者的特徵、香港市民的住屋意願及他們對於物業市場的看法,以及公屋住戶的環境保護意識等;及
- (二)專題研究一分析平均輪候租住公屋的時間、未來公屋單位的面積分佈、公屋的需求、公屋輪候冊申請人的入息及資產限額、公屋租戶的租金與入息比例,以及非長者一人申請者的配額及計分制對公屋需求的影響等。
- 19.3 統計組定期編製的統計報告和刊物,以及有關的統計數據庫,為管理階層提供方便快捷的重要房屋數字。
- 19.4 統計組將進行更多及更廣泛的專題研究,進一步分析公屋居民的社會經濟特徵,研究項目包括他們在不同時段內的收入增長變化與搬出公屋的情況,以及合資格申請公屋的住戶實際登記公屋輪候冊的情況等。

#### Statistical Unit of the Housing Department

- 19.1 The statistical unit of the Housing Department (HD) conducts research studies and surveys, compiles statistical information and maintains statistical database. In addition, it advises various sections within the HD on statistical methodology and interpretation.
- 19.2 To facilitate the review and formulation of housing policies, the unit engaged in various surveys and research studies, which encompassed an array of topics relevant to housing, in 2005 :
- (a) Surveys opinions of the tenants living in public rental housing (PRH) towards estate management services and estate improvement and maintenance works, life style of PRH tenants and their expectations on architectural design of new PRH blocks, socio-economic characteristics of waiting list (WL) applicants for PRH, profiles of domestic property buyers, future housing plan of the people in Hong Kong and their views towards property market, and awareness of the PRH tenants towards environment protection; and
- (b) Research studies analysis of average waiting time for PRH, flat size distribution of future production of PRH, demand for PRH, income and asset limits for WL applicants of PRH, rent to household income ratio of PRH and impact of the Quota and Points Scheme for non-elderly one-person WL applicants on requirements of PRH.
- 19.3 The regular statistical reports and publications compiled by the section, together with the statistical database, equip the management with a convenient means of quick reference to key housing statistics.
- 19.4 It is planned that more research studies will be conducted for analysing the socio-economic characteristics of the households living in PRH, such as their income growth and tendency to move out of PRH over time. The propensity of eligible households to apply for PRH through the WL will also be studied.

#### 20 衛生 Health

#### 衞生署統計組

20.1 衞生署統計組提供及時的數據和研究統計分析方法,以助密切監測及防止傳染病的蔓延。統計組亦負責管理用以監測流行性感冒病類、手足口病、急性結膜炎(紅眼症)及急性腸道傳染病的統計系統。為了進一步加強對選定傳染病數緣發的監測工作,以老人院和幼兒院為對象的新定點監測系統,及一個以中醫師為對象的試驗定點監測系統均已設立。統計組既提供發展有關系統的統計技術支援,亦負責系統的日常運作。

20.2 衞生署設立的公共衞生資訊系統 於二零零五年十二月全面投入服務,該 系統有助增強政府記錄市民健康狀況和 疾病模式的資料庫。統計組現正負責該 系統日常的系統及數據管理工作。此 外,統計組亦為更新「香港健康寶庫」 網頁提供支援,其資料取材自公共衞生 資訊系統,是一個發布本地公眾健康統 計資料的平台。

20.3 統計組就統計調查和研究計劃提供統計及技術上的支援。這些調查和研究計劃包括「人口健康統計調查」、「兒童健康統計調查」、「兒童健康統計調查」、與子宮頸普查計劃有關的調查、「行為風險因素調查」、「醫療衛生服務人力統計調查」、「二至五歲幼童防疫注射覆蓋率調查」,以及「疾病、損傷和死亡原因國際統計分類第九次修訂本」(ICD-10)的比較研究。

#### Statistical Unit of the Department of Health

20.1 The statistical unit of the Department of Health (DH) provides timely statistics and explores statistical methods for closely monitoring and preventing the spread of communicable diseases. The statistical systems for the surveillance of influenza-like illness, hand-foot-mouth disease, acute conjunctivitis and acute diarrhoeal diseases are also maintained. To further improve the outbreak detection of selected communicable diseases in the community, new sentinel surveillance systems on residential care homes for the elderly and child care centres, as well as a pilot sentinel surveillance system on Chinese medicine practitioners have been set up. Statistical and operational support is provided for the development and day-to-day running of the systems.

20.2 The Public Health Information System (PHIS) set up by the DH has been in full implementation since December 2005. It aims to enhance the Government's information base on the community's health status and disease patterns. The statistical unit is responsible for providing on-going support to system and data administration of the PHIS. Besides, the statistical unit also renders support to the updating of the website "HealthyHK", which is engineered by PHIS. The website serves as a platform to disseminate statistical information related to the health status of population.

20.3 Statistical and technical support has been rendered in conducting surveys and studies, such as Population Health Surveys, Cardiovascular Disease and Risk Factor Survey, Child Health Survey, surveys related to the Cervical Screening Programme, Behavioural Risk Factor Survey, Health Manpower Survey, Survey on Immunization Coverage Among Children Aged Two to Five, as well as Comparability Study of the Ninth Revision of the International Statistical Classification of Diseases, Injuries and Causes of Death (ICD-9) and the Tenth Revision of the International Statistical Classification of Diseases and Related Health Problems (ICD-10).

20.4 The DH publishes an online publication *Hong Kong Population Health Profile Series*, which aims to summarise the current health-related information in Hong Kong. Statistical

20.5 統計組負責一切與「政府流行性 感冒防疫注射計劃」有關的統計工作。 這個計劃是根據衞生防護中心轄下的疫 苗可預防疾病科學委員會建議,為選定 類別人士提供免費流感疫苗注射,包括 受流行性感冒感染而有較高發病及死亡 率的人士。

#### 衞生福利及食物局統計工作

20.6 統計專業人員亦為更新本地醫療 衞生總開支帳目、長遠醫療服務模式、 醫療融資及健康與醫療發展諮詢委員會 提供統計上的支援。

20.7 一項有關香港居民使用醫療服務、僱主或機構提供醫療福利予僱員及個人購買醫療保險保障的統計調查已於二零零五年年底開展,目的是搜集相關數據作為更新香港醫療衞生總帳目及醫療服務發展的參考。

社會福利 Social Welfare

#### 社會福利署統計組

21.1 社會福利署統計組負責進行研究、編製和估算統計數據,並設立、管理和改進電腦化資料系統,以便策劃、檢討及監察福利服務。

21.2 為了解社工系畢業生的最新就業情況,統計組於二零零五年四月進行了一次以二零零四年該系畢業生為對象的統計調查。此外,該組亦正與一間大學合作,進行有關協助綜合社會保障援助計劃受助人就業的研究,對象主要是「深入就業援助計劃」的參加者。

services in the form of data compilation and analysis, and comments on the presentation and layouts of the tables and charts are provided to support health statistics production.

20.5 The statistical unit is responsible for the statistical activities related to the Government Influenza Vaccination Programme. The programme aims to provide free influenza vaccinations to targeted groups of people who are at a higher risk of morbidity and mortality due to influenza infection. The programme is conducted in accordance with the recommendations of the Scientific Committee on Vaccine Preventable Diseases established under the Centre for Health Protection.

#### Statistical work in the Health, Welfare and Food Bureau

20.6 Statistical professional staff also provides statistical support to the updating of the Hong Kong Domestic Health Accounts, long-term health care model, health care financing, and the Health and Medical Development Advisory Committee.

20.7 A survey on health services utilisation by Hong Kong residents, provision of medical benefits by employers or organisations and coverage of medical insurance purchased by individuals was started at the end of 2005 with an aim to collect supportive information for updating the Hong Kong Domestic Health Accounts and providing reference for the development of health care services.

#### Statistical Unit of the Social Welfare Department

21.1 The statistical unit of the Social Welfare Department (SWD) conducts research studies; undertakes statistical compilation and estimation exercises; and develops, maintains and enhances computerised data systems to facilitate planning, review and monitoring of the provision of welfare services.

21.2 In April 2005, the unit conducted a survey to study the up-to-date employment situation of 2004 social work graduates. Moreover, a study mainly on participants of the Intensive Employment Assistance Projects targeting at employable Comprehensive Social Security Assistance (CSSA) recipients is being conducted in collaboration with a university.

- 21.3 統計組繼續管理及更新六個有關 社會福利事宜的資料系統,如社會工作 人力策劃資料系統及統計資料系統,並 按需要加以改善。此外,統計組正為設 立服務使用者資訊系統提供統計支援, 該系統旨在提供一個社會福利署服務使 用者的中央數據庫。
- 21.4 統計組根據從各服務單位及資料 系統搜集的資料,按月及按季編製工作 表現統計數據,並定期出版刊物,如 《社會福利服務統計數字一覽》小冊子。
- 21.5 一個新設計的服務表現管理資訊 系統已投入服務,統計組會為該系統的 資料更新提供支援。
- 21.6 由社會福利署統計組與政府統計 處合作進行的「二零零四至零五年度綜 援受助家庭的住戶開支統計調查」的資 料搜集工作已於二零零五年九月完成。 統計調查結果的分析工作亦已展開。

#### 衞生福利及食物局統計工作

21.7 衞生福利及食物局研究處的專業統計人員就多項研究提供統計支援,當中包括估算長者長期護理服務的需求及供應情況、長者福利津貼及退休保障檢討、香港康復計劃方案檢討,以及其他社會專題研究。

#### 22 治安 Law and Order

#### 保安局統計組

22.1 保安局統計組主要提供統計數據 和研究工作上的支援,以便政府制定和 檢討有關政策。其中,統計組的職責包 括管理和更新治安統計資料綜合系統和 藥物濫用資料中央檔案室,並就禁毒處 委託或禁毒基金贊助進行的各項與藥物

- 21.3 Six data systems on selected social welfare issues (e.g. Social Work Manpower Planning System and Statistical Information System) continue to be maintained and updated. Enhancements continue to be made to these systems as required. Moreover, statistical support is being rendered in the implementation of the Client Information System. This system aims to provide a central database on clients of the SWD.
- 21.4 Based on data collected from various service units and data systems, the statistical unit compiles performance statistics on a monthly and quarterly basis for monitoring purpose. Regular publications such as the pamphlet *Social Welfare Services in Figures* are published.
- 21.5 A newly designed Service Performance Management Information System has been launched. The unit will provide statistical support for the data updating of the system.
- 21.6 The data collection work of the 2004/05 Household Expenditure Survey on CSSA Households, which was conducted jointly by the statistical unit of the SWD and the Census and Statistics Department, concluded in September 2005. Analysis of the survey results has started.

## Statistical work in the Health, Welfare and Food Bureau

21.7 Professional statistical staff of the Research Office of the Health, Welfare and Food Bureau provides statistical support to various studies relating to the supply and demand of elderly long-term care services, the review of financial support and retirement protection to older persons, the review of rehabilitation programme plan and other social issues.

#### Statistical Unit of the Security Bureau

22.1 The statistical unit of the Security Bureau mainly provides statistical and research support for policy formulation and reviews. Among others, the unit is responsible for maintaining and updating the Integrated Law and Order Statistical System (ILOSS) and the Central Registry of Drug Abuse (CRDA). It is also responsible for monitoring the progress and quality of

22.2 自一九八九年設立以來,治安統計資料綜合系統一直提供涉及刑事審判制度各層面的統計數據,以便政府制定和檢討有關政策。

22.3 藥物濫用資料中央檔案室提供有關資料以監察藥物濫用趨勢,有助政府制定適合香港的禁毒策略和計劃。檔案室電腦系統自二零零五年提升功能後,可儲存更多藥物濫用數據,支援電子數據是呈報和提供更深入的數據分析。為進一步擴大檔案室的涵蓋範圍,由二零零五年五月起,呈報機構的數目從34間增至67間。此外,禁毒處在該處網頁(www.nd.gov.hk/index.htm)發布更多以圖展示的藥物濫用趨勢,並提供線上查詢數據的功能,方便市民使用。

22.4 在不久的將來,統計組將會擴大 工作範圍,負責管理數個新建立的資訊 系統,協助政府監察藥物服務的最新情 況,以及其他與濫藥有關的情報。

#### 香港警務處統計組

22.5 香港警務處刑事部統計組主要負責搜集罪案資料,以及編製和分析罪案統計數據。在二零零五年,統計組參與多項計劃,例如研究不同種類的暴力罪案。

#### 懲敎署統計組

22.6 懲教署統計組提供統計及研究服務,以支援該署進行策略性籌劃工作, 監察和檢討懲教計劃,以及監控部門運作。

22.7 除因應管理及策劃所需而編製定期的統計報告外,統計組按年進行一項統計調查,搜集在囚人口的社會經濟特

various drug-related research studies commissioned by the Narcotics Division and those supported by the Beat Drugs Fund.

22.2 The ILOSS has been providing statistics on the various aspects of the criminal justice system for policy formulation and review since 1989.

22.3 The CRDA provides relevant information for monitoring the trends of drug abuse in order to facilitate the planning of suitable anti-drugs strategies and programmes in Hong Kong. The CRDA computer system, which was enhanced in 2005, can now cater for the capturing of more drug abuse data, online electronic data submission and more in-depth analyses. To broaden the coverage of the CRDA, the number of reporting agencies has been increased from 34 to 67 since May 2005. Besides, more graphical presentation of drug abuse trend in conjunction with online enquiry functions are available on Narcotics Division webpage (www.nd.gov.hk/index.htm) for public use.

22.4 In the near future, the unit will also expand its responsibilities to the maintenance of some newly established information systems, which will help gauge the situation of drug related services and other drug abuse related intelligence.

#### Statistical Unit of the Hong Kong Police Force

22.5 The statistical unit of the Crime Wing, Hong Kong Police Force is mainly responsible for collecting crime data as well as compiling and analysing crime statistics. In 2005, the statistical unit participated in a number of projects such as the studies on different kinds of violent crimes.

#### Statistical Unit of the Correctional Services Department

22.6 The statistical unit of the Correctional Services Department provides statistical and research support for the strategic planning, monitoring and review of the correctional services programmes and operational control.

22.7 Apart from compiling regular statistical reports to meet management and planning needs, the statistical unit conducts an annual survey to collect statistics on the socio-economic

22.9 香港海關統計組按月編製《海關工作成效報告》。該報告旨為香港海關管理層提供參考資料,以制定策略和監察部門的工作成效。此外,該報告也能協助有關人員分析趨勢,進行各種統計研究和回應查詢。

22.10 該組亦負責編製各種特定的統計報告,以協助香港海關分析當前的形勢,從而制定反走私和其他非法活動的策略。此外,該組已檢討及更新統計系統,以配合預計於二零零六年年底前落成使用的深圳灣口岸一地兩檢管制站。

characteristics and criminal background of the penal population. The unit updates the penal population projection on a regular basis to provide an updated assessment of the adequacy of future provision of penal accommodation. It also conducts studies on psychotropic drug abuse among sentenced persons admitted, self-harm behaviour of persons in custody and recidivism of discharged local offenders.

22.8 Based on additional information available from the re-developed ILOSS and the Penal Record Information System, a refined method of counting the discharge and reconviction cases has been adopted in compiling the recidivism rates.

#### Statistical Unit of the Customs and Excise Department

22.9 The statistical unit of the Customs and Excise Department (C&ED) publishes a monthly statistical report *Customs Performance and Achievements*. This report serves to provide the management of C&ED with a reference for formulating strategies and monitoring the work effectiveness of the department. It is also designed to assist the officers concerned in conducting trendal analyses, carrying out statistical researches and responding to enquiries.

22.10 The unit is also responsible for compiling a variety of tailor-made statistical reports to assist C&ED in analysing the current situation and devising strategies to combat smuggling and other illegal activities. Besides, the unit has also reviewed and updated statistical systems to tie in with the planned opening of the co-located port "Shenzhen Bay Port" by end 2006.

#### 23 運輸 Transport

#### 運輸署統計組

23.1 運輸署統計組使用行政記錄編製交通及運輸統計資料,主要範圍包括各公共交通營辦商的營運資料、車輛登記及發牌、駕駛執照、車輛檢驗、道路交通意外、隧道交通流量及過境交通流量。這些統計數字按月在《交通運輸資料月報》發布。市民可於運輸署的網站(www.td.gov.hk)免費下載該月報。

#### Statistical Unit of the Transport Department

23.1 The statistical unit of the Transport Department (TD) compiles traffic and transport statistics based on various administrative returns. The main areas covered include operating characteristics of public transport operators, vehicle registration and licensing, driving licence, vehicle inspection and examination, road accident, traffic flows through tunnels and cross-boundary vehicular traffic. These statistics are released monthly in the *Monthly Traffic and Transport Digest*, which is available for free download on the website of the TD (www.td.gov.hk).

23.2 統計組亦負責外判統計調查的監管工作,並為署內其他部的統計調查進行資料分析。另一主要工作範圍是就各項運輸研究及調查提供統計諮詢。

23.2 The statistical unit also manages outsourced surveys and analyses results of surveys conducted by other divisions in the TD. Another major area of work is the provision of statistical advice on various transport studies and surveys.

#### 海事處統計組

23.3 海事處統計組編製船舶進出香港 數字和貨櫃吞吐量,將有關統計數字上 載至該處網頁(www.mardep.gov.hk),並 進行統計分析。

23.4 統計組就經濟發展及勞工局所進行的「香港港口貨運量預測二零零五/零六」,提供統計資料及意見。

#### Statistical Unit of the Marine Department

23.3 The statistical unit of the Marine Department (MD) compiles port statistics on vessel movements and container throughput, releases them on the website of the MD (www. mardep.gov.hk) and conducts statistical analyses.

23.4 The unit provides statistical information and comments on the Hong Kong Port Cargo Forecasts 2005/06, which is conducted by the Economic Development and Labour Bureau.

#### 24 社區資訊 Community Information

#### 民政事務局統計組

24.1 民政事務局統計組自二零零四年 五月起每季進行清潔評審工作,以編製 分區「社區清潔指數」。該指數提供客 觀的方法定期評審社區的整體清潔程 度,找出具體的環境衞生問題作改和市 同時亦反映衞生改善措施的成效和市民 的支持程度。編製「社區清潔指數」的 方法於二零零五年進行檢討,有關改善 措施已於二零零六年第一輪的評審工作 中開始實行。

24.2 統計組經常進行特定的意見調查,目的是搜集市民對政府各項政策和計劃的意見。二零零五年所進行的調查包括「有關公眾對種族歧視的意見調查」、「有關市民對同性戀者看法的意見調查」,以及「香港人參與賭博活動情況的意見調查」。

24.3 統計組將於二零零六年進行一項 有關現時香港企業所履行社會責任的情 況的統計調查,用以編訂企業公民手冊 及約章。

#### Statistical Unit of the Home Affairs Bureau

24.1 A quarterly cleanliness assessment for the compilation of Community Cleanliness Index at district level has been carried out since May 2004. The index measures objectively and regularly the general cleanliness of the community, identifies specific environmental hygiene problems for remedial action and also tracks the effectiveness of the hygiene improvement measures and the degree of community support. A review of the compilation method of the Community Cleanliness Index was conducted in 2005. The related enhancements have been implemented starting from the first round of the exercise in 2006.

24.2 Ad hoc opinion surveys are conducted from time to time to gauge public opinions on various government policies and programmes. The surveys conducted in 2005 included the Survey on Public Attitudes on Racial Discrimination, the Survey on Public Attitudes towards Homosexuals and the Survey on Hong Kong People's Participation in Gambling Activities.

24.3 A survey will be conducted in 2006 to find out the present situation of corporate social responsibility in Hong Kong companies with a view to preparing a handbook and building up a charter for corporate citizenship.

24.4 統計組計劃在日後進行更多有關 青少年及社區發展的意見調查及數據分 析工作。 24.4 The statistical unit plans to conduct more surveys and data analyses on youth and community development.

#### 25 食物及環境衞生 Food and Environmental Hygiene

#### 食物環境衞生署統計組

25.1 食物環境衞生署(食環署)統計組 為署內各組別提供統計支援,並進行各 類統計調查及編製統計報告,從而提供 有用資料,協助該署監察服務表現、進 行決策及政策規劃。

25.2 在二零零五年,統計組完成了「風險傳達組顧客對有關衞生教育的單張意見統計調查」,並就「二零零五年市民購買食物習慣統計調查」及「市民對食環署垃圾桶上的宣傳貼紙效用意見統計調查」,提供了統計方面的支援服務。

25.3 統計組提供的服務包括擬備外判統計調查服務投標規格,評估統計調查建議,就調查的樣本和問卷設計提供意見,以及監察統計調查的進度等。

## Statistical Unit of the Food and Environmental Hygiene Department

25.1 The statistical unit of the Food and Environmental Hygiene Department (FEHD) renders statistical support to various sections of the FEHD. The unit conducts statistical surveys and compiles statistical reports, which provide FEHD with useful information for performance monitoring, decision making and policy planning.

25.2 In 2005, the unit completed a survey on the views of Risk Communication Section customers on printed health education publicity materials. Moreover, statistical support services were provided to the Survey on Food Purchasing Habits in 2005 and the Survey on the Effectiveness of Publicity Stickers on FEHD Litter Containers.

25.3 The services rendered include preparation of tender specifications for the outsourcing of the surveys, assessment on survey proposals, provision of advice on sample and questionnaire design, and monitoring of survey progress.

#### 26 康樂及文化事務 Leisure and Cultural Services

#### 康樂及文化事務署統計組

26.1 康樂及文化事務署統計組編製有 關該署所提供的設施及服務的統計資料,並出版載列主要指標的統計季報及 年報。此外,統計組亦進行統計調查, 以取得資料供該署人員參考。

#### Statistical Unit of the Leisure and Cultural Services Department

26.1 The statistical unit of the Leisure and Cultural Services Department (LCSD) compiles statistics related to its facilities and services. Statistical reports containing major indicators are published quarterly and annually. The statistical unit also conducts surveys to obtain information for the reference of the LCSD officers.

26.2 在二零零五至零六年度,統計組 共參與進行 16 項統計調查,其中包括 「康樂及文化事務署體育館意見調查」 及「康樂及文化事務署泳池意見調 查」。 26.2 In 2005-06, the statistical unit engaged in 16 surveys, including among others Opinion Survey on LCSD Sports Centres and Opinion Survey on LCSD Swimming Pools.

#### 27 水務 Water Supplies

#### 水務署統計組

27.1 水務署統計組為該署各組別提供統計服務,主要包括編製有關水務的統計數字、進行統計調查與研究,以及提供統計諮詢服務。

27.2 統計組計劃進行一系列統計調查,搜集及分析公眾人士對供水服務的意見,以供該署檢討供水系統及制定優質供水服務的策略性規劃之用。

#### Statistical Unit of the Water Supplies Department

27.1 The statistical unit of the Water Supplies Department (WSD) provides statistical services to various sections of the WSD, including mainly the compilation of waterworks statistics, the conduct of statistical surveys and studies, and the provision of statistical advice.

27.2 The statistical unit plans to conduct a series of surveys for collecting and analysing the views of the public on water supply services. This will facilitate the WSD in reviewing water supply systems and formulating strategic planning for the provision of quality water supply services.

#### 28 環境 The Environment

28.1 環境保護署定期編製多個範疇的環境統計數字,涵蓋環境監察、環境改善,以及執法行動。

28.2 《香港統計年刊》載有有關空氣 素質、水質、污染投訴,以及固體廢物 排放及成分的選定統計數字。 28.1 Statistics on various aspects of the environment are compiled regularly by the Environmental Protection Department, covering environmental monitoring, environmental achievement/improvement and enforcement.

28.2 Selected statistics on air quality, water quality, pollution complaints as well as solid waste generation and composition have been included for publication in the *Hong Kong Annual Digest of Statistics*.

#### 29 專題研究 Topical Studies

#### 社會研究

29.1 本處不時進行「主題性住戶統計 調查」及「專題訪問」,以搜集其他政 府部門及決策局所需的社會經濟數據, 供規劃及政策檢討之用。「主題性住戶

#### **Social Studies**

29.1 In order to collect socio-economic data required by other government departments and policy bureaux for planning and policy review purposes, the department conducts Thematic Household Survey (THS) and Special Topic Enquiry (STE) from

29.3 本處向由財政司司長領導的扶貧委員會,提供從「綜合住戶統計調查」所得的詳細勞動人口及住戶統計數字,以協助其編製一系列貧窮指標,用作衡量貧窮問題及理解其嚴重性。本處會因應扶貧委員會的需求更新有關的統計數字。

#### 發展為研究有關香港、澳門及珠江 三角洲的資料庫

29.4 香港特別行政區政府已訂下明確政策,務求開拓因香港與珠江三角洲更密切的連繫可能帶來的商機,並推動兩地的發展和合作。成功推行這新政策需要長期的數據支援有關研究。為此,一個以地理訊息系統為基礎,載列相關社會經濟統計數列的資料庫已於二零零五年四月投入服務。

time to time. The THS, adopting the "user pays" principle, is outsourced to private research firms under the co-ordination and management of the department. The STE, conducted via the General Household Survey, is generally dedicated to topics which are labour related; with significant policy implications and urgency; or for which outsourcing is not suitable.

29.2 The department compiles an annual publication entitled *Women and Men in Hong Kong – Key Statistics* based on a wide variety of data sources. It provides a ready source of information for those interested in the current situation of women and men, and the gender equality in Hong Kong.


29.3 The department has provided detailed labour force and household statistics compiled based on the General Household Survey to the Commission on Poverty, which is chaired by the Financial Secretary, to facilitate the preparation of a set of poverty indicators for measuring and sizing the problem of poverty. Updated statistics will be provided to the Commission as and when required.

#### Development of an Information Database for Studies Related to Hong Kong, Macao and the Pearl River Delta (PRD)

29.4 It is a stated policy of the HKSAR Government to tap the business opportunities that may arise from a closer link between Hong Kong and the PRD, and to promote development and co-operation between the two regions. The success of this policy initiative will need the support of research studies underpinned by long-term data. In this connection, a Geographic Information System based information database containing relevant series of socio-economic statistics has been put in use starting from April 2005.
