概況

二零零三年第一季按開支組成部分劃分的本地生產總值

本地生產總值在二零零三年第一季與上年同期比較實質上升4.5%，而二零零二年第四季則錄得5.1%的升幅。

經季節性調整而作相連季度比較的本地生產總值，在二零零三年第一季錄得0.3%的輕微實質跌幅。

按本地生產總值各個主要組成部分分析，私人消費開支繼二零零二年第四季錄得1.8%的跌幅後，在二零零三年第一季與上年同期比較實質下跌2.1%。

按國民經濟核算定義計算的政府消費開支，在二零零三年第一季與上年同期比較實質增長1.1%，而二零零二年第四季的升幅則為0.8%。

本地固定資本形成總額在二零零三年第一季溫和實質上升3.9%，而二零零二年第四季則下跌0.7%。

當中，機器、設備及電腦軟件開支在二零零三年第一季與上年同期比較錄得11.9%的實質增長，這較二零零二年第四季的3.2%升幅為大。

在二零零三年第一季，樓宇及建造開支實質下跌2.7%，較二零零二年第四季的6.2%跌幅有所緩和。

私營部門的樓宇及建造開支在二零零三年第一季實質下跌3.0%。至於公營部門亦錄得2.0%的跌幅。

貨物出口總額（包括轉口及本地產品出口），在二零零三年第一季與上年同期比較大幅實質增長19.1%，略高於二零零二年第四季的18.4%升幅。貨物進口在二零零三年第一季亦顯著實質上升18.8%。

無形貿易方面，服務輸出在二零零三年第一季與上年同期比較錄得12.2%的實質升幅，較二零零二年第四季的18.1%升幅為慢。服務輸入在二零零三年第一季下跌4.0%。

General Observations

GDP by expenditure component for the first quarter of 2003

In the first quarter of 2003, the Gross Domestic Product (GDP) increased by 4.5% in real terms over a year earlier, compared with the growth of 5.1% in the fourth quarter of 2002.

On a seasonally adjusted quarter-to-quarter comparison, GDP recorded a marginal decrease of 0.3% in real terms in the first quarter of 2003.

Analysed by major GDP component, private consumption expenditure (PCE) recorded a year-on-year decline of 2.1% in real terms in the first quarter of 2003 over a year earlier, following the 1.8% decline in the fourth quarter of 2002.

Government consumption expenditure (GCE) in national accounts terms grew by 1.1% in real terms in the first quarter of 2003 over a year earlier, compared with the increase of 0.8% in the fourth quarter of 2002.

Gross domestic fixed capital formation (GDFCF) grew moderately by 3.9% in real terms in the first quarter of 2003, as against the decline of 0.7% in the fourth quarter of 2002.

Within the total GDFCF, expenditure on machinery, equipment and computer software recorded an increase of 11.9% in real terms in the first quarter of 2003 over a year earlier. This was higher than the 3.2% growth in the fourth quarter of 2002.

Expenditure on building and construction decreased by 2.7% in real terms in the first quarter of 2003, moderating from the 6.2% decline in the fourth quarter of 2002.

Over the same period, expenditure on building and construction of the private sector fell by 3.0% in real terms while that of public sector recorded a decline of 2.0%.

Total exports (comprising re-exports and domestic exports) grew markedly by 19.1% in real terms in the first quarter of 2003 over a year earlier, slightly higher than the 18.4% growth in the fourth quarter of 2002. Imports of goods also increased significantly by 18.8% in real terms in the first quarter of 2003.

On invisible trade, exports of services registered an increase of 12.2% in real terms in the first quarter of 2003 over a year earlier, at a slower pace than the 18.1% growth in the fourth quarter of 2002. Imports of services decreased by 4.0% in the first quarter of 2003.

用作概括量度整體通脹的本地生產總值內含平減物價指數，在二零零三年第一季較上年同期下跌4.7%。

經納入最新資料後，二零零一年本地生產總值的按年實質變動率由0.6%向下修訂至0.5%。

二零零二年第四季及二零零二年全年按經濟活動劃分的本地生產總值

在二零零三年三月底發布的二零零二年第四季及二零零二年全年以固定價格計算按經濟活動劃分的本地生產總值初步數字，在獲得更多資料後，現已被修訂。

修訂數字顯示所有服務行業的淨產值在二零零二年第四季較一年前同期合計實質上升6.4%，較第三季4.3%的升幅為大。二零零二年全年的增長為3.1%。

按不同組成的服務行業分析，批發、零售、進出口貿易、飲食及酒店業在二零零二年第四季的淨產值較一年前同期實質顯著上升14.5%，明顯較第三季6.9%的升幅為快。二零零二年全年合計，批發、零售、進出口貿易、飲食及酒店業的淨產值實質上升5.1%。

運輸、倉庫及通訊業在二零零二年第四季的淨產值較一年前同期實質上升6.2%，第三季的升幅為5.5%。增長主要由運輸及倉庫業帶動，受惠於貨物裝卸活動隨著對外貿易回升而進一步擴充。二零零二年全年合計，運輸、倉庫及通訊業的淨產值實質上升4.0%。

金融、保險、地產及商用服務業在二零零二年第四季的淨產值較一年前同期實質上升2.5%，第三季的升幅為1.6%。二零零二年全年合計，金融、保險、地產及商用服務業的淨產值實質上升0.9%。

社區、社會及個人服務業在二零零二年第四季的淨產值較一年前同期實質微升0.5%，第三季的升幅為1.1%。二零零二年全年合計，升幅大致相若，有0.7%的實質增長。

另一方面，本地製造業繼二零零二年第三季實質下跌6.4%後，第四季的淨產值較一年前同期實質下跌7.2%。二零零二年全年合計，本地製造業淨產值有8.9%的實質跌幅。

The implicit price deflator of GDP, as an overall measure of inflation in the economy, recorded a year-on-year decline of 4.7% in the first quarter of 2003.

In the light of the latest information available, the GDP real growth rate for 2001 was revised slightly downwards to 0.5% (from 0.6%).

GDP by economic activity for the fourth quarter of 2002 and the whole year of 2002

Preliminary figures of GDP by economic activity at constant prices for the fourth quarter of 2002 and the whole year of 2002, which were released in end-March 2003, were revised as more data became available.

The revised figures showed that net output in all the service activities taken together increased by 6.4% in real terms in the fourth quarter of 2002 over a year earlier, larger than the 4.3% increase in the third quarter. For 2002 as a whole, there was an increase of 3.1%.

Analysed by constituent sector and on a year-on-year comparison, net output in the wholesale, retail and import and export trades, restaurants and hotels surged by 14.5% in real terms in the fourth quarter of 2002, distinctly faster than the 6.9% increase in the third quarter. For 2002 as a whole, net output in the wholesale, retail and import and export trades, restaurants and hotels increased by 5.1% in real terms.

Net output in transport, storage and communications grew notably, by 6.2% in real terms in the fourth quarter of 2002 over a year earlier, after a 5.5% rise in the third quarter. The growth impetus came mainly from transport and storage services, underpinned by a further expansion in cargo handling activity upon a pick-up in external trade. For 2002 as a whole, net output in transport, storage and communications went up by 4.0% in real terms.

Net output in financing, insurance, real estate and business services rose by 2.5% in real terms in the fourth quarter of 2002 over a year earlier, after an increase of 1.6% in the third quarter. For 2002 as a whole, net output in financing, insurance, real estate and business services increased by 0.9% in real terms.

Net output in community, social and personal services edged up by 0.5% in real terms in the fourth quarter of 2002 over a year earlier, after a 1.1% rise in the third quarter. For 2002 as a whole, the increase was broadly similar, at 0.7% in real terms.

On the other hand, net output in the local manufacturing sector shrank by 7.2% in real terms in the fourth quarter of 2002 over a year earlier, following a 6.4% decrease in the third quarter. For 2002 as a whole, net output in the local manufacturing sector had a decrease of 8.9% in real terms.

建造業在二零零二年第四季的淨產值較一年前同期實質下跌6.4%，扭轉了第三季上升2.4%的情況。然而，二零零二年全年合計，建造業淨產值實質溫和下跌1.0%。

至於電力、燃氣及水務業，其淨產值繼二零零二年第三季實質上升了2.9%後，第四季較一年前同期實質溫和上升0.7%。二零零二年全年合計，電力、燃氣及水務業的淨產值實質上升3.0%。

二零零一年按經濟活動劃分的本地生產總值(以當時價格計算)

按經濟活動劃分的本地生產總值統計數字，主要是根據按年經濟統計調查所得的資料而編製，作為分析不同經濟活動對於整體本地生產總值的貢獻十分有用。

二零零一年按經濟活動劃分的本地生產總值修定數字顯示「批發、零售、進出口貿易、飲食及酒店業」佔本地生產總值最大部分(26.7%)、其次是「金融、保險、地產及商用服務業」(22.6%)和「社區、社會及個人服務業」(21.8%)。

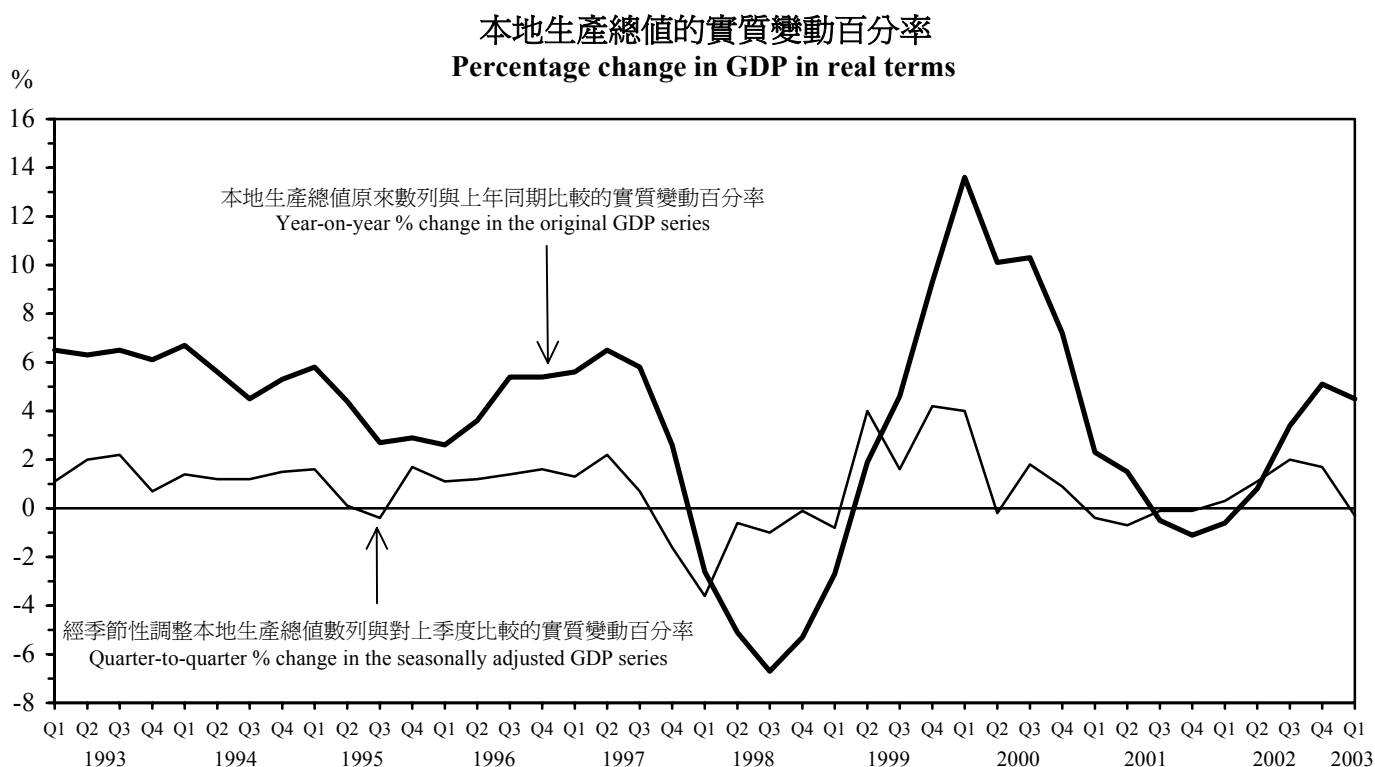
Net output in the construction sector declined by 6.4% in real terms in the fourth quarter of 2002 over a year earlier, reversing the 2.4% increase in the third quarter. For 2002 as a whole, net output of the construction sector nevertheless decreased moderately, by 1.0% in real terms.

As to the electricity, gas and water sector, net output rose mildly by 0.7% in real terms in the fourth quarter of 2002 over a year earlier, following a 2.9% increase in the third quarter. For 2002 as a whole, net output in the electricity, gas and water sector grew by 3.0% in real terms.

GDP by economic activity at current prices for 2001

The GDP by economic activity statistics which are compiled mainly based on data collected from the annual economic surveys are useful for analysis of the contributions of different economic activities to the total GDP.

The revised figures of GDP by economic activity for 2001 showed that the “wholesale, retail and import/export trades, restaurants and hotels” accounted for the largest share (26.7%) of the GDP, followed by the “financing, insurance, real estate and business services” (22.6%), and “community, social and personal services”(21.8%).

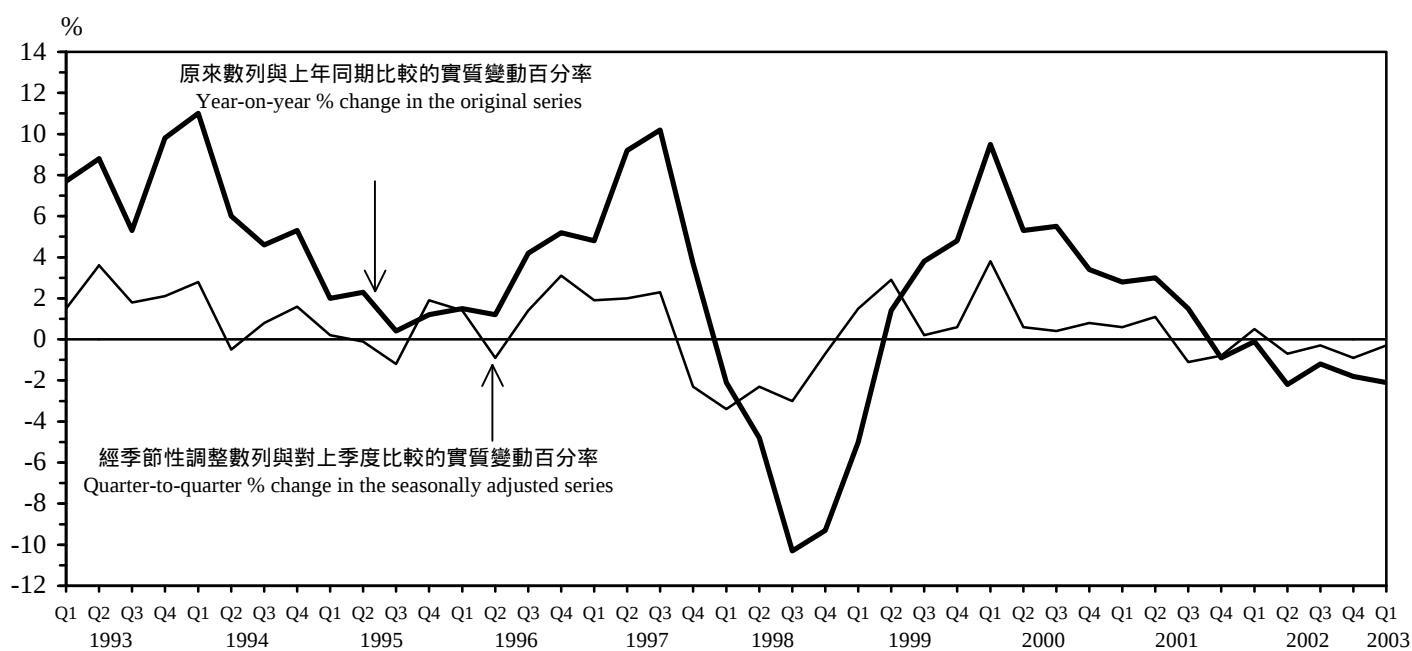

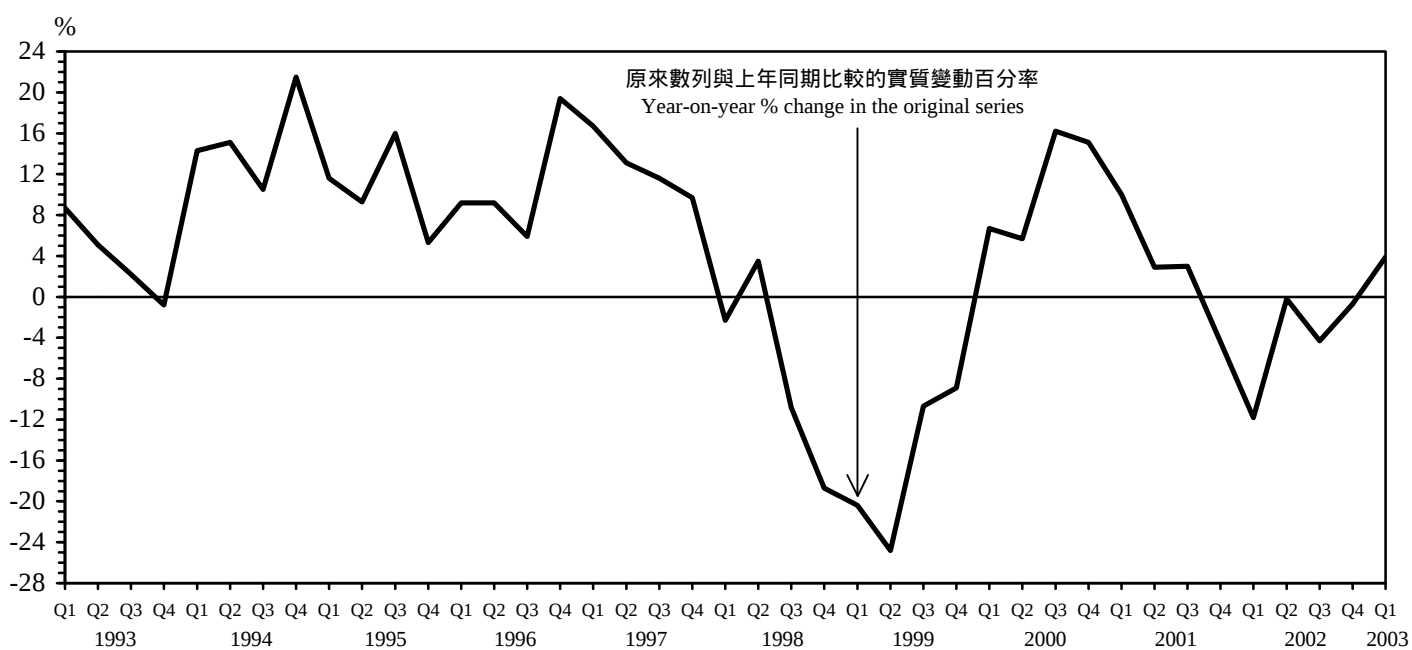
私人消費開支的實質變動百分率

Percentage change in gross domestic fixed capital formation in real terms



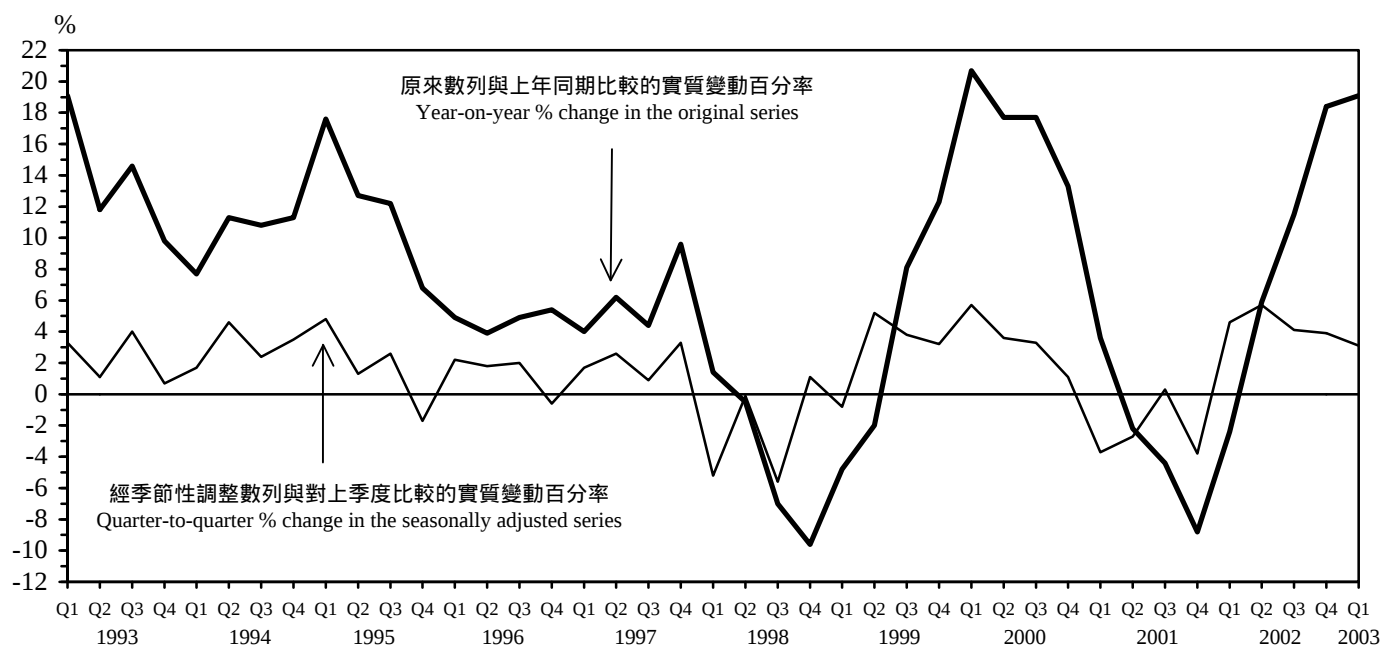

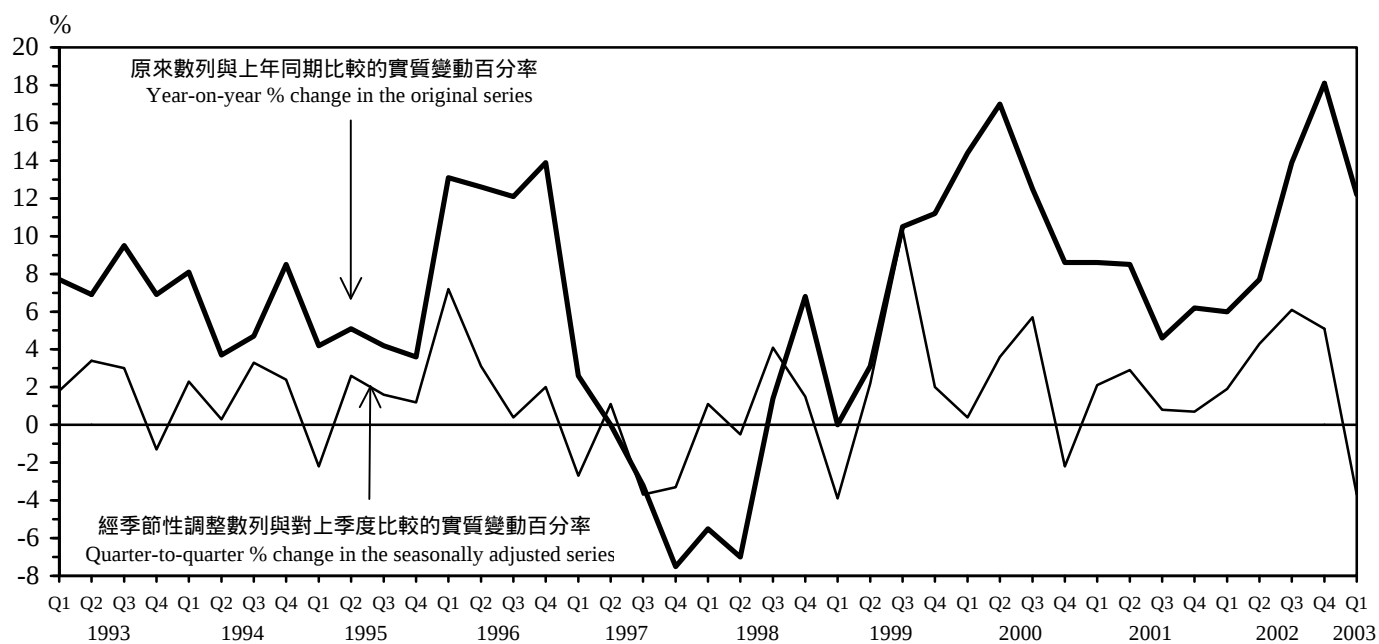

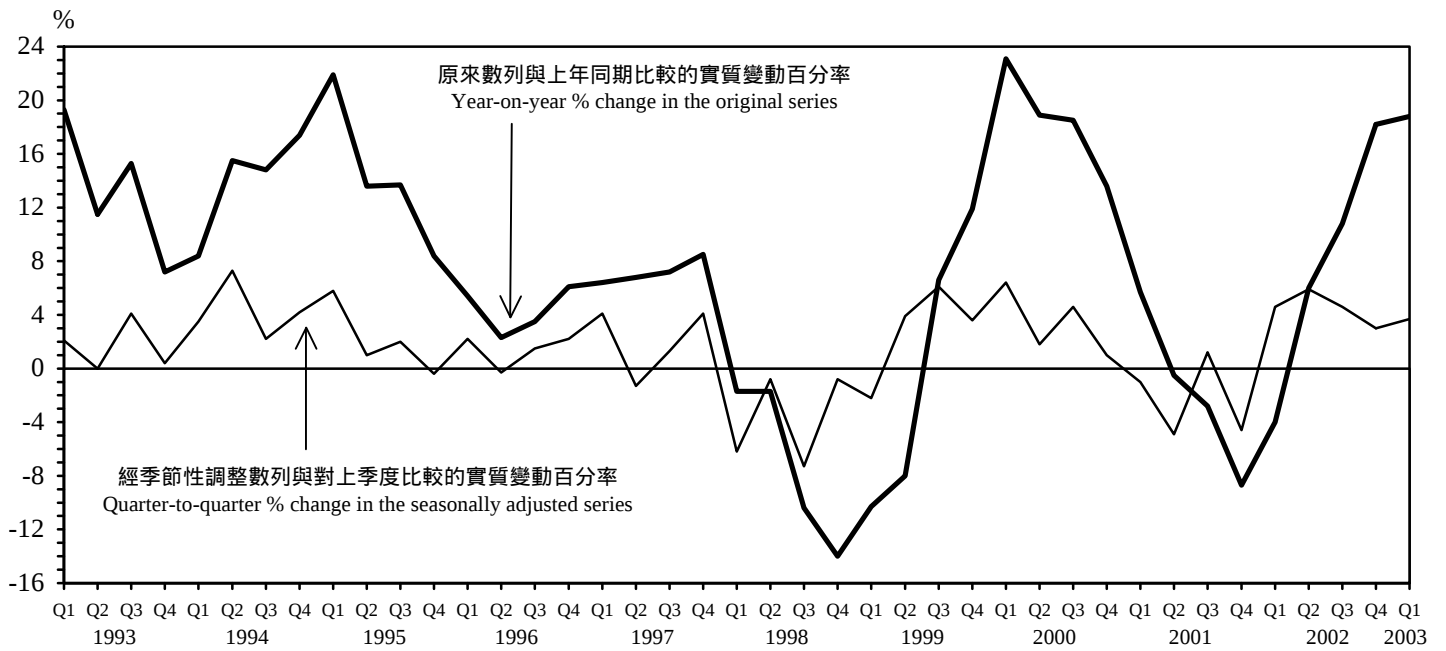
貨物出口的實質變動百分率
Percentage change in exports of goods in real terms



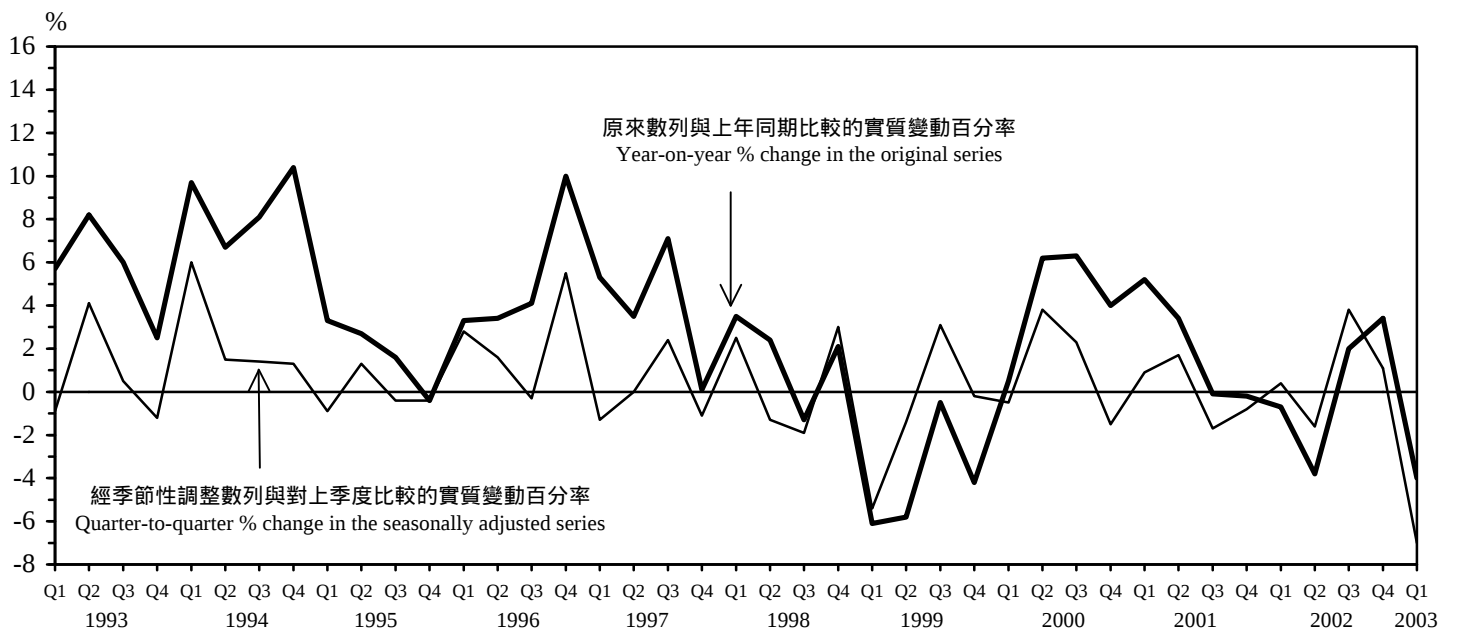
服務輸出的實質變動百分率

註釋

本地生產總值的概念與編製方法

1. 本地生產總值是指一個國家或地區的所有常住生產單位，在一個指定的期間內，未扣除固定資本消耗的生產總值。如果一個生產單位以一個國家或地區的經濟領域為其經濟利益中心，這生產單位就是該國家或地區的常住單位。一個國家或地區的經濟領域，是指該國家或地區政府所管治的地域，而在該領域內的人士、貨物及資本均可自由流動。
2. 於一九九七年七月一日，香港成為中華人民共和國的特別行政區。在本系列報告書中就一九九七年七月或以後的統計資料而言，「香港」是指香港特別行政區。香港特別行政區與中國內地之間的經濟交易，視作國際交易（例如貨物貿易及服務貿易）。
3. 一個國家或地區的「按人口平均計算的本地生產總值」是指把該國家或地區在某統計年的「本地生產總值」除以該國家或地區在該年的人口總數而得的數字。
4. 本地生產總值可由不同層面計算。香港的以當時價格及以固定價格計算的按年本地生產總值數字分別以開支面和生產面編製。按季數字方面，以固定價格計算的數字分別以開支面和生產面編製，而以當時市價計算的本地生產總值則只以開支面編製。
5. 進行有關經濟結構的分析較適宜使用以當時價格計算按經濟活動劃分的按年本地生產總值數列，而不是按季本地生產總值數列，因為按季數據有時會大幅波動。統計先進的經濟體系的普遍做法都只是按年而不是按季公布以當時價格計算按經濟活動劃分的本地生產總值。

按開支組成部分劃分的本地生產總值

6. 從開支面編製的本地生產總值，是將作最終用途的貨物和服務的總產值，扣除其進口成分而得。它是以下開支組成部分的總和：—
 - (i) 私人消費開支是住戶和為住戶服務的私人非牟利機構在貨物和服務方面的最終消費開支價值。計算方法是把本地市場內對貨物及服務的消費開支，加上本港居民在外地的開支，減去非本地居民在本地市場的開支。
 - (ii) 政府消費開支是非參與商業活動的各個政府部門及非牟利半政府機構用於購買貨物及服務的開支。政府消費開支的計算方法，是將僱員報酬加上購買貨物及服務支出，扣除銷售貨物及服務的收

Explanatory Notes

Concepts and Methods for Compiling GDP

1. GDP is a measure of the total value of production of all resident producing units of a country or territory in a specified period, before deducting allowance for consumption of fixed capital. A producing unit is considered as a resident in a country or territory if it maintains a centre of economic interest in the economic territory of that country or territory. The economic territory of a country or territory is the geographic territory administered by the government of the country or territory within which persons, goods and capital circulate freely.
2. On 1 July 1997, Hong Kong became a Special Administrative Region of the People's Republic of China. In respect of statistics in this series of report, "Hong Kong" stands for the Hong Kong Special Administrative Region with effect from July 1997. Data on transactions vis-a-vis the mainland of China are treated as international transactions (e.g. trade in goods and trade in services).
3. Per capita GDP of a country or territory is obtained by dividing total GDP in a year by the population of that country or territory in the same year.
4. GDP can be measured using different approaches. In Hong Kong, annual GDP at current and constant prices are compiled using the expenditure approach and the production approach. For quarterly GDP, constant price figures are compiled using both approaches while quarterly GDP at current market prices is compiled using the expenditure approach only.
5. For analysis relating to economic structure, it is more appropriate to use *annual* rather than *quarterly* series of current price GDP by economic activity. This is because quarterly data are often subject to large fluctuations. It is a common practice of statistically advanced economies to publish current price GDP by economic activity on annual rather than quarterly basis.

GDP by expenditure component

6. Under the expenditure approach, GDP is equal to the value of goods and services produced for final use less their import content. It is the sum of the following expenditure components:-
 - (i) *Private consumption expenditure* refers to the value of final consumption expenditure on goods and services by households and private non-profit institutions serving households. It is calculated as the sum of consumption expenditure on goods and services in the domestic market and the expenditure of Hong Kong residents abroad, less the expenditure of non-residents in the domestic market.
 - (ii) *Government consumption expenditure* refers to the current expenditure on goods and services by government departments which are not engaged in trading activities and quasi-government non-profit institutions. It is calculated as the sum of compensation of employees and purchases of goods and services, less

- (iii) 本地固定資本形成總額包括機器、設備及電腦软件的開支總額、樓宇及建造開支和擁有權轉讓費用。這些數字是按公營及私營部門分類列出，公營部門的數字是指政府、半政府部門和公營機構的資本開支。根據資產擁有權分類，出租公屋的建築開支屬公營部門開支，至於「居者有其屋計劃」則屬私營部門開支。私營部門的樓宇及建造開支亦包括地產發展商從新建樓宇工程所得的毛利。
- (iv) 存貨增減是指商業機構（主要是製造商及分銷商）所持有的半製成品、原料及製成品存貨的實質增減價值。
- (v) 貨物出口及服務輸出減去貨物進口及服務輸入：貨物出口包括以離岸價計算的本地產品出口和貨物轉口總值。貨物進口是指以離岸價計算的貨物進口總值。非貨幣黃金的對外貿易亦包括在內。服務輸入及輸出包括本港居民與世界各地進行的服務交易。主要服務組別包括運輸、旅遊、商貿服務及其他與貿易相關的服務，以及其他服務。而其他服務包括多類服務例如金融服務、保險服務、商業及專業服務。

按經濟活動劃分的本地生產總值

7. 以生產面編製的本地生產總值，是本地各生產單位（例如工廠、商店、服務機構）的「增加價值」的總和。一個生產單位的「增加價值」是其生產的貨物和服務的價值（「生產總額」）減去在其生產過程中耗用的貨物和服務的價值（「中間投產消耗」）。按經濟活動劃分的本地生產總值，顯示個別經濟活動的增加價值。

8. 按經濟活動劃分的本地生產總值提供數據，以助對各行業進行各方面的分析。首先，以當時價格計算按經濟活動劃分的按年本地生產總值，可以用來分析各類經濟活動較長期趨勢的相對重要性，有助展示經濟根本結構的變化。所應用的數據，是按年以當時價格計算各經濟活動的增加價值在本地生產總值所佔的百分比。第二，以固定價格計算按經濟活動劃分的本地生產總值按年變動百分率可提供數據，幫助評估不同經濟活動的相對表現。而以固定價格計算的數列已剔除價格變動的影響。第三，以固定價格計算按經濟活動劃分的本地生產總值，可以用來分析各類經濟活動對整體經濟增長的貢獻，有助了解經濟增長的來源。所

receipts from sales of goods and services. Government departments engaged in trading activities are not covered. They are distinguished from other government departments in that they are engaged in the production of goods and services mainly for sale to the public.

- (iii) *Gross domestic fixed capital formation* covers the gross value of expenditure on machinery, equipment and computer software; expenditure on building and construction; and costs of ownership transfer. Statistics are classified by public and private sectors. Public sector includes capital expenditure of government, quasi-government institutions and public corporations. According to the ownership criterion for classifying fixed assets into public and private sectors, construction expenditure on public rental housing is classified to the public sector whereas that on Home Ownership Scheme is classified to the private sector. Private sector expenditure on building and construction also includes real estate developers' margin of new building projects.
- (iv) *Changes in inventories* refer to the value of physical change in the inventories of work-in-progress, raw materials and finished goods held by business enterprises, mainly manufacturers and distributors.
- (v) *Exports of goods and services less imports of goods and services*: Exports of goods include domestic exports and re-exports of goods recorded on f.o.b. basis. Imports of goods are valued on f.o.b. basis. External trade of non-monetary gold is also included. Exports and imports of services cover transactions in services between Hong Kong residents and the rest of the world. The major service groups include transportation, travel, merchanting and other trade-related services, and other services. Other services cover a wide variety of services including financial services; insurance services; business and professional services.

GDP by economic activity

7. Under the production approach, GDP is the sum of the value added of resident producing units, e.g. factories, shops, service organizations. Value added of a producing unit is the value of goods and services it produces ('gross output') less the value of goods and services it uses up in the course of production ('intermediate consumption'). GDP by economic activity shows the value added of individual economic activities.

8. GDP by economic activity provides data to support sectoral analyses from various perspectives. Firstly, annual current price GDP by economic activity provides data for analyzing the longer-term trend in the relative importance of economic activities. This helps depict changes in the underlying economic structure. The statistics used are the percentage share of annual current price value added of various economic activities in overall GDP. Secondly, the year-on-year percentage change of constant price GDP by economic activity provides data for assessing the relative performance of different economic activities. In the constant price series, the effect of price changes has been removed. Thirdly, constant price GDP by economic activity provides data for analysing the contribution of economic activities to overall economic growth. This facilitates analysis of the source of growth of an economy.

9. 生產面本地生產總值採用《香港標準行業分類1.1版》的經濟活動分類方法。為編製國民經濟核算，還需包括兩個經濟組別，即樓宇業權和非直接計算的金融中介服務。

10. 在國民經濟核算方面，樓宇業權被視為一項經濟活動，涵蓋(a)自住業主(即居住在自己擁有的住宅的住戶)為本身提供的租賃服務；(b)業主使用政府及私人非牟利機構的自置及自用樓宇；(c)業主以個人身分向租客提供的租賃服務。

11. 金融中介服務是由金融中介機構(如銀行和接受存款公司)向存款者及借貸者提供的服務。這些金融中介機構提供服務時沒有直接收取服務費，而是賺取存款及借貸的利息之間的差額。編製本地生產總值時，非直接計算的金融中介服務的價值會計入金融服務業的生產總額內，因而亦包括在其增加價值之內。因此，必須從使用有關服務的其他行業的增加價值中扣除這類服務費。不過，在實行上要設立準則以進行這個計算，是十分困難的，而國際認可的做法是把這項收費總額從所有生產者的總增加價值中扣除，以調整本地生產總值的數字。

以固定價格計算的本地生產總值

12. 以固定價格計算本地生產總值的組成部分和次組成部分的數字，是以適當的物價指數去平減以當時市價計算的數值，或是根據基年的價格而將現時數量重新計算。以固定價格計算的本地生產總值是把以固定價格計算的組成部分加起來而得。以固定價格計算的數列撇除了價格變動的影響，而以固定價格計算本地生產總值的變動反映有關經濟活動的物量變動情況。

13. 以固定市價計算的本地生產總值的基年，是指用作計算各類貨物及服務的詳細價格結構的年份，以提供加權數字，來合計各種生產或購買的貨物及服務的總體物量變動。雖然年與年之間的價格結構只會逐漸改變，但經若干年後便會累積成顯著的變動幅度，故此統計機構通常會每隔若干年便把以固定市價計算的本地生產總值的基年更新，以確保計算物量變動所用的權數可反映較接近當時狀況的價格結構。

14. 在二零零二年度的主要修訂中，以固定市價計算的本地生產總值的基年由一九九零年重訂於二零零零年。二零零零年新基年及以後的本地生產總值與其開支組成部分的物量估計，會根據二零零零年的價格結構重新加權。重訂基年並不應用於二零零零年以前的數列。一些統計先進的經濟體系亦採用這方法重訂以固定市價計算的本地生產總值的基年。

The statistics used are the percentage point contribution of various economic activities to the year-on-year percentage change in GDP at constant prices.

9. The Hong Kong Standard Industrial Classification Version 1.1 (HSIC V1.1) is used in classifying economic activities of GDP under production approach. For national accounting purposes, two additional activities are also covered, viz. ownership of premises and financial intermediation services indirectly measured (abbreviated as FISIM).

10. Ownership of premises is treated as an economic activity in the national accounts. This activity covers (a) the leasing services provided by residential owner-occupiers (i.e. households living in dwellings that they own) to themselves; (b) owners using owner-occupied premises of government and private non-profit institutions; (c) the leasing services provided to tenants by owners of premises in individual capacity.

11. Financial intermediation services are services provided by financial intermediaries (such as banks and deposit-taking companies) to depositors and borrowers. These financial intermediaries do not charge explicitly on the services they provide. They earn from paying and charging different interest rates to depositors and borrowers. In compiling GDP, the value of financial intermediation services indirectly measured (FISIM) is added to the gross output and consequently to the value added of financing services industry. Having done this, it is necessary to deduct such from the value added of other industries which are charged for the use of services. However, in practice it is very difficult to establish a basis for this to be done, and the internationally accepted practice is to adjust the GDP by deducting the value of FISIM from the aggregated value added of all producers.

Constant Price GDP

12. Constant price figures of the components and sub-components of the GDP are prepared either by deflating current values by appropriate price indices, or by revaluing the current period quantities at base year prices. The constant price GDP is obtained by aggregating the constant price data of its components. In the constant price series, the effects of price changes have been eliminated and changes in GDP at constant prices reflect changes in the volume of economic activities.

13. The base year for the constant price GDP is the reference year in respect of which detailed price structure is used in calculating the values which provide weights for aggregating changes in volume of various types of goods and services produced or purchased. While the price structure changes only gradually from year to year, cumulative changes may become significant over a number of years. Thus, the base year of the constant price GDP needs to be updated from time to time in order to ensure that the weights underlying the measurement of volume changes reflect the more current price structure.

14. In the 2002 round of the major revision, the base year for the constant price GDP is updated to year 2000 from 1990. The volume estimates of GDP and various expenditure components as from the new base year of 2000 and onwards are re-weighted according to the 2000 price structure. Rebasings of the historical series before the new base year of 2000 is not undertaken. Some statistically advanced economies also adopt this method in rebasing the constant price GDP.

15. 二零零零年新基年以前的數列是根據以往的基年在整體及各個組成部分層面而編製，用簡單的拼接法接連至重新加權後的數列。因此，在這次重訂基年的工作中，新基年以前的本地生產總值及其組成部分的實質增長率並不會因重訂基年而有所影響，但由於有更完備的資料及採用新的國際指引，部分估計數字已作出相應修訂。

按開支組成部分劃分的本地生產總值

16. 編製以固定市價計算按開支組成部分劃分的本地生產總值時，會採用一個標準的平減物價方法。每個開支組成部分固定價格數值的計算方法，是把經平減物價的各個分項組成部分加起來；而這些分項組成部分固定價格數值的編製，是採用適當的物價指數平減以當時價格計算的數值，或是根據基年的價格而將現時數量重新計算而得。把以固定價格計算的各個開支組成部分進一步相加起來，便取得以固定價格計算的本地生產總值。

17. 本地生產總值內含平減物價指數(或簡稱本地生產總值平減物價指數)通常會用作概括地量度一個經濟體系的整體通貨膨脹。這個指數涵蓋有關消費、投資和進出口的價格變動。

18. 將以當時價格計算的本地生產總值，除以以固定價格計算的本地生產總值，便可以隱含方式計算出本地生產總值平減物價指數。使用類似方法，將每個以當時價格計算的本地生產總值組成部分，除以相應的固定價格數值，便可以隱含方式計算出個別開支組成部分的相關內含平減物價指數。因此，本地生產總值及其開支組成部分的內含平減物價指數，並不是用以計算有關的固定價格數值的。

按經濟活動劃分的本地生產總值

19. 從生產面以固定價格計算的本地生產總值，是以固定價格計算各項經濟活動的增加價值的總和，加上以固定價格計算的生產和進口稅額。增加價值的計算方法，是生產總額減去中間投產消耗。要獲得以市價計算的本地生產總值，必須將生產和進口稅加進有關經濟活動以要素成本計算的增加價值總額。

20. 隨著政府統計處近年擴大和加強按月及按季經濟統計調查，更多經濟數據得以齊備，包括短期經濟指標(例如服務業的按季業務收益)和為某些選定服務業編製的生產者價格指數。生產者價格指數旨在量度本地生產者對其產品及服務所收取價格的平均變動。生產者價格是指本地生產者對其產出所收取的實際交易價格，即已扣除任何退回買家的折扣、回佣或津貼，但包括附加費用。這些資料的齊備，使以固定價格計算按經濟活動劃分的按季本地生產總值的編製得以實行。

15. For the historical series prior to the new base year of 2000, the volume estimates compiled on the earlier base years at both the aggregate and component levels are linked by simple splicing to the re-weighted series. Thus, in the rebasing exercise, the real growth rates of GDP and its components for the earlier periods are not affected at all, except where data revisions and methodological changes have been made in the light of more comprehensive information and adoption of new international guidelines.

GDP by expenditure component

16. In compiling the GDP by expenditure component at constant market prices, a standard deflation approach is adopted. The constant price measure of each expenditure component is obtained by adding up the respective deflated sub-components, each of the latter is compiled either by deflating the current price value using an appropriate price index, or by revaluing the current period quantities at base year prices. The constant price expenditure components are further aggregated to arrive at the constant price GDP.

17. The implicit price deflator of GDP (or GDP deflator in short) is generally used as a broad measure of overall inflation in the economy. It takes account of all price changes relating to consumption, investment, exports and imports.

18. The GDP deflator is implicitly obtained by dividing the current price GDP by the constant price GDP. Similarly, by dividing each of the GDP components at current prices with each of the corresponding constant price figures, the respective implicit price deflators for individual expenditure components are implicitly obtained. Hence as it stands, the implicit price deflators of GDP and its expenditure components are not used as input for compiling the corresponding constant price measures.

GDP by economic activity

19. Under the production approach, constant price GDP is measured by the sum of constant price value added of economic activities plus constant price taxes on production and imports. Value added is calculated by deducting intermediate consumption from the gross output. To arrive at GDP measured at market prices, it is necessary to add taxes on production and imports to sum of value added of economic activities measured at factor cost.

20. With the development and enhancement of monthly and quarterly economic surveys conducted by the Census and Statistics Department in recent years, more economic data are available, including the availability of short-term economic indicators (e.g. quarterly business receipts of service industries) and producer price indices (PPIs) for selected services industries. PPI is a measure of the average change in prices of goods and services received by local producers. Producer prices are transacted prices, net of any discounts, rebates or allowances given to buyers but including surcharges received by producers. The availability of such data enables the compilation of quarterly constant price GDP by economic activity.

21. 本港以固定價格計算各項經濟活動的增加價值一般用四種方法編製：(a) 以基年增加價值單一外推編算方法(外推指標是經平減的生產總額(如經生產者價格指數平減的業務收益))；(b) 以基年增加價值單一外推編算方法(外推指標是物量／數量數據(如貿易量和產品的實質數量))；(c) 以基年增加價值單一外推編算方法(外推指標是投入指標(如工作時數))；(d) 雙指標編算方法。統計先進的經濟體系(例如澳洲、新西蘭和英國)編算以固定價格計算的按季增加價值時普遍採用首兩個方法，香港一般也採用這兩個方法。有關詳細方法和指標，請參閱二零零三年三月出版的《二〇〇二年本地生產總值》第四章。

編製本地生產總值的資料來源

22. 編製按開支組成部分劃分的本地生產總值的資料來源，包括對外貿易統計、對工商機構及住戶的按年、按季及按月統計調查、政府賬目、各政府部門及其他組織的行政資料。

23. 至於按經濟活動劃分的按年本地生產總值，資料來源主要包括從「按年經濟統計調查計劃」及行政紀錄所得的資料。編製以固定價格計算按經濟活動劃分的按季本地生產總值的資料來源，主要包括對工商機構及住戶的按季及按月統計調查、政府賬目、各政府部門及其他組織的行政資料。

本地生產總值的發表形式

24. 在發表以固定價格計算按經濟活動劃分的按季本地生產總值後，以開支面編製的本地生產總值仍會繼續被採用作為單一本地生產總值數字。以開支面編製的本地生產總值已編製了一段頗長時間，並提供準確和及時的經濟實質增長量度。

25. 以固定價格計算按經濟活動劃分的本地生產總值，提供數據作按行業的分析。在顯示按經濟活動劃分的本地生產總值的統計表中，本地生產總值等於各經濟活動組別增加價值的總和加生產及入口稅加統計差額。

26. 統計差額是以開支面編製的本地生產總值與以生產面編製的本地生產總值的差額。這差額是由於使用不同資料來源及估算方法而引起的。

本地生產總值數字發布的名稱法

27. 香港某一期間的本地生產總值，首次公布的數字稱為「初步數字」。當獲得更多資料後，這些數字會作出修訂。這是符合世界各國的一般做法，要盡早編製和發表本地生產總值數字，雖然當時只有不齊全的資料可供採用。其後經修訂的數字稱為「修訂數字」。已採納了全部定期資料來源所得的數據而編製成的數字，則為最終的本地生產總值。

21. Constant price value added of economic activities in Hong Kong is generally compiled using four methods: (a) single extrapolation of base year value added by deflated gross output measures e.g. business receipts deflated by PPI; (b) single extrapolation of base year value added by volume / quantity measures such as volume of trade and physical units of outputs; (c) single extrapolation of base year value added by input indicators such as hours worked; (d) double indicators methods. The first two methods are most frequently applied in Hong Kong for compiling quarterly constant price value added, as in statistically advanced economies (e.g. Australia, New Zealand, and U.K.). For detailed method and indicators used, please refer to chapter 4 of the report "2002 Gross Domestic Product" published in March 2003.

Data Sources for Compiling GDP

22. The data sources used for compiling GDP by expenditure component include external trade statistics, annual, quarterly and monthly surveys on industrial/business establishments and on households, government accounts and administrative data from government departments and other organizations.

23. As for GDP by economic activity, data sources for compiling annual figures mainly cover data collected from the Programme of Annual Economic Surveys and administrative records. The data sources for compiling quarterly constant price figures mainly include quarterly and monthly surveys on industrial/business establishments and on households, government accounts and administrative data from government departments and other organizations.

Presentation of GDP

24. With the introduction of the quarterly constant price GDP by economic activity, the practice of using GDP compiled from the expenditure approach as the single measure of GDP is to continue. GDP compiled from the expenditure approach has been produced for a long time, providing a timely and accurate measure of economic growth in real terms.

25. GDP by economic activity in real terms is compiled to support sectoral analyses. In presenting GDP by economic activity, the sum of value added of respective economic activities plus taxes on production and imports plus statistical discrepancy is equal to the GDP.

26. Statistical discrepancy refers to the difference in values of GDP compiled using the expenditure and production approaches, as a result of the adoption of different data sources and estimation methods.

Nomenclature for Data Release of GDP

27. In Hong Kong, the first release of GDP in respect of a period is called "Preliminary figures". When more data become available, the preliminary figures will be revised. This routine is in accordance with international practice to compile and release GDP figures at the earliest possible time by using only partial data. All those figures published subsequently, on revision, are called "Revised figures". The figures are finalized when data from all regular sources are incorporated.

本地生產總值的修訂及公布辦法

28. 從開支面編製的按年本地生產總值初步數字，是在統計年度結束後約兩個月公布。至於從生產面編製的按年本地生產總值初步數字，由於資料所限，只能在該統計年度結束後約十一個月發表。隨後，已發表的本地生產總值開支面及生產面的按年數字便會根據最新資料作出修訂。每年的最終數字會在該統計年度結束後第三年的三月份公布。

29. 按開支組成部分劃分的按季本地生產總值初步數字，在統計季度結束後約兩個月公布。這些按季數列其後會根據最新資料作出修訂，尤其是在修訂其按年數字時。本地生產總值按季的最新數字是刊載在《本地生產總值》季刊內。

30. 以固定價格計算按經濟活動劃分的本地生產總值的按季數列，會在統計季度後約三個月公布。編製按經濟活動劃分的本地生產總值的時滯，比編製按開支組成部分劃分的本地生產總值的較長，這是因為編製以固定價格計算按經濟活動劃分的按季本地生產總值所需的資料大部分是從以機構為統計調查單位的各類統計調查得來，這些機構通常需要較多時間填報資料給政府統計處。

31. 本刊物內二零零一年及以後的數列，在得到更多資料時會作出修訂。

本地生產總值按季數字應用時須注意的要點

32. 本地生產總值按季數列，提供最新資料，用作評估當時的經濟表現。但在應用這些資料時，應該留意，由於數據所限，本地生產總值及其組成部分的按季數列，有時會作出重大修訂。普遍來說，本地生產總值按季數列的準確程度，是較其按年數列為低。

經季節性調整的本地生產總值

33. 本地生產總值按季數字是會受季節性變動影響。例如第三季及第四季的本地生產總值，通常會高於同年的第一季及第二季。因此，在比較相連兩季的價值時，必須十分小心。不過，如計算按年同季的增長率，即是把某一季的數字與上一年同季比較，則大致上可剔除這些季節效應。

34. 本地生產總值及其一些組成部分(包括私人消費開支、政府消費開支、貨物出口、服務輸出、貨物進口和服務輸入)的經季節性調整數列，現時已有編製。然而，由於本地資本形成總額並沒有明顯的季節性模式，所以並沒有編製這個組成部分的經季節性調整數列。

Revision and Publication Schedule of GDP

28. For annual GDP compiled by expenditure approach, preliminary figures are released about two months after the reference year. For annual GDP compiled by production approach, preliminary figures are released about eleven months after the reference year because of data limitation. Subsequently, both sets of annual GDP figures are revised based on latest information available until they become finalized around the third March after the reference year.

29. Preliminary figures for quarterly GDP by expenditure component are released about two months after the reference quarter. The quarterly series are then revised and released based on latest information available, in particular when the annual figures are revised. Latest quarterly GDP are published in the quarterly report on "Gross Domestic Product".

30. The quarterly series of constant price GDP by economic activity is released with a time lag of around three months after the reference quarter. The time lag for producing GDP by economic activity is longer than that of GDP by expenditure component. This is because the estimates of the quarterly constant price GDP by economic activity are mainly compiled from various surveys on firms, for which more time is normally required for the companies to report data to the Census and Statistics Department.

31. In this report, GDP series for the year 2001 and onwards are subject to further revision as more data become available.

Caution on the Use of Quarterly GDP Figures

32. Quarterly GDP provides up-to-date information for assessing the current economic performance. However, users should note that quarterly series of GDP and its components are sometimes subject to large revision because of data limitations. Generally speaking, the quarterly series are less precise than the annual series.

Seasonally Adjusted GDP

33. Quarterly GDP figures are subject to seasonal variations. For instance, the value of the GDP are normally higher in the third and fourth quarters than in the first and second quarters of the same year. Therefore, great care has to be exercised in comparing the value of a quarterly GDP with that for the preceding quarter. Such seasonal effects, nevertheless, may be largely removed by calculating the year-on-year growth rate, which compares a quarterly figure with the corresponding one in the preceding year.

34. Seasonally adjusted data series are currently compiled for the aggregate GDP and some of its components, including private consumption expenditure, government consumption expenditure, exports of goods, exports of services, imports of goods and imports of services. However, seasonally adjusted data series is not compiled for gross domestic capital formation as no clear seasonal pattern is found in this component.

35. 經季節性調整的數列，由於季節性效應就統計方法而言已予剔除，所以相連兩個季度的數字可以進行更有意義的比較。將本地生產總值原來數列的按年變動數字與經季節性調整數列的相連季度變動數字一起進行分析，能更清楚看到本地生產總值的趨勢，尤其是在經濟出現轉折點的時候。

各組成部分在本地生產總值的按年實質變動百分率中所佔的比率

按開支組成部分劃分的本地生產總值

36. 各組成部分在本地生產總值實質變動中所佔的比率，是量度個別組成部分的變動對本地生產總值變動的影響。計算個別組成部分*i*在某季*t*的本地生產總值的按年實質變動百分率中所佔的比率的方法如下:-

$$\frac{\text{GDP}_{i,t} - \text{GDP}_{i,t-4}}{\text{GDP}_{t-4}} \times 100$$

其中 $\text{GDP}_{i,t}$ 表示本地生產總值中第*i*個組成部分在*t*季的固定價格數字；

$\text{GDP}_{i,t-4}$ 表示本地生產總值中第*i*個組成部分在*t-4*季的固定價格數字；

GDP_{t-4} 表示本地生產總值在*t-4*季的固定價格數字。

按經濟活動劃分的本地生產總值

37. 各經濟活動在本地生產總值實質變動中所佔的比率，是量度個別經濟活動的變動對本地生產總值變動的影響。計算個別經濟活動*i*在某季*t*的本地生產總值的按年實質變動百分率中所佔的比率的方法如下:-

$$\frac{\text{VA}_{i,t} - \text{VA}_{i,t-4}}{\text{GDP}_{t-4}} \times 100$$

其中 $\text{VA}_{i,t}$ 表示增加價值中第*i*個經濟活動在*t*季的固定價格數字；

$\text{VA}_{i,t-4}$ 表示增加價值中第*i*個經濟活動在*t-4*季的固定價格數字；

GDP_{t-4} 表示本地生產總值在*t-4*季的固定價格數字。

35. In the seasonally adjusted series, seasonal effects have been removed statistically, thus enabling meaningful quarter-to-quarter comparison. When the year-on-year quarterly changes in the original GDP series and the quarter-to-quarter changes in the seasonally adjusted GDP series are analysed together, the trend of the GDP can be more clearly discerned, particularly in regard to turning points in the economy.

Component Contributions to Year-on-year Rate of Change in Real Terms of GDP

GDP by expenditure component

36. The contributions to the percentage change in real terms of GDP provide a measure of the composition of GDP rate of change that is attributable to changes in individual components. The percentage point contribution of component *i* to the year-on-year percentage change of GDP in a particular quarter *t* is calculated as follows :-

$$\frac{\text{GDP}_{i,t} - \text{GDP}_{i,t-4}}{\text{GDP}_{t-4}} \times 100$$

where $\text{GDP}_{i,t}$ refers to the constant price figure of *ith* component of GDP at quarter *t*;

$\text{GDP}_{i,t-4}$ refers to the constant price figure of *ith* component of GDP at quarter *t-4*;

GDP_{t-4} refers to the constant price figure of GDP at quarter *t-4*.

GDP by economic activity

37. The percentage point contribution to the year-on-year percentage change of GDP provide a measure of the composition of percentage change in GDP that is attributable to changes in individual economic activities. The percentage point contribution of *ith* economic activity to year-on-year percentage change of GDP in a particular quarter *t* is calculated as follows:-

$$\frac{\text{VA}_{i,t} - \text{VA}_{i,t-4}}{\text{GDP}_{t-4}} \times 100$$

Where $\text{VA}_{i,t}$ refers to the constant price value added figure of *ith* economic activity at quarter *t*;

$\text{VA}_{i,t-4}$ refers to the constant price value added figure of *ith* economic activity of GDP at quarter *t-4*;

GDP_{t-4} refers to the constant price figure of GDP at quarter *t-4*.

本地居民生產總值的概念與編製方法

38. 本地居民生產總值是指一個經濟體系內的居民，由從事各項經濟活動所賺取的收益，不論該等經濟活動是否在該經濟體系內進行。換言之，編製本地居民生產總值應包括本地居民在經濟領域內或領域外從事各類經濟活動的收益，而扣除非本地居民在領域內從事經濟活動的收益。

39. 計算本地居民生產總值，可用以下方程式：
本地居民生產總值 = 本地生產總值

- + 本地居民從經濟領域外所賺取的要素收益
- 非本地居民在經濟領域內所賺取的要素收益

40. 一個國家或地區的「按人口平均計算的本地居民生產總值」是指把該國家或地區在某統計年的「本地居民生產總值」除以該國家或地區在該年的人口總數而得的數字。

41. 以固定市價計算的本地居民生產總值是以固定市價計算的本地生產總值加上實質對外要素收益流動淨值而得來。計算實質對外要素收益流動淨值的方法須將名義對外要素收益流動淨值用「本地內部需求內含平減物價指數」予以平減。

42. 實質本地居民總收入是量度一個經濟體系內的實質購買力的指標。計算實質本地居民總收入，是把以固定市價計算的本地生產總值、貿易價格比率變動的調整和實質對外要素收益流動淨值加起來。

43. 於一九九七年七月一日，香港成為中華人民共和國的特別行政區。香港特別行政區與中國內地之間的經濟交易、資產與負債數據，視作對外交易及對外頭寸。因此，香港與內地之間的因素收益流動，視作對外要素收益流動，並計算在香港的本地居民生產總值之內。

44. 對外要素收益流動的分類，基本上類似國際貨幣基金在一九九三年公布的《國際收支平衡手冊》內收入帳目的標準組成部分。這些收益組成部分稱為直接投資收益、有價證券投資收益、其他投資收益及僱員報酬。

- (i) *直接投資收益*是指本地居民從直接投資在經濟領域外的業務所賺取的收益，而對該業務有持久利益或在管理方面具有相當程度的影響力和控制權。這些收益屬於公司間債務的淨利息收益、分發紅利的收益、未分發利潤的分額及租金。

Concepts and Methods for Compiling GNP

38. GNP is a measure of the total income earned by residents of an economy from engaging in various economic activities, irrespective of whether the economic activities are carried out within the economic territory or outside. In other words, in compiling GNP, earnings of residents from various economic activities within or outside the economic territory are included, whereas earnings of non-residents from economic activities within the economic territory are excluded.

39. GNP is estimated by the following formula:

$$\begin{aligned} \text{GNP} &= \text{GDP} \\ &+ \text{Factor income earned by residents from outside the economic territory} \\ &- \text{Factor income earned by non-residents from within the economic territory} \end{aligned}$$

40. Per capita GNP of a country or territory is obtained by dividing GNP in a year by the population of that country or territory in the same year.

41. GNP at constant market prices are obtained by adding to GDP at constant market prices the real net External Factor Income Flows (EFIF). Real net EFIF is obtained by deflating nominal net EFIF using the implicit price deflator of domestic demand.

42. Real Gross National Income (RGNI) is a measure of real purchasing power of an economy. RGNI is obtained by adding terms of trade adjustment and real net EFIF to GDP at constant market prices.

43. On 1 July 1997, Hong Kong became a Special Administrative Region of the People's Republic of China. Data on transactions and assets and liabilities vis-à-vis the mainland of China (the Mainland) are treated as external transactions and external positions respectively. Hence, factor income flows between Hong Kong and the Mainland are treated as external factor income flows and are covered in Hong Kong's GNP figures.

44. The classification of EFIF is basically similar to the classification of standard components of the Income Account of the Balance of Payments Manual (BPM) published by the International Monetary Fund in 1993. These income components are direct investment income (DII), portfolio investment income (PII), other investment income (OII) and compensation of employees (CE).

- (i) *Direct Investment Income* refers to earnings of residents from direct investment in business outside the economic territory, in which they have a lasting interest and a degree of influence or control over the management. These earnings are in the form of net interest receipts on intercompany debts, receipts of distributed dividends, share of undistributed profits and gross rentals.

《國際收支平衡手冊》指明對外投資在地產亦屬一種直接投資。根據統計慣例，一個經濟體系的土地及其他不動產及實物（例如樓宇），只可由該經濟體系的居民所擁有。假如一個香港居民在經濟領域外擁有地產，他會被視為在該有關經濟體系擁有一間名義上的公司，而這公司則擁有該地產。此等名義公司與該等土地及建築物的法權擁有人的關係，可視作直接投資關係。

- (ii) 有價證券投資收益是指本地居民從投資非本地股本（即股票）及債券（例如可轉讓存款證、債券及票據）所得的收益。與進行直接投資的投資者相比，有價證券投資者在投資非本地企業所發行的股票及債券時，對該等企業並無持久的利益或在管理方面有任何影響力。凡持有一間公司不足10%股分，則作為有價證券投資論。
- (iii) 其他投資收益是指從其他非本地財務債權及負債所得的對外利息收益流動，而這些收益並不屬於直接投資收益或有價證券投資收益。該等非本地財務債權及負債包括短期及長期非市場上買賣的貸款、存款、財務租約、貿易信貸等。
- (iv) 僱員報酬是指非本地居民從香港經濟領域內作短期受僱及本地居民從經濟領域外作短期受僱所賺取的勞工收益，包括工資、薪金及其他現金或實物報酬。

本地居民生產總值的資料來源

45. 本地居民生產總值是根據本地生產總值及「對外申索、負債及收益統計調查」所得的對外要素收益流動數據編製，並輔以由其他來源所得資料。這項統計調查是根據《普查及統計條例》進行。

實質本地總收入、實質本地居民總收入和本地居民可支配總收入

46. 實質本地總收入是將本地生產總值加上貿易價格比率變動的調整計算而得。這指標所量度的實質本地總收入，能反映實質生產額的對外購買力。由於進出口價格的相對變動，引致以一定數量的出口產品所能換取的進口產品有所改變。計算貿易價格比率變動的調整是 $(\frac{X}{P_m} - \frac{X}{P_x})$ ，其中X為以當時價格計算的貨物出口和服務輸出的總值， P_m 為貨物進口及服務輸入的價格指數， P_x 為貨物出口及服務輸出的價格指數。

External investment in real estate, as specified by BPM, is also a form of direct investment. By statistical convention, land and other immovable structures and objects (e.g. building) in an economy can only be owned by residents of that economy. If a Hong Kong resident owns real estate outside the economic territory of Hong Kong, he should be regarded as owning a nominal company in the economy in question which in turn owns the real estate. The relationship between such nominal company and legal owner of the land and structures is then treated as a direct investment relationship.

- (ii) *Portfolio Investment Income* refers to earnings of residents from investment in non-resident equities (i.e. stocks and shares) and debt securities (e.g. negotiable certificates of deposits, bonds and bills). Compared with investors making direct investment, portfolio investors in equity and debt securities of non-resident business enterprises have no lasting interest or influence in the management of the companies they invest. A holding of less than 10% of equity in a company is regarded as portfolio investment.
- (iii) *Other Investment Income* refers to external flows of interest incomes derived from other financial claims on and liabilities to non-residents that are not classified as DII or PII. Examples of these claims and liabilities include short-term and long-term non-marketable loans, deposits, financial leases and trade credit.
- (iv) *Compensation of Employees* refers to labour income earned by non-residents from their short-term employment within the economic territory of Hong Kong and labour income earned by residents from their short-term employment outside the economic territory of Hong Kong. It comprises wages, salaries and other remuneration whether paid in cash or in kind.

Data Sources for Compiling GNP

45. GNP is compiled based on GDP and data on EFIF collected from the Survey of External Claims, Liabilities and Income (SECLI), supplemented by data from other sources. The survey is conducted under the provision of the Census and Statistics Ordinance.

Real Gross Domestic Income, Real Gross National Income and Gross National Disposable Income

46. Real Gross Domestic Income (RGDI) is calculated as the GDP plus terms of trade adjustment. It reflects the external purchasing power of the real output, as the relative movements in import and exports prices result in a varying volume of imports being exchangeable for a given volume of exports. The terms of trade adjustment is calculated as $(\frac{X}{P_m} - \frac{X}{P_x})$, where

X is the total value of exports of goods and services at current prices, P_m the price index for imports of goods and services and P_x the price index for exports of goods and services.

47. 實質本地居民總收入是將實質對外要素收益流動淨值加進實質本地總收入。它是量度某一經濟體系的居民所賺取的總收入所帶來的實質購買力。

48. 本地居民可支配總收入是將本地居民生產總值加上經常轉移淨值計算而得。這指標反映本地居民可用於最終消費和儲蓄總額的收入。

有關刊物

49. 本地生產總值及本地居民生產總值的詳細概念、定義、資料來源及編製方法刊載於《二〇〇二年本地生產總值》年刊。此刊物備有中英文版。

47. Real Gross National Income (RGNI) is obtained by adding to RGDI the real net EFIF. It measures the real purchasing power of the total income earned by residents of an economy.

48. Gross National Disposable Income is derived as the GNP plus net current transfers. It measures the income available to residents for final consumption and gross saving.

49. More details on the concept, definitions, data sources and compilation methods of GDP and GNP are contained in the report “2002 Gross Domestic Product”, which is available in separate English and Chinese versions.
