1. 概念及方法

1.1 消費物價指數量度住戶一般所購買的消費商品及服務的價格水平隨時間而變動的情況。消費物價指數的按年變動率，是廣泛被用作反映消費者所面對的通貨膨脹的指標。

1.2 由於不同開支範圍的住戶的開支模式各有差別，消費物價轉變對它們的影響也各有不同。因此，香港編製三項針對不同開支組別住戶的消費物價指數。甲類、乙類及丙類消費物價指數分別根據較低、中等及較高開支範圍的住戶的開支模式編製而成。綜合消費物價指數根據以上所有住戶的整體開支模式編製，反映消費物價轉變對整體住戶的影響。

1.3 每月的消費物價指數是根據(一)有關住戶的開支模式及(二)統計月內搜集的價格資料編製。

1.4 以2014/15年為基期的消費物價指數所採用的開支權數是以政府統計處在2014年10月至2015年9月期間進行的「住戶開支統計調查」所得的住戶開支模式為根據。本報告內的所有統計表及分析，均根據以2014/15年為基期的消費物價指數新數列。

1.5 以2014/15年為基期的各項消費物價指數數列的開支範圍及所佔住戶的百分比臚列如下：

1. Concepts and methods

1.1 The Consumer Price Index (CPI) measures the changes over time in the price level of consumer commodities and services generally purchased by households. The year-on-year rate of change in the CPI is widely used as an indicator of the inflation affecting consumers.

1.2 As households in different expenditure ranges have varying expenditure patterns, the impacts of consumer price changes on households in different expenditure ranges are different. Hence, three series of CPIs, each referring to households in a different expenditure range, are compiled in Hong Kong. The CPI(A), CPI(B) and CPI(C) are compiled based on the expenditure patterns of households in the relatively low, medium and relatively high expenditure ranges respectively. A Composite CPI is compiled based on the overall expenditure pattern of all of the above households taken together to reflect the impact of consumer price changes on the household sector as a whole.

1.3 Monthly CPIs are compiled on the basis of (1) expenditure patterns of relevant households and (2) prices collected in the reference month.

1.4 The expenditure weights for compiling the 2014/15-based CPI series are derived based on the household expenditure patterns obtained from the Household Expenditure Survey (HES) conducted during October 2014 to September 2015 by the Census and Statistics Department (C&SD). All tables and analyses in this report are based on the 2014/15-based CPI series.

1.5 The expenditure brackets for and percentages of households covered in the various 2014/15-based CPI series are as follows:

1.6 上述的開支範圍是以2014年10月至2015年9月基期內的物價計算。將自基期起物價轉變的影響計算在內，甲類、乙類及丙類消費物價指數所涵蓋住戶的每月平均開支，以2020年的價格水平計算，分別大約在6,300元至27,600元之間、27,600元至49,400元之間及49,400元至99,600元之間，而綜合消費物價指數所涵蓋住戶的每月平均開支則大約在6,300元至99,600元之間。

1.7 在物價變動資料方面，政府統計處持續地進行一項「按月零售物價統計調查」，藉此搜集住戶消費籃子內各項商品及服務的價格變動資料。政府統計處每月在本港各區大約4 000間零售商店（例如超級市場、街市檔位、百貨公司及時裝店）及服務行業商號（例如電影院、醫院及美容院）搜集約共47 000個價目。搜集價格資料的方式，主要是採用外勤訪問形式進行，亦有部分以電話查詢、網上搜集或郵遞問卷方式進行。

1.8 為應對2019冠狀病毒病疫情的影響，政府統計處積極利用網上採價及電話訪問等其他數據搜集方法以取代部分「按月零售物價統計調查」的外勤訪問。政府統計處亦根據國際建議，使用科學方法處理缺答的價目，並進行嚴緊的數據審核和檢視，以確保消費物價指數的可靠性。

1.9 至於一些如公共交通、電力及郵遞服務的主要服務，其價格數據則直接從有關機構搜集或從行政紀錄中獲得。而私人房屋租金方面，有關新訂租約、續訂租約及現時租戶的租金資料，是透過一項以私人房屋租戶為對象的按月抽樣統計調查搜集得來。另一方面，有關公營房屋租金變動的數據則由香港房屋委員會及香港房屋協會定期提供。

1.10 在編製消費物價指數時，所搜集的價格數據是消費者支付的實際價格，包括產品的各種稅項和服務費，亦已考慮大部分折扣、補貼和回扣。使用數據時要注意不應將消費物價指數所量度的價格變動直接視為反映相關生產成本的變動，特別是獲政府大量補貼的項目，例如教育服務和醫療服務。

1.6 The above expenditure ranges relate to prices in the base period from October 2014 to September 2015. Taking into account the impact of price changes since the base period, the monthly household expenditure ranges of the CPI(A), CPI(B) and CPI(C) adjusted to the price level of 2020 are broadly equivalent to \$6,300-\$27,600, \$27,600-\$49,400 and \$49,400-\$99,600 respectively, and that of the Composite CPI is broadly equivalent to \$6,300-\$99,600.

1.7 As regards information on price changes, C&SD continuously conducts a Monthly Retail Price Survey to capture the price changes of items included in the household consumption basket. C&SD collects some 47 000 price quotations each month from around 4 000 retail outlets (e.g. supermarkets, market stalls, department stores and fashion shops) and service providers (e.g. cinemas, hospitals and beauty salons) throughout the territory. Price data are collected mainly by field visits and some also through the modes of telephone, online or postal enquiries.

1.8 In response to the impact of the coronavirus disease (COVID-19), C&SD has been actively adopting alternative data collection modes such as online pricing and telephone interviews in the Monthly Retail Price Survey to replace part of the field visits. C&SD is also following the international recommendations to treat the missing prices by scientific methods, and conducts rigorous data validation and review to ensure reliability of the CPIs.

1.9 As for principal services such as public transport, electricity and postal services, price data are either collected directly from the companies concerned or obtained from administrative records. Rental data on private housing for new, renewed and continued lettings are collected from a monthly sample survey on private housing renter households. On the other hand, data on rental movements of public housing are regularly provided by the Hong Kong Housing Authority and the Hong Kong Housing Society.

1.10 The price data collected for compiling the CPIs are the actual prices paid by consumers, including any taxes and service charges on the products, and taking account of most discounts, subsidies and rebates. Care should be taken not to directly relate the price changes measured by the CPI as changes in production costs, especially for items which are subject to heavy government subsidies, e.g. educational services and medical services.

1.11 根據定義，某一個月份的消費物價指數，是通過比較在該月份與在基期購買同一籃子的消費項目所需付的總開支而計算出來的。在數學上，這等同於運用已更新至一年前（或一個月前）的價格水平的開支比重，把每個消費項目在當月所錄得的按年（或按月）價格變動加權，然後計算總和。換句話說，用以編製消費物價指數的計算公式已充分計及因個別項目自基期以來的價格變動而直接引致的開支權數變動。因此，這些變動不會影響消費物價指數及其變動率的準確性。相關的技術細節詳載於《2014/15年住戶開支統計調查及重訂消費物價指數基期》的附錄2。

1.12 按2014/15年度價格水平計算的消費物價指數內各商品／服務類別的開支權數，以及更新至2021年3月的一年前（即2020年3月）及一個月前（即2021年2月）的價格水平的開支權數列於本報告的附錄1，以供參考。

1.13 值得留意是住戶的消費模式會因應其收入及其它社會經濟因素的變動而改變。因此，除上述的價格因素外，開支比重亦會受這些影響而隨時間逐漸轉變。例如，住戶一般傾向多買一些價格升幅較小的商品和服務，以替代價格升幅較大的商品和服務。由於這種替代效應，根據固定消費模式計算的消費物價指數，可能會高估了價格的升幅。然而，過去的經驗顯示，消費模式只會隨時間慢慢地轉變，而在少於5年間的累積變化一般都不會對消費物價指數的變動率構成顯著影響。因此，香港消費物價指數的開支權數會每隔5年更新一次。這做法符合國際統計標準。

1.11 By definition, the CPI in a specific month is computed by comparing the total expenditure required to purchase a basket of consumption items in that month with that required to purchase the same basket in the base period. Mathematically, this is equivalent to computing the composite sum of the year-on-year (or month-to-month) price changes of individual items in that month, each weighted by the corresponding item-specific expenditure weight updated to the price level in a year (or month) ago. In other words, the CPI compilation formula has already taken into account changes in expenditure weights directly caused by price changes in individual items since the base period and thus, the accuracy of the CPI and its rate of changes are not affected by such changes. Relevant technical details are fully discussed in Appendix 2 of the report *2014/15 Household Expenditure Survey and the Rebasing of the Consumer Price Indices*.

1.12 The expenditure weights of individual commodity/service sections in the CPI based on the price level in 2014/15, as well as those updated to the price levels in the preceding year of March 2021 (i.e. March 2020) and in the preceding month of March 2021 (i.e. February 2021), are shown in Appendix 1 of this report for reference.

1.13 It should be noted that in addition to the price factor mentioned above, the expenditure weights do change gradually over time due to changes in consumption pattern of households in response to such factors as changes in income and other socio-economic factors. For example, households usually tend to buy more of the goods and services with smaller price increases to substitute those with larger price increases; and due to such substitution effect, the CPI compiled based on fixed consumption pattern tends to over-state price increases over time. However, past experience revealed that changes in consumption pattern would only take place gradually and generally changes accumulated in a period of less than 5 years would not have a significant impact on the rate of change in the CPI. Therefore, the expenditure weights of the CPI are updated once every 5 years in Hong Kong. The practice conforms to international statistical standards.

1.14 有見及此，政府統計處正進行新一輪的「住戶開支統計調查」，搜集資料以更新現時的消費物價指數的開支權數。以2019/20年為基期的消費物價指數新數列，將於2021年年中左右公布。經重訂基期後，自2020年10月起消費物價指數的按年變動率將以2019/20年為基期的新數列計算，這與本報告內以2014/15年為基期的數列計算的變動率或會有些不同。政府統計處將會繼續編製及發布以2014/15年為基期的消費物價指數數列，直至2021年12月的統計月份止。

1.15 一併研究消費物價指數原來數列的按年變動數字和經季節性調整數列的按月變動數字，有助分析消費物價的最新趨勢。經季節性調整數列的按月變動仍會受其他不規則的因素影響而波動。參考經季節性調整的指數在最近3個月內的平均每月變動率，能更清楚看到消費物價指數的趨勢。

1.16 由於經季節性調整的數列已透過統計方法剔除季節性變異，可更有意義地比較相連月份數字。

2. 摘要統計數字

2.1 最新的消費物價指數及其變動率和剔除政府一次性紓困措施影響後的相關變動率載列於表S1。消費物價指數自2007年起的變動率受到數項政府一次性紓困措施所影響，當中主要包括電費津貼、公營房屋租金寬免、差餉寬減和考試費寬免，有關措施臚列於表S1附件。這些一次性措施會降低措施實施當月的消費物價指數，對消費物價指數造成波動。

1.14 In this regard, a new round of HES is being conducted to collect information for updating the expenditure weights of the CPI series. The new 2019/20-based CPI series will be available around mid-2021. As a result of the rebasing exercise, the year-on-year changes of the new 2019/20-based CPI series will be compiled from October 2020 onwards. The year-on-year changes compiled from the new 2019/20-based CPI series may be different from those compiled from the 2014/15-based CPI series in this report. The 2014/15-based CPI series will continue to be compiled and published until the reference month of December 2021.

1.15 For analysing the latest trend in consumer prices, it is useful to study the year-on-year changes in the original CPI series and the month-to-month changes in the seasonally adjusted series together. The month-to-month changes in the seasonally adjusted series still tend to fluctuate due to other irregular factors. The trend of the CPIs may be more clearly discerned by looking at the average monthly rates of change of the seasonally adjusted indices during the latest 3 months.

1.16 In the seasonally adjusted series, seasonal variations have been eliminated by statistical methods, thus enabling figures for consecutive months to be compared more meaningfully.

2. Summary statistics

2.1 The latest available figures for the CPIs and their rates of change as well as the related rates of change after netting out the effects of all Government's one-off relief measures are summarised in Table S1. The rates of change in CPIs since 2007 were affected by a number of Government's one-off relief measures, including mainly electricity charges allowance, waiver of public housing rentals, rates concession, and waiver of examination fees as shown in Annex to Table S1. These one-off measures would lower the CPIs in the months of implementation and resulted in some fluctuations in the CPIs.

3. 消費物價指數與上年同月比較的變動詳情

3.1 在 2021 年 3 月份，綜合、甲類、乙類及丙類消費物價指數均錄得按年升幅，分別為 0.5%、1.3%、0.2%及 0.2%。如表 S2 所示，剔除所有政府一次性紓困措施的影響，綜合、甲類及乙類消費物價指數的按年變動率分別為 0.2%、0.7%及-0.2%，而丙類消費物價指數則維持不變。

3.2 為了更清楚地觀察到通脹的趨勢，剔除所有政府一次性紓困措施的影響後的綜合消費物價指數的按年變動率顯示於圖 1。

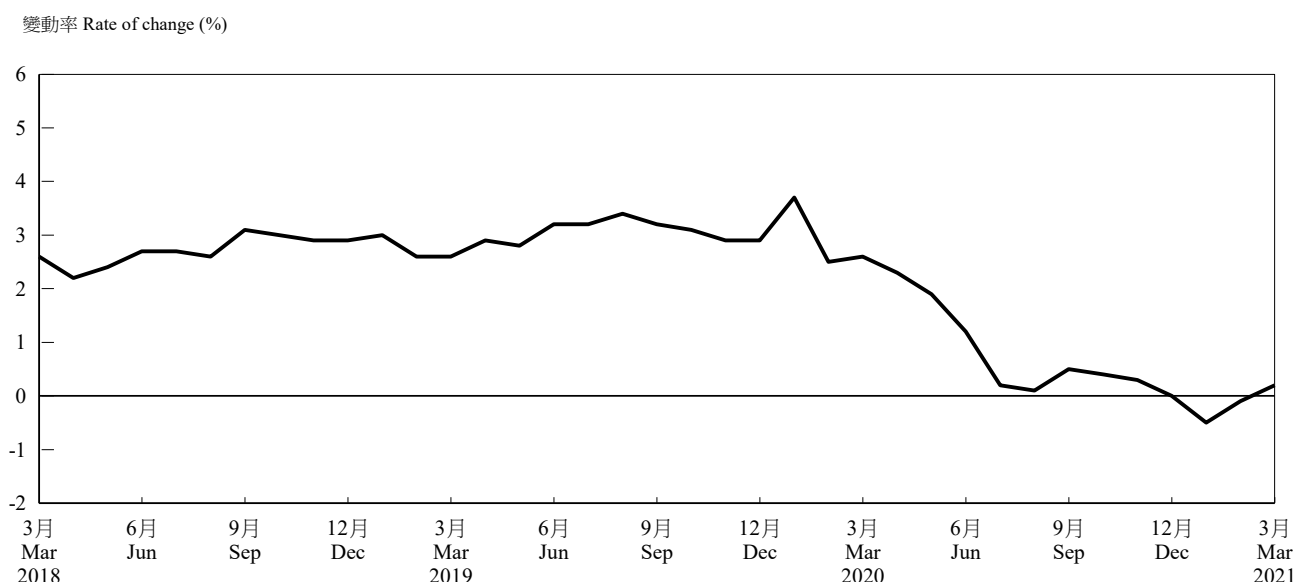
3. Detailed changes in the CPIs, as compared with same month in preceding year

3.1 In March 2021, the Composite CPI, CPI(A), CPI(B) and CPI(C) all registered year-on-year rates of increase, at 0.5%, 1.3%, 0.2% and 0.2% respectively. As shown in Table S2, netting out the effects of all Government's one-off relief measures, the year-on-year rates of change in the Composite CPI, CPI(A) and CPI(B) were 0.2%, 0.7% and -0.2% respectively. Meanwhile, the CPI(C) remained unchanged.

3.2 The year-on-year rates of change in the Composite CPI after netting out the effects of all Government's one-off relief measures are presented graphically in Chart 1 for discerning the inflationary trend more clearly.

3.4 2021年3月份與2020年3月份比較，綜合消費物價指數中類別指數錄得升幅的有電力、燃氣及水(21.2%);食品(不包括外出用膳)(3.1%);外出用膳(0.7%);煙酒(0.5%)和雜項服務(0.4%)。

3.5 另一方面，綜合消費物價指數中類別指數在2021年3月份錄得按年跌幅的有交通費(-2.3%);耐用物品(-1.2%);雜項物品(-0.7%)和住屋(-0.5%)。

3.6 在衣履方面，綜合消費物價指數較一年前同期維持不變。

3.7 消費物價指數中各商品/服務類別指數及其按年變動率的時間數列分別載列於表1.1至1.4及表2.1至2.4。而各商品/服務組別指數的按年變動情況則在表3.1至3.4列出。至於各類別指數在消費物價指數整體變動中所佔的比率則載列於表5。

3.8 消費物價總指數和各類別指數的變動情況及其按年變動率顯示於圖2及3。

3.9 自2000年代起，一些經濟體開始採用由聯合國發展的「按目的劃分的個人消費分類」分析消費物價指數。相對應於香港消費物價指數的編製而言，「按目的劃分的個人消費分類」是以交易的「目的」把住戶的個別消費開支歸納為12個主要類別。

3.4 Compared with March 2020, increases in the section indices of the Composite CPI in March 2021 were recorded for electricity, gas and water (21.2%); food (excluding meals bought away from home) (3.1%); meals bought away from home (0.7%); alcoholic drinks and tobacco (0.5%) as well as miscellaneous services (0.4%).

3.5 On the other hand, year-on-year decreases in the section indices of the Composite CPI were recorded in March 2021 for transport (-2.3%); durable goods (-1.2%); miscellaneous goods (-0.7%) and housing (-0.5%).

3.6 As for clothing and footwear, the Composite CPI remained unchanged over a year earlier.

3.7 The time series of the CPIs and their year-on-year rates of change at commodity/service section level are presented respectively in Tables 1.1 to 1.4 and Tables 2.1 to 2.4. The year-on-year movements at commodity/service group level are given in Tables 3.1 to 3.4. The contributions of each section to the overall changes in CPIs are shown in Table 5.

3.8 Movements of the all-item CPIs and their section indices together with their year-on-year rates of change are presented graphically in Charts 2 and 3.

3.9 Starting in 2000s, some economies have started to adopt the Classification of Individual Consumption According to Purpose (COICOP) developed by the United Nations in analysing the CPI. Corresponding to Hong Kong CPI compilation, the COICOP classifies individual consumption expenditure of households into 12 major divisions according to the “purposes” of the transactions.

3.10 為方便國際間進行比較，政府統計處亦根據「按目的劃分的個人消費分類」編製消費物價指數。根據「按目的劃分的個人消費分類」的綜合、甲類、乙類及丙類消費物價指數的類別指數及其按年變動率的時間數列分別列於附錄 2.1 至 2.4和附錄 3.1 至 3.4。

3.10 To facilitate international comparison, C&SD also compiles the CPI based on the COICOP. The time series of the Composite CPI, CPI(A), CPI(B) and CPI(C), and their year-on-year rates of change at division level based on the COICOP are presented respectively in Appendices 2.1 to 2.4 and Appendices 3.1 to 3.4.

4. 消費物價指數與上月比較的變動詳情

4.1 2021年3月份與2021年2月份比較，四項消費物價指數的變動比較輕微。乙類及丙類消費物價指數均上升0.1%，而綜合及甲類消費物價指數則維持不變。剔除所有政府一次性紓困措施的影響，綜合、甲類、乙類及丙類消費物價指數的按月變動率則分別為0.0%、-0.1%、0.1%及0.1%。

4.2 2021年3月份消費物價指數中各商品／服務類別指數及其按月變動率臚列於表S4。

4.3 各商品／服務類別指數中，衣履指數在綜合、甲類、乙類及丙類消費物價指數分別上升7.1%、7.4%、7.7%及6.4%。電力、燃氣及水指數分別上升0.9%、1.3%、0.5%及0.4%。而煙酒指數分別上升0.5%、0.6%、0.3%及1.1%。其他類別指數的變動則比較輕微。

4.4 以下簡要地解釋各商品／服務類別指數在2021年2月與3月間的變動。

4. Detailed changes in the CPIs, as compared with preceding month

4.1 Compared with February 2021, movements of the four CPIs for March 2021 were relatively small. While the CPI(B) and CPI(C) both increased by 0.1%, the Composite CPI and CPI(A) remained unchanged. Netting out the effects of all Government's one-off relief measures, the Composite CPI, CPI(A), CPI(B) and CPI(C) registered month-to-month rates of change, at 0.0%, -0.1%, 0.1% and 0.1% respectively.

4.2 The indices and month-to-month rates of change of the CPIs for March 2021, analysed by section of commodity/service, are shown in Table S4.

4.3 Among the indices for various commodity/service sections, the index for clothing and footwear increased by 7.1%, 7.4%, 7.7% and 6.4% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. The corresponding increases in the index for electricity, gas and water were 0.9%, 1.3%, 0.5% and 0.4% respectively. The corresponding increases in the index for alcoholic drinks and tobacco were 0.5%, 0.6%, 0.3% and 1.1% respectively. Movements in the indices for other sections were relatively small.

4.4 The following explains briefly the movement of the index for each commodity/service section between February and March 2021.

4.5 食品指數在綜合、甲類及乙類消費物價指數中分別下跌 0.3%、0.5%及 0.2%，主因是新鮮蔬菜、豬肉及鹹水魚價格下跌所致。而指數在丙類消費物價指數中則維持不變。

- (i) 新鮮蔬菜 - 新鮮蔬菜的平均零售價格在綜合、甲類及乙類消費物價指數中分別下跌 6.2%、6.6%及 5.9%。
- (ii) 豬肉 - 豬肉的平均零售價格在綜合、甲類及乙類消費物價指數中分別下跌 2.5%、2.3%及 2.6%。
- (iii) 鹹水魚 - 鹹水魚的平均零售價格在綜合、甲類及乙類消費物價指數中分別下跌 4.0%、4.3%及 3.8%。

4.6 表 8 載列選定食品在本月、上月及上年同月的平均零售價格及價格範圍。

4.7 住屋指數在綜合、甲類、乙類及丙類消費物價指數中分別下跌 0.1%、0.1%、0.2%及 0.1%，這是由於私人房屋租金下跌所致。

4.8 電力、燃氣及水指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 0.9%、1.3%、0.5%及 0.4%，主要是電力的燃料調整費向上調整所致。

4.9 煙酒指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 0.5%、0.6%、0.3%及 1.1%，主要是由於洋酒價格上升所致。

4.5 The index for food decreased by 0.3%, 0.5% and 0.2% in the Composite CPI, CPI(A) and CPI(B) respectively, largely due to the decreases in the prices of fresh vegetables, pork and salt-water fish. Meanwhile, the index remained unchanged in the CPI(C).

- (i) Fresh vegetables - The average retail prices of fresh vegetables decreased by 6.2%, 6.6% and 5.9% in the Composite CPI, CPI(A) and CPI(B) respectively.
- (ii) Pork - The average retail prices of pork decreased by 2.5%, 2.3% and 2.6% in the Composite CPI, CPI(A) and CPI(B) respectively.
- (iii) Salt-water fish - The average retail prices of salt-water fish decreased by 4.0%, 4.3% and 3.8% in the Composite CPI, CPI(A) and CPI(B) respectively.

4.6 The average retail prices and price ranges of selected food items for the current month, preceding month and same month in preceding year are shown in Table 8.

4.7 The index for housing decreased by 0.1%, 0.1%, 0.2% and 0.1% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, due to the decreases in private housing rentals.

4.8 The index for electricity, gas and water increased by 0.9%, 1.3%, 0.5% and 0.4% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was largely because of the upward adjustment in the fuel cost variation charge for electricity..

4.9 The index for alcoholic drinks and tobacco increased by 0.5%, 0.6%, 0.3% and 1.1% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, mainly due to the increases in the prices of foreign-style wines.

4.10 衣履指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 7.1%、7.4%、7.7%及 6.4%，主要是外衣價格上升所致。

4.11 耐用物品指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 0.7%、0.6%、0.8%及 0.6%，主要是資訊科技及電訊設備和旅行及體育用品價格上升所致。

4.12 雜項物品指數在綜合、甲類、乙類及丙類消費物價指數中分別下跌 0.5%、0.6%、0.5%及 0.4%，主要是首飾及藥物價格下跌所致。

4.13 交通指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 0.7%、0.4%、0.7%及 0.9%，主要是進出香港交通費用和汽車牌照、保險、學車、泊車及隧道收費上升所致。

4.14 雜項服務指數在綜合、甲類、乙類及丙類消費物價指數中分別下跌 0.6%、0.2%、0.6%及 0.7%，主要是家庭服務費用下跌所致。

4.15 四項消費物價指數的商品／服務組別指數在 2021 年 3 月份的按月變動情況分別顯示於表 3.1 至 3.4。

4.16 各商品／服務類別指數在消費物價指數整體按月變動中所佔的比率載列於表 6。至於佔消費物價指數整體變動中最大比率的商品／服務組別則在表 7.1 至 7.4 列出。

4.10 The index for clothing and footwear increased by 7.1%, 7.4%, 7.7% and 6.4% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was largely because of the higher prices of outerclothing.

4.11 The index for durable goods increased by 0.7%, 0.6%, 0.8% and 0.6% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, largely due to the increases in the prices of information technology and telecommunications equipment as well as travel and sports goods.

4.12 The index for miscellaneous goods decreased by 0.5%, 0.6%, 0.5% and 0.4% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, mainly because of the decreases in the prices of jewellery as well as proprietary medicines and supplies decreased.

4.13 The index for transport increased by 0.7%, 0.4%, 0.7% and 0.9% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was largely attributable to the increases in inbound and outbound transport fares as well as motor licences, insurance, instructor's fees, parking fees and tunnel tolls.

4.14 The index for miscellaneous services decreased by 0.6%, 0.2%, 0.6% and 0.7% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. This was mainly attributable to the decreases in the charges for household services.

4.15 The month-to-month movements of the four CPIs for March 2021 by commodity/service group are shown in Tables 3.1 to 3.4 respectively.

4.16 The contribution of each commodity/service section to the overall month-to-month change in the CPIs is presented in Table 6. The commodity/service groups with the largest contributions to the overall change in CPIs are listed in Tables 7.1 to 7.4.

5. 經季節性調整消費物價指數

5.1 消費物價指數原來數列的按月變動率會受到季節性變異的影響。把這些季節性變異從數列中剔除，便可更有意義地比較相連月份數字。

5.2 經季節性調整的數列可因應數據增加而作出修訂。由 2004 年 10 月開始，每年發表 10 月份的數字時，會一併修訂對上 3 年的經季節性調整消費物價指數。

5.3 自 2008 年 10 月開始，編製經季節性調整的消費物價指數的方法由過往「X-11 自迴歸—求和—移動平均」(X-11 ARIMA)方法更改為「X-12 自迴歸—求和—移動平均」(X-12 ARIMA)方法。自 2005 年 10 月開始的經季節性調整的消費物價指數數列亦已按這個新方法作出修訂。「X-12 自迴歸—求和—移動平均」方法改良自「X-11 自迴歸—求和—移動平均」方法，能提供更佳的模型建造及模型評估能力。「X-12 自迴歸—求和—移動平均」方法是用作編製經季節性調整的統計數列的標準方法。

5.4 [表 4.1](#) 及 [4.2](#) 載列經季節性調整的消費物價指數在過去 3 年的按月變動率。

5.5 參考經季節性調整的指數在最近 3 個月內的平均每月變動率，能更清楚看到消費物價指數的趨勢。如表 [S5](#) 顯示，就綜合消費物價指數而言，這變動率在 2021 年 3 月份為 0.4%，而 2021 年 2 月份的相應變動率則為 0.0%。但應留意這些變動率是受到個別政府一次性紓困措施只在某些月份實施所影響。剔除這些影響，截至 2021 年 3 月止的 3 個月期間，綜合消費物價指數的平均每月變動率為 0.2%，而在 2021 年 2 月的 3 個月期間的相應變動率則為-0.1%。

5. Seasonally adjusted CPIs

5.1 Month-to-month rates of change based on the original CPI series are affected by seasonal variations. By removing these seasonal variations from the series, figures for consecutive months can be compared more meaningfully.

5.2 Seasonally adjusted series may be revised as more data become available. Starting from October 2004, the seasonally adjusted CPIs for the preceding 3 years are revised each year when releasing the figures for October.

5.3 Starting from October 2008, the seasonal adjustment of the CPI is compiled by the “X-12 ARIMA” method to replace the previous “X-11 ARIMA” method. The seasonally adjusted CPI series since October 2005 have also been revised using the new method. “X-12 ARIMA” method is an update to the “X-11 ARIMA” method with enhanced modelling and diagnostic capabilities. The “X-12 ARIMA” method is a standard method applied in compiling seasonally adjusted statistical data series.

5.4 The month-to-month rates of change of the seasonally adjusted CPIs in the past 3 years are presented in [Tables 4.1 and 4.2](#).

5.5 The trend of the CPIs may be more clearly discerned by looking at the average monthly rate of change of the seasonally adjusted indices during the latest 3 months. As shown in [Table S5](#), such rate of change in the Composite CPI was 0.4% in March 2021. The corresponding rate of change in February 2021 was 0.0%. It should be noted that these rates of change were affected by Government’s one-off relief measures implemented only in some months. Netting out these effects, the corresponding average monthly rate of change in the Composite CPI for the 3-month period ending March 2021 was 0.2%, and that for the 3-month period ending February 2021 was -0.1%.

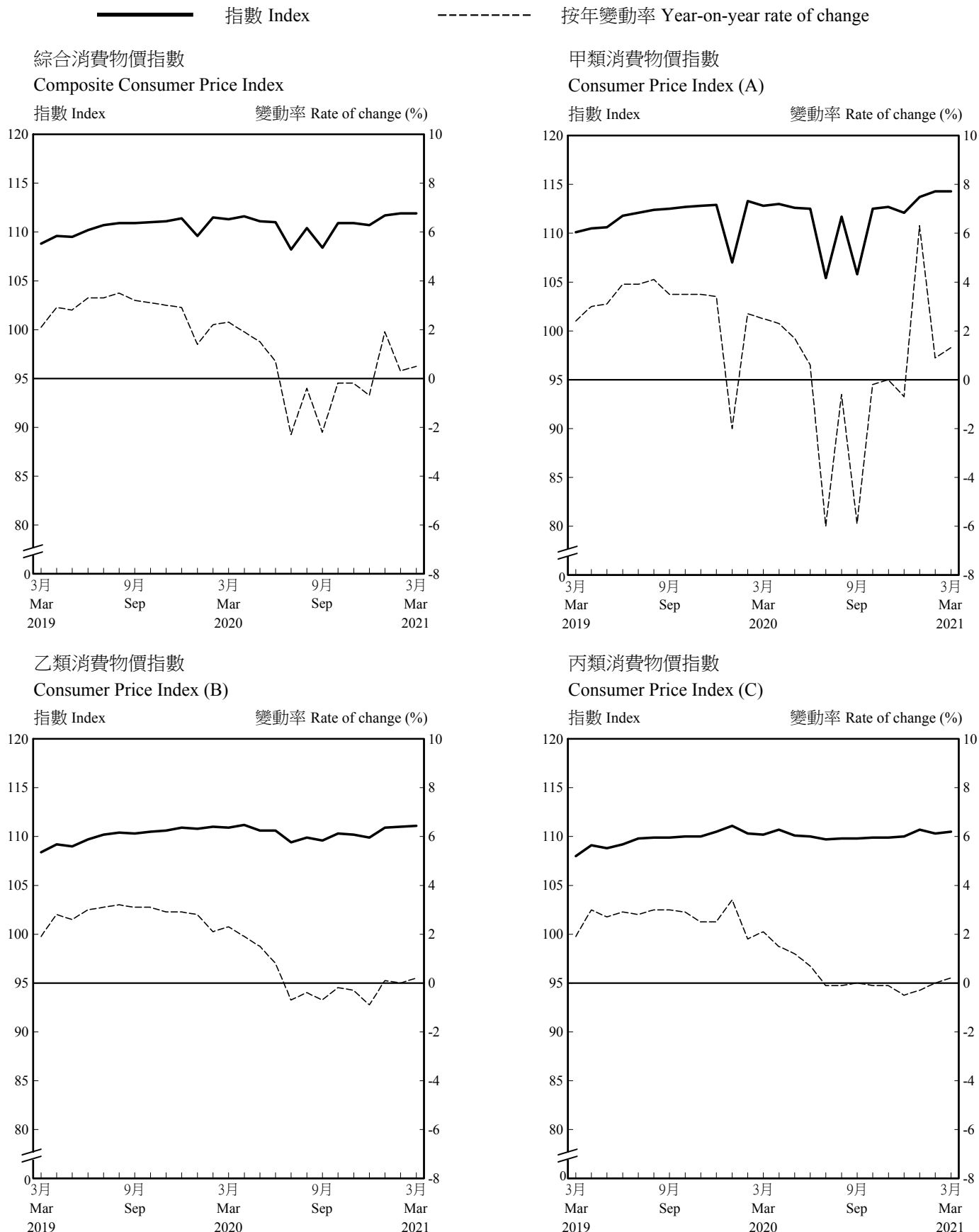
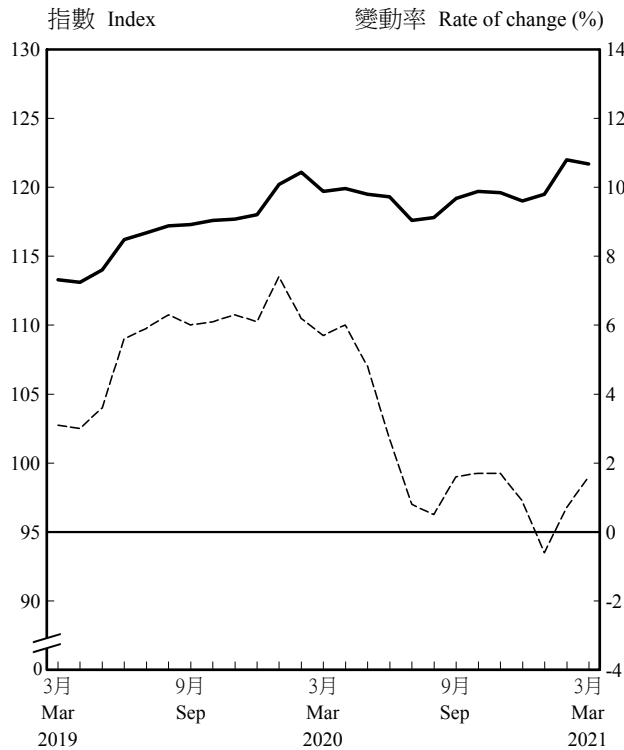


圖 3 消費物價指數的商品／服務類別指數
(2014年10月至2015年9月 = 100)

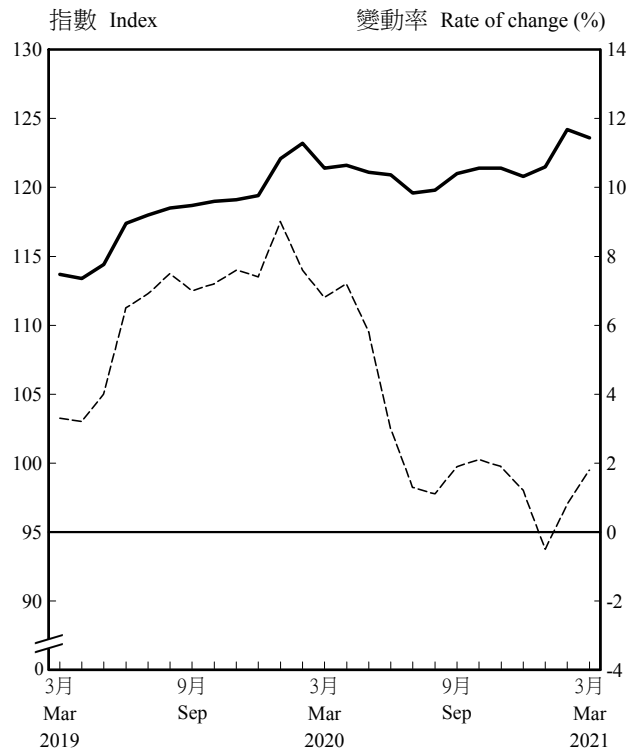

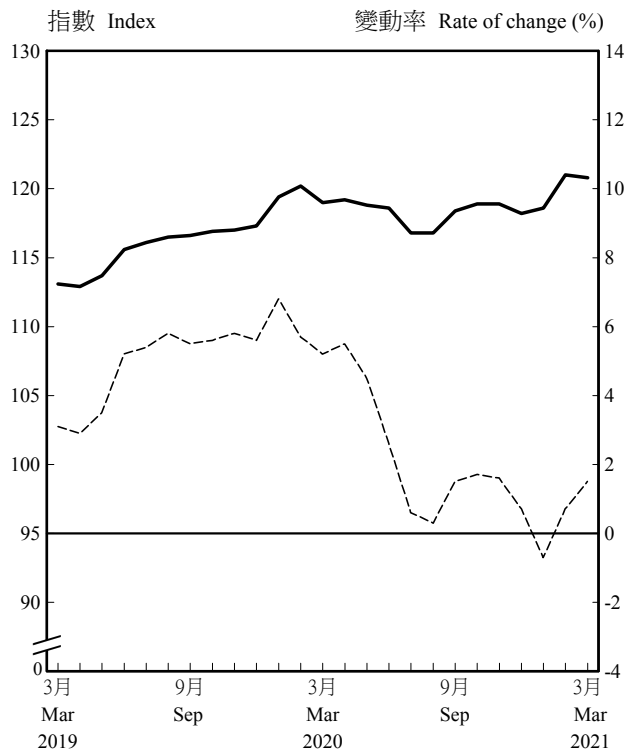

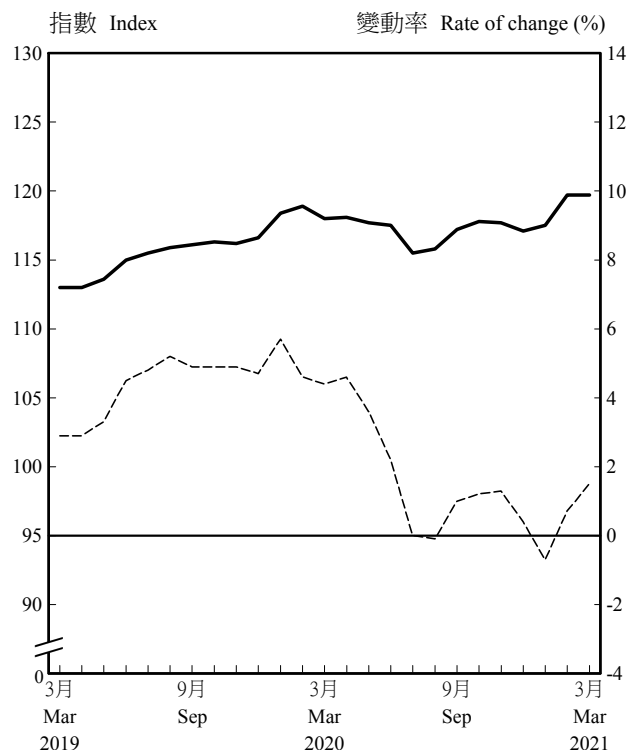
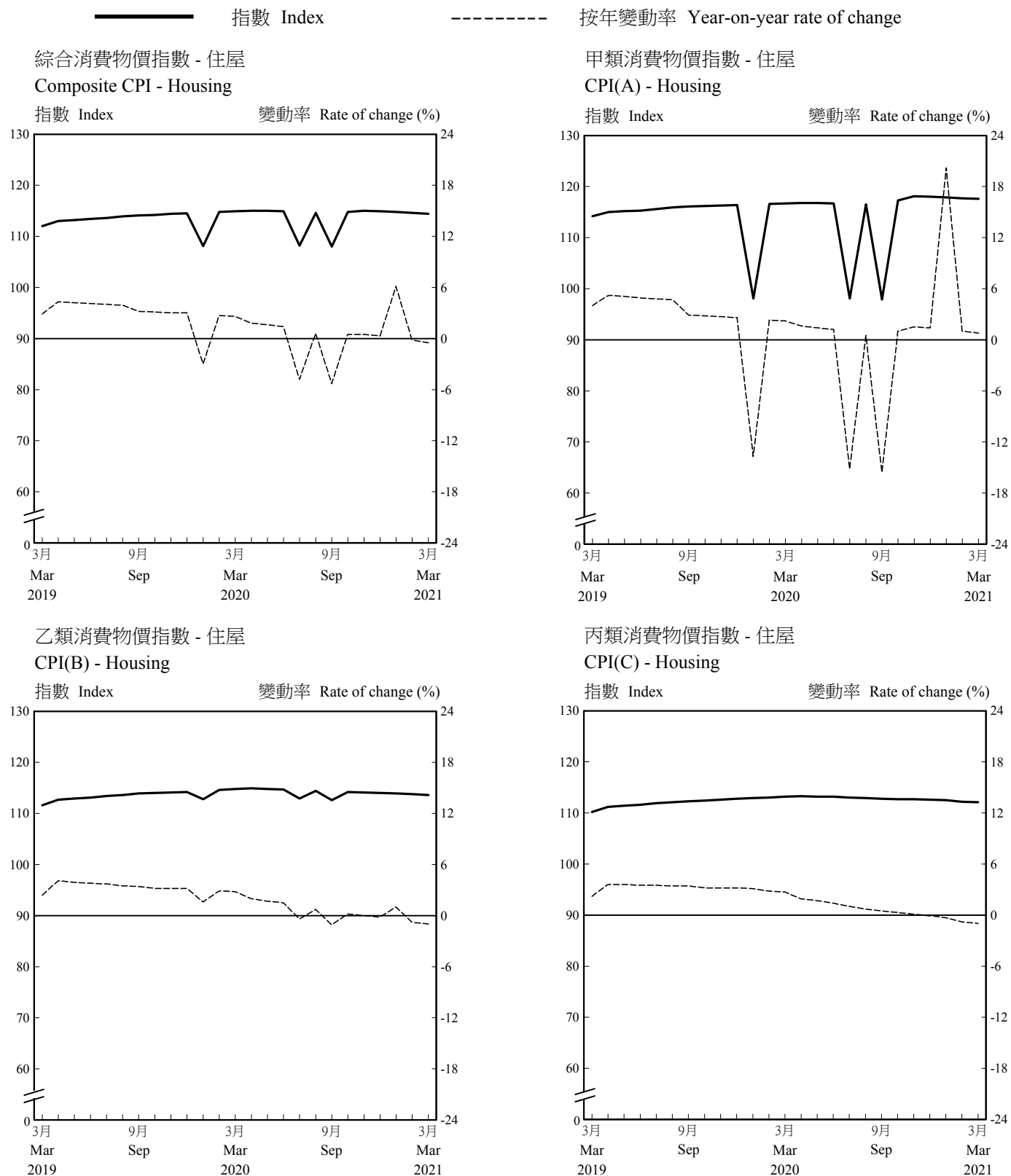


圖 3 消費物價指數的商品／服務類別指數

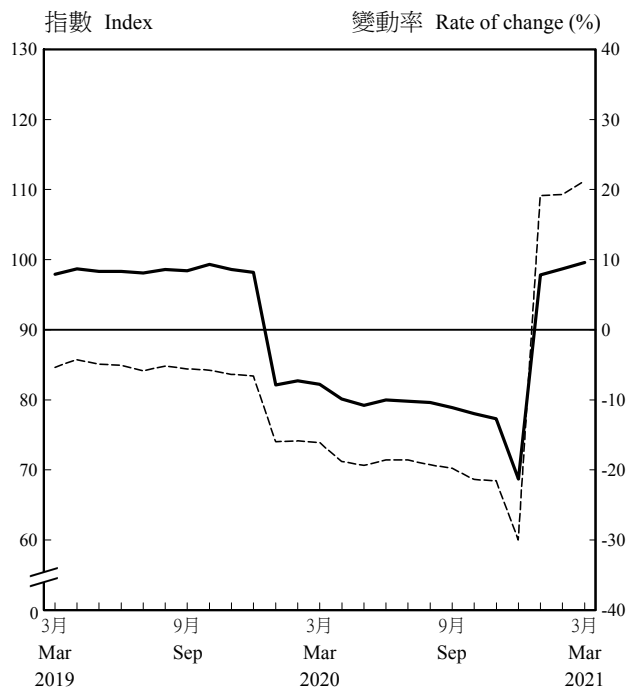

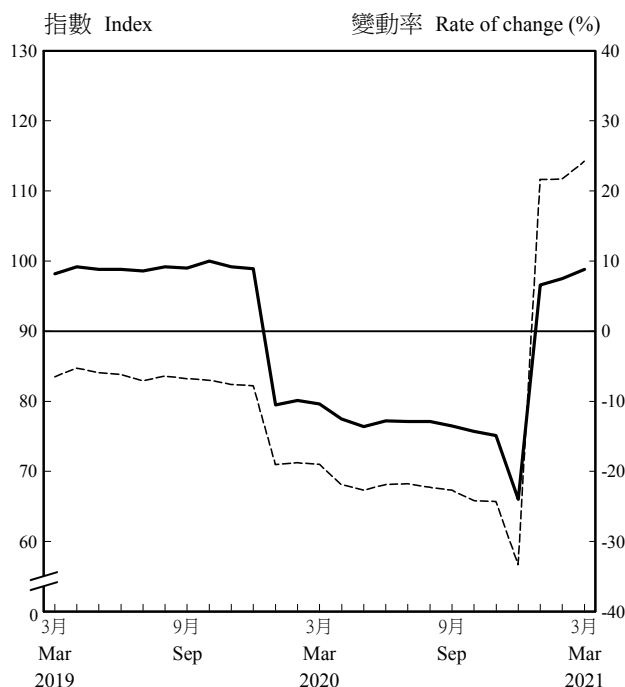

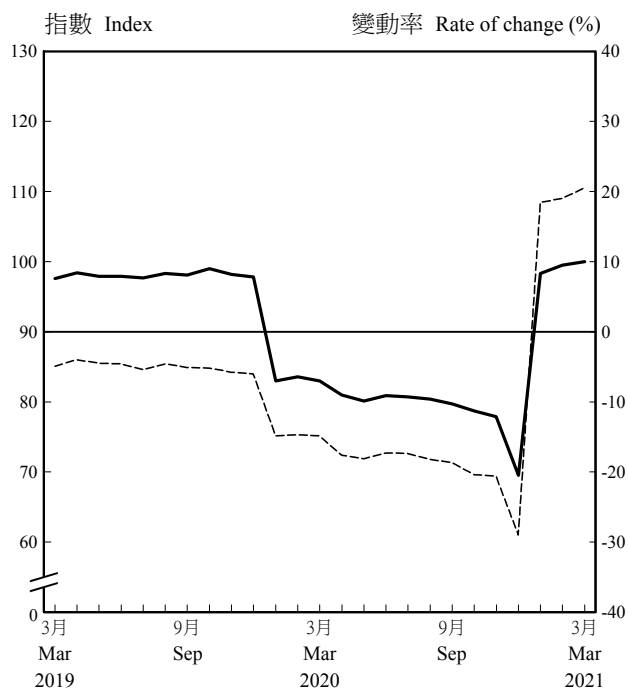

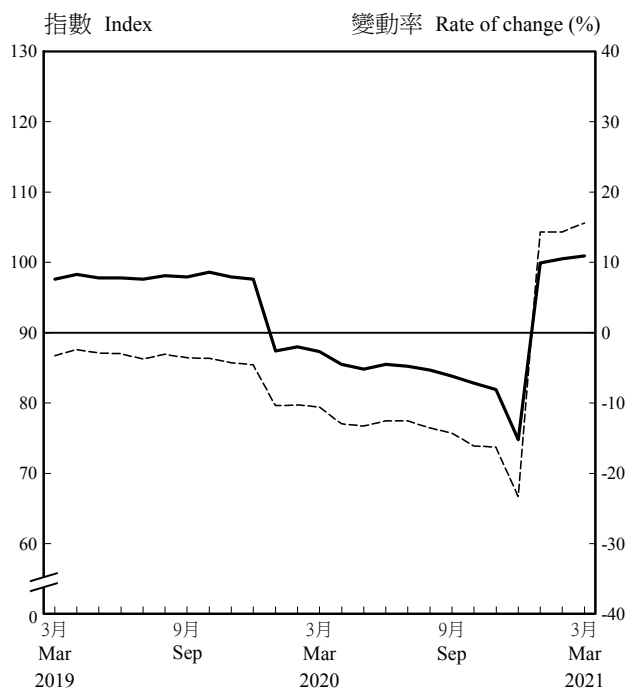

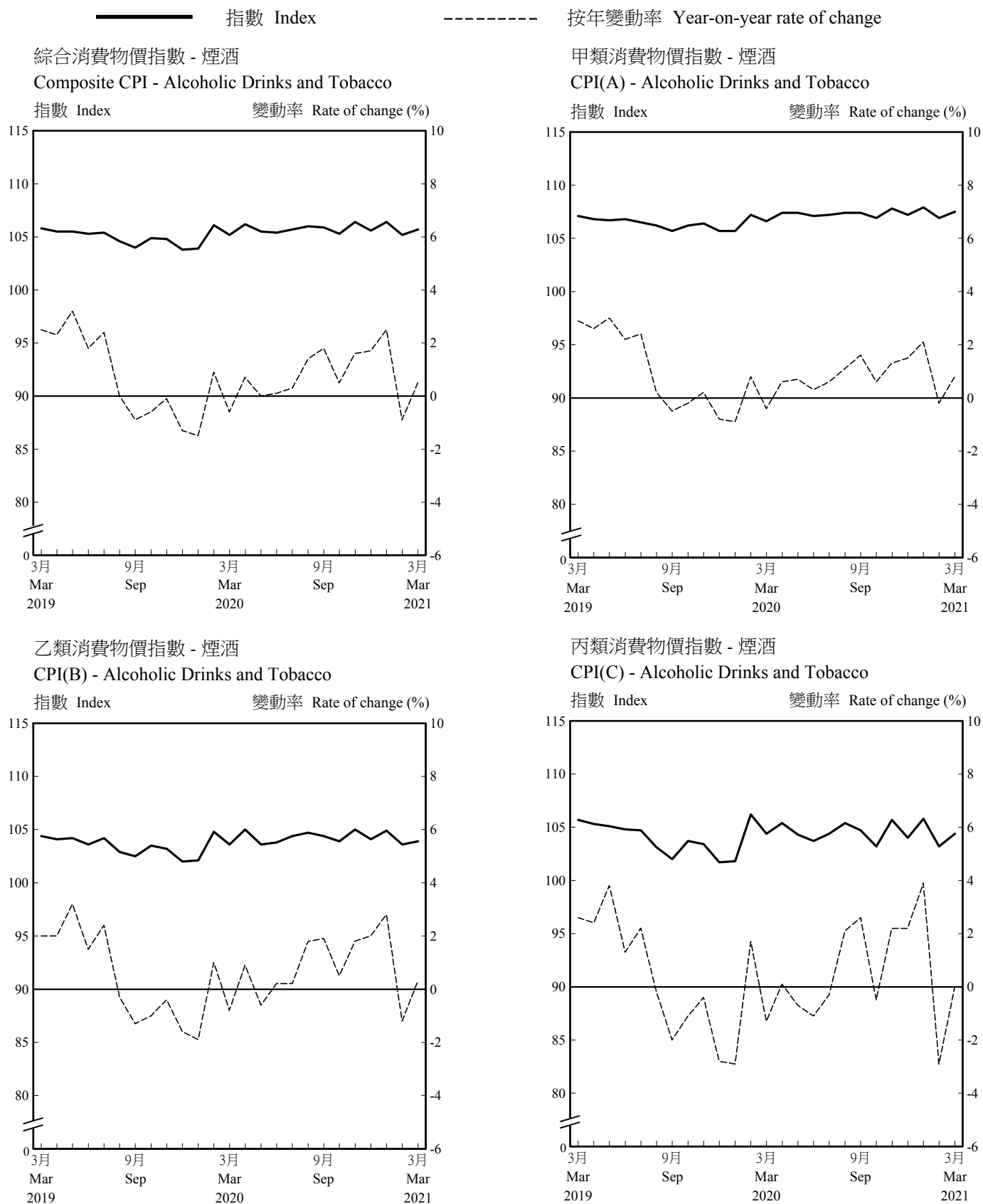
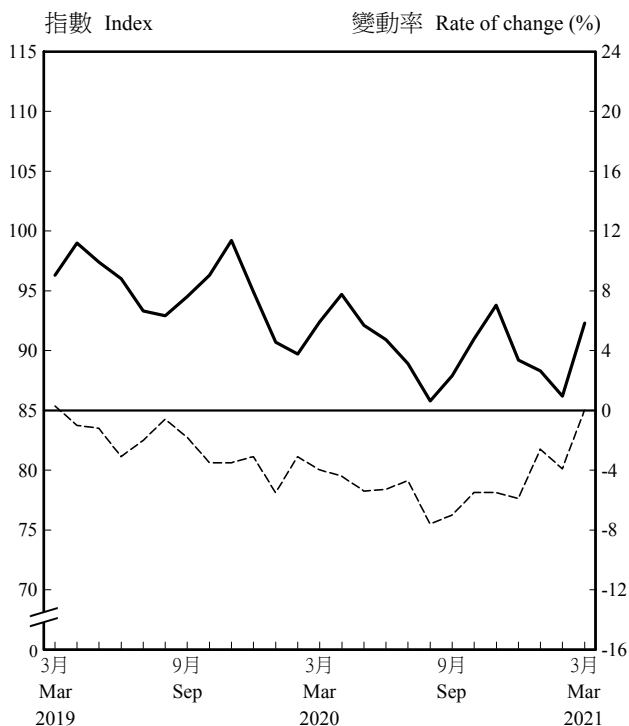

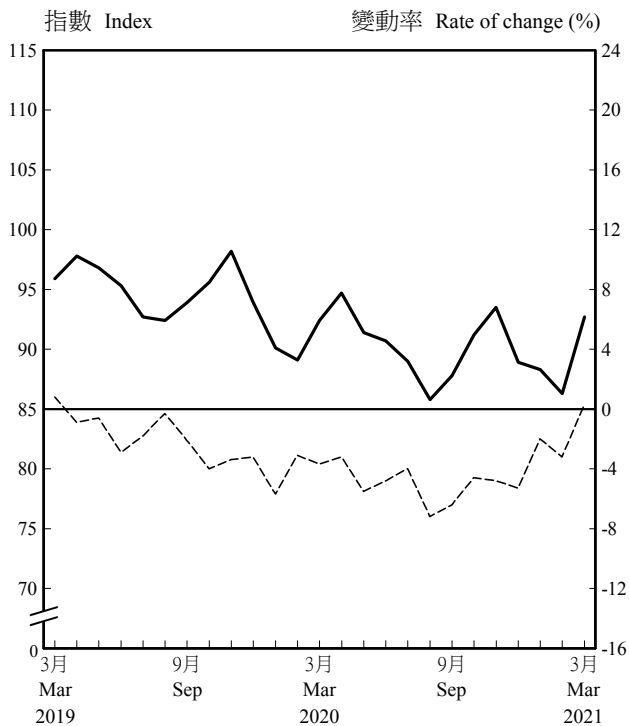

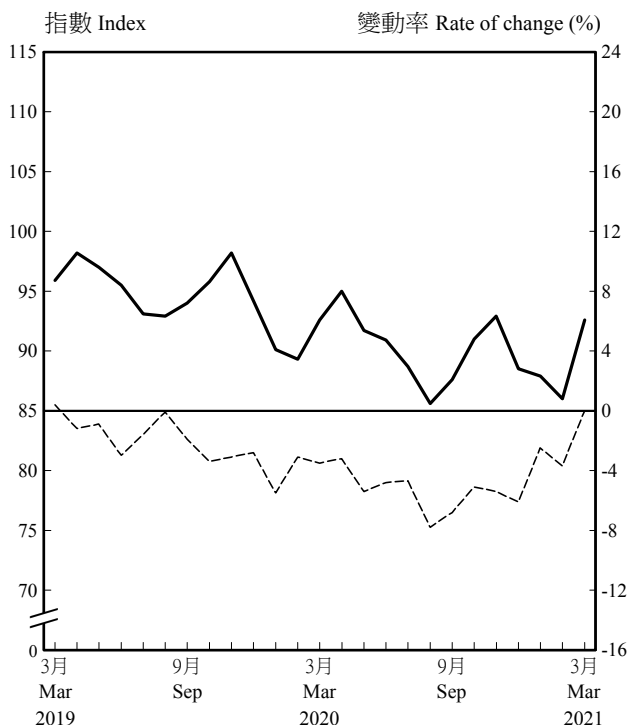

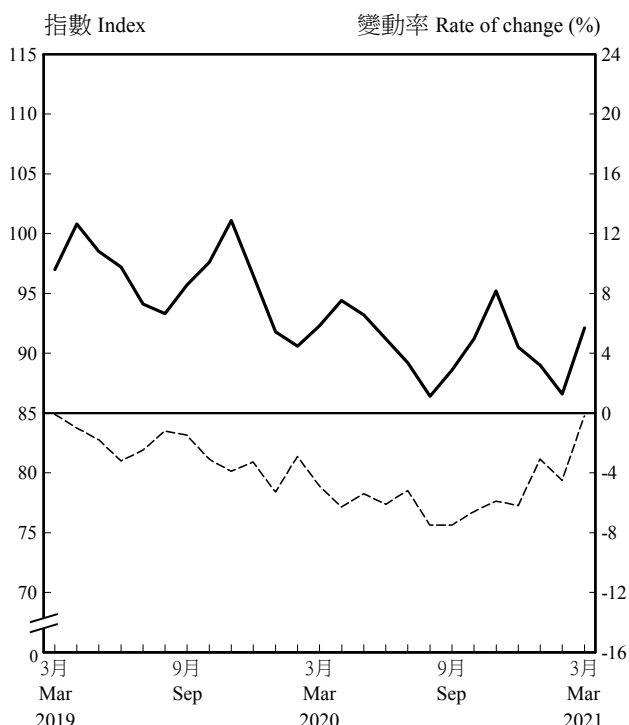

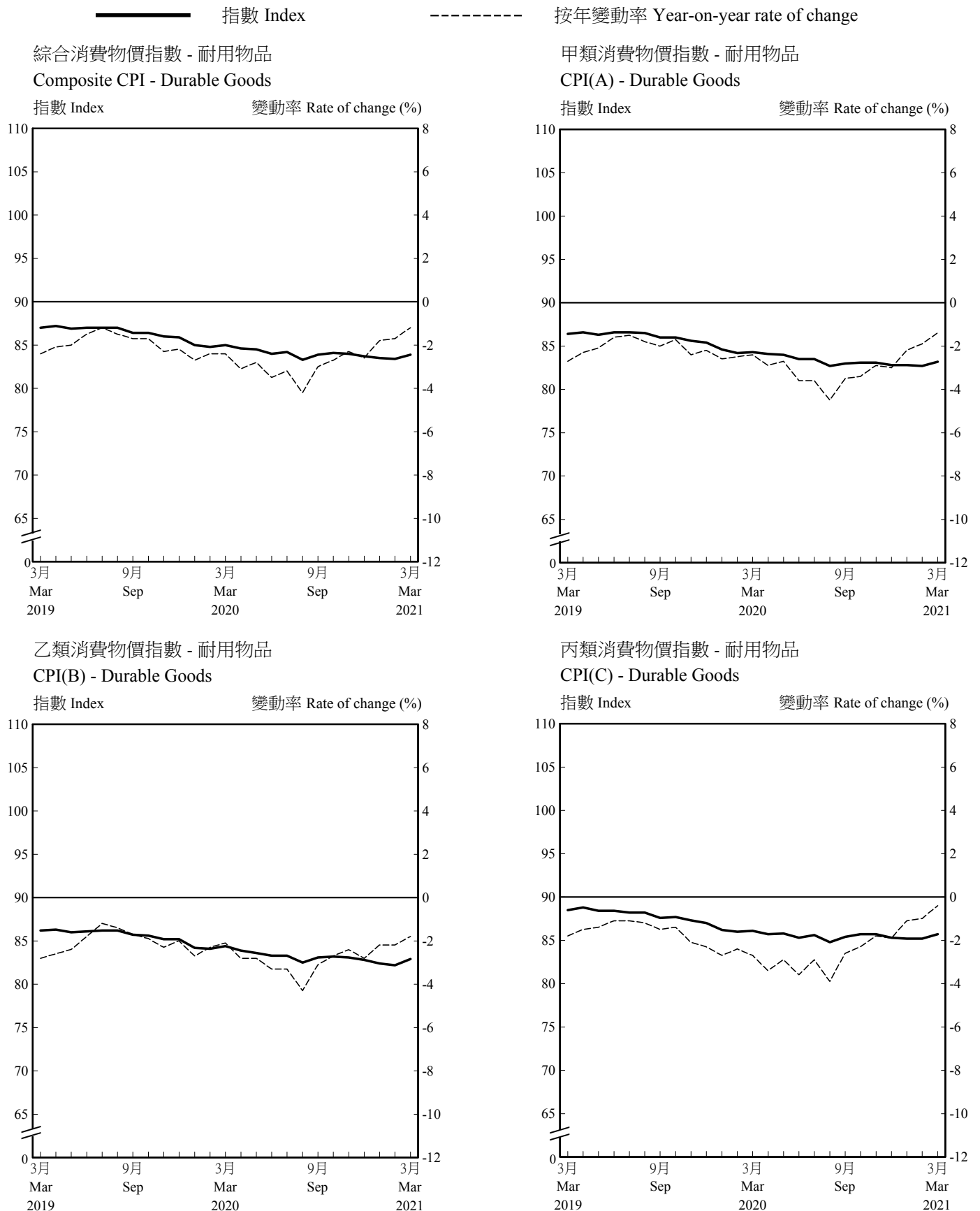
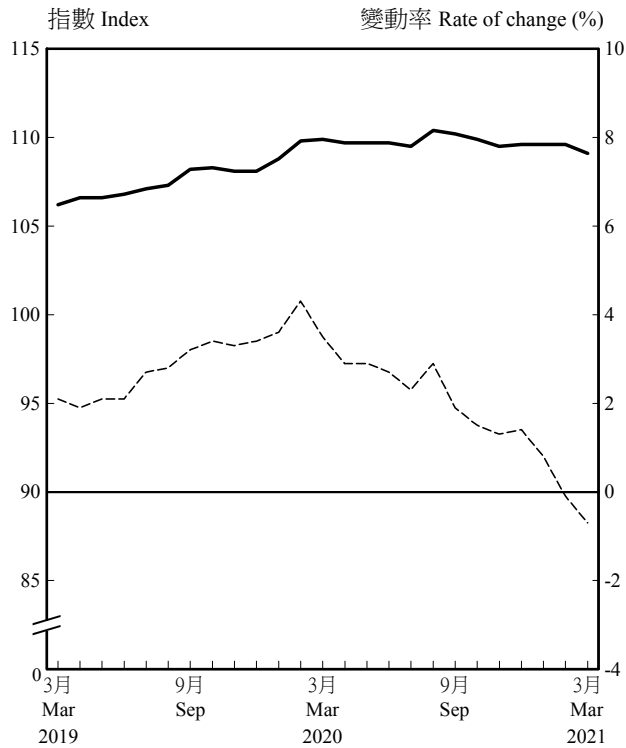

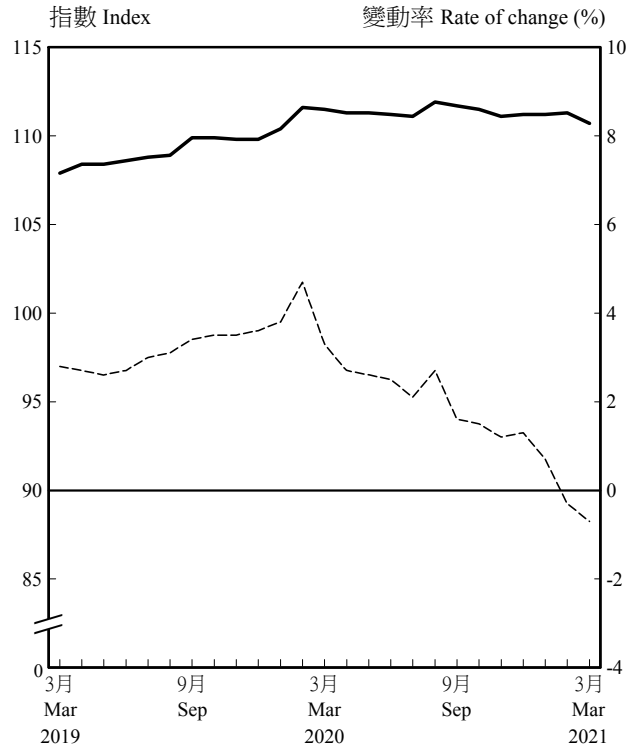

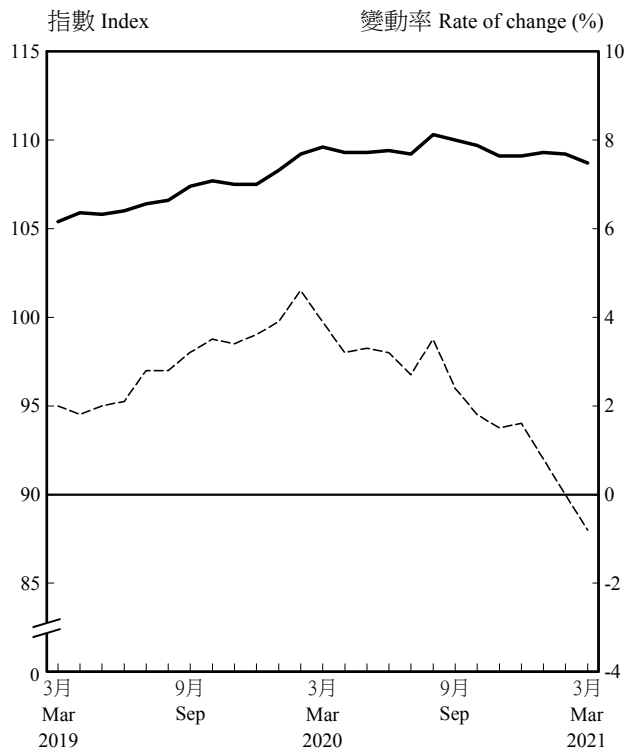

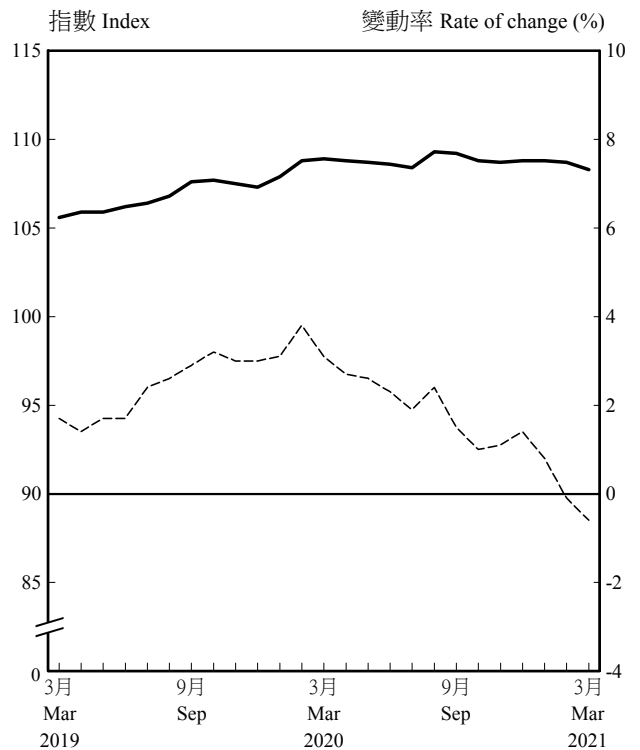
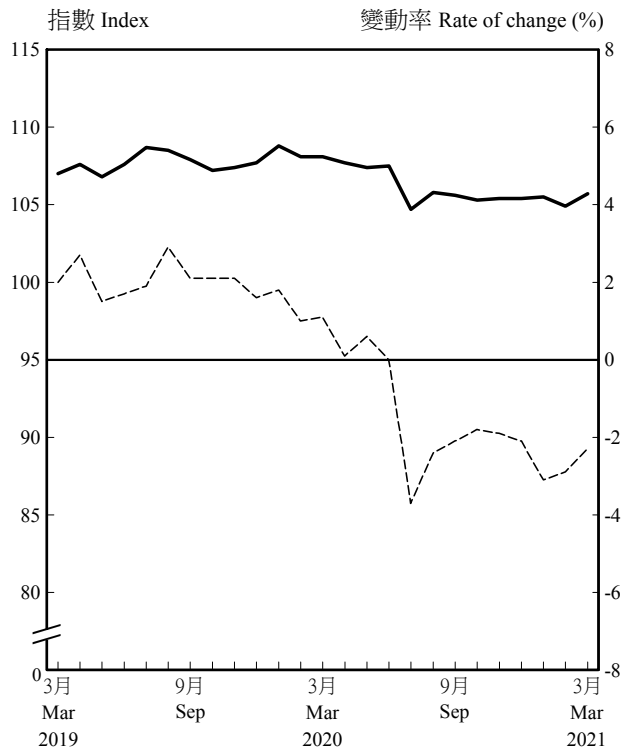

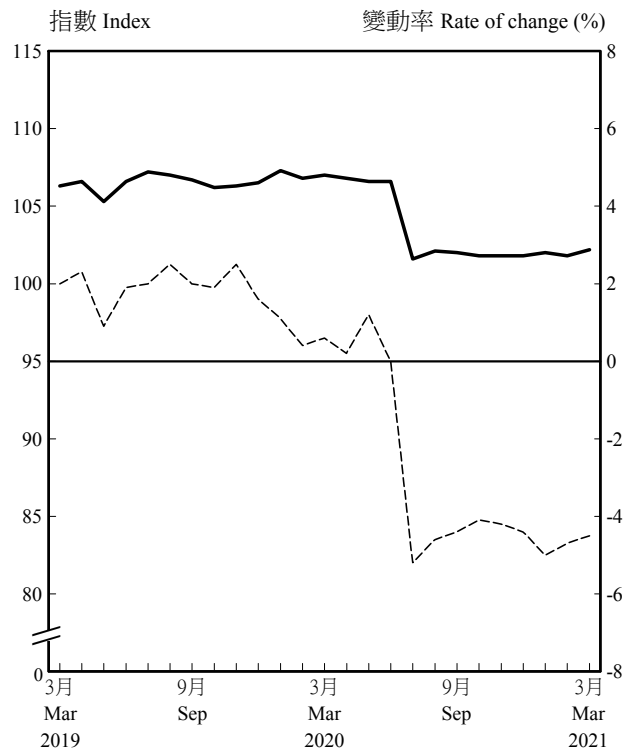

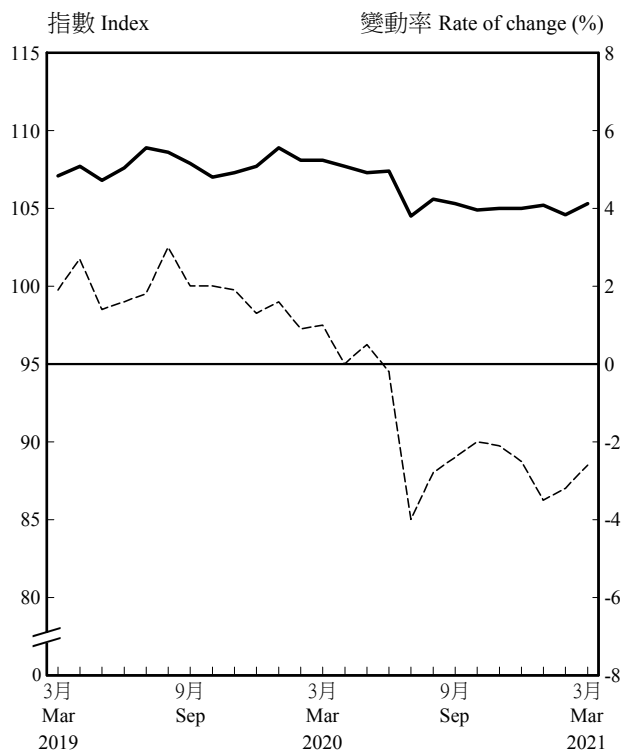

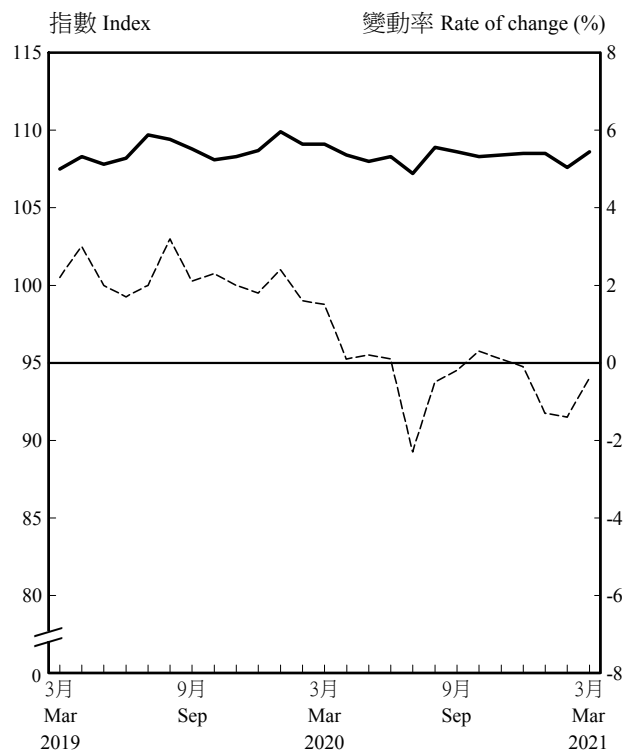
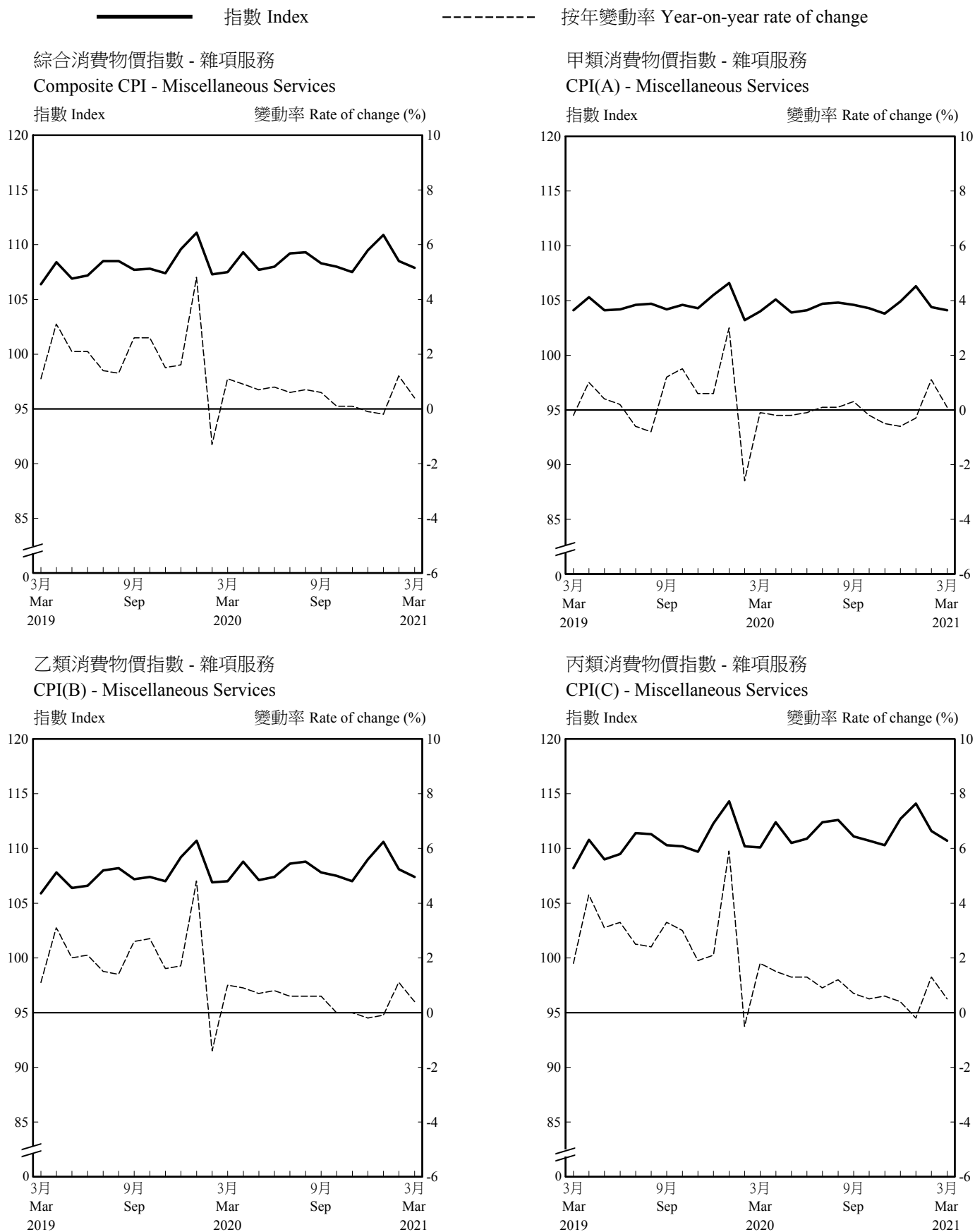


圖 3 消費物價指數的商品／服務類別指數
