1. 概念及方法

- 1.1 消費物價指數量度住戶一般所購買的消費 商品及服務的價格水平隨時間而變動的情況。消 費物價指數的按年變動率,是廣泛被用作反映消 費者所面對的通貨膨脹的指標。
- 1.2 由於不同開支範圍的住戶的開支模式各有差別,消費物價轉變對它們的影響也各有不同。因此,香港編製三項針對不同開支組別住戶的消費物價指數。甲類、乙類及丙類消費物價指數分別根據較低、中等及較高開支範圍的住戶的開支模式編製而成。綜合消費物價指數根據以上所有住戶的整體開支模式編製,反映消費物價轉變對整體住戶的影響。

- 1.3 每月的消費物價指數是根據(一)有關住戶的開支模式及(二)統計月內搜集的價格資料編製。
- 1.4 消費物價指數所採用的開支權數大部分是根據政府統計處進行的「住戶開支統計調查」所得的住戶開支模式,輔以其他來源的數據(如用以調整政府一次性措施影響的數據)得出。以2019/20 年為基期的消費物價指數數列所採用的開支權數是根據在2019年10月至2020年9月期間進行的「2019/20年住戶開支統計調查」的結果編製。本報告內的所有統計表及分折,均根據以2019/20年為基期的消費物價指數數列。

1. Concepts and methods

- 1.1 The Consumer Price Index (CPI) measures the changes over time in the price level of consumer commodities and services generally purchased by households. The year-on-year rate of change in the CPI is widely used as an indicator of the inflation affecting consumers.
- As households in different expenditure 1.2 ranges have varying expenditure patterns, the impacts of consumer price changes on households in different expenditure ranges are different. Hence, three series of CPIs, each referring to households in a different expenditure range, are compiled in Hong Kong. The CPI(A), CPI(B) and CPI(C) are compiled based on the expenditure patterns of households in the relatively low, medium and relatively high expenditure ranges A Composite CPI is compiled respectively. based on the overall expenditure pattern of all of the above households taken together to reflect the impact of consumer price changes on the household sector as a whole.
- 1.3 Monthly CPIs are compiled on the basis of (1) expenditure patterns of relevant households and (2) prices collected in the reference month.
- 1.4 The expenditure weights for compiling the CPIs are largely derived based on the household expenditure patterns obtained from the Household Expenditure Survey (HES) conducted by the Census and Statistics Department (C&SD), supplemented by data from other sources (such as those for adjustment on the effect of Government's one-off measures). The expenditure weights for compiling the 2019/20-based CPI series were derived based on the results of the 2019/20 HES conducted during October 2019 to September 2020. All tables and analyses in this report are based on the 2019/20-based CPI series.

- 1.5 「2019/20 年住戶開支統計調查」的數據搜集工作在 2019 年 10 月至 2020 年 9 月進行,期間消費行為嚴重受到 2019 冠狀病毒病疫情的影響。在這統計調查期間,住戶在某些商品或服務上的開支(如外出用膳、衣履、娛樂、本地及跨境交通,以及旅遊)與正常情況的開支應有顯著偏差。儘管如此,政府統計處已按照這一輪「住戶開支統計調查」的結果,更新消費物價指數的開支權數。這是參照至少每 5 年一次更新消費物價指數開支權數的國際標準,並能確保消費物價指數能準確反映住戶在疫情下面對的通脹情況。
- 1.6 除消費物價指數的開支權數外,以 2019/20 年為基期的消費物價指數數列的開支範圍亦更新 如下:

1.7 上述的開支範圍是以 2019 年 10 月至 2020 年 9 月基期內的物價計算。將自基期起物價轉變的影響計算在內,甲類、乙類及丙類消費物價指數所涵蓋住戶的每月平均開支,以 2022 年的價格水平計算,分別大約在 6,700 元至 28,700 元之間、28,700 元至 49,600 元之間及 49,600 元至 94,200 元之間,而綜合消費物價指數所涵蓋住戶的每月平均開支則大約在 6,700 元至 94,200 元之間。

- The data collection of the 2019/20 HES was conducted from October 2019 to September 2020, during which consumer behaviour was severely affected by the COVID-19 epidemic. Household spending on some commodities/services (such as meals out, clothing and footwear, entertainment, local and cross-boundary transport and package tours) during the survey period should have deviated significantly from those under normal C&SD has nonetheless updated circumstances. the CPI expenditure weights using this round of HES results in accordance with the international standard of updating the weighting patterns at least every 5 years. This also ensures that the CPIs can accurately reflect the inflation experienced by the households under the epidemic.
- 1.6 On top of the expenditure weights, the expenditure brackets for the 2019/20-based CPI series are also updated as follows:

1.7 The above expenditure ranges relate to prices in the base period from October 2019 to September 2020. Taking into account the impact of price changes since the base period, the monthly household expenditure ranges of the CPI(A), CPI(B) and CPI(C) adjusted to the price level of 2022 are broadly equivalent to \$6,700-\$28,700, \$28,700-\$49,600 and \$49,600-\$94,200 respectively, and that of the Composite CPI is broadly equivalent to \$6,700-\$94,200.

- 1.8 在物價變動資料方面,政府統計處持續地進行一項「按月零售物價統計調查」,藉此搜集住戶消費籃子內各項商品及服務的價格變動資料。政府統計處每月從大約 3 500 間本地零售商店(例如超級市場、街市檔位、百貨公司及時裝店)及服務行業商號(例如電影院、醫院及美容院)搜集多於40 000 個價目。搜集價格資料的方式,主要是採用外勤訪問形式進行,亦有部分以電話查詢、網上搜集或郵遞問卷方式進行。
- 1.9 因應網上購物愈來愈流行,政府統計處亦從本港住戶經常光顧的網上商店搜集價目,以編製消費物價指數。按照編製消費物價指數時處理網上購物的最新國際指引,非本地網上商店的網上價目也包括在內。
- 1.10 就 2019 冠狀病毒病疫情對「按月零售物價統計調查」部分採價工作的影響,政府統計處會在合適的情況下使用網上及電話訪問等其他採價方法取代外勤訪問,以減少缺答的價目。政府統計處亦會根據國際建議,使用科學方法處理缺答的價目,並進行嚴緊的數據審核和檢視,以確保消費物價指數的可靠性。
- 1.11 至於一些如公共交通、電力及郵遞服務的主要服務,其價格數據則直接從有關機構搜集或從行政紀錄中獲得。而私人房屋租金方面,有關新訂租約、續訂租約及現時租戶的租金資料,是透過一項以私人房屋租戶為對象的按月抽樣統計調查搜集得來。另一方面,有關公營房屋租金變動的數據則由香港房屋委員會及香港房屋協會定期提供。

- 1.8 As regards information on price changes, C&SD continuously conducts a Monthly Retail Price Survey to capture the price changes of items included in the household consumption basket. C&SD collects over 40 000 price quotations from some 3 500 local retail outlets (e.g. supermarkets, market stalls, department stores and fashion shops) and service providers (e.g. cinemas, hospitals and beauty salons) each month. Price data are collected mainly by field visits and some also through the modes of telephone, online or postal enquiries.
- 1.9 In response to the increasing popularity of internet purchases, C&SD also collects price quotations from online outlets commonly patronised by households in Hong Kong for the compilation of the CPI. In accordance with the latest international guidelines regarding the treatment for online purchases in the CPI compilation, online price quotations from non-local online outlets are also included.
- 1.10 For some price collection of the Monthly Retail Price Survey affected by the COVID-19, C&SD, where appropriate, adopts alternative collection methods such as online pricing and telephone interviews to replace field visits so as to reduce missing prices. C&SD also follows international recommendations to treat the missing prices by scientific methods, and conducts rigorous data validation and review to ensure reliability of the CPIs.
- 1.11 As for principal services such as public transport, electricity and postal services, price data are either collected directly from the companies concerned or obtained from administrative records. Rental data on private housing for new, renewed and continued lettings are collected from a monthly sample survey on private housing renter households. On the other hand, data on rental movements of public housing are regularly provided by the Hong Kong Housing Authority and the Hong Kong Housing Society.

- 1.12 在編製消費物價指數時,所搜集的價格數據 是消費者支付的實際價格,包括產品的各種稅項和 服務費,亦已考慮大部分折扣、補貼和回扣。使用 數據時要注意不應將消費物價指數所量度的價格 變動直接視為反映相關生產成本的變動,特別是獲 政府大量補貼的項目,例如教育服務和醫療服務。
- 1.13 根據定義,某一個月份的消費物價指數,是通過比較在該月份與在基期購買同一籃子的消費項目所需付的總開支而計算出來的。在數學上,這等同於運用已更新至一年前(或一個月前)的價格水平的開支比重,把每個消費項目在當月所錄得的按年(或按月)價格變動加權,然後計算總和。換句話說,用以編製消費物價指數的計算公式已充分計及因個別項目自基期以來的價格變動而直接引致的開支權數變動。因此,這些變動不會影響消費物價指數及其變動率的準確性。相關的技術細節詳載於《2019/20 年住戶開支統計調查及重訂消費物價指數基期》的附錄 3。

1.14 值得留意是住戶的消費模式會因應其收入 及其它社會經濟因素的變動而改變。因此,除上述 的價格因素外,開支比重亦會受這些影響而隨時間 逐漸轉變。例如,住戶一般傾向多買一些價格升幅 較小的商品和服務,以替代價格升幅較大的商品和 服務。由於這種替代效應,根據固定消費模式計算 的消費物價指數,可能會高估了價格的升幅。然 而,過去的經驗顯示,消費模式只會隨時間慢慢地 轉變,而在少於 5 年間的累積變化一般都不會對消 費物價指數的變動率構成顯著影響。因此,香港消 費物價指數的開支權數會每隔 5 年更新一次。這做 法符合國際統計標準。

- 1.12 The price data collected for compiling the CPIs are the actual prices paid by consumers, including any taxes and service charges on the products, and taking account of most discounts, subsidies and rebates. Care should be taken not to directly relate the price changes measured by the CPI as changes in production costs, especially for items which are subject to heavy government subsidies, e.g. educational services and medical services.
- By definition, the CPI in a specific month is computed by comparing the total expenditure required to purchase a basket of consumption items in that month with that required to purchase the same basket in the base period. Mathematically, this is equivalent to computing the composite sum of the year-on-year (or month-to-month) price changes of individual items in that month, each weighted by the corresponding item-specific expenditure weight updated to the price level in a year (or month) ago. In other words, the CPI compilation formula has already taken into account changes in expenditure weights directly caused by price changes in individual items since the base period and thus the accuracy of the CPI and its rate of changes are not affected by such changes. Relevant technical details are fully discussed in Appendix 3 of the report 2019/20 Household Expenditure Survey and the Rebasing of the Consumer Price Indices.
- It should be noted that in addition to the price factor mentioned above, the expenditure weights do change gradually over time due to changes in consumption pattern of households in response to such factors as changes in income and other socio-economic factors. For example, households usually tend to buy more of the goods and services with smaller price increases to substitute those with larger price increases; and due to such substitution effect, the CPI compiled based on fixed consumption pattern tends to over-state price increases over time. However, past experience revealed that changes in consumption pattern would only take place gradually and generally changes accumulated in a period of less than 5 years would not have a significant impact on the rate of change in the CPI. Therefore, the expenditure weights of the CPI are updated once every 5 years in Hong Kong. The practice conforms to international statistical standards.

1.15 由於2019/20年受2019冠狀病毒病疫情導致消費模式出現較大的轉變,政府統計處會在2024/25年下一次全面重訂基期前,根據其他來源的最新數據(例如零售業銷貨額及食肆收益)就消費物價指數的開支權數每年進行特別檢討。就2020年10月至2021年9月統計期進行的特別檢討已完成,結果顯示2020/21年與2019/20年期間的開支權數沒有顯著轉變,而該些轉變對消費物價指數的影響亦十分輕微。因此,政府統計處認為現時無需更新消費物價指數的開支權數。政府統計處會繼續不時就開支權數進行特別檢討,並在有需要時適當調整權數,以確保編製消費物價指數過程已適時考慮因疫情的影響轉變或回復常態對開支模式所引致的主要變動。

- 1.16 一併研究消費物價指數原來數列的按年變動數字和經季節性調整數列的按月變動數字,有助分析消費物價的最新趨勢。經季節性調整數列的按月變動仍會受其他不規則的因素影響而波動。參考經季節性調整的指數在最近3個月內的平均每月變動率,能更清楚看到消費物價指數的趨勢。
- 1.17 由於經季節性調整的數列已透過統計方法 剔除季節性變異,可更有意義地比較相連月份數 字。

- In view of the larger changes in consumption pattern brought about by the COVID-19 epidemic in 2019/20, C&SD will conduct special reviews on the CPI expenditure weights annually based up-to-date data from other sources (such as retail sales and restaurant receipts) before the next round of full-scale rebasing exercise in 2024/25. A special review for the reference period of October 2020 to September 2021 has been completed. The results revealed that there were no major changes in the expenditure weights between 2020/21 and 2019/20 and the impacts of the changes on the CPIs were insignificant. Thus, C&SD considers it not necessary to update the CPI expenditure weights at C&SD will continue to conduct the moment. special reviews on the expenditure weights from time to time, and make appropriate adjustments to the weights when needed, to ensure that major shifts in expenditure patterns caused by changing impacts of the epidemic or resumption of normalcy can be timely taken into account in compiling the CPIs.
- 1.16 For analysing the latest trend in consumer prices, it is useful to study the year-on-year changes in the original CPI series and the month-to-month changes in the seasonally adjusted series together. The month-to-month changes in the seasonally adjusted series still tend to fluctuate due to other irregular factors. The trend of the CPIs may be more clearly discerned by looking at the average monthly rates of change of the seasonally adjusted indices during the latest 3 months.
- 1.17 In the seasonally adjusted series, seasonal variations have been eliminated by statistical methods, thus enabling figures for consecutive months to be compared more meaningfully.

2. 摘要統計數字

2.1 最新的消費物價指數及其變動率和剔除政府一次性紓困措施影響後的相關變動率載列於表<u>S1</u>。消費物價指數自 2007 年起的變動率受到數項政府一次性紓困措施所影響,當中主要包括電費津貼、公營房屋租金寬免、差餉寬減和考試費寬免,有關措施臚列於表<u>S1 附件</u>。這些一次性措施會降低措施實施當月的消費物價指數,對消費物價指數造成波動。

2. Summary statistics

2.1 The latest available figures for the CPIs and their rates of change as well as the related rates of change after netting out the effects of all Government's one-off relief measures are summarised in Table S1. The rates of change in CPIs since 2007 were affected by a number of Government's one-off relief measures, including mainly electricity charges allowance, waiver of public housing rentals, rates concession, and waiver of examination fees as shown in Annex to Table S1. These one-off measures would lower the CPIs in the months of implementation and resulted in some fluctuations in the CPIs.

3. 消費物價指數與上年同月比較的變動 詳情

- 3.1 在 2023 年 2 月份,綜合、甲類、乙類及 丙類消費物價指數均錄得按年升幅,分別為 1.7%、1.7%、1.6%及 1.8%。如表 S2 所示,剔 除所有政府一次性紓困措施的影響,綜合、甲 類、乙類及丙類消費物價指數的按年升幅分別為 1.7%、1.7%、1.6%及 1.8%。
- 3.2 為了更清楚地觀察到通脹的趨勢,剔除所有政府一次性舒困措施的影響後的綜合消費物價指數的按年變動率顯示於<u>圖</u>1。


3. Detailed changes in the CPIs, as compared with same month in preceding year

- 3.1 In February 2023, the Composite CPI, CPI(A), CPI(B) and CPI(C) all registered year-on-year rates of increase, at 1.7%, 1.7%, 1.6% and 1.8% respectively. As shown in <u>Table S2</u>, netting out the effects of all Government's one-off relief measures, the year-on-year rates of increase in the Composite CPI, CPI(A), CPI(B) and CPI(C) were 1.7%, 1.7%, 1.6% and 1.8% respectively.
- 3.2 The year-on-year rates of change in the Composite CPI after netting out the effects of all Government's one-off relief measures are presented graphically in <u>Chart 1</u> for discerning the inflationary trend more clearly.

- 3.4 2023 年 2 月份與 2022 年 2 月份比較,綜合消費物價指數中類別指數錄得升幅的有電力、燃氣及水(20.7%)、煙酒(14.0%)、衣履(5.5%)、外出用膳及外賣(4.3%)、雜項服務(1.8%)、雜項物品(0.7%),以及交通(0.4%)。
- 3.5 另一方面,綜合消費物價指數中類別指數在 2023 年 2 月份錄得按年跌幅的有耐用物品 (-2.1%)、基本食品(-0.6%),以及住屋(-0.1%)。
- 3.6 消費物價指數中各商品/服務類別指數 及其按年變動率的時間數列分別載列於表1.1至 1.4及表2.1至2.4。而各商品/服務組別指數的 按年變動情況則在表3.1至3.4列出。至於各類 別指數在消費物價指數整體變動中所佔的比率 則載列於表5。
- 3.7 消費物價總指數和各類別指數的變動情況及其按年變動率顯示於<u>圖2及3</u>。
- 3.8 自 2000 年代起,一些經濟體開始採用由 聯合國發展的「按目的劃分的個人消費分類」分 析消費物價指數。相對應於香港消費物價指數的 編製而言,「按目的劃分的個人消費分類」是以 交易的「目的」把住戶的個別消費開支劃分。

- 3.4 Compared with February 2022, increases in the section indices of the Composite CPI in February 2023 were recorded for electricity, gas and water (20.7%), alcoholic drinks and tobacco (14.0%), clothing and footwear (5.5%), meals out and takeaway food (4.3%), miscellaneous services (1.8%), miscellaneous goods (0.7%), and transport (0.4%).
- 3.5 On the other hand, year-on-year decreases in the section indices of the Composite CPI were recorded in February 2023 for durable goods (-2.1%), basic food (-0.6%), and housing (-0.1%).
- 3.6 The time series of the CPIs and their of vear-on-vear rates change at commodity/service section level are presented respectively in Tables 1.1 to 1.4 and Tables 2.1 to The year-on-year movements commodity/service group level are given in Tables 3.1 to 3.4. The contributions of each section to the overall changes in CPIs are shown in Table 5.
- 3.7 Movements of the all-item CPIs and their section indices together with their year-on-year rates of change are presented graphically in Charts 2 and 3.
- 3.8 Starting in 2000s, some economies have started to adopt the Classification of Individual Consumption According to Purpose (COICOP) developed by the United Nations in analysing the CPI. Corresponding to Hong Kong CPI compilation, the COICOP classifies individual consumption expenditure of households according to the "purposes" of the transactions.

3.9 為方便國際間進行比較,政府統計處亦根據「按目的劃分的個人消費分類」編製消費物價指數。由 2021 年 5 月份開始,政府統計處採用最新的「2018 年按目的劃分的個人消費分類」,以取代舊有的分類。根據「按目的劃分的個人消費分類」的綜合、甲類、乙類及丙類消費物價指數的類別指數及其按年變動率的時間數列分別列於附錄 2.1 至 2.4 和附錄 3.1 至 3.4。

3.9 To facilitate international comparison, C&SD also compiles the CPI based on the COICOP. Starting from May 2021, the new COICOP 2018 is adopted to replace the previous COICOP. The time series of the Composite CPI, CPI(A), CPI(B) and CPI(C), and their year-on-year rates of change at division level based on the COICOP are presented respectively in Appendices 2.1 to 2.4 and Appendices 3.1 to 3.4.

4. 消費物價指數與上月比較的變動詳情

- 4.1 2023 年 2 月份與 2023 年 1 月份比較,甲類消費物價指數上升 0.1%。但丙類消費物價指數則下跌 0.1%。而綜合及乙類消費物價指數則維持不變。剔除所有政府一次性紓困措施的影響,2023 年 2 月份甲類消費物價指數的按月變動率為 0.1%。但丙類消費物價指數則下跌 0.1%。而綜合及乙類消費物價指數則維持不變。
- 4.2 2023 年 2 月份消費物價指數中各商品/服務類別指數及其按月變動率臚列於表 S4。
- 4.3 各商品/服務類別指數中,煙酒指數在綜合、甲類、乙類及丙類消費物價指數分別上升 13.0%、14.4%、12.3%及 9.9%。其他類別指數的 變動則比較輕微。
- 4.4 以下簡要地解釋各商品/服務類別指數 在 2023 年 1 月與 2 月間的變動。

4. Detailed changes in the CPIs, as compared with preceding month

- 4.1 Compared with January 2023, the CPI(A) increased by 0.1% in February 2023. However, the CPI(C) decreased by 0.1%. Meanwhile, the Composite CPI and CPI(B) remained unchanged. Netting out the effects of all Government's one-off relief measures, the month-to-month rates of change in the CPI(A) was 0.1% in February 2023. However, the CPI(C) decreased by 0.1%. Meanwhile, the Composite CPI and CPI(B) remained unchanged.
- 4.2 The indices and month-to-month rates of change of the CPIs for February 2023, analysed by section of commodity/service, are shown in Table S4.
- 4.3 Among the indices for various commodity/service sections, the index for alcoholic drinks and tobacco increased by 13.0%, 14.4%, 12.3% and 9.9% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively. Movements in the indices for other sections were relatively small.
- 4.4 The following explains briefly the movement of the index for each commodity/service section between January and February 2023.

Given the heavy government subsidy on public medical services in Hong Kong, the CPI for medical services should not be interpreted as reflecting changes in the costs for providing medical services in Hong Kong. Details about the price coverage are given in paragraph 1.12 of this report.

- 4.5 <u>食品</u>指數在綜合、甲類及乙類消費物價指數中下跌 0.1%,主要是新鮮蔬菜和其他新鮮海產價格下跌所致。而指數在丙類消費物價指數中則維持不變。
- (i) 新鮮蔬菜 新鮮蔬菜的平均零售價格在 綜合、甲類及乙類消費物價指數中分別下 跌 4.0%、4.1%及 4.0%。
- (ii) 其他新鮮海產 其他新鮮海產的平均零售價格在綜合、甲類及乙類消費物價指數中分別下跌 6.5%、7.2%及 6.3%。
- 4.6 <u>表</u>8載列選定食品在本月、上月及上年同月的平均零售價格及價格範圍。
- 4.7 <u>住屋</u>指數在四項消費物價指數中維持不變。
- 4.8 <u>電力、燃氣及水</u>指數在四項消費物價指數中均上升 0.4%,主要是煤氣費上升所致。
- 4.9 <u>煙酒</u>指數在綜合、甲類、乙類及丙類消費物價指數中分別上升 13.0%、14.4%、12.3%及 9.9%,主要是煙草稅自 2023 年 2 月底上調約 31% 所致。
- 4.10 <u>衣履</u>指數在綜合、甲類、乙類及丙類消費物價指數中分別下跌 0.5%、0.1%、0.4%及 0.8%,主要是外衣價格下跌所致。

- 4.5 The index for <u>food</u> decreased by 0.1% in the Composite CPI, CPI(A) and CPI(B). This was largely attributable to the decreases in the prices of fresh vegetables as well as other fresh sea products. Meanwhile, the index remained unchanged in the CPI(C).
 - (i) Fresh vegetables The average retail prices of fresh vegetables decreased by 4.0%, 4.1% and 4.0% in the Composite CPI, CPI(A) and CPI(B) respectively.
- (ii) Other fresh sea products The average retail prices of other fresh sea products decreased by 6.5%, 7.2% and 6.3% in the Composite CPI, CPI(A) and CPI(B) respectively.
- 4.6 The average retail prices and price ranges of selected food items for the current month, preceding month and same month in preceding year are shown in <u>Table 8</u>.
- 4.7 The index for <u>housing</u> remained unchanged in all the four CPIs.
- 4.8 The index for <u>electricity</u>, <u>gas and water</u> increased by 0.4% in all the four CPIs, mainly due to the increases in the charges for towngas.
- 4.9 The index for alcoholic drinks and tobacco increased by 13.0%, 14.4%, 12.3% and 9.9% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, mainly due to the upward adjustment in tobacco duty by about 31% since late February 2023.
- 4.10 The index for <u>clothing</u> and <u>footwear</u> decreased by 0.5%, 0.1%, 0.4% and 0.8% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, mainly due to the lower prices of outerclothing.

- 4.11 耐用物品指數在四項消費物價指數中均 上升 0.1%,主要是家庭電器及氣體用具和鐘 錶、照相機及光學用品價格上升所致。
- 4.12 <u>雜項物品</u>指數在綜合、甲類、乙類及丙類 消費物價指數中分別上升 0.9%、0.9%、0.9%及 0.8%,主要是化妝品及個人護理用品和藥物價格 上升所致。
- 4.13 交通指數在綜合、甲類及乙類消費物價指數中分別上升 0.1%、0.7%及 0.1%,主要是港鐵車費優惠減少所致。但指數在丙類消費物價指數中則下跌 0.5%,主要是進出香港交通費用下調所致。
- 4.14 <u>雜項服務</u>指數在綜合、甲類、乙類及丙類 消費物價指數中分別下跌 0.5%、0.3%、0.4%及 0.7%,部分是資訊及通訊服務費用下跌所致。
- 4.15 四項消費物價指數的商品/服務組別指數在 2023 年 2 月份的按月變動情況分別顯示於表 3.1 至 3.4。
- 4.16 各商品/服務類別指數在消費物價指數整體按月變動中所佔的比率載列於表 6。至於佔消費物價指數整體變動中最大比率的商品/服務組別則在表 7.1 至 7.4 列出。

- 4.11 The index for <u>durable goods</u> increased by 0.1% in all the four CPIs, largely due to the increases in the prices of home appliances, electric and gas as well as watches, clocks, cameras and optical goods.
- 4.12 The index for <u>miscellaneous goods</u> increased by 0.9%, 0.9%, 0.9% and 0.8% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, mainly because of the increases in the prices of cosmetics and personal care products as well as proprietary medicines and supplies.
- 4.13 The index for <u>transport</u> increased by 0.1%, 0.7% and 0.1% in the Composite CPI, CPI(A) and CPI(B) respectively, largely attributable to the lower discounts on MTR fares. However, the index decreased by 0.5% in the CPI(C), mainly because of the downward adjustment in inbound and outbound transport fares.
- 4.14 The index for <u>miscellaneous services</u> decreased by 0.5%, 0.3%, 0.4% and 0.7% in the Composite CPI, CPI(A), CPI(B) and CPI(C) respectively, partly attributable to the decreases in the charges for information and communications services.
- 4.15 The month-to-month movements of the four CPIs for February 2023 by commodity/service group are shown in <u>Tables 3.1 to 3.4</u> respectively.
- 4.16 The contribution of each commodity/service section to the overall month-to-month change in the CPIs is presented in <u>Table 6</u>. The commodity/service groups with the largest contributions to the overall change in CPIs are listed in Tables 7.1 to 7.4.

5. 經季節性調整消費物價指數

- 5.1 消費物價指數原來數列的按月變動率會 受到季節性變異的影響。把這些季節性變異從數 列中剔除,便可更有意義地比較相連月份數字。
- 5.2 經季節性調整的數列可因應數據增加而 作出修訂。由 2004 年 10 月開始,每年發表 10 月份的數字時,會一併修訂對上 3 年的經季節性 調整消費物價指數。
- 5.3 自 2008 年 10 月開始,編製經季節性調整的消費物價指數的方法由過往「X-11 自迴歸一求和一移動平均」(X-11 ARIMA)方法更改為「X-12 自迴歸一求和一移動平均」 (X-12 ARIMA)方法。自 2005 年 10 月開始的經季節性調整的消費物價指數數列亦已按這個新方法作出修訂。「X-12 自迴歸一求和一移動平均」方法改良自「X-11 自迴歸一求和一移動平均」方法,能提供更佳的模型建造及模型評估能力。「X-12 自迴歸一求和一移動平均」方法是用作編製經季節性調整的統計數列的標準方法。
- 5.4 <u>表 4.1 及 4.2</u> 載列經季節性調整的消費物 價指數在過去 3 年的按月變動率。
- 5.5 參考經季節性調整的指數在最近3個月內的平均每月變動率,能更清楚看到消費物價指數的趨勢。如表 S5 顯示,就綜合消費物價指數而言,這變動率在2023年2月份為0.2%,而2023年1月份的相應變動率則為0.4%。但應留意這些變動率是受到個別政府一次性紓困措施只在某些月份實施所影響。剔除這些影響,截至2023年2月止的3個月期間,綜合消費物價指數的平均每月變動率為0.2%,而在2023年1月的3個月期間的相應變動率則為0.4%。

5. Seasonally adjusted CPIs

- 5.1 Month-to-month rates of change based on the original CPI series are affected by seasonal variations. By removing these seasonal variations from the series, figures for consecutive months can be compared more meaningfully.
- 5.2 Seasonally adjusted series may be revised as more data become available. Starting from October 2004, the seasonally adjusted CPIs for the preceding 3 years are revised each year when releasing the figures for October.
- 5.3 Starting from October 2008, the seasonal adjustment of the CPI is compiled by the "X-12 ARIMA" method to replace the previous "X-11 ARIMA" method. The seasonally adjusted CPI series since October 2005 have also been revised using the new method. "X-12 ARIMA" method is an update to the "X-11 ARIMA" method with enhanced modelling and diagnostic capabilities. The "X-12 ARIMA" method is a standard method applied in compiling seasonally adjusted statistical data series.
- 5.4 The month-to-month rates of change of the seasonally adjusted CPIs in the past 3 years are presented in Tables 4.1 and 4.2.
- 5.5 The trend of the CPIs may be more clearly discerned by looking at the average monthly rate of change of the seasonally adjusted indices during the latest 3 months. As shown in <u>Table S5</u>, such rate of change in the Composite CPI was 0.2% in February 2023. The corresponding rate of change in January 2023 was 0.4%. It should be noted that these rates of change were affected by Government's one-off relief measures implemented only in some months. Netting out these effects, the corresponding average monthly rate of change in the Composite CPI for the 3-month period ending February 2023 was 0.2%, and that for the 3-month period ending January 2023 was 0.4%.




























