### 引言

- 1. 食肆收益及購貨額統計數字 是從「食肆的收入及購貨額按季統 計調查」搜集的數據編製,用來量 度消費者在香港餐飲服務的消費 水平及趨勢。
- 2. 食肆的分類是採用「香港標準行業分類」。該行業分類用於各經濟統計調查,把經濟單位撥歸不同的行業類別。本報告內把香港所有食肆歸納為五個主要類別,包括:
- (i) 中式餐館;
- (ii) 非中式餐館;
- (iii) 快餐店;
- (iv) 酒吧;以及
- (v) 其他飲食場所。
- 3. 政府統計處在二零零八年十月推行新的「香港標準行業分類 2.0 版」後,「食肆的收入及購貨額按季統計調查」已作出改變,採用新行業分類編製食肆收益及購貨額統計數字。由二零零九年第一季起,所有食肆收益及購貨額統計數字均按「香港標準行業分類 2.0 版」編製。
- 4. 為方便加深了解飲食業的短期業務表現,本刊物亦發布有關季度內個別月份的食肆收益及購貨額統計數字。

#### Introduction

- 1. The Quarterly Survey of Restaurant Receipts and Purchases (QSR) collects data for compiling restaurant receipts and purchases statistics, for gauging the level and trend of consumer spending on catering services in Hong Kong.
- 2. The classification of restaurants follows the Hong Kong Standard Industrial Classification (HSIC), which is used in various economic surveys for classifying economic units into different industry classes. In this report, all restaurants in Hong Kong have been grouped into five broad types, including:
- (i) Chinese restaurants;
- (ii) non-Chinese restaurants;
- (iii) fast food shops;
- (iv) bars; and
- (v) other eating and drinking places.
- 3. Upon the implementation of the new HSIC Version 2.0 by the Census and Statistics Department in October 2008, the QSR has been enhanced to adopt the new classification in compiling the restaurant receipts and purchases statistics. Starting from the reference quarter of Q1 2009, all the restaurant receipts and purchases statistics are compiled based on the HSIC Version 2.0.
- 4. To facilitate better understanding of the short-term business performance of the restaurants sector, statistics in respect of the restaurant receipts and purchases in individual months of the reference quarter are also published.

## 概況

- 5. 根據「食肆的收入及購貨額按季統計調查」,二零一一年第三季的**食肆總收益價值**的臨時估計為 223 億元,較二零一零年第三季上升 6.2%。同時,**食肆總購貨價值**的臨時估計為 80 億元,按年上升 9.7%。
- 6. 扣除價格變動的影響後,二零一一年第三季與二零一零年同期比較,食肆的總收益以數量計上升 0.5%。所用的物價平減指數是從消費物價指數內相關的項目選取。
- 7. 按食肆類別分析,**雜類飲食場** 所於二零一一年第三季的總收益以價值計,較二零一零年同期上升8.1%, 以數量計則上升0.6%。
- 8. 同期間,**酒吧**的總收益以價值計上升 7.4%,以數量計則上升 3.3%。中**式餐館**的總收益以價值計上升 7.3%,以數量計則上升 1.5%。
- 9. 與二零一零年同期比較,二零一一年第三季**快餐店**的總收益以價值計上升 6.9%,以數量計則上升 1.7%。至於**非中式餐館**的總收益以價值計上升 3.5%,但以數量計則下跌 2.3%。
- 10. 二零一一年第三季與第二季 比較,經季節性調整的食肆總收益 數量上升0.8%。
- 11. 二零一一年首三季與二零一零年同期比較,食肆總收益以價值計上升 6.0%,以數量計則上升 1.0%。

#### **General observations**

- 5. According to the QSR, the *value of total receipts of the restaurants sector* was provisionally estimated at \$22.3 billion in the third quarter of 2011, up by 6.2% over the third quarter of 2010. Over the same period, the *value of total purchases by restaurants* was provisionally estimated at \$8.0 billion, increased by 9.7%.
- 6. After discounting the effect of price changes, total restaurant receipts rose by 0.5% in volume in the third quarter of 2011 as compared to a year earlier. The relevant components of the Consumer Price Index are used as deflators.
- 7. Analysed by type of restaurant, total receipts of *miscellaneous eating and drinking places* increased by 8.1% in value and 0.6% in volume in the third quarter of 2011 as compared to a year earlier.
- 8. Over the same period, total receipts of *bars* increased by 7.4% in value and 3.3% in volume, while total receipts of *Chinese restaurants* increased by 7.3% in value and 1.5% in volume.
- 9. Total receipts of *fast food shops* increased by 6.9% in value and 1.7% in volume in the third quarter of 2011 as compared to a year earlier. As for *non-Chinese restaurants*, total receipts increased by 3.5% in value but decreased by 2.3% in volume.
- 10. On a seasonally adjusted quarter-to-quarter comparison, the volume of total restaurant receipts increased by 0.8% in the third quarter of 2011 as compared to the second quarter of 2011.
- 11. Comparing the first three quarters of 2011 with the same period in 2010, total restaurant receipts increased by 6.0% in value and 1.0% in volume.

- 12. 按月份分析,二零一一年七月、八月及九月的食肆總收益價值的臨時估計分別為 76 億元、74 億元及 73 億元。二零一一年七月、八月及九月的食肆購貨總額的臨時估計則同時為 27 億元。
- 13. 扣除價格變動的影響後,二零一一年七月與二零一零年同月比較,食肆的總收益以數量計上升2.3%,而二零一一年八月及九月的相應數字則分別下跌 0.5%及0.3%。
- 14. <u>表一</u>列出二零一零年第三季至二零一一年第三季按食肆類別劃分的食肆收益及食肆總購貨價值。同時亦列出按月劃分的分項數字。
- 15. <u>表二</u>列出二零一零年第三季至二零一一年第三季按食肆類劃分的食肆收益價值指數,其中食肆收益價值指數是以二零零九年十月至二零一零年九月期內的平均食肆收益價值指數定為一百。同時亦列出按月劃分的分項數字。
- 16. <u>表三</u>列出二零一零年第三季至二零一一年第三季按食肆類劃分的食肆收益數量指數,其中食肆收益數量指數是以二零零九年十月至二零一零年九月期內的平均食肆收益數量指數定為一百。同時亦列出按月劃分的分項數字。
- 17. <u>表四</u>展示食肆總收益數量指數的變動情況。它列出以原來數列計算某季度與上年同季比較的按年變動百分率,及以經季節性調整數列計算的某季度與上一季度比較的變動百分率。

- 12. Analysed by month, the value of total receipts of the restaurants sector was provisionally estimated at \$7.6 billion, \$7.4 billion and \$7.3 billion respectively in July, August and September 2011. The provisional value of total purchases by restaurants was the same in July, August and September 2011, at \$2.7 billion each month.
- 13. After discounting the effect of price changes, total restaurant receipts increased by 2.3% in volume in July 2011 but decreased by 0.5% and 0.3% respectively in August and September 2011 as compared to a year earlier.
- 14. <u>Table 1</u> presents the figures of restaurant receipts by type of restaurant and total restaurant purchases from Q3 2010 to Q3 2011. Detailed figures by month are also presented.
- 15. <u>Table 2</u> presents the value indices of restaurant receipts by type of restaurant from Q3 2010 to Q3 2011. The value indices are compiled with the average value index of restaurant receipts from October 2009 to September 2010 taken as 100. Detailed figures by month are also presented.
- 16. <u>Table 3</u> presents the volume indices of restaurant receipts by type of restaurant from Q3 2010 to Q3 2011. The volume indices are compiled with the average volume index of restaurant receipts from October 2009 to September 2010 taken as 100. Detailed figures by month are also presented.
- 17. <u>Table 4</u> shows the movement of the volume of total restaurant receipts in terms of the year-on-year rate of change for a quarter compared with the same quarter in the preceding year based on the original series, and in terms of the rate of change of a quarter compared with the preceding quarter based on the seasonally adjusted series.

- 19. <u>Chart 2</u> depicts the movement of the quarterly volume index of total restaurant receipts and its seasonally adjusted index from Q4 2008 to Q3 2011.
- 20. <u>Chart 3</u> depicts the movement of the monthly value and volume indices of total restaurant receipts from July 2010 to September 2011.


(1) 經季節性調整數列是由「X-12 自迴歸-求和-移動平均(X-12ARIMA)」方法編製,該方法是用作編製經季節 性調整的統計數列的標準方法。在按季食肆總收益指數方面,當每年第一季的數字發表時,會一併修訂對上三 年的經季節性調整數列。至於按月食肆總收益數量指數,將於有較長數列時才會進行季節性調整。

The seasonally adjusted series is compiled using the X-12 ARIMA method, which is a standard method applied in compiling seasonally adjusted statistical data series. For the quarterly volume index of total restaurant receipts, its seasonally adjusted series for the preceding three years is revised each year when the figures for the first quarter are published. For the monthly volume index of total restaurant receipts, seasonal adjustment will be performed when a longer data series is available in future.

(二零零九年十月至二零一零年九月期內的季度平均指數=100) (Average of quarterly indices from October 2009 to September 2010=100)



## Chart 2: Quarterly volume index of total restaurant receipts



#### 統計調查方法

## 統計調查的涵蓋範圍

「食肆的收入及購貨額按季統計調查」涵蓋香港所有食肆。由二零零九年第一季起,「香港標準行業分類 2.0 版」已取代「香港標準行業分類 1.1 版」作為食肆的經濟活動的分類。

在採用「香港標準行業分類 2.0 版」後,一些原先在舊行業分類下歸納為食肆的機構單位,可能會重新歸納於其他食肆類別,或甚至已不再歸類為食肆。有關各食肆類別涵蓋範圍的轉變詳情,讀者可參閱附錄甲及附錄乙分別載述的「各食肆類別的修訂涵蓋範圍」及「食肆類別按新舊分類對照表」。

## 樣本設計

這項統計調查是使用分層輪換複 樣本抽樣設計。

抽樣框是先以食肆類別分層,然後在每個食肆類別分層內,再以就業人數分層。最後在每一分層中,抽取指定數目的複樣本。每個分層所抽取的複樣本規模是依照內曼配置方式,按各食肆類別的估計食肆收益的期望精確程度而決定。在每季的六個複樣本當中,會換出三個舊複樣本,由另外三個新複樣本取代。每季共選出約一千一百間食肆作統計調查樣本。

## 資料搜集

每一輪的統計調查問卷會郵寄予 獲選的機構單位。數據經郵遞方式收 取,如有需要,則輔以電話或面談訪問, 以搜集及核實有關資料。亦製備問卷的 電子版本供機構單位填報及以電郵方式 提交問卷。

### Survey methodology

#### Survey coverage

The Quarterly Survey of Restaurant Receipts and Purchases (QSR) covers all restaurants in Hong Kong. Starting from the first quarter of 2009, the Hong Kong Standard Industrial Classification (HSIC) Version 2.0 has been adopted in place of HSIC Version 1.1 for classifying the economic activities of restaurants.

should be noted establishments originally classified as restaurants under the old version of HSIC may be re-classified into other restaurant types or may even no longer be classified as restaurants after the implementation of HSIC Version 2.0. For details of the changes in coverage of each readers may restaurant type, refer Appendices A and B which present the revised coverage of each restaurant type and a concordance table for types of restaurants under the old and new classifications respectively.

## Sample design

A stratified rotational replicate sample design is adopted for the survey.

Restaurants are first stratified by type and then by employment size. Within each stratum, a given number of replicates are created. Sample size in each replicate is determined by Neyman's Allocation according to the desired level of precision for the estimated restaurant receipts for various restaurant types. For each quarter, six replicates are used, with three new replicates rotated in and three old replicates rotated out. A total of around 1 100 restaurants are selected for enumeration for each reference quarter.

#### **Data collection**

For each survey round, questionnaires are mailed to sampled establishments. Data are collected by post, supplemented by telephone or face-to-face enumeration and verification as necessary. An electronic template of the questionnaire is also available upon request to facilitate completion and submission of the questionnaire by email.

為方便加深了解飲食業的短期業務表現,由二零零八年第一季開始,亦同時按季搜集有關季度內個別月份的食肆收益及購貨額數據,並由本刊物的二零一零年第一季期號開始,發布有關季度內個別月份的食肆收益及購貨額統計數字。

## 食肆的分類

自一九九零年,本處已採納「香港標準行業分類」,用作劃分香港的機構單位的經濟活動。「香港標準行業分類」是以「所有經濟活動的國際標準產業分類(國際標準產業分類)修訂本第2版」為藍本,加以編訂,使其切合本地環境,從而反映本港經濟結構。「香港標準行業分類」是一套統計分類架構,按照主要經濟活動把經濟單位撥歸行業類別。這個分類架構不僅是在不同的統計調查中作為抽選經濟單位樣本的基本分層,也是用以編製、分析和發布按經濟活動劃分的統計數字的標準行業分類。

政府統計處就「香港標準行業分 類」不時予以檢討,以反映香港經濟產 業結構的變化和新興的經濟活動。「香港 標準行業分類 1.1 版」於二零零一年推 行,為了使「香港標準行業分類」更能 反映本地經濟活動的最新情況,並改善 官方統計數字的國際可比性,以便利不 同的使用者,「香港標準行業分類」在二 零零八年已全面作出修訂。已修訂的「香 港標準行業分類」(即「香港標準行業分 類 2.0 版」) 於二零零八年十月公布。由 二零零九年開始,政府統計處在不同的 統計調查相繼採用「香港標準行業分類 2.0 版」。有關修訂「香港標準行業分類」 的詳情,讀者可參閱刊載於《香港統計 月刊》二零零八年十一月號的「修訂「香 港標準行業分類」」的專題文章。

To facilitate better understanding of the short-term business performance of the restaurants sector, data on restaurant receipts and purchases for individual months of a reference quarter are also collected at quarterly intervals as from the reference quarter of Q1 2008. Statistics in respect of the restaurant receipts and purchases in individual months of the reference quarter are published as from the Q1 2010 issue of this report.

#### **Classification of restaurants**

Since 1990, the HSIC has been adopted for classifying the economic activities of establishments in Hong Kong. The HSIC is International devised using the Standard Economic Classification of Industrial All Activities Revision 2 (ISIC Rev. 2) as a framework with local adaptation to reflect the structure of the Hong Kong economy. It is a statistical classification framework for classifying economic units into industry classes based on their major economic activities. This framework not only provides a basic stratification for sample selection of economic units in various surveys, but also serves as a standard industrial classification in Hong Kong for compilation, analysis and dissemination of statistics by economic activities.

The HSIC has been reviewed from time to time to reflect significant changes in the structure of the Hong Kong economy and the emergence of new economic activities. HSIC Version 1.1 was implemented in 2001 and in order to bring HSIC more up-to-date on local economic activities as well as to foster international comparability of official statistics for different users, a full-scale revision exercise was completed in 2008. revised HSIC, i.e. HSIC Version 2.0, was released in October 2008. HSIC Version 2.0 is being used progressively in different surveys by the Census and Statistics Department (C&SD) starting from 2009. Readers may refer to the feature article "Revision of the Hong Kong Standard Industrial Classification" published in the November 2008 issue of the Hong Kong Monthly Digest of Statistics for more details on the revision of HSIC.

## 數字的發布

臨時數字(包括有關季度的數字及 其按月劃分的分項數字)於統計季度後 約1.1個月後以新聞稿形式發布。這些臨 時數字是根據外勤工作截止日期前所搜 集的統計調查數據而編製。在截止日期 後所收到的數據(通常佔很小部分),會 用作修訂臨時數字。修訂數字會於臨時 數字發布後約一個月提供。二零一一年 第三季食肆收益及購貨額的修訂數字 (以及該季按月劃分的分項數字),將於 二零一一年十二月二十日開始在政府統 計 網 払 (http://www.censtatd.gov.hk/hong\_kong\_ statistics/index\_tc.jsp)及有關刊物發布。

Starting from the first quarter of 2009, the restaurant receipts and purchases statistics are compiled based on the HSIC Version 2.0.

# Backcasted series of new restaurant receipts and purchases statistics

Parallel coding of the industry classes of restaurants covered in the QSR, one under the HSIC Version 1.1 and the other under the HSIC Version 2.0, was undertaken in different rounds of survey in the reference year of 2008. Based on the 2008 survey data with dual classifications, the series of quarterly restaurant receipts and purchases statistics under HSIC Version 2.0 has been backcasted to the fourth quarter of 2004. #### **Data dissemination**

Provisional figures (including the figures for the reference quarter and their breakdown by month) are published around 1.1 months after the reference quarter in the form of a press release. These provisional figures are compiled based on survey data collected up to the fieldwork cut off date. Late returns (usually involving only a very small proportion) are used to revise the provisional figures. The revised figures are available about one month after the release of provisional figures. The revised figures on restaurant receipts and purchases for the third quarter of 2011 (with breakdown of the figures for that quarter by month) will be released through the website of the (www.censtatd.gov.hk/hong\_kong\_statistics/index .jsp) and relevant publications of the Department starting from December 20, 2011.
