### 入境旅遊統計數字 Statistics on Inbound Tourism

香港是一個充滿動感的都會,亦是區內國際旅客往來頻繁的旅遊中心。在二零零二年,香港接待的訪港旅客達 16.6 百萬人次。與入境旅遊相關的總開支達 774 億元,當中到港旅客的「境內消費開支」為 585 億元,而「國際客運服務開支」為 189 億元。本專題文章描述近年入境旅遊的最新趨勢。文中亦陳述「香港旅遊發展局」在二零零三年十一月所發布一套新的旅遊開支數列,並介紹旅遊開支數字在編製本地生產總值及國際收支平衡統計數字方面的應用。

Hong Kong is a dynamic metropolitan and a vibrant travel hub in the region. In 2002, Hong Kong received 16.6 million visitors. The total tourism expenditure associated with inbound tourism amounted to \$77.4 billion, comprising \$58.5 billion in *destination consumption expenditure* of incoming visitors and travellers and \$18.9 billion in *passenger international transportation expenditure*. This feature article describes the latest trend of inbound tourism. It highlights the new data series on tourism expenditure released by the Hong Kong Tourism Board in November 2003. It also describes the application of tourism expenditure statistics in the compilation of the Gross Domestic Product and Balance of Payments statistics.

#### 入境旅遊統計數字

#### **Statistics on Inbound Tourism**

#### 1. 引言

- 1.1 香港是一個充滿動感的都會,亦是區內國際旅客往來頻繁的旅遊中心。在二零零二年,香港接待的訪港旅客達 16.6 百萬人次。與入境旅遊相關的總開支達 774 億元,當中到港旅客的「境內消費開支」為 585 億元,而「國際客運服務開支」為 189 億元。
- 1.2 本專題文章描述近年入境旅遊的最新趨勢。文中亦陳述「香港旅遊發展局」(旅發局)在二零零三年十一月所發布一套新的旅遊開支數列,並介紹旅遊開支數字在編製本地生產總值及國際收支平衡統計數字方面的應用。

#### 2. 訪港旅客人次的最新趨勢

- 2.1 根據「世界旅遊組織」就旅遊統計的建議,旅遊是指個人離開慣常的環境到其他的地方,作消閑、商業及其他目的的旅遊活動,而停留在到訪地方的時間不連續多於一年。就統計的目的,旅遊量化的量度一般是以旅客人次的數目計算。「世界旅遊組織」的資料顯示,以國際旅客人次計算,香港在全球排行第 11 位。
- 2.2 在一九九八年至二零零二年間,訪港旅客 人次平均每年的增長率爲 13.0%。下列<u>表一</u>描 述訪港旅客的市場分布情况。這些數字是旅發 局根據訪港旅客向入境事務處填報的旅客抵港 申報表的資料,採用每六份抽選一份的樣本的 方式編製而成。
- 2.3 由於香港與中國內地(以下簡稱內地)毗鄰,兩地在社會及經濟方面有着緊密的聯繫,內地逐漸成爲香港的入境旅遊的一個主要市場。內地入境旅客人次佔訪港旅客總人次的比例由一九九八年的 26.3%增加至二零零二年的41.2%。在二零零二年,台灣及日本爲訪港旅客第二及第三大的市場,分別佔訪港旅客總人次的14.7%及8.4%。

#### 1. Introduction

- 1.1 Hong Kong is a dynamic metropolitan and a vibrant travel hub in the region. In 2002, Hong Kong received 16.6 million visitors. The total tourism expenditure associated with inbound tourism amounted to \$77.4 billion, comprising \$58.5 billion in destination consumption expenditure of incoming visitors and travellers and \$18.9 billion in passenger international transportation expenditure.
- 1.2 This feature article describes the latest trend of inbound tourism. It highlights the new data series on tourism expenditure released by the Hong Kong Tourism Board (HKTB) in November 2003. It also describes the application of tourism expenditure statistics in the compilation of the Gross Domestic Product (GDP) and Balance of Payments (BoP) statistics.

#### 2. Latest trend of visitor arrivals

- 2.1 According to the international recommendations for tourism statistics by the World Tourism Organization, tourism comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes. The volume of tourism, for statistical purposes, is generally measured by the number of visitor arrivals. According to information from the World Tourism Organization, Hong Kong ranked 11th in the world in terms of the number of international visitor arrivals.
- 2.2 Between 1998 and 2002, the number of visitor arrivals increased by 13.0% each year on the average. Table 1 below depicts the market composition of visitors. The data are compiled by the HKTB based on a one-in-six sample of completed arrival cards submitted by incoming visitors to the Immigration Department.
- 2.3 With the geographical proximity and close socio-economic ties between Hong Kong and the Mainland of China (the Mainland), the Mainland has become a major market for inbound tourism. The share of Mainland visitors of the total arrivals increased from 26.3% in 1998 to 41.2% in 2002. In 2002, the second and third largest markets are Taiwan and Japan, accounting for 14.7% and 8.4% of the total arrivals.

香港正發展成爲區內的主要旅遊中心及 前往內地的門戶。在地理上處於方便的位置、 完善的交通設施以及頻密的飛機航班是促成香 港成爲旅遊中心的一些因素。近年來出現了一 個旅遊的新趨勢,就是那些短暫停留並於訪港 即日離港的旅客(尤其是來自鄰近的經濟體系 如內地、台灣、日本等的旅客)的數量日漸增 加。該類旅客界定爲「入境不過夜旅客」。表二 顯示入境不過夜旅客佔訪港旅客總人次的比例 於近幾年持續增加,由一九九八年的 29.7%增 至二零零二年的 35.4%。於一九九八年至二零 零二年間, 訪港旅客的概況是: 訪港旅客總人 次的數目平均每年以 13.0%增加。一方面過夜 旅客的人次平均有 10.6% 雙位數字的增幅,而 入境不過夜旅客人次於一九九八年至二零零二 年間則錄得較強勁的平均每年 18.1%增幅。

Hong Kong is developing into a major travel hub in the region and gateway to the Mainland. Geographical convenience, well-developed transportation facilities and frequent flight schedules are some of the contributing factors. A new trend of travel has emerged in recent years. There are an increasing number of visitors, particularly those from the neighbouring economies (such as Mainland, Taiwan, and Japan) who make short visits to Hong Kong and leave on the same day of arrival. Such visitors are referred to as same-day in-town visitors. Table 2 below shows that the proportion of same-day in-town visitors has been on the rise in recent years, from 29.7% in 1998 to 35.4% in 2002. Thus, the general picture in recent years is that, between 1998 and 2002, overall visitor arrivals recorded an average rate of increase of 13.0% per year. While arrivals of overnight visitors recorded a double-digit average increase of 10.6% per year, increase in arrivals of same-day in-town visitors has been even more rapid with an average rate of increase of 18.1% per year between 1998 and 2002.

Notes: \* Visitors include overnight visitors, same-day in-town visitors and cruise-in/cruise-out passengers. Nevertheless, the number of cruise passengers is very small compared with the other two categories of vicitors.

3. 一套新的訪港旅客開支數列

- 3.1 旅發局爲入境旅遊統計數字的主要數據 提供者。旅發局不斷致力於改良旅遊統計數字 的素質,就旅遊統計的架構進行了檢討,並加 強了資料搜集的系統。因應這次檢討的結果, 旅發局所進行的「離境旅客問卷調查」的樣本 規模大幅增加。數據的涵蓋範圍亦比以往的更 加全面,尤其是因應不過夜旅客的訪港數字近 年迅速增長,更特別搜集該類旅客消費模式的 資料。
- 3.2 旅發局跟隨「世界旅遊組織」就旅遊統計的建議,於二零零三年十一月發布一套更加全面的與入境旅遊相關的開支數字,取代以往的「旅遊收益」數字。

## 3. New data series on tourism expenditure

- 3.1 HKTB is a main provider of inbound tourism statistics. As a continuing effort to improve the quality of tourism statistics, HKTB has undertaken a review of the statistical framework and revamped the data collection system. As a result of this review, HKTB's Departing Visitors Survey has been enhanced with a considerable increase in sample size. Data coverage is now more comprehensive than before, particularly in regard to the expenditure profile of same-day in-town visitors whose arrivals has been increasing rapidly in recent years.
- 3.2 In line with the recommendations for tourism statistics stipulated by the World Tourism Organization, HKTB released in November 2003 a more comprehensive set of data namely tourism expenditure associated with inbound tourism to replace the previous set of data on "tourism receipts".

- 3.3 新一套的旅遊開支數字包括以下兩個主要組成部分:
  - (1) **到港旅客的境內消費開支**:包括過夜旅客、入境不過夜旅客、郵輪旅客、軍人、 機組人員及過境旅客在本港於貨品及服 務的開支。
  - (2) **國際客運服務開支**:是指本港客運公司為非本港居民提供航空、海上或陸上的國際<sup>(1)</sup>客運服務所得的收益。
- 3.4 新一套數據與以往的數字比較,旅客開 支總額的涵蓋範圍已擴大至包括郵輪旅客的開 支及國際客運服務開支。而且,到港旅客境內 消費開支的估計亦更爲精細,分別有過夜旅客 及入境不過夜旅客開支的分項估計數字。
- 3.5 為提供可比較資料作旅遊開支趨勢分析,旅發局與政府統計處合作,根據新的模式 將以前的數列追溯至一九八八年。(表三)
- 3.6 二零零二年入境旅遊相關開支的總值達774億元,較二零零一年增長25.3%。同期間,隨着訪港旅客人次增加20.7%,境內消費開支增長了27.1%。而二零零二年的國際客運服務開支較二零零一年則增加20.0%。

- 3.3 The new set of tourism expenditure data comprises the following two main components:
  - (1) Destination consumption expenditure of incoming visitors and travellers, which include the expenditure on goods and services in Hong Kong by overnight visitors, same-day in-town visitors, cruise passengers, servicemen, aircrew members and transit/transfer passengers.
  - (2) Passenger international transportation expenditure, which are the receipts of Hong Kong-based carriers for international transportation of non-resident visitors by air, sea or land.
- 3.4 Compared with the previous set of data, the coverage of tourism expenditure in the new set of data is expanded to include expenditure of cruise passengers and expenditure of passengers in international transportation. Furthermore, the estimation of destination consumption expenditure of incoming visitors and travellers is refined with separate constituent estimates for overnight visitors and same-day in-town visitors.
- 3.5 To provide comparable data for analysis of the trend of tourism expenditure, the historical data series have been backdated to 1988 based on the new framework by HKTB, in collaboration with the Census and Statistics Department (C&SD). (Table 3)
- 3.6 In 2002, tourism expenditure associated with inbound tourism amounted to \$77.4 billion, representing an increase of 25.3% in value terms over 2001. Over the same period, destination consumption expenditure increased by 27.1%, in tandem with the increase of visitor arrivals by 20.7%. In 2002, passenger international transportation expenditure increased by 20.0% over 2001.

3.7 二零零二年過夜旅客於本港的人均消費開支爲 4,904 元,而入境不過夜旅客於本港的人均消費開支則爲 620 元。 表四載列按主要市場區域劃分過夜旅客及入境不過夜旅客的境內消費開支和人均消費的分項數字。上述資料及有關旅客消費的詳細資料刊載於旅發局於二零零三年十一月出版的《與入境旅遊相關的開支2002 年 1 至 12 月份》。

3.7 In 2002, the average per capita spending in Hong Kong for overnight visitors was \$ 4,904. For same-day in-town visitors, the average per capita spending in Hong Kong was \$620. Table 4 provides data breakdown on destination consumption expenditure and per capita spending of overnight visitors and same-day in-town visitors by major market area. These data, and further data on the subject, are contained in the report "Tourism Expenditure Associated to Inbound Tourism January – December 2002" issued in November 2003 by HKTB.

4. 旅客開支數據於編製本地生產總值 和國際收支平衡統計數字的應用

## 旅客開支與相關的本地生產總值組成部分

- 4.1 以開支面編製本地生產總值的架構下,到港旅客的境內消費開支屬於服務輸出下的「旅遊服務輸出」。境內消費開支數字亦用作編製私人消費開支的估計數字。私人消費開支的一個主要組成部分爲本地居民住戶在本地的消費開支,其計算方法是本地市場的消費開支總額扣除旅客(非本地居民)在本地的消費開支總額扣除旅客(非本地居民)在本地的消費開支維算而得。本地市場的消費開支總額是根據政府統計處的統計調查所搜集的數據及其他資料編製而成,而資料來源獨立於旅發局的「離境旅客問卷調查」。
- 4.2 因應旅發局所發布一套新的境內消費開 支數字,服務輸出及私人消費的數字亦作出相 應修訂。即服務輸出(向下修訂)和私人消費 開支(向上修訂)按相同數值,但相反方向作 修訂。因此,更精確地計算到港旅客境內消費 開支的數字,對本地生產總值的總體數值完全 沒有影響。經納入一套新的境內消費開支數字 後的私人消費開支和服務輸出追溯至一九八六 年的數字載於表五。

# 4. Application of tourism expenditure data in the compilation of GDP and BoP statistics

## Tourism expenditure and relevant expenditure components of GDP

- 4.1 Under the compilation framework for GDP by the expenditure approach, destination consumption expenditure of incoming visitors and travellers comes under exports of services (XS) as "exports of travel services". Destination consumption expenditure data are also used in compiling the estimates of private consumption expenditure (PCE). Being a main component of PCE, the estimate of resident household consumption expenditure in the domestic market of Hong Kong is derived from total consumption expenditure in the domestic market (CXDM) after deducting the expenditure of incoming visitors and travellers (non-residents) in Hong Kong. The estimates on CXDM are based on statistical surveys conducted by the C&SD and other sources which are independent of the Departing Visitors Survey conducted by HKTB.
- 4.2 With the release of new data on destination consumption expenditure by HKTB, the estimates of XS and PCE have been revised accordingly. The estimates of XS and PCE are revised to the same absolute magnitude yet in the opposite direction, with XS down and PCE up. Thus, the refinement made to the data on destination consumption expenditure of incoming visitors and travellers does not lead to any change in the overall GDP. With the new destination consumption expenditure data incorporated, the data series of PCE and XS backdated to 1986 are given in Table 5.

#### 旅客開支數據與國際收支平衡統計數字

- 4.3 國際收支平衡是量度香港與世界其他各地的經濟交易。由於入境旅遊涉及本地居民生產者與非本地居民旅客間的經濟交易,與入境旅遊相關的開支屬於國際收支平衡架構下服務輸出的相關組成部分。
- 4.4 境內消費開支被分類爲國際收支平衡表下服務帳內的「服務,旅遊,貸方」。國際客運服務開支被分類爲服務帳內的「運輸,客運服務,貸方」。境內消費開支數據是由旅發局所進行的「離境旅客問卷調查」所得來的資料編製。國際客運服務開支數據則透過政府統計處所進行的統計調查所得的資料編製。

## Tourism expenditure data and BoP statistics

- 4.3 BoP measures the economic transactions of the Hong Kong economy with the rest of the world. As inbound tourism involves economic transactions between resident producers with non-resident visitors, tourism expenditure associated with inbound tourism correspond to relevant components of exports of services in the BoP framework.
- Destination consumption expenditure is classified as "Services, Travel, Credit" under the services account of BoP. Passenger international transportation expenditure is classified "Transportation, Passenger Services, Credit" under services account. Data of destination consumption expenditure are compiled on data from the Departing Visitors Survey conducted by HKTB. Data on passenger international transportation are compiled on data from statistical surveys conducted by the C&SD.

- 4.5 旅發局於二零零三年十一月所公布一套新的境內消費開支數列已被納入國際收支平衡統計數字。境內消費開支資料的改變會導致服務貿易的差額,以致經常帳的差額作出同等數值的改變。然而,整體國際收支完全不受影響,這是由於整體國際收支是反映官方儲備的改變,是由另一個資料來源所確定。不過,經常帳數字的改變,會對國際收支平衡表內的「淨誤差及遺漏」這個項目,產生數值相同但方向相反的相應調整。
- 4.6 就一套新的到港旅客的境內消費開支數字而引致服務輸出的向下修訂,二零零一年及二零零二年的服務貿易盈餘分別向下修訂至1,152億元及1,445億元。二零零一年及二零零二年的經常帳盈餘亦分別向下修訂至775億元及1,181億元,相對這兩年的本地生產總值的比率分別爲6.1%及9.4%。追溯至一九九七年的數列載列於表六。
- 4.5 The new data series on destination consumption expenditure recently released by HKTB in November 2003 has been incorporated into the BoP The change to the destination statistics. consumption expenditure data leads to the same change in absolute amount in the balance of trade in services, and hence also the same change in absolute the current account amount in Nevertheless, the overall BoP balance, being the exact mirror image of the change in official reserves which is ascertained from a separate source, is totally unaffected. Yet a parallel adjustment, to the same absolute amount as with the change on the current account balance but in opposite direction, is made to net errors and omissions in the BoP account.
- 4.6 With the new set of data on destination consumption expenditure of incoming visitors and travellers leading to lower exports of services, the surplus in trade in services is revised down to \$115.2 billion in 2001 and \$144.5 billion in 2002. Thus, the current account surplus is also revised down, to \$77.5 billion in 2001 and \$118.1 billion in 2002, corresponding to 6.1% and 9.4% of GDP in those two years. The data series backdated to 1997 are given in Table 6.






