1991 年至 2024 年香港的結婚及離婚趨勢

Marriage and Divorce Trends in Hong Kong, 1991 to 2024

這篇文章概述 1991 年至 2024 年期間香港的結婚及離婚趨勢。

男性及女性遲婚或不結婚的情況越趨普遍。在 2021 年，30.9% 的男性及 27.0% 的女性從未結婚（數字不包括外籍家庭傭工）。男性和女性首次結婚時的年齡中位數，分別從 1991 年的 29.1 歲和 26.2 歲，上升至 2024 年的 32.6 歲和 31.0 歲。香港的登記結婚數目由 1991 年的 42 568 宗下降至 2001 年 32 825 宗，隨後逐漸回升至 2012 年的 60 459 宗，之後再呈大致下降趨勢。2024 年的登記結婚數目為 44 196 宗。另一方面，香港女性與內地男性結婚的情況越趨普遍，其佔所有跨境婚姻的比例由 1991 年的 6.1% 大幅上升至 2024 年的 40.0%。此外，離婚的數目在過去約 30 年亦有所上升，以每千名人口計算的粗離婚率由 1991 年的 1.11 人上升至 2024 年的 2.52 人。

This article provides an overview on the marriage and divorce trends in Hong Kong from 1991 to 2024.

There has been an increasing tendency towards marriage postponement or non-marriage in both genders. In 2021, 30.9% of males and 27.0% of females had never been married (figures excluding foreign domestic helpers). The median ages at first marriage for males and females increased from 29.1 and 26.2 in 1991 to 32.6 and 31.0 in 2024 respectively. The number of registered marriages in Hong Kong decreased from 42 568 in 1991 to 32 825 in 2001 and gradually rebounded to 60 459 in 2012. A general downward trend resumed afterwards, with 44 196 registered marriages in 2024. On the other hand, Hong Kong females marrying Mainland males has become more common. The proportion of such marriages to all cross-boundary marriages increased significantly from 6.1% in 1991 to 40.0% in 2024. Furthermore, the number of divorces increased in the past 3 decades or so, with the crude divorce rate (per 1 000 population) increased from 1.11 in 1991 to 2.52 in 2024.

1991 年至 2024 年香港的結婚及離婚趨勢

Marriage and Divorce Trends in Hong Kong, 1991 to 2024

1. 引言

1.1 由於結婚及離婚行為影響家庭的組成、家庭結構及生育，因此人口學家及普羅大眾對結婚及離婚行為均感興趣。

1.2 這篇文章利用人口普查／中期人口統計所搜集的資料，以及登記結婚和獲頒布離婚令的行政紀錄，概述香港人口在 1991 年至 2024 年期間的結婚及離婚趨勢。

2. 人口的婚姻狀況趨勢

2.1 人口的婚姻狀況趨勢可由過去人口普查／中期人口統計的統計數字中分析。人口的性別分布和年齡結構對婚姻狀況的統計數字有很大影響。因此，此章節運用標準化百分比，即根據「2021 年人口普查」參考時刻的人口年齡及性別分布情況作為標準而計算，讓不同年份的婚姻狀況統計數字能在統一的基礎上比較，以作分析。

2.2 撇除外籍家庭傭工，15 歲及以上從未結婚男性的標準化百分比由 1991 年的 22.4%，平穩上升至 2021 年的 30.9%。而女性的從未結婚標準化百分比則由 1991 年的 15.2% 上升至 2021 年的 27.0%。上升趨勢反映男女均趨向遲婚或不結婚。（表 1）

2.3 香港已婚男女的標準化百分比在 1991 年至 2021 年間持續下跌，與從未結婚比例的升勢形成對比。已婚男性的標準化百分比由 1991 年的 71.6% 跌至 2021 年的 62.0%。已婚女性的跌幅更大，由 1991 年的 65.7% 跌至 2021 年的 55.4%。（表 1）

1. Introduction

1.1 Marriage and divorce behaviours are of interest to both demographers and the general public as they shed light on family formation, family composition and fertility.

1.2 This article provides an overview on the marriage and divorce trends of the Hong Kong population from 1991 to 2024, using information obtained from population censuses/by-censuses and administrative records of registered marriages and divorce decrees granted.

2. Trend in marital status of the population

2.1 Trend in the marital status of the population can be analysed using data obtained from past population censuses/by-censuses. Statistics on marital status are very much affected by the age and sex structures of the population. Therefore, in the ensuing paragraphs under this section, standardised percentages, as computed using the age-sex structure of the population at the reference moment of the 2021 Population Census as standard, are adopted so that comparison over different years can be done on the same basis.

2.2 Excluding foreign domestic helpers, the standardised percentage of never married males aged 15 and over increased gradually from 22.4% in 1991 to 30.9% in 2021. That of females also increased from 15.2% in 1991 to 27.0% in 2021. The increasing trend reflected the tendency towards marriage postponement or non-marriage in both genders. (Table 1)

2.3 In contrast to the increasing proportion of never married population, the standardised percentages of married Hong Kong males and females dropped continuously from 1991 to 2021. While that of married males decreased from 71.6% in 1991 to 62.0% in 2021, a larger decline was observed for married females from 65.7% in 1991 to 55.4% in 2021. (Table 1)

2.4 在 2021 年，男性及女性的標準化離婚／分居百分比分別是 4.8% 及 7.2%。在所有選定比較年份中，離婚／分居女性的比例均較男性高，這與離婚男性再結婚的傾向高於離婚女性有關。（表 1）

2.4 In 2021, the standardised percentages of divorced/separated persons were 4.8% for males and 7.2% for females. The proportions of divorced/separated females were higher than that of males in all the selected years under comparison, which was related to the greater tendency of remarriage by divorced males than divorced females. (Table 1)

3. 結婚

3.1 香港的登記結婚數目由 1991 年的 42 568 宗下降至 2001 年的 32 825 宗，隨後逐漸回升至 2012 年的 60 459 宗，之後再呈大致下降趨勢。2024 年的登記結婚數目為 44 196 宗。期間因受 2019 冠狀病毒病疫情的影響，登記結婚數目曾一度大幅下跌至 2021 年的 26 899 宗，為過去約 30 年最低。此外，2021 年男性及女性的粗結婚率亦同為過去約 30 年最低。（表 2）

3.2 在過去約 30 年，再婚的情況越趨普遍。再婚數目（其中一方或雙方屬再婚）由 1991 年的 4 892 宗大幅上升至 2024 年的 20 971 宗。在 2024 年的所有登記結婚數目中，47.4% 屬再婚，比例顯著高於 1991 年的 11.5%。（表 2）

3.3 男性和女性首次結婚時的年齡中位數，分別從 1991 年的 29.1 歲和 26.2 歲，上升至 2024 年的 32.6 歲和 31.0 歲。反映遲婚的趨勢持續。雖然相比女性來說，男性仍較遲結婚，但差距由 1991 年的 2.9 歲收窄至 2024 年的 1.6 歲。（表 3）

3. Marriage

3.1 The number of registered marriages in Hong Kong decreased from 42 568 in 1991 to 32 825 in 2001 and gradually rebounded to 60 459 in 2012. A general downward trend resumed afterwards, with 44 196 registered marriages in 2024. During this period, the number of registered marriages once dropped substantially to 26 899 in 2021, the lowest in the past 3 decades or so, amidst the impact of COVID-19 pandemic. Moreover, the respective crude marriage rates for males and females in 2021 were also the lowest recorded in the past 3 decades or so. (Table 2)

3.2 Remarriages has become more common in the past 3 decades or so. The number of remarriages (either or both parties have married before) rose significantly from 4 892 in 1991 to 20 971 in 2024. Remarriages constituted 47.4% of all registered marriages in 2024, notably higher than that in 1991, at 11.5%. (Table 2)

3.3 The median ages at first marriage for males and females increased from 29.1 and 26.2 in 1991 to 32.6 and 31.0 in 2024 respectively. It's reflecting the continued trend of marriage postponement. Although males continued to marry at older ages than females, the gap narrowed from 2.9 years in 1991 to 1.6 years in 2024. (Table 3)

4. 內地與香港跨境婚姻

4.1 在過去約 30 年來，有不少香港與中國內地（內地）居民的跨境婚姻。這些婚姻可循下列兩個途徑進行：（i）香港居民可在香港申請無結婚紀錄證明書，然後到內地結婚；以及（ii）內地居民可以遊客身分來港與香港居民登記結婚。

4.2 隨着香港與內地交往頻繁，很多跨境婚姻是透過日常交往而產生，例如工作和學習交流等。跨境婚姻在近年亦出現結構性的轉變。

4. Mainland-Hong Kong cross-boundary marriages

4.1 There have been a significant number of cross-boundary marriages between residents of Hong Kong and Chinese Mainland (Mainland) over the past 3 decades or so. These marriages may take place in two ways: (i) Hong Kong residents may apply for a Certificate of Absence of Marriage Record (CAMR) and get married in Mainland; and (ii) Mainland residents may come to Hong Kong as a visitor and register their marriages with Hong Kong residents.

4.2 In view of the closer ties between Hong Kong and Mainland, many cross-boundary marriages occurred as a result of routine social contact, such as work and study. Some structural changes have also been observed in cross-boundary marriages in recent years.

4.3 早年的跨境婚姻絕大多數是香港男性與內地女性結婚，在 1991 年有 21 220 宗，佔該年所有跨境婚姻的 93.9%，而香港女性與內地男性的婚姻則只有 1 390 宗，佔餘下 6.1%。然而，近年新娘為香港女性的跨境婚姻有上升趨勢。2024 年的跨境婚姻數目為 26 790 宗，其中 10 712 宗（40.0%）為香港女性與內地男性結婚。（表 4 及圖 1）

4.4 此外，在跨境婚姻中新郎與新娘的年齡差異有收窄的趨勢。由於「無結婚紀錄證明書」的申請無須提供內地配偶的資料，而早年的跨境婚姻以「無結婚紀錄證明書」的個案為主，以下分析只涵蓋自 2006 年起在香港登記的婚姻。2006 年香港男性與內地女性的跨境婚姻中，新郎普遍比新娘年長甚多，新郎比新娘年長 5 年或以上的比例為 69.0%，年齡差異中位數為 9 年。在 2024 年，香港新郎與內地新娘的年齡差異明顯減少，新郎比新娘年長 5 年或以上的比例降至 53.8%，年齡差異中位數亦降至 5 年。至於香港女性與內地男性的婚姻，新郎和新娘的年齡差異一般較少，自 2006 年起年齡差異中位數一直維持在 1 年或以下。而且，新娘比新郎年長的情況，在香港女性與內地男性的婚姻中相對較為普遍，在 2024 年佔 49.1%，遠高於香港男性與內地女性的婚姻中的相應比例（15.2%）。（表 5）

4.3 In the earlier years, the vast majority of cross-boundary marriages were marriages between Hong Kong males and Mainland females, with 21 220 such marriages in 1991, accounting for 93.9% of all cross-boundary marriages that year. There were only 1 390 marriages between Hong Kong females and Mainland males, accounting for the remaining 6.1%. However, there has been a rising trend of brides being Hong Kong females in cross-boundary marriages in recent years. In 2024, there were 26 790 cross-boundary marriages, among which 10 712 (40.0%) were marriages between Hong Kong females and Mainland males. (Table 4 and Chart 1)

4.4 Moreover, there has been a narrowing of the age gap between the bridegroom and the bride in cross-boundary marriages. Since information about Mainland spouse is not required in CAMR applications, and CAMR cases accounted for the majority of cross-boundary marriages in earlier years, only marriages registered in Hong Kong since 2006 are covered in the analysis below. In 2006, the bridegroom was generally much older than the bride in cross-boundary marriages between Hong Kong males and Mainland females. In 69.0% of such marriages, the bridegroom was older than the bride by 5 years or more, with a median age difference of 9 years. In 2024, the age difference between the Hong Kong bridegroom and the Mainland bride decreased notably. The proportion of bridegroom being older than the bride by 5 years or more dropped to 53.8%, and the median age difference also dropped to 5 years. As for marriages between Hong Kong females and Mainland males, the age difference between the bridegroom and the bride was generally smaller, with a median age difference of 1 year or less since 2006. Furthermore, the situation of the bride being older than the bridegroom was relatively more prevalent in marriages between Hong Kong females and Mainland males, accounting for 49.1% of such marriages in 2024. This was notably higher than the corresponding proportion observed in marriages between Hong Kong males and Mainland females, which was 15.2% in 2024. (Table 5)

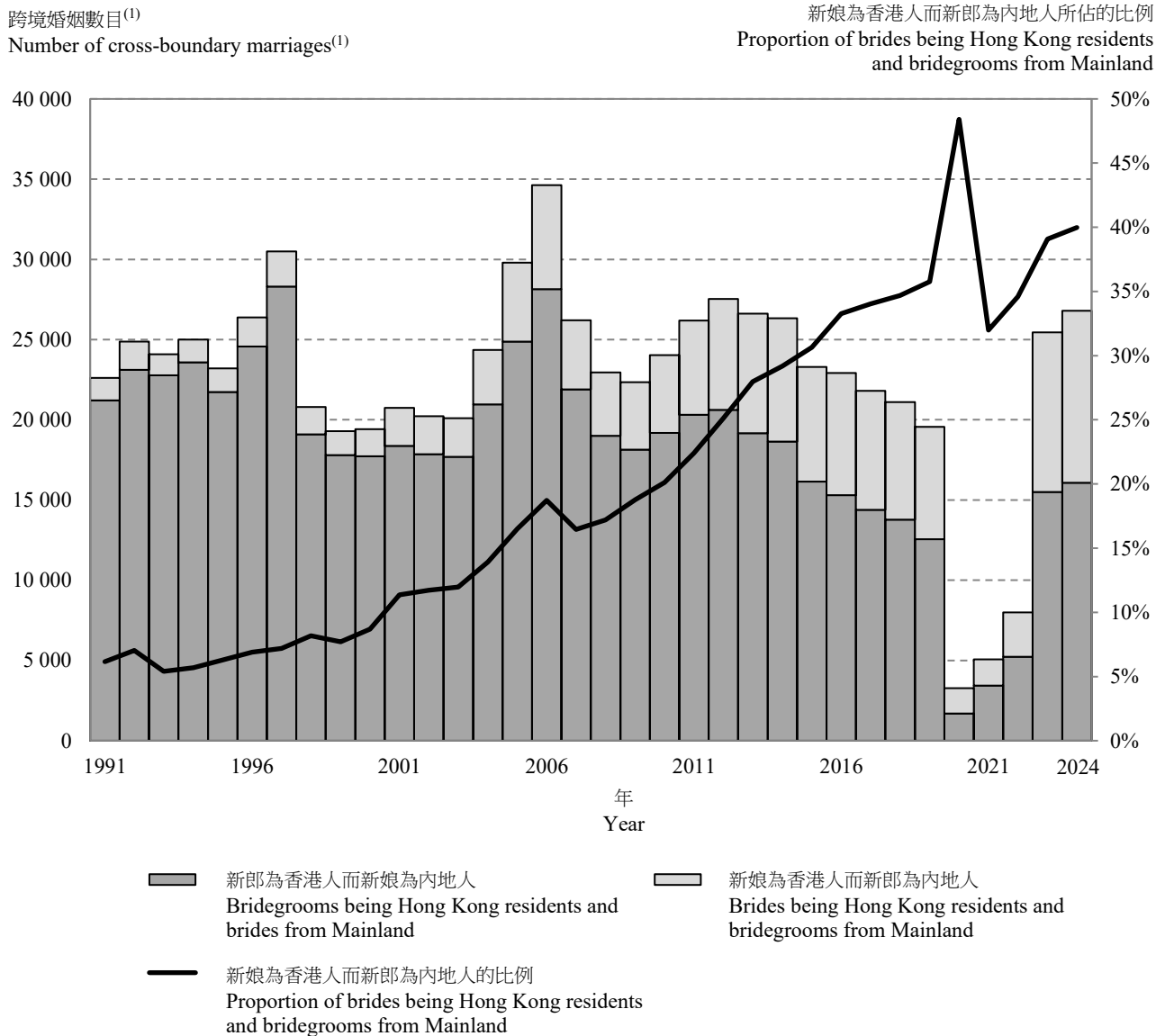
註釋：(1) 2010 統計年度以前的數字是根據入境事務處按月提供的個人結婚登記紀錄內的兩項資料，即「來港前居住的地方」是中國內地和「在香港的逗留時間」少於 1 年，來估算內地新郎／新娘的數字。這數字可能包括持有單程通行證來港並於不足 1 年內結婚的人士。然而，有關數字仍是提供跨境婚姻統計一個很好的指標。由 2010 統計年度起，除上述兩項資料外，採用更多相關的資料（例如所持旅行證件類別）用以改良內地新郎／新娘的估算。

(2) 由於獲發「無結婚紀錄證明書」（聲稱作為在中國內地申請結婚之用）人士最後未必結婚，數字只能作跨境婚姻統計的一個粗略指標。

Notes: (1) Before the reference year of 2010, the figures of bridegrooms/brides from Mainland are estimated with reference to two data items in the individual registered marriage records provided by the Immigration Department on a monthly basis, viz. "place of previous residence" being in Chinese Mainland and "duration of stay in Hong Kong" being less than one year. The figure thus compiled might have included one-way permit holders entering Hong Kong and getting married in less than one year. Nevertheless, it still provides a good proxy indicator to cross-boundary marriage statistics. Since the reference year of 2010, besides the above two data items, more information (e.g. holding of travel document type) is used to enhance the estimates of bridegrooms/brides from Mainland.

(2) Since the issuance of Certificate of Absence of Marriage Records (claimed for the purpose of marrying in Chinese Mainland) may not eventually lead to marriages, the figures only serve as a proxy indicator to cross-boundary marriage statistics.

5. 離婚

5.1 2019 冠狀病毒病疫情期間，獲頒布離婚判令的數目一度回落至 2022 年的 13 026 宗。然而，隨著社會復常，2024 年的獲頒布離婚判令的數目已回升至 18 938 宗，數目約是 1991 年的 3 倍。撇除人口增長的影響，粗離婚率（即獲頒布離婚判令的數目相對年中人口的比率）在 1991 年至 2024 年間仍急速增加。2024 年以每千名人口計算的粗離婚率是 2.52 人，遠高於 1991 年的 1.11 人。（表 6）

5. Divorce

5.1 During the COVID-19 pandemic, the number of divorce decrees granted once declined to 13 026 in 2022. However, with the resumption of normalcy, the number of divorce decrees granted rebounded to 18 938 in 2024, about tripled the number in 1991. Eliminating the effect of population growth, the crude divorce rate, which relates the number of divorce decrees granted to the mid-year population, still increased rapidly over the period from 1991 to 2024. In 2024, the crude divorce rate was 2.52 per 1 000 population, far higher than the rate of 1.11 in 1991. (Table 6)
