金融服務、貿易及物流、旅遊和工商業支援及專業服務是香港經濟的四個主要行業。這四個主要行業帶動其他行業的發展，並且製造就業，是香港經濟動力所在。

有關四個主要行業在二零零九年對本港經濟貢獻及各行業的就業情況，政府統計處曾在二零一一年四月出版的《香港統計月刊》一篇專題文章中加以分析。本文加入了四個主要行業在二零一零年的統計數字，是二零一一年四月出版的專題文章的更新版。

Financial services, trading and logistics, tourism, and producer and professional services are the Four Key Industries in the Hong Kong economy. They have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment.

A feature article analysing the economic contribution and employment situation in 2009 in respect of the Four Key Industries was published in the April 2011 issue of the *Hong Kong Monthly Digest of Statistics*. This article is an updated version of the article published in April 2011, with figures on the Four Key Industries for 2010 incorporated.

香港經濟四個主要行業在二零一零年的情況

The Situation of the Four Key Industries in the Hong Kong Economy in 2010

1. 引言

1.1 金融服務、貿易及物流、旅遊¹和工商業支援及專業服務是香港經濟的四個主要行業。這四個主要行業帶動其他行業的發展，並且製造就業，是香港經濟動力所在。

1.2 有關四個主要行業在二零零九年對本港經濟貢獻（以增加價值量度）及各行業的就業情況，政府統計處曾在二零一一年四月出版的《香港統計月刊》一篇專題文章中加以分析。本文加入了四個主要行業在二零一零年的統計數字，是二零一一年四月出版的專題文章的更新版。

2. 金融服務

2.1 金融服務的涵蓋範圍廣泛，包括銀行、保險、證券經紀、資產管理及其他金融服務。香港是主要的國際金融中心，為市場使用者（包括本地和境外使用者，以及零售和機構使用者）提供多元化產品及服務。香港的銀行從事多方面的零售及批發銀行業務，例如接受存款、貿易融資、公司財務、財資活動及證券經紀業務。此外，香港是投資股票、單位信託和互惠基金的區域中心。在二零一零年年底，香港交易及結算所有限公司在亞洲排名第三，僅次於東京證券交易所及上海證券交易所。香港的股票市場亦是內地企業的重要集資平台。

1 嚴格來說，旅遊是一個服務界別，而不是一個行業，因為旅遊只包括橫跨不同行業（例如零售業）的經濟活動中與服務旅客有關的部分。很多行業，例如零售業和餐飲服務，都同時提供服務給旅客和本地居民。

1. Introduction

1.1 Financial services, trading and logistics, tourism¹, and producer and professional services are the Four Key Industries in the Hong Kong economy. The Four Key Industries have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment.

1.2 A feature article analysing the economic contribution (in terms of value added) and employment situation in 2009 in respect of the Four Key Industries was published in the April 2011 issue of the *Hong Kong Monthly Digest of Statistics*. This article is an updated version of the article published in April 2011, with figures on the Four Key Industries for 2010 incorporated.

2. Financial Services

2.1 Financial services cover a wide range of services including banking, insurance, stock brokerage, asset management, and other financial services. Hong Kong is a major international financial centre, providing a wide range of products and services to market users, both local and international, and both retail and institutional. Banks in Hong Kong engage in a wide range of retail and wholesale banking business such as deposit taking, trade financing, corporate finance, treasury activities and securities broking. Besides, Hong Kong is the regional centre for trading of shares, unit trusts and mutual funds. As at the end of 2010, the Hong Kong Exchanges and Clearing Limited was the third largest in Asia, after Tokyo Stock Exchange Group, Inc. and Shanghai Stock Exchange. The Hong Kong stock market is also an important fund-raising platform for Mainland enterprises.

1 Strictly speaking, tourism is a service domain rather than an industry, because tourism comprises only those parts of economic activities straddling different industries (e.g. retail trade) which serve visitors. Many industries including, for example, retail trade and food and beverage services, serve both visitors and local residents.

2.2 保險服務亦歸類為金融服務²。香港的保險服務主要包括人壽保險及一般保險（例如：醫療保險、火險及其他財產損壞保險）。

2.3 在二零一零年，金融服務的增加值合共2,620 億港元，在二零零五年為 1,721 億港元，每年平均增長 8.8%。金融服務佔本地生產總值的百分比由二零零五年的 12.7%增加至二零一零年的 15.4%，而就業人數在二零一零年有 219 500 人，佔總就業人數的 6.3%。（表一）

2.2 Insurance services are also classified as financial services². Insurance services in Hong Kong mainly cover life insurance and general insurance (e.g. medical insurance and insurance for fire and other damages to property).

2.3 The value added of financial services amounted to HK\$262.0 billion in 2010, increasing at an average annual rate of 8.8% from HK\$172.1 billion in 2005. Its share in Gross Domestic Product (GDP) increased from 12.7% in 2005 to 15.4% in 2010. The number of persons engaged in financial services in 2010 was 219 500, or 6.3% of total employment. (Table 1)

2 保險服務與一般銀行服務一樣，在本地生產總值編製手冊《國民經濟核算體系》中，亦被歸類為金融中介服務。

2 Similar to normal banking services, insurance is also classified as financial intermediation services in the *System of National Accounts* which is a manual for the compilation of GDP.

3. 貿易及物流

3.1 物流是指籌劃、實施和控制貨物（包括原材料、半製成品和製成品）、服務及相關資訊從來源地至使用地的運送及儲存的過程。因此，物流活動橫跨以「香港標準行業分類」界定的幾個行業，包括貨運³、貨運代理、倉庫、郵政及速遞服務，而物流服務⁴的統計數據可以從這幾種經濟活動的增加價值的總和估算出來。

3.2 有效率的物流服務可縮短貨物從供應商運送到客戶的時間，因而減低貨物儲存量及節省成本，有助提高生產力。

3.3 貿易公司⁵與物流活動有緊密的聯繫。很多時候這些貿易公司都會參與籌劃和監察上文第 3.1 段所提及的物流活動。為方便分析，貿易服務⁶與物流服務的經濟貢獻和就業情況的統計數據會一併陳列在本專題文章中。

3 就以香港作基地的航空公司及直升機公司，以及其他航空運輸服務而言，航空貨運服務的增加值和就業數字是按該行業的貨運收入相對於客運收入及貨運收入之和的比例來估算。

4 應注意的是一間公司是否被分類為物流服務公司是根據該公司的主要業務而定。因此，一些內部有物流支援活動，但主要從事非物流服務的公司，其增加值和就業數據並不包括在本專題文章的物流服務統計數據中。例如，一間主要從事進出口貿易公司內的航運業務部門的生產額是歸納入進出口貿易業的。

5 這裏的貿易公司是指進出口和批發貿易公司。零售商不包括在內，因為零售業主要的銷售對象是本地顧客，與國際貿易沒有直接關係。

6 貿易服務是工商業支援服務（請參閱第 5.1 段的有關定義），因差不多所有進出口貿易商的銷售都是賣給本地的批發／零售商或境外買家。由於貿易服務有重大的經濟貢獻及與物流服務有緊密的關係，因此貿易服務的分析載列在這貿易及物流服務的一節內而不載列在其他工商業支援服務的一節內。

3. Trading and Logistics

3.1 Logistics refers to the process of planning, implementing and controlling the movement and storage of goods (including raw materials, goods in progress and finished goods), services and related information from the point of origin to the point of consumption. Hence, the activities of logistics cut across a number of economic activities as defined in the Hong Kong Standard Industrial Classification. These include freight transport³, freight forwarding, storage, postal and courier services. Statistics on logistics services⁴ can therefore be estimated by adding up the figures on these economic activities.

3.2 Effective logistics services contribute to productivity growth, as the time taken to deliver goods from the suppliers to the customers is shortened and this results in lower inventory levels and cost savings.

3.3 Trading firms⁵ are closely associated with logistics activities. In many instances, these firms are involved in the planning and monitoring of the logistics activities mentioned in paragraph 3.1 above. For analytical purposes, statistics on the economic contribution and employment situation of trading services⁶ are presented together with those in respect of logistics services in this article.

3 For Hong Kong-based airline and helicopter companies as well as air transport services not elsewhere classified, figures on value added and employment of air freight transport are estimated by prorating the corresponding figures by the share of freight revenue in the sum of passenger revenue and freight revenue.

4 It should be noted that classification of a firm into logistics or otherwise is based on the principal activity of the firm. Hence, for firms with supportive in-house logistics activities but principally engaged in non-logistics activities, their value added and employment are not accounted for in statistics of logistics presented in this article. For example, the output of an in-house shipping department of a firm primarily engaged in import and export trade is accounted for in the import and export trade.

5 Trading firms here refer to import/export and wholesale trading firms. Retail firms are not included as they involve primarily sales to local customers and are not directly related to international trade.

6 Trading services are producer services (please refer to paragraph 5.1 for the definition), as nearly all sales of importers/exporters are to local wholesalers/retailers or buyers abroad. In view of the substantial economic contribution of the trading services and their close relationship with logistics services, analyses of trading services are presented here in the section of trading and logistics services rather than in the section of other producer services.

3.4 香港的貿易公司從事兩類主要貿易活動：（一）傳統貿易活動，即從本港及本港以外地區（特別是中國內地）採購貨物再經本港轉口到其他經濟體系；以及（二）離岸貿易活動，即從香港以外地區採購貨物後將貨物轉售至香港以外地區，而有關貨物並沒有進出本港。在二零一零年，進出口貿易的增加價值中，傳統貿易佔 54%，離岸貿易及其他活動則佔 46%。

3.5 以對香港經濟的貢獻而言，貿易及物流服務在二零一零年為香港帶來 4,345 億港元的增加價值，佔本地生產總值的 25.5%，而就業人數在二零一零年有 785 900 人，佔總就業人數的 22.4%。（表二）

3.6 貿易在貿易及物流服務中佔主要部分。貿易在二零一零年的增加價值為 3,521 億港元，在二零零五年為 3,181 億港元，每年平均增長 2.1%。貿易服務佔本地生產總值的百分比由二零零五年的 23.4%減少至二零一零年的 20.7%，而就業人數在二零一零年有 591 100 人。（表二）

3.7 至於物流，在二零一零年的增加價值達 824 億港元，在二零零五年為 703 億港元，每年平均增長 3.2%。按物流服務的類別分析，貨運及倉庫服務的增加價值由二零零五年的 646 億港元上升至二零一零年的 768 億港元，每年平均升幅為 3.5%，增長主要來自航空貨運服務。同時，郵政及速遞服務的增加價值由二零零五年的 57 億港元減少至二零一零年的 56 億港元，每年平均下跌 0.2%。（表二）

3.4 Hong Kong's trading firms are engaged in two main types of trading activities : (i) conventional trading activities which involve sourcing goods locally and elsewhere (particularly from the mainland of China) for re-exports through Hong Kong to other economies; and (ii) offshore trading activities which involve sourcing goods from and selling goods to parties outside Hong Kong, without the goods passing through Hong Kong. In terms of value added of import and export trade in 2010, 54% was related to conventional trade, and 46% to offshore trade and other activities.

3.5 In terms of economic contribution, trading and logistics services generated value added of HK\$434.5 billion in 2010, accounting for 25.5% of GDP. The number of persons engaged was 785 900 in 2010, or 22.4% to total employment. (Table 2)

3.6 Trading accounted for the main part of trading and logistics services. Its value added amounted to HK\$352.1 billion in 2010, increasing at an average annual rate of 2.1% from HK\$318.1 billion in 2005. Its share in GDP decreased from 23.4% in 2005 to 20.7% in 2010. The number of persons engaged was 591 100 in 2010. (Table 2)

3.7 As regards logistics, its value added amounted to HK\$82.4 billion in 2010, increasing at an average annual rate of 3.2% from HK\$70.3 billion in 2005. Analysed by the type of logistics services, the value added of freight transport and storage services increased at an average annual rate of 3.5% from HK\$64.6 billion in 2005 to HK\$76.8 billion in 2010. The major contribution to growth came from air freight transport services. Meanwhile, the value added of postal and courier services decreased at an average annual rate of 0.2% from HK\$5.7 billion in 2005 to HK\$5.6 billion in 2010. (Table 2)

4. 旅遊

4.1 香港是亞太區最著名的旅遊地點之一。近年間，訪港旅客人數持續錄得增長。另一方面，香港居民亦喜愛到世界各地旅遊。

4.2 在本文中，旅遊⁷包括入境旅遊⁸及外訪旅遊⁹。估算入境旅遊的經濟及就業貢獻是較困難的。因為入境旅遊橫跨幾個行業範圍的經濟活動，如零售業、餐飲服務、運輸、住宿服務¹⁰及個人服務業。這些行業的服務對象不單只是旅客，還包括本地居民。因此需要發展一個方法，把選定經濟活動內由於入境旅遊所衍生的增加價值及就業人數區分出來。

4.3 要估算入境旅遊的經濟及就業貢獻，先要就選定與旅遊相關的經濟活動編製旅遊比率，然後利用這些比率把選定經濟活動內由於入境旅遊所衍生的增加價值和就業人數區分出來。這個方法跟國際慣用方法一致。在香港，旅遊比率是根據來自旅客的收益佔總業務收益的百分比而計算出來。

7 在一些經濟體系，旅遊亦包括本地旅遊。本地旅遊是指一個經濟體系的居民在該經濟體系中到自己「經常環境」以外的地方旅遊及逗留。本地旅遊適用於一些較大的國家／地區，因為這些國家／地區的居民可從一個省／城市到另一個遠的省／城市旅遊；但本地旅遊不太適用於香港這個地方細小的城市型經濟體系。這是因為本港居民絕大部分在本地的外出活動不能符合本地旅遊的條件，即（一）外出距離要遠；及（二）在目的地要過夜。故此，我們沒有編製本地旅遊的統計數字。

8 入境旅遊包括零售業、住宿服務、餐飲服務、其他個人服務、客運服務及旅行代理、代訂服務及相關活動，但只限於向抵港的旅客提供服務的部分。

9 外訪旅遊包括過境客運服務及旅行代理、代訂服務及相關活動，但只限於向本港居民提供到境外旅遊的服務的部分。

10 住宿服務包括酒店、賓館、旅舍及其他提供短期住宿服務的機構單位。

4. Tourism

4.1 Hong Kong is one of the most popular destinations for visitors in the Asia Pacific region. Visitor arrivals have undergone sustained growth over the recent years. On the other hand, residents of Hong Kong are keen to visit other places of the world.

4.2 Tourism⁷ in this article covers inbound tourism⁸ and outbound tourism⁹. The economic and employment contributions from inbound tourism are more difficult to measure. This is because inbound tourism comprises a range of economic activities straddling different industries e.g. retail trade, food and beverage services, transport, accommodation services¹⁰ and personal services. These industries serve not only visitors, but also local residents. Hence, a method has to be developed to apportion the value added and employment figures in respect of the selected economic activities to inbound tourism.

4.3 To estimate the economic and employment contributions of inbound tourism, tourism ratios for tourism-related economic activities are compiled to allocate the value added and employment figures in respect of these economic activities to inbound tourism. This method is in line with international practices. In Hong Kong, the tourism ratios are estimated by the shares of the business receipts from visitors in total business receipts.

7 Tourism in some economies also covers domestic tourism. Domestic tourism refers to residents of an economy travelling to and staying in places inside that economy, but outside their "usual environment". While it may be relevant to large countries/territories where residents travel long distance from one province/city to another for leisure, domestic tourism is not really applicable to Hong Kong which is a city economy of relatively small geographical size. It is because most cases of resident travels within Hong Kong do not meet the criteria for domestic tourism i.e. (i) travelling over long distance; and (ii) staying overnight at the destination visited. Therefore, no statistics on domestic tourism have been compiled.

8 Inbound tourism covers retail trade, accommodation services, food and beverage services, other personal services, passenger transport services and travel agency, reservation service and related activities, yet pertaining only to that segment of services provided to visitors to Hong Kong.

9 Outbound tourism covers cross-boundary passenger transport services and travel agency, reservation service and related activities, yet pertaining only to that segment of services provided to Hong Kong residents travelling abroad.

10 Accommodation services cover hotels, guesthouses, boarding houses and other establishments providing short term accommodation.

4.4 在二零一零年，旅遊帶來 746 億港元的增加價值，佔本地生產總值的 4.4%，而就業人數有 218 100 人¹¹，佔整體就業人數的 6.2%。（表三）

4.5 入境旅遊佔旅遊的增加價值的最大部分。入境旅遊的增加價值在二零一零年為 592 億港元，與二零零五年比較，每年平均上升 12.5%。受惠於個人遊計劃的推行及逐步擴大，中國內地訪港旅客成為最主要的上升推動力。入境旅遊佔本地生產總值的百分比在二零一零年為 3.5%¹²，較二零零五年的 2.4% 為高。入境旅遊在二零一零年提供了 190 500 個職位，自二零零五年起每年平均增加 6.8%。（表三）

4.6 一個有趣的現象是零售業的增加價值相對業務收益的比率（二零一零年是 14.8%）較其他與旅遊相關的經濟活動，包括住宿服務（二零一零年是 64.1%）及餐飲服務（二零一零年是 36.9%）的相應比率為低。這顯示若旅客增加在香港住宿及外出用膳的開支，會較他們增加在購物方面的開支，帶來較高的增加價值。

4.4 In 2010, tourism generated value added of HK\$74.6 billion, or 4.4% of GDP. The number of persons engaged in tourism was 218 100¹¹, or 6.2% of total employment. (Table 3)

4.5 Inbound tourism accounted for the largest share of the value added of tourism. The value added of inbound tourism in 2010 was HK\$59.2 billion. Compared with 2005, its value added increased by an average annual rate of 12.5%. The main impetus of growth came from visitors from the mainland of China, benefited from the launch and progressive extension of the Individual Visit Scheme. The share of inbound tourism in GDP was 3.5%¹² in 2010, higher than that of 2.4% in 2005. Inbound tourism provided jobs for 190 500 persons in 2010, increasing at an average annual rate of 6.8% from 2005. (Table 3)

4.6 One interesting observation is that the ratio of value added to business receipts for retail trade is relatively low (14.8% in 2010), when compared with the corresponding ratio for other tourism-related economic activities, including accommodation services (64.1% in 2010) and food and beverage services (36.9% in 2010). This implies that a larger amount of value added would have been generated if a visitor to Hong Kong spends more on accommodation and dining out rather than on shopping.

11 以上文所述的方法編製的就業統計數字，適用於有關旅遊的職位創造和經濟貢獻的分析。此外，政府統計處在《服務業統計摘要二零一一年版》報告書第 15 章亦刊登另外一套與旅遊相關的就業數字，那套就業數字是指與旅遊經濟活動有關的總就業人數。換句話說，那套與旅遊經濟活動相關的就業數字是沒有利用旅遊比率計算出來的。從廣義的角度來看，那套較高的就業數字，可視為所需訓練的從業員的上限數字，因那數字包括現時正在服務旅客及有可能服務旅客的所有從業員。

12 為了解入境旅遊的經濟效益，一些分析員計算與入境旅遊相關的總開支（例如二零一零年為 2,100 億港元）相對本地生產總值的比率作為指標，這個比率在近數年間大約是 10%。應留意不要把這個比率與本文中提及入境旅遊佔本地生產總值的增加價值（在二零一零年為 3.5%）混淆。這是因為前者包括入口貨品及其他中間投產消耗的價值在內，而這些都需要在計算本地生產總值時扣除。

11 Figures on employment as compiled using the above method should be used in the analysis of job creation and economic contribution of tourism. Besides, there is another set of tourism-related employment figures published in Chapter 15 of the report *Statistical Digest of the Services Sector 2011 Edition* by the Census and Statistics Department. That set of employment figures refers to the total employment of economic activities related to tourism. In other words, tourism ratios are not applied to the employment figures of tourism-related economic activities. In broad terms, that set of larger employment figures may be construed as a ceiling figure for the size of the work force that should be targeted for job training as it covers all workers who serve visitors, either at present or potentially.

12 As an indicator of the economic significance of inbound tourism, some analysts have compiled the ratio of total tourism expenditure associated with inbound tourism (e.g. HK\$210.0 billion in 2010) to GDP, which was around 10% in recent years. One should be careful not to confuse this ratio with the value added contribution of inbound tourism to GDP, which is 3.5% in 2010 as given in this article. It is because the former ratio has included the value of imported goods and other intermediate consumption which need to be deducted in the estimation of GDP of Hong Kong.

4.7 至於外訪旅遊，其增加價值由二零零五年的 116 億港元上升至二零一零年的 154 億港元，每年平均增加 5.8%。二零一零年從事外訪旅遊的就業人數有 27 600 人。（表三）

5. 工商業支援及專業服務

5.1 工商業支援服務是指提供予本地經濟體系內其他公司使用的服務（即中間投產消耗），以及向公司及個別人士輸出的服務。工商業支援服務的概念在香港很重要，因為在過去 20 年，多種工商業支援服務在香港急速發展，當中包括進出口、貨物運輸、貿易融資及貨物保險。這些支援服務的急速增長，與本港企業在香港以外，特別是南中國，擴展貨物生產活動有密切關係。事實上，工商業支援服務的興起已把香港從一個製造業中心轉化為以工商業支援服務為主導的服務中心。

5.2 從現時的國民經濟核算架構，我們不容易編製有關工商業支援服務的統計數據。因為將一種服務分類為工商業支援服務或分類為其他服務（即消費服務或集體服務¹³）不是以該服務的特性來決定，而是以使用該服務的目的來決定。事實上，同一項服務，例如餐飲服務，由商務人員為商業目的使用時，便會歸類為工商業支援服務，但由個別住戶使用時，則會歸類為消費服務。

4.7 As regards outbound tourism, its value added amounted to HK\$15.4 billion in 2010, increasing at an average annual rate of 5.8% from HK\$11.6 billion in 2005. The number of persons engaged in outbound tourism in 2010 was 27 600. (Table 3)

5. Producer and Professional Services

5.1 Producer services refer to services for use by other companies (i.e. intermediate consumption) in the local economy, as well as exports of services to companies and individuals. The concept of producer services is important for Hong Kong. This is because over the past two decades, many types of producer services, particularly import and export, freight transport, trade financing, and insurance services on goods have expanded rapidly in Hong Kong. The rapid expansion is closely linked to the expansion of the goods-producing activities of Hong Kong entrepreneurs offshore, particularly across the boundary in South China. Indeed, the rise of producer services has transformed Hong Kong from a manufacturing centre into a service hub dominated by producer services.

5.2 Statistics of producer services cannot be readily compiled from the existing national accounting framework. This is because the classification of a service as producer services or other services (viz. consumer or collective services¹³) is determined not by the characteristics but by the purpose of using the service. In fact, the same service, for example, food and beverage services, is a producer service when it is consumed by a business executive for business purposes, but can also be a consumer service when it is used by a household.

5.3 由於同樣的服務可由公司和個人作不同目的使用，而準確的界定於實行時也是常常遇到困難，因此我們需要利用適當的代指標估算某種服務中有多少屬工商業支援服務。例如，在估算證券經紀服務中有多少屬工商業支援服務時，我們利用了由證監會發布的有關證券經紀從公司客戶賺取經營收入總額的資料作為代指標。若找不到適當的代指標，便要作出假設。例如，我們假設所有寫字樓保養管理和租賃服務都屬於工商業支援服務。至於零售業方面，我們就提供給旅遊人士及作商業用途的服務的比例作出估算。

5.4 專業服務包括法律服務、會計服務、核數服務、建築及工程活動、技術測試及分析、科學研究及發展、管理及管理顧問活動、資訊科技相關服務、廣告、專門設計及相關服務等。這些服務提供給本地、中國內地以至全球的客戶。香港商業服務運作暢順，並已發展成為地區服務中心，實有賴香港提供卓越的專業服務。

5.5 專業及其他工商業支援服務¹⁴ 在二零一零年合共為本港帶來 2,172 億港元的增加價值，並為 466 700 人提供職位。在二零一零年，這些服務的增加價值佔本地生產總值的 12.8%。（表四）

5.3 As the same service can be used by companies and households for different purposes, yet an exact delineation is often difficult in practice, relevant proxy indicators are used for estimating the proportion of the service that is attributable to producer services. For example, to estimate the proportion of stock brokerage service attributable to producer services, statistics of gross operating income of stock brokers earned from institutional clients, as released by the Securities and Futures Commission, are used as proxy indicator. In the absence of suitable proxy indicators, assumptions are made. For example, real estate management maintenance and leasing services of office buildings are assumed to be all related to producer services. As for retail trade, an estimated proportion of the service consumed by tourists and related to business purposes is made.

5.4 Professional services cover legal, accounting, auditing, architecture and engineering activities, technical testing and analysis, scientific research and development, management and management consultancy activities, information technology related services, advertising, specialised design and related services, etc. These services are provided to clients in Hong Kong, the mainland of China and throughout the world. Hong Kong's strength in professional services underpins the smooth operation of the business sector and Hong Kong's development into a regional services hub.

5.5 Professional and other producer services¹⁴ together generated value added of HK\$217.2 billion and provided jobs for 466 700 persons in 2010. The percentage contribution of these services to GDP in 2010 is 12.8%. (Table 4)

6. 香港經濟的四個主要行業

6.1 香港經濟的四個主要行業在二零一零年合共帶來 9,884 億港元的增加價值（即本地生產總值的 58.0%），並僱用 1 690 200 人（即整體就業人數的 48.2%）。二零零五年至二零一零年期間，增加價值每年平均增長 5.5%，而就業人數每年平均增幅為 1.6%。（表五及表六）

6.2 這四個主要行業在本地生產總值內所佔的百分比，在二零一零年是 58.0%，較二零零五年的 55.6% 為高。這主要是由於金融服務的增加價值佔本地生產總值的百分比上升。（表五）

6.3 以上分析的焦點是四個主要行業在二零零五年至二零一零年的五年間，增加價值及就業人數的平均按年變動率。表五及表六亦載有由二零零零年至二零一零年的十年間的相應數字，以供參考。

6.4 在四個主要行業以外的經濟活動，包括製造業、建造業、供給本地個別居民使用的服務（例如：零售、餐飲、通訊、運輸、金融、地產、法律等服務），以及由政府與私人非牟利團體所提供的社區及社會服務。

6. The Four Key Industries in the Hong Kong Economy

6.1 Taken together, the Four Key Industries in the Hong Kong economy generated value added of HK\$988.4 billion (or 58.0% of GDP) and employed 1 690 200 persons (or 48.2% of total employment) in 2010. The value added increased at an average annual rate of 5.5%, while the employment increased at an average annual rate of 1.6% between 2005 and 2010. (Table 5 and Table 6)

6.2 The contribution of the Four Key Industries to GDP in 2010 was 58.0%, higher than the 55.6% in 2005. This was mainly due to the increase in the value added share of financial services in GDP. (Table 5)

6.3 While the above analyses highlight the average annual rates of change in value added and employment in respect of the Four Key Industries in the five-year period from 2005 to 2010, corresponding figures for the ten-year period from 2000 to 2010 are also given in Table 5 and Table 6 for reference.

6.4 Economic activities that fall outside the Four Key Industries include manufacturing, construction, services consumed by local individual residents (e.g. retail, food and beverage, communication, transport, financial, real estate, legal services), and community and social services produced by the government and private non-profit bodies.

7. 資料來源及其他參考資料

7.1 有關增加價值的數據，主要的資料來源是按經濟活動劃分的本地生產總值詳細數字，這是主要根據政府統計處的「經濟活動按年統計調查」搜集得來的數據而編製的。有關就業的數據，主要的資料來源是就業綜合估計數字¹⁵及以按年統計調查所得的資料作補充。旅遊方面，資料來源亦包括香港旅遊發展局的旅遊統計資料。

7. Data Sources and Further References

7.1 For value added figures, the main data sources are GDP by economic activity at detailed levels compiled primarily from data collected through the Annual Survey of Economic Activities conducted by the Census and Statistics Department. For employment figures, the main data sources are the composite employment estimates¹⁵ supplemented by data from annual economic surveys. For tourism, data sources also include tourism statistics of the Hong Kong Tourism Board.

15 Composite Employment Estimates (CEE) are derived by reconciling, under a designated statistical framework, the employment figures obtained from Quarterly Survey of Employment and Vacancies (SEV) and the General Household Survey (GHS). The CEE can reflect a more comprehensive and accurate picture of the territory-wide employment in individual industries, when compared to figures from these two surveys. The estimates are superior to the SEV figures in that the coverage of employed population is more complete. On the other hand, they are also superior to the GHS figures in that the industrial classification in respect of employment figures is more reliable.
