香港經濟的四個主要行業

The Four Key Industries in the Hong Kong Economy

香港政府一直積極推動經濟發展，以保持香港的競爭優勢。香港的四個傳統主要行業，包括金融服務、旅遊、貿易及物流、專業服務及其他工商業支援服務，可帶動其他行業的發展，創造就業，是香港經濟動力的所在。

本文分析有關四個主要行業在 2024 年的經濟貢獻及就業人數。

The Government has been actively pursuing economic development in order to keep up the competitive advantage of Hong Kong. The traditional Four Key Industries in Hong Kong, including financial services, tourism, trading and logistics, professional services and other support services for commerce and industry, have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment.

This article analyses the economic contribution and employment situation in respect of the Four Key Industries in 2024.

香港經濟的四個主要行業

The Four Key Industries in the Hong Kong Economy

1. 引言

1.1 香港政府一直積極推動經濟發展，以保持香港的競爭優勢。香港的四個傳統主要行業，包括金融服務、旅遊、貿易及物流、專業服務及其他工商業支援服務，可帶動其他行業的發展，創造就業，是香港經濟動力的所在。

1.2 根據「香港標準行業分類 2.0 版」¹的界定，四個主要行業中，有些會橫跨不同的行業。有見及此，政府統計處已發展相關的統計架構以量度這些行業的增加價值²及就業人數。

1.3 有關四個主要行業在 2023 年的經濟貢獻及就業人數，政府統計處已在 2024 年 12 月出版的《香港統計月刊》的專題文章中加以分析。本文加入了 2024 年的初步統計數字以更新有關分析。修訂數字將會在 2026 年 5 月於政府統計處網站發布。有關各行業的涵蓋範圍的詳情，請參閱政府統計處的網站 (<https://www.censtatd.gov.hk/tc/scode80.html>) 內所載的資料。

1. Introduction

1.1 The Government has been actively pursuing economic development in order to keep up the competitive advantage of Hong Kong. The traditional Four Key Industries in Hong Kong, including financial services, tourism, trading and logistics, professional services and other support services for commerce and industry, have been the driving force of Hong Kong's economic growth, providing impetus to growth of other sectors and creating employment.

1.2 Noting that some of the Four Key Industries straddle across different industries defined by the Hong Kong Standard Industrial Classification (HSIC) Version 2.0¹, the Census and Statistics Department (C&SD) has developed the relevant statistical framework for measuring the value added² and employment in respect of these industries.

1.3 A feature article analysing the economic contribution and employment situation in respect of the Four Key Industries in 2023 was published in the December 2024 issue of the *Hong Kong Monthly Digest of Statistics*. This article updates the relevant analyses with preliminary figures for 2024 incorporated. Revised figures will be released at C&SD's website in May 2026. 1 香港標準行業分類是一個統計分類系統，用以編製和發布行業統計數字。「香港標準行業分類 2.0 版」是香港標準行業分類的最新版本，以聯合國的《所有經濟活動的國際標準行業分類修訂本第 4 版》為藍本，配合本地的情况作出修訂而編製。

2 增加價值是一個國民經濟核算的名詞。簡單來說，增加價值量度一個經濟活動的淨產值，即所生產的貨物和服務的價值減去生產過程中消耗的貨品和服務（例如購買日常經營所需用品、租金、商用服務費）的價值。一個經濟體中所有經濟活動的增加價值的總和等於這個經濟體的本地生產總值。

1 HSIC is a statistical classification scheme for compilation and dissemination of sectoral economic statistics. The HSIC Version 2.0 is the latest version of HSIC modelled on the United Nations' *International Standard Industrial Classification of All Economic Activities Revision 4* with local adaptations.

2 Value added is a term used in national accounting. In brief, value added measures the net output of an economic activity, i.e. the value of goods and services produced less the value of goods and services (e.g. purchase of materials and supplies, rental, business services charge) used in production. Sum of value added of all economic activities in an economy equals to its Gross Domestic Product.

2. 四個主要行業

2.1 整體計算，四個主要行業在 2024 年為香港經濟帶來 18,119 億元的增加價值，並僱用 1 562 900 人。與 2023 年比較，2024 年四個主要行業的增加價值上升 9.0%，就業人數則下跌 0.6%。（圖 1、表 1 及 2）

2.2 就近年四個主要行業對整個經濟體的貢獻而言，四個主要行業的總增加價值在 2024 年佔本地生產總值的 58.2%，較 2019 年的 56.4% 上升。這主要是由於 2024 年金融服務業佔本地生產總值的百分比較 2019 年為高。四個主要行業的就業人數在 2024 年佔總就業人數的 42.3%，則較 2019 年的 45.4% 為低。（表 1 及 2）


2. Four Key Industries

2.1 Taken together, the Four Key Industries in the Hong Kong economy generated value added of \$1,811.9 billion and employed 1 562 900 persons in 2024. The value added in respect of the Four Key Industries increased by 9.0% in 2024 compared with 2023, while employment decreased by 0.6%. (Chart 1, Tables 1 and 2)

2.2 As regards the contribution of the Four Key Industries to the total economy in recent years, the share of the total value added of these industries in Gross Domestic Product (GDP) was 58.2% in 2024, higher than that of 56.4% in 2019. This was mainly due to the higher percentage share of the financial services industry in GDP in 2024 compared with 2019. The contribution of the Four Key Industries to total employment in 2024 was 42.3%, lower than that of 45.4% in 2019. (Tables 1 and 2)




3. 金融服務

3.1 香港是一個國際金融中心。在 2024 年 9 月，香港於《全球金融中心指數》排名全球第三位，反映香港作為國際金融中心的持久優勢和韌性獲得肯定。除此，在 2024 年底，香港資產管理規模按年增加 13% 至 35.1 萬億港元，充分顯示海內外投資者對香港市場的肯定。

3.2 金融服務的涵蓋範圍廣泛，包括銀行、保險、證券經紀、資產管理及其他金融服務。2024 年金融服務業的增加價值為 8,162 億元（佔本地生產總值的 26.2%），較 2023 年的 7,248 億元上升 12.6%。就業人數在 2024 年為 265 000 人（佔總就業人數的 7.2%），較 2023 年的 269 100 人下跌 1.5%。（表 1 及 2）

3.3 香港的銀行從事多方面的零售及批發銀行業務，例如接受存款、貿易融資、公司財務、財資活動及證券經紀業務。銀行業在 2024 年的增加價值為 5,868 億元（佔本地生產總值的 18.9%），較 2023 年的 5,284 億元上升 11.1%。該行業在 2024 年僱用了 96 100 人（佔總就業人數的 2.6%）。（表 1 及 2）

3.4 至於保險及其他金融服務，主要包括人壽保險及一般保險、證券經紀、資產管理、融資租賃和投資及控股公司等。保險及其他金融服務的增加價值由 2023 年 1,964 億元上升 16.8% 至 2024 年的 2,294 億元（佔本地生產總值的 7.4%）。就業人數在 2024 年為 168 900 人（佔總就業人數的 4.6%）。（表 1 及 2）

3. Financial Services

3.1 Hong Kong is an international financial centre. As of September 2024, Hong Kong ranked third globally in *Global Financial Centres Index*, reflecting recognition of Hong Kong's sustained strength and robustness as an international financial centre. Apart from that, in end-2024, asset under management (AUM) in Hong Kong rose by 13% year-on-year to \$35.1 trillion, fully reflecting the affirmation of domestic and foreign investors towards the Hong Kong market.

3.2 Financial services cover a wide range of services including banking, insurance, stock brokerage, asset management, and other financial services. In 2024, the value added of financial services industry amounted to \$816.2 billion (or 26.2% of GDP), increased by 12.6% from \$724.8 billion in 2023. The employment in 2024 was 265 000 persons (or 7.2% of total employment) with a decline of 1.5% from 269 100 persons in 2023. (Tables 1 and 2)

3.3 Banks in Hong Kong engage in a wide range of retail and wholesale banking business such as deposit taking, trade financing, corporate finance, treasury activities and securities broking. The value added of banking industry was \$586.8 billion in 2024 (or 18.9% of GDP), with an increase of 11.1% from \$528.4 billion in 2023. This industry employed 96 100 persons (or 2.6% of total employment) in 2024. (Tables 1 and 2)

3.4 The insurance and other financial services mainly cover life insurance and general insurance, stock brokerage, asset management, financial leasing, and investment and holding companies, etc. The value added of insurance and other financial services increased by 16.8% from \$196.4 billion in 2023 to \$229.4 billion (or 7.4% of GDP) in 2024. The employment was 168 900 persons (or 4.6% of total employment) in 2024. (Tables 1 and 2)

4. 旅遊

4.1 旅遊業在 2024 年的增加價值為 864 億元（佔本地生產總值的 2.8%），較 2023 年的 753 億元上升 14.7%。就業人數在 2024 年為 159 700 人（佔總就業人數的 4.3%），較 2023 年的 145 300 人上升 9.9%。趨勢與整體訪港旅客持續上升的情況一致。（表 1 及 2）

4.2 旅遊業包括入境及外訪旅遊。入境旅遊³包括零售業、住宿服務、餐飲服務、運輸及其他個人服務等，但只限於向旅客提供服務的部分。入境旅遊的增加價值由 2023 年的 503 億元上升 14.6% 至 2024 年的 577 億元（佔本地生產總值的 1.9%）。入境旅遊在 2024 年為 137 400 人提供職位（佔總就業人數的 3.7%）⁴。（表 1 及 2）

4.3 外訪旅遊則包括過境客運服務及旅行代理、代訂服務及相關活動，但只限於向本港居民提供到境外旅遊的服務的部分。外訪旅遊的增加價值由 2023 年的 249 億元上升 15.1% 至 2024 年的 287 億元（佔本地生產總值的 0.9%）。2024 年從事外訪旅遊的就業人數有 22 300 人（佔總就業人數的 0.6%）。（表 1 及 2）

3 根據國際慣用方法，在量度入境旅遊的貢獻時，會根據來自旅客的收益佔與旅遊有關的經濟活動的總業務收益的百分比計算旅遊比率，再利用這些比率把有關經濟活動內由入境旅遊所衍生的增加價值和就業人數區分。

4 從事入境旅遊的就業人數在 2024 年上升，主要是由於與旅遊有關的經濟活動的旅遊比率上升，從而使利用旅遊比率區分出來的就業人數上升。該就業人數變化不應闡釋為組成入境旅遊的個別行業的整體就業人數變化。

4. Tourism

4.1 Value added of tourism industry was \$86.4 billion in 2024 (or 2.8% of GDP), with an increase of 14.7% from \$75.3 billion in 2023. The employment in 2024 was 159 700 persons (or 4.3% of total employment), with an increase of 9.9% from 145 300 persons in 2023. The trend was in line with the continuous growth in total visitor arrivals. (Tables 1 and 2)

4.2 Tourism industry includes both inbound tourism and outbound tourism. Inbound tourism³ covers retail trade, accommodation services, food and beverage services, transport and personal services, etc., yet pertaining only to the part of services provided to visitors. Value added of inbound tourism increased by 14.6% from \$50.3 billion in 2023 to \$57.7 billion in 2024 (or 1.9% of GDP). Inbound tourism provided jobs for 137 400 persons in 2024 (or 3.7% of total employment)⁴. (Tables 1 and 2)

4.3 Outbound tourism covers cross-boundary passenger transport services and travel agency, reservation service and related activities, yet pertaining only to the part of services provided to Hong Kong residents travelling abroad. The value added of outbound tourism amounted to \$28.7 billion in 2024 (or 0.9% of GDP), increased by 15.1% from \$24.9 billion in 2023. The number of persons engaged in outbound tourism in 2024 was 22 300 (or 0.6% of total employment). (Tables 1 and 2)

3 According to international practices, to measure the contribution of inbound tourism, tourism ratios for tourism-related economic activities are estimated by shares of business receipts from visitors in total business receipts, and are used to allocate value added and employment in respect of these activities to inbound tourism.

4 The increase in employment of inbound tourism in 2024 was mainly attributable to the increase in tourism ratios for tourism-related economic activities. Consequently, employment allocated using tourism ratios increased. Such change in employment should not be interpreted as the change in overall employment of the individual constituent sectors of inbound tourism.

5. 貿易及物流

5.1 在 2024 年，香港為全球第七大商品貿易經濟體系。與 2023 年比較，香港的貨物貿易總值在 2024 年上升 7.3% 至 94,645 億元，其中進口和出口商品貿易分別上升 6.0% 及 8.7% 至 49,221 億元及 45,424 億元。同年，香港國際機場的貨物吞吐量達 490 萬公噸，在世界各地機場排名首位。

5.2 貿易及物流業在 2024 年為香港帶來 5,882 億元的增加價值（佔本地生產總值的 18.9%），較 2023 年 5,479 億元的增加價值上升 7.4%。就業人數方面，貿易及物流業在 2024 年僱用 555 200 人（佔總就業人數的 15.0%）。（表 1 及 2）

5.3 貿易在貿易及物流服務中佔主要部分。貿易在 2024 年的增加價值為 4,756 億元（佔本地生產總值的 15.3%），較 2023 年的 4,447 億元上升 6.9%。就業人數在 2024 年有 384 400 人（佔總就業人數的 10.4%）。（表 1 及 2）

5.4 物流是指籌劃、實施和控制貨物（包括原材料、半製成品和製成品）、服務及相關資訊從來源地至使用地的運送及儲存的過程。這些活動包括貨運、貨運代理、倉庫、郵政及速遞服務。在 2024 年，物流業的增加價值為 1,126 億元（佔本地生產總值的 3.6%），就業人數為 170 700 人（佔總就業人數的 4.6%）。（表 1 及 2）

5. Trading and Logistics

5.1 In 2024, Hong Kong was the world's 7th largest trading economy in goods. Compared with 2023, Hong Kong's value of total merchandise trade increased by 7.3% to \$9,464.5 billion in 2024, of which imports and exports increased by 6.0% and 8.7% to \$4,922.1 billion and \$4,542.4 billion respectively. In the same year, the cargo throughput of the Hong Kong International Airport amounted to 4.9 million tonnes, ranked first among all airports in the world.

5.2 Trading and logistics industry generated value added of \$588.2 billion in 2024 (or 18.9% of GDP), with a 7.4% increase from \$547.9 billion in 2023. In terms of employment, the trading and logistics industry employed 555 200 persons in 2024 (or 15.0% of total employment). (Tables 1 and 2)

5.3 Trading accounted for the main part of trading and logistics services. Its value added amounted to \$475.6 billion in 2024 (or 15.3% of GDP), increased by 6.9% from \$444.7 billion in 2023. The number of persons engaged was 384 400 in 2024 (or 10.4% of total employment). (Tables 1 and 2)

5.4 Logistics refers to the process of planning, implementing and controlling the movement and storage of goods (including raw materials, goods in progress and finished goods), services and related information from the point of origin to the point of consumption. The activities include freight transport, freight forwarding, storage, postal and courier services. In 2024, the value added of logistics industry amounted to \$112.6 billion (or 3.6% of GDP), and the employment was 170 700 persons (or 4.6% of total employment). (Tables 1 and 2)

6. 專業服務及其他工商業支援服務

6.1 作為一個重要的全球商業樞紐，香港的專業服務行業發展多元化，擁有優秀本地人才和豐富國際經驗。

6.2 專業服務及其他工商業支援服務業在2024年合共為香港帶來3,212億元的增加價值（佔本地生產總值的10.3%），並為583 000人（佔總就業人數的15.8%）提供職位。與2023年比較，專業服務及其他工商業支援服務業的增加價值及就業人數分別上升1.9%及0.2%。（表1及2）

6.3 專業服務包括法律服務、會計服務、核數服務、建築及工程活動、技術測試及分析、科學研究及發展、管理及管理顧問活動、資訊科技相關服務、廣告、專門設計及相關服務等。專業服務的增加價值由2023年的1,399億元上升至2024年的1,428億元（佔本地生產總值的4.6%）。就業人數在2024年為253 300人（佔總就業人數的6.9%）。（表1及2）

6.4 工商業支援服務是指提供予本地經濟體系內其他公司使用的服務（即中間投產消耗），以及向外地公司及個別人士輸出的服務。在2024年，其他工商業支援服務（不包括金融服務、貿易及物流、旅遊和專業服務）的增加價值為1,783億元（佔本地生產總值的5.7%），較2023年的1,753億元上升1.8%。就業人數在2024年有329 800人（佔總就業人數的8.9%）。（表1及2）

6. Professional services and Other support services for commerce and industry

6.1 Being an important global business hub, Hong Kong's professional services sector developed diversely, with strong pool of local talent and substantial international experience.

6.2 Professional services and other support services for commerce and industry in Hong Kong together generated value added of \$321.2 billion (or 10.3% of GDP) and provided jobs for 583 000 persons (or 15.8% of total employment) in 2024. Value added and employment of professional services and other support services for commerce and industry increased by 1.9% and 0.2% respectively compared with 2023. (Tables 1 and 2)

6.3 Professional services cover legal, accounting, auditing, architecture and engineering activities, technical testing and analysis, scientific research and development, management and management consultancy activities, information technology related services, advertising, specialised design and related services, etc. The value added of professional services increased from \$139.9 billion in 2023 to \$142.8 billion in 2024 (or 4.6% of GDP). The employment number was 253 300 persons in 2024 (or 6.9% of total employment). (Tables 1 and 2)

6.4 Support services for commerce and industry refer to services for use by other companies (i.e. intermediate consumption) in the local economy, as well as exports of services to companies and individuals outside Hong Kong. In 2024, the value added of other support services for commerce and industry⁵ (other than financial services, trading and logistics, tourism and professional services) was \$178.3 billion (or 5.7% of GDP), increased by 1.8% from \$175.3 billion in 2023. The employment number was 329 800 persons in 2024 (or 8.9% of total employment). (Tables 1 and 2)

5 "Other producer services" has been renamed to "other support services for commerce and industry". The definition and coverage of the industry remain unchanged.

7. 其他備註

7.1 有關四個主要行業對經濟及就業貢獻的估計數字，是反映與其經濟活動有直接關係的增加價值及就業人數。直接經濟效應以外的貢獻，例如其他行業為該行業的生產活動而提供所需投入的溢出效應，並不計算在內。

7. Other remarks

7.1 It should also be noted that the estimates on the economic and employment contributions in respect of the Four Key Industries reflect the value added and employment directly related to their economic activities. Contributions other than the direct economic impact, such as the spillover impact to other industries which provide inputs for use by the industry concerned for its production activities, are not taken into account.
