## 香港貨物協調制度二零一二年版 Hong Kong Harmonized System 2012 Edition

主要作進出口報關用途的「香港貨物協調制度」(簡稱「港貨協制」)已於二零一二年一月一日進行較重要的更新。就二零一二年一月一日或以後裝運貨物所遞交的進/出口報關單,必須按照港貨協制二零一二年版的貨物分類編號及數量單位填報。本文簡單闡述在港貨協制二零一二年版內所作的修訂。

Hong Kong Harmonized System (HKHS), used principally for import and export declaration purpose, has undergone major updating since 1 January 2012. Import/export declarations for shipments on or after 1 January 2012 must be completed using commodity codes and units of quantity in accordance with the 2012 Edition of the HKHS. This article briefly discusses the amendments made in the 2012 Edition of the HKHS.

### 香港貨物協調制度二零一二年版

### **Hong Kong Harmonized System 2012 Edition**

### 1. 背景

- 1.1 「貨物名稱及編號協調制度」(簡稱「協調制度」),是由世界海關組織制訂的多種用途貨物分類制度,可供海關及統計當局、進出口人士、運輸業及其他與國際貿易有關的人士及機構採用。超過 200 個國家和經濟體系已採用這系統,作為徵收關稅和編制國際貿易統計數據的基礎。香港已於一九九二年一月一日起,全面採用協調制度作貿易報關之用。
- 1.2 世界海關組織所制訂的協調制度是一個層次式的貨物分類及編號制度。個別貨品由六個位編號代表,其中首兩個位編號表示該貨品在協調制度內所屬的「章」,首四個位編號表示該貨品所屬的「項」,而整個六位編號則表示所屬的「分項」。例如,母雞屬於分項010594「雉科家禽」內,而該分項則爲第一章「活的動物」內0105項「活家禽」以下的其中一個分項。
- 1.3 協調制度規定以六位編號分項爲貨物的 分類,作爲國際間比較的標準。個別國家/地 區亦可依照本身的特定需要,增添貨物編號的 位數,以作更詳細的貨物分類。「香港貨物協 調制度」(簡稱「港貨協制」)採用合共八位 編號的貨物分類系統,其中首六位編號是全面 採用世界海關組織制定的協調制度,加添的第 七及第八位則用作更詳細的貨物分類,以配合 本地需要。
- 1.4 中華人民共和國香港特別行政區基本法 內註明,香港特別行政區爲單獨的關稅地區。 香港具備本身的貨物編號,與中國內地貿易報 關使用的詳細分類編號不盡相同,但兩者的首 六位編號則是共通的。儘管有不同的關稅系 統,但近年香港與中國內地的貿易關係越趨緊

### 1. Background

- 1.1 The Harmonized Commodity Description and Coding System, or the Harmonized System (HS), is designed by the World Customs Organization (WCO) as a multi-purpose classification system of commodities suitable for use by customs and statistical authorities, importers/exporters, carriers and others involved in international trade. The system is used by more than 200 countries and economies as a basis for their Customs tariff and for the compilation of international trade statistics. Hong Kong has adopted the HS in full for trade declaration purposes since 1 January 1992.
- 1.2 The HS designed by the WCO is a hierarchical system of commodity classification and coding. Each commodity is identified by a 6-digit HS code, in which the first two digits denote the "chapter" in the HS under which the commodity is classified, the first four digits denote the "heading" and the whole six digits denote the "subheading". For example, hens are classified in subheading 0105 94 "fowls of the species *Gallus domesticus*", which is under heading 0105 (live poultry) in Chapter 1 (live animals).
- 1.3 While the HS specifies the commodity classification up to 6-digit subheading level for international comparison, individual countries/territories are free to use additional digits for more refined classification to meet their specific local needs. The Hong Kong Harmonized System (HKHS) uses an 8-digit classification system with the first six digits complying fully with the HS designed by the WCO; and the additional 7<sup>th</sup> and 8<sup>th</sup> digits meeting requirements for more detailed commodity classification in Hong Kong.
- 1.4 As stated in the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China, Hong Kong Special Administrative Region is a separate customs territory. Hong Kong has its own commodity classification which is different from the detailed classification for trade declaration in the mainland of China; but both

密。一項主要的發展是自二零零四年一月一日 起實施的《內地與香港關於建立更緊密經貿關 係的安排》(《安排》)。在《安排》下,附有 《安排》下原產地證書的港製貨物,從香港出 口往中國內地時,可享有零關稅優惠。雙方同 意自二零零六年起,每年按業界提出的申請作 兩次檢討,以增加《安排》涵蓋的貨物項目。 「港貨協制」亦須配合這發展而進行相應修 訂。

### 2. 港貨協制的按年修訂

- 2.1 政府統計處每年均會根據貿易模式及科技方面的重大改變、本地及國際規定和《安排》的發展,更新港貨協制。
- 2.2 本處每年修訂港貨協制時,會把爲了配合《安排》的最新發展所需的改動適當地倂入港 貨協制內。對於《安排》所涵蓋貨物的港貨協 制的修訂,主要是把現有的港貨協制八位編號 分拆爲更詳細的分項,使中國內地與香港在貨 物分類方面更爲協調。
- 2.3 在二零零九年,世界海關組織建議對協調制度作出 220 項的修訂,並要求各《協調制度國際公約》的締約成員在二零一二年一月一日起實施該修訂。為了確保香港的貨物分類制度能繼續與其主要貿易夥伴一致,香港亦於二零一二年一月一日起實施該修訂。

are fully compatible up to the 6-digit level. Notwithstanding the separate customs systems, trade relations between the mainland of China and Hong Kong have become increasingly close in recent years. A major development is the implementation of the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) which has come into effect since 1 January 2004. Under CEPA, exports to the mainland of China can claim zero tariff if the consignment is accompanied by a CEPA Certificate of Hong Kong Origin. Both sides have agreed to review the applications by traders twice a year since 2006, with a view to enriching the coverage of commodity items under CEPA. The HKHS has to be amended accordingly to cope with this development.

### 2. Annual Amendment on the HKHS

- 2.1 Each year, updating of the HKHS is made by the Census and Statistics Department (C&SD) to take account of significant changes in trade pattern and technology, local and international requirements, and development of CEPA.
- 2.2 The required changes in the HKHS to cope with the latest development in CEPA would be suitably incorporated during each annual amendment exercise. Amendments to the HKHS for commodities covered by CEPA are mainly achieved through splitting the existing 8-digit HKHS item codes into more detailed breakdowns, with a view to achieving greater harmonization between commodity classifications of the mainland of China and Hong Kong.
- 2.3 In 2009, the WCO recommended 220 sets of amendments to the HS. Contracting parties to the International Convention on the HS were required to adopt these amendments as from 1 January 2012. To ensure that Hong Kong's commodity classification system continues to be compatible with those of its major trading partners, Hong Kong has also implemented these amendments with effect from 1 January 2012.

2.4 相對於慣常的按年更新工作,是次更新涉及較多貨物條目和進出口人士,因此必須詳細策劃和準備,確保修訂順利進行。港貨協制二零一二年版的籌備工作早於二零一零年十月開始進行。

### 3. 諮詢機制

- 3.1 政府統計處在二零一一年三月至四月進 行諮詢,收集進出口人士、商會、貿易數據使 用者及各政府部門對港貨協制的建議修訂的意 見。
- 3.2 在爲期約一個月的諮詢期,政府統計處在 部門網站邀請公眾對修訂提供意見。期內亦通 知所有使用進/出口報關單及貨物艙單查詢熱 線的人士,可透過傳真索取相關諮詢的文件。
- 3.3 商業機構和有關政府部門的意見和回應,對修訂當時建議的港貨協制二零一二年版均十分有用。透過諮詢收集得到的意見會予以整合及考慮,本處尤其關注進出口人士在按照經修訂的貨物分類制度報關時會否遇到困難。完成諮詢後,港貨協制二零一二年版於二零一一年九月定稿。

2.4 The number of Commodity Items involved and number of importers/exporters affected for the 2012 round updating were much more substantial than those in the regular annual updating exercise. Hence, detailed planning and sufficient preparatory were required to ensure a smooth implementation. Preparatory work for implementing the 2012 Edition of the HKHS started in October 2010.

### 3. Consultation Mechanism

- 3.1 Consultation with importers/exporters, trade organisations, users of trade statistics and government departments was conducted by C&SD during March 2011 to April 2011, the purpose of which was to solicit their comments on the proposed amendments for the HKHS.
- 3.2 The consultation exercise lasted for around one month, during which invitation for suggestions on amendment was also posted on the C&SD website for access by the general public. Furthermore, notification was made under the Import/Export Declaration and Cargo Manifest Enquiry Hotline to all incoming enquirers during the consultation period on the availability of consultation document through the fax-on-demand service of the Hotline.
- 3.3 The comments and feedback from the business sector, together with those obtained from relevant government departments, provided useful inputs for refining the then proposed 2012 Edition of the HKHS. Suggestions received from consultations were consolidated and considered. Particular attention was given to ascertaining whether importers/exporters would have difficulties in lodging declarations in accordance with the changes in commodity classification. The 2012 Edition of the HKHS was finalised in September 2011 after completion of the consultation process.

### 4. 港貨協制二零一二年版的主要修訂

- 4.1 港貨協制二零一二年版的修訂,主要涉及以下部分:
  - 農業部分
  - 化學部分
  - 紙製品部分
  - 紡織原料部分
  - 賤金屬部分
  - 機械部分

這些修訂反映了以下方面的變動和發展:

### (i) 糧食安全的關注

由於聯合國糧食及農業組織,就那些對糧食安全和早期預警方面較爲重要的貨品,採用協調制度作爲基礎進行分類及編碼,所以在食品和農產部分(協調制度的第一至二類)進行了較大量的修訂。修訂中已新增分項以分辨某些品種的魚類、甲殼動物、軟體動物和其他水生無脊椎動物;亦已新增分項以分辨某些可食用蔬菜、根莖、水果及硬殼果和穀物。

### (ii) 環境保護的重要性

修訂中有相當多是與環境保護有關的,包括爲便於監控《蒙特利爾議定書》所管制的消耗臭氧層物質而新增的分項290371至290375;以及爲《鹿特丹公約》所管制的危險化學品及殺蟲劑而新增的分項,例如爲4,6-二硝基-鄰-甲酚及其鹽新增的分項290892。

# 4. Major Amendments in the 2012 Edition of the HKHS

- 4.1 Amendments incorporated into the 2012 Edition of the HKHS mainly involve the following sectors:
  - agricultural sector
  - chemical sector
  - paper sector
  - textile sector
  - base metal sector
  - machinery sector

These amendments reflect changes and development in the following aspects:

### (i) Concerns on food security

The Food and Agriculture Organization of the United Nations (FAO) has used the HS as standard in classifying and coding commodities of specific importance to food security and the early warning system on food and agriculture. The volume of amendments made to food and agricultural sectors (Section I-II of HS) are therefore quite substantial. New subheadings have been created for the separate identification of certain species of fish and crustaceans, molluscs and other aquatic invertebrates; and for the separate identification of certain edible vegetables, roots and tubers, fruit and nuts, as well as cereals.

### (ii) Importance of environmental protection

Many amendments are related to the protection of the environment, including the creation of new subheadings 2903 71 to 2903 75 to facilitate the monitoring of ozone-depleting substances controlled under the Montreal Protocol; and the creation of new subheadings for certain hazardous chemicals and pesticides controlled under the Rotterdam Convention, such as subheading 2908 92 for 4,6-Dinitro-o-cresol (DNOC(ISO)) and its salts.

### (iii) 貿易量的變動

對貿易總量較低的商品分項進行合併或 刪除,從而簡化港貨協制。另一方面,就 貿易量相當的產品新增分項,例如百合 花、蔓越橘及蔓越橘汁、水煙筒煙絲和木 粒。

#### (iv) 科技的發展

隨著科技的演變,市場上有不少新產品推出。配合這方面的發展,爲生物柴油新增項目 3826,亦修訂項目 3002 "免疫產品"的定義及其相關的章註釋。

### (v) 《安排》的發展

舉例來說,爲配合《安排》第九階段的實施,在港貨協制二零一一年版的條目 2309 1000 所指供零售的狗或貓飼料已在 二零一二年版細分爲兩個不同條目,分別 爲條目 2309 1010 - 罐頭狗或貓飼料和條目 2309 1090 - 其他供零售的狗或貓飼料。

### (vi) 確保闡釋和應用協調制度的一致性

為確保闡釋和應用協調制度的一致性,通過在類註釋、章註釋、項目註釋及分項註釋和文字方面的修訂,進一步詳細描述和界定某些條目的產品範圍,以減少混淆。例如,分項 4706 93 的條文 "半化學"修改為 "經機械和化學結合製程獲得";以及在第 42 章新增註釋,以界定"皮革"的定義。

### (iii) Change in trade volume

Some subheadings are deleted or combined on account of low volume of trade with a view to simplifying the HKHS. On the other hand, new subheadings are created for those products with significant trade volume, such as lilies (*Lilium spp.*), cranberries and cranberry juice, water pipe tobacco and wood pellets.

### (iv) Technological development

Alongside with technological progress, new products have been launched in the market. To cope with this trend, new heading 3826 has been created for biodiesel. Amendments have also been made to the chapter note in defining immunological products under heading 3002.

### (v) Development of CEPA

For example, item code 2309 1000 for dog or cat food, put up for retail sale in 2011 Edition of the HKHS has been split into two different item codes in 2012 Edition to cope with the implementation of CEPA Phase IX, including item code 2309 1010 for canned dog or cat food and item code 2309 1090 for other dog or cat food, put up for retail sale.

# (vi) Ensuring uniform interpretation and application of the HS

To ensure the uniform interpretation and application of the HS, amendments have been made to some section notes, chapter notes, heading notes, subheading notes and textual descriptions so as to further elaborate and specify the coverage of products for certain item codes to reduce confusion. Examples include the replacement of "semi-chemical" by "obtained by a combination of mechanical and chemical processes" for subheading 4706 93; and addition of a new note for Chapter 42 to specify the definition of "leather".

4.2 第4.1 段提及的修訂涉及約500 個貨物條目,其變動可分爲下列四類:

### (i) 貨物編號改變

指港貨協制二零一二年版以不同的貨物 編號替代了二零一一年版的編號,而新 編號涵蓋範圍和舊的則完全一致。例如:

### (ii) 貨物編號分拆

港貨協制二零一二年版

1604 3100 - 魚子醬

1604 3200 - 魚子醬代替品

### (iii) 貨物編號合併

指港貨協制二零一一年版為兩個或多個 貨物編號,在二零一二年版則合併為一個 編號。例如:

2932 2100 - 香豆素、甲基香豆素及乙基香豆素

2932 2900 - 其他內酯

<u>港貨協制二零一二年版</u> 2932 2000 - 內酯 4.2 Around 500 Commodity Items are involved in the amendments mentioned in paragraph 4.1. Changes resulted from these amendments can be categorised into the following four types:

### (i) Change in Commodity Item code

A Commodity Item code in the 2011 Edition of the HKHS is replaced by a different code in the 2012 Edition without change in scope. For example,

2011 Edition of the HKHS

0101 9011 - Horses for racing

2012 Edition of the HKHS

0101 2910 - Horses for racing

### (ii) Splitting of Commodity Item code

One Commodity Item code in the 2011 Edition of the HKHS is split into two or more separate codes in the 2012 Edition. For example,

2011 Edition of the HKHS

1604 3000 – Caviar and caviar substitutes

2012 Edition of the HKHS

1604 3100 - Caviar

1604 3200 – Caviar substitutes

### (iii) Merging of Commodity Item codes

Two or more Commodity Item codes in the 2011 Edition of the HKHS are merged into one code in the 2012 Edition. For example,

### 2011 Edition of the HKHS

2932 2100 – Coumarin, methylcoumarins and ethylcoumarins

2932 2900 - Other lactones

2012 Edition of the HKHS

2932 2000 - Lactones

### (iv) 部分轉移

指港貨協制二零一一年版爲一個貨物編 號所涵蓋的貨品,其中部分在二零一二年 版分拆至不同編號。例如:

4101 2011 - 整張牛皮,經逆鞣處理, 只經晾乾的每張重量不 超過八公斤、經乾鹽醃的 不超過 10 公斤、新鮮或 經濕鹽醃或用其他方法 保藏的不超過 16 公斤

4101 2011 - 整張牛皮,未經剖切,經 逆鞣處理,只經晾乾的每 張重量不超過八公斤、經 乾鹽醃的不超過 10 公 斤、新鮮或經濕鹽醃或用 其他方法保藏的不超過 16 公斤

Part of commodities covered in a Commodity Item code in the 2011 Edition of the HKHS is transferred to other code(s) in the 2012 Edition. For example,

### 2011 Edition of the HKHS

4101 2011 – Whole hides and skins of bovine animals, undergone a reversible tanning process, of a weight per skin not exceeding 8 kg when simply dried, 10 kg when dry-salted, or 16 kg when fresh, wet-salted or otherwise preserved

### 2012 Edition of the HKHS

4101 2011 – Whole hides and skins of bovine animals, unsplit, undergone a reversible tanning process, of a weight per skin not exceeding 8 kg when simply dried, 10 kg when dry-salted, or 16 kg when fresh, wet-salted or otherwise preserved

4101 9000 – Other whole hides and skins

4.4 《香港進出口貨物分類表(協調制度) 二零一二年版》是載有全套港貨協制二零一二 年版的刊物,共分爲兩冊,進出口人士可於政 府統計處網站(www.censtatd.gov.hk/trader/ declaration/index\_tc.jsp)免費下載該刊物。刊 物亦備有印刷版,現已發售,每冊 72 元。顧 客可親臨政府統計處刊物出版組購買(地址: 灣仔港灣道十二號灣仔政府大樓十九樓;電 話: 2582 3025 )或於網上政府書店 (www.bookstore.gov.hk)購買。

### 5. 港貨協制二零一二年版的宣傳活動

- 5.1 香港是一個自由港,有很多從事進出口業務的人士。因此,有必要廣泛宣傳,讓進出口人士清楚知道港貨協制二零一二年版的變動。在這方面,統計處於二零一一年十月至二零一二年三月期間進行一連串宣傳活動,加強進出口人士對港貨協制二零一二年版的認識。
- 5.2 相關的宣傳活動包括於二零一一年十一月十四日發出新聞稿、透過報關事宜查詢熱線作出宣傳及郵寄進出口報關須知予約 13 000 個受影響的進出口人士。有關修訂事宜已於二零一一年十一月十一日刊登憲報。
- 5.3 除提高各界對分類表的一般認識之外, 政府統計處與香港海關攜手合作,在二零一一 年底至二零一二年初舉辦主題研討會,向進出 口人士介紹港貨協制於二零一二的修訂事項。

4.4 The "Hong Kong Imports and Exports Classification List (Harmonized System) 2012 Edition" is a publication in two volumes, containing the complete 2012 Edition of the HKHS. Importers/exporters can download this publication free of charge from the website of C&SD (www.censtatd.gov.hk/trader/declaration/index.jsp). Print version of this publication is also available for sale at HK\$72 per volume. Purchase can be done in person at the Publications Unit of C&SD (Address: 19/F, Wanchai Tower, 12 Harbour Road, Wan Chai; Tel.: 2582 3025) or through Online Government Bookstore (www.bookstore.gov.hk).

# 5. Publicity Activities of 2012 Edition of the HKHS

- 5.1 While Hong Kong is a free port with a large number of persons involved in import and export business, extensive publicity activities have to be organised to ensure that importers/exporters are well informed of the changes in the 2012 Edition of the HKHS. In this regard, a series of publicity activities is launched from October 2011 to March 2012 to enhance the awareness of importers/exporters about the 2012 Edition of the HKHS.
- 5.2 These publicity activities include the issue of a press release on 14 November 2011; making announcement in the Import/Export Declaration and Cargo Manifest Enquiry Hotline and mailing Notice on Lodgement of Import and Export Declaration to some 13 000 affected importers and exporters. The corresponding gazette notice was issued on 11 November 2011.
- 5.3 Apart from raising general awareness about the Classification List, topical seminars were also conducted jointly by C&SD and the Customs and Excise Department during late 2011 to early 2012 to give an introduction on the amendments to the HKHS in 2012 to importers/exporters.
